The MSP has not always been so closed-mouthed about their investigation in the OCKK case since they reopened the investigation in 2005. On August 23, 2007, "Scientists at the Michigan State Police Crime Lab say they have completed a reanalysis of the evidence from the Oakland County Child Killer case. Their search turned up new genetic material." <http://www.wxyz.com/news/story/New-DNA-in-Oakland-County-Child-Killer-Case/GkOlbVcZJUaP5BLQOwGbKg.csp> "We had nothing but a single hair up until the lab went over all the information again," explained Sgt. Garry Gray of the MSP. "We're excited about what we have found. I'm not saying it's gonna solve the case, but it's given us a little information, we're going forward with that," he said.

Here's what happens if you are from Bloomfield Village:

"Michigan State Police officials have declined to comment on whether a suicide victim and suspected sex offender was a suspect in the Oakland County child killer case. State Police Capt. Harold Love said they have no comment on recent media reports about the possibility Christopher Brian Busch is a suspect in the more than 30-year-old serial killer case." (First of all, if you plead guilty to criminal sexual conduct with a minor, which Busch did (see, for example, Case No. 77-27478-FY, Genesee County), that makes you more than a "suspected" sex offender. Second—suicide?! Or "apparent suicide"?)

Here's what happens if you are NOT from Bloomfield Village:

On February 17, 2005, the MSP hosted a news conference to discuss new leads in the OCKK investigation. <http://www.clickondetroit.com/news/4210177/detail.html> The MSP gave no specific details about their new lead, however it was reported that DNA evidence did not link David Norberg to the killings, "BUT HE REMAINS A SUSPECT." If you're David Norberg, your name gets printed, your DNA status gets printed and the fact that you are still a suspect is printed.

If you're Todd Warzcheha, the fact that he was found hanging in a shed in June 2005, dead of an APPARENT suicide, after MSP detectives contacted him to ask about the 1972 cold case homicides of two teenage boys and the OCKK killings, is news. <http://www.clickondetroit.com/news/4620716/detail.html> Not only that, the then Oakland County Prosecutor speculated that the suicide "could be 'compelling evidence' in regards to the" OCKK killings. I wonder if he had a drawing of one of the victims in the shed with him? I wonder why Busch's apparent suicide is in no way compelling? Also, Warzcheha "was previously questioned about the deaths of the four children." DNA samples were obtained from his body "to determine if there is a match in the Oakland County homicides."

(Hey, John H. and Chris Busch were previously questioned in this case but no one wants to talk about that. John does not and cannot deny that he was questioned in 1977, 1992 and 2008. Nor can he deny that he was asked for and provided a DNA sample to the

Georgia Bureau of Investigation in February 2008. But you're not going to read or hear a news report about that. Think Chris Busch was never questioned about the OCCK murders? Then check out an article in The Detroit News on February 22, 1977, "Oakland County link probed in sexual exploiting of boys," written by Richard Willing. Chris Busch, Gregory Green and Douglas Bennett were arrested in Flint for sexual exploitation of an estimated 30 boys. "Oakland County Prosecutor L. Brooks Patterson confirmed today that information developed in the Flint investigation suggests that some of the victimized boys had been procured in Oakland County." "Patterson emphasized that the cases are seemingly unrelated to the murder of Mark Stebbins, a 12-year-old Ferndale boy, sexually molested and then killed early last year." "Oakland County investigators have interviewed two of the men arrested in Flint, have given them lie-detector tests and concluded they are not suspects in the Stebbins case." February 22, 1977 was after Mark, Jill and Kristine had been abducted and murdered, but before Tim was abducted and murdered.)

If you are Randall Raar, it's news that the MSP raided your Lincoln Park home in May 2006 based on information from a federal inmate that you "may be linked to the Oakland County child killer case." <http://www.clickondetroit.com/news/9202297/detail.html>

"Raar is considered a link in the case and a task force is currently collecting evidence to eliminate him as a suspect in the slaying of four area children." "The task force met on Thursday to discuss the case. They will go back to the Lincoln Park home to serve another warrant. Task force members of the Oakland County child killer investigation said there are 10 suspects on the list, but Raar was not one of them; they hope Raar can help them figure out who the child killer is.

(Searching Busch's old home in Bloomfield Village is not news, however. It was such a big, fat secret that David Gorcyca, the Oakland County prosecutor who obtained the search warrant for the home in late October 2008 did not even tell his successor, Jessica Cooper about it when she took over the office in January 2009. Somebody should ask him about that. The MSP wanted Raar's help, but does not want Johns' help in "figuring out" who the child killer is.)

If you are Michael Dean Grant, it's news in February 2007 that your son thinks you are the OCCK and that "Detectives are hoping to get a DNA sample from Grant." "They would like to compare his DNA with a strand of hair that might have belonged to the Oakland County Child Killer."

I think everyone remembers what happens if you are Ted Lamborgine. (If not, Google him—this was in early 2007).

But none of this happens if you are Chris Busch or anyone who could possibly be linked to him. It doesn't happen if you are John H. No, "Love would not comment on whether Busch is a suspect in the case, saying it is an ongoing investigation." <http://www.macombdaily.com/articles/2009/11/08/news/srv0000006778918.txt>

Wasn't it an ongoing investigation when the MSP provided information about those other men? "We are hoping there will come a point and time to bring this together and have everybody come together and present a conclusion to the public and to everybody else so we can put this thing to bed," he said." If that isn't the most mealy-mouthed bunch of bullshit ever, it is pretty damn close. Compare that with the words of the editorial in The Royal Oak Daily Tribune on November 25, 2009. "The King family believes that investigators are dragging their feet, perhaps as a result of friction between different agencies involved. It's possible. Friction between investigating agencies has gotten in the way solving a crime before, from federal to local levels. □ We hope that's not the case here. A lot of people in this region would like the killer brought to justice if he's still alive, his name known for certain if he's dead. And for family members and some retired investigators, it's more than "like." It's a pressing need."
