## OCCKC INVESTIGATIVE QUESTIONS REVISED 05-23-2011

## QUESTIONS RELATING TO CHRISTOPHER BUSCH

- Where did Christopher Busch (hereinafter "CB") work before being employed at Franklin apartments?
- 2. What was his work schedule at the apartments?
- Who did he work with besides Susan Gorosh at the apartments? Were they interviewed?
- 4. Who were the other victims CB tried to molest in the Flint, MI area? Were these victims ever identified and interviewed?
- 5. Who were the other suspects listed on the MSP Flint report besides CB and Gregory Greene (hereinafter GG)? Were they located and interviewed? Polygraphed? Provide DNA samples? Note: Former Detective Doan (Southfield PD) said one of the suspects moved to Alabama and the other went to jail.
- Where is the evidence confiscated by Flint (MSP)P.D. from the Alma residence on 1-28-1977? i.e., Two suit cases, ropes, two shotguns etc. Was this evidence processed by MSP or FBI crime labs? Was this picked up by the FBI back in 1977?
- 7. Where is the evidence from the CB suicide scene now? i.e., vodka bottle, three spent shell casings, box of bullets, marijuana, ropes and crime scene photos? Was this processed by the FBI or MSP crime lab?
- 8. Who was the CB associate from Berkley and was he identified and interviewed?
- Was CB a meticulous and or very neat person? Suggest Charles Busch, Jr. and or CB's nephews be contacted again to find this out. Note: Why? The killer reportedly meticulously groomed, bathed, and cleaned his victims.
- 10. Did CB associate with other Big Brothers from the program? Who were the other Big Brothers? Was he involved with a girl his age in the program? i.e., a staff person?
- 11. Who was at CB's funeral that also went up to Ess Lake to ride motorcycles? Note: CB's nephew mentioned this when interviewed. He said that a friend of CB's was at the funeral who also went up to Ess Lake to ride motorcycles. The funeral was held at the Hamilton Funeral Home (Bell Chapel) in Birmingham on Maple Rd. right across from the Hunter Maple pharmacy. What other friends or associates signed in at the CB funeral? Note: locate ownership history.

- 12. Were the minors seen with CB at Ess Lake on 3-19-2011 ever identified and or interviewed?
- 13. Was it ever confirmed in writing/official records that CB or CB's parents owned the cottage at Ess Lake? Note: it appears so from the reports
- 14. Were CB and GG cousins?
- 15. Was it ever confirmed that CB bought a blue Chevy Vega at Al Serra Chevrolet back in January 1977?
- 16. Who did Detective Junior Brandenberg interview regarding his/her claim that they saw CB with three young boys approx. 13, 14 and 15 years old at the IGA on March 19, 1977? Was the information credible?
- 17. Who did CB admit he molested when interviewed by Detective Brandenberg on 3-3-1977? Was this victim interviewed during the recent investigation?
- 18. CB stated to Detective Brandenberg on 3-3-1977, that Gregory Greene was violent and tried to strangle a boy in Flint? Was this victim Kenneth Bowman?
- 19. Bowman claimed that CB and GG had another associate, who was he?
- 20. Was the Bowman interview by MSP productive? Was he able to name any other associates of CB? Was a cousin of CB involved? If so, who was he and was he interviewed recently?
- 21. Was CB, GG, Lamborgine, Lawson and or Hastings artistically inclined?
- 22. Did CB (or any of his relatives, i.e. his brother who lived on Mohegan) or GG ever work at the Hunter Maple Pharmacy? Was there anyone else working there also involved with the Big Brother program or associated with Tiny Tim's Hobby shop? Note: Is there a list of employees available?
- 23. Did the latent prints lifted from the rifle at the CB suicide scene come back to CB or GG? Were they good enough to run through the national data base (AFIS)? What were the results if any?
- 24. Were the CB residences in Alma and Sanford forensically searched (specifically for animal hairs) by MSP or FBI evidence response teams in the recent investigation? Brent Busch stated that CB took his dogs to Ess Lake, Alma and Sanford.
- 25. Charles Busch, Jr. stated that someone (likely a family member-brother) "is an artist and was employed as an advertising executive during the mid

1970's when CHRIS committed suicide." Who was this family member? Could they have been the artist that drew the picture of the boy that resembled Mark Stebbins that was recovered at the suicide scene?

- 26. Did CB have any associates that worked at the Hunter Maple Pharmacy? If so, was he interviewed and polygraphed in the recent or investigation? Does he have a criminal history?
- 27. Who ran the Big Brother program that was CB involved in?
- 28. Did CB take any other art classes besides those required at the Switzerland boarding school?
- 29. Did the hair recovered from Tim King's scrotum match CB or any other suspect?
- 30. What was tip # 1035?
- 31. How did Charles Busch, Jr. know that CB had molested a boy from the Big Brother program in Birmingham and how did he know his mother worked at Fishers Food Market down the street? Was this boy identified and interviewed? Note: Charles Busch, Jr. must have been pretty close to CB to know this.
- 32. Was Charles Busch, Jr. asked if CB owned a handgun and or handcuffs?
- 33. Were the carpet fibers from CB's parent's home compared to the fibers from the victim's socks?
