

1 inmate about the Oakland County Child Killings. During this conversation, the corrections officer
2 overheard Lamborgine tell the other inmate that he had sex with the kids from the Oakland County
3 Child Killings, but he was not the one that killed them. This is a very interesting statement if it can be
4 confirmed. Based on my knowledge of Lamborgine and things we've learned about Ted during this
5 investigation it leads me to believe that he did in fact make this admission. A statement like this also
6 corroborates Lamborgine's actions during this investigation, the failed polygraph about the OCCK case
7 and statements he has made to detectives. I am referring to statements that he made during
8 questioning about the killings. Never once during this investigation has there been an adamant denial
9 by Lamborgine regarding his involvement in the killings and never did he have a valid explanation for
10 failing the polygraph in the OCCK case. Lamborgine, when questioned about the killings stated, "I
11 haven't done what you think I have." This would match him having molested the kids, but not killing
12 them. Also, when we were trying to negotiate with Lamborgine to cooperate with us in the OCCK case,
13 Lamborgine stated, "I don't want to be labeled a murderer or accessory to murder." This statement also
14 corroborates this admission Lamborgine supposedly made to the corrections officer recently.

15 John Ouelett (FBI) asked Garry Gray if this statement by Ted is being investigated, to which Gray
16 stated that they were looking into it. We had some discussion about serving investigative subpoenas
17 on Ted's family and the Tazelaar brothers. I stated that [REDACTED] needs to be interviewed first
18 before serving the Tazelaars, because [REDACTED] may be able to clarify the connection between Ted, the
19 Tazelaars & Francis Sheldon, which, Josiah Tazelaar has been lying about. The meeting was then
20 adjourned.

21 9-29-07: *** (See 2-14-07 in this report for the connections between Ted Lamborgine, Josiah
22 Tazelaar, "Duffy", Ted Miller, Francis Sheldon, Bob Moore and others. Also some theories
23 about the connections and their possible involvement as co-conspirators in the OCCK case) ***
24 I identified and located [REDACTED] earlier this year. He needs to be interviewed to possibly establish
25 the connection between Ted Lamborgine, the Tazelaar brothers and Francis Sheldon. This would make
26 Lawson's theory even more credible. The info Lawson gave Barry King in 1988 has for the most part
27 been confirmed, including the information about "Kim" in Amsterdam naming #1 by name, to Lawson,
28 as a person involved in the King killing. Tazelaar lied to investigators about knowing Lamborgine, until
29 he was confronted and couldn't deny it, then he minimized his connection with Lamborgine. It makes
30 sense that Tazelaar is the subject Lawson called #1 that was a co-conspirator with Bob Moore and Ted
31 in the King killing, with Tazelaar possibly traveling to Amsterdam to see Francis Sheldon after Sheldon
32 fled the United States while under indictment in 1976. Tazelaar lived and hung around the 6 Mile &
33 Woodward area in Highland Park. *** Again, see 2-14-07 for all the connections, so far. —————>

34 9-30-07: Tomorrow is the Circuit Court motion in front of Judge Tim Kenny, where a decision will be
35 made on whether or not the polygraph examiner (Larry Wasser) will be ordered by the judge to give me
36 the name of the person who supposedly confessed to the killings in front of Wasser and the subject's
37 attorney, in Wasser's office 30 years ago. This person may be connected to Lamborgine, Moore and/or
38 Tazelaar.

39 10-3-07: I was talking to John Oulette today from the FBI, who told me that Jason Bolinger (FBI) &
40 Dave Wurtz (Oakland County Sheriffs) went and talked to Ted Lamborgine today about re-taking the
41 polygraph. I guess Ted told these guys that an inmate in his facility that claims to be a distant relative
42 of Tim King's is threatening to kill him if he doesn't re-take the polygraph. John stated that Ted agreed
43 to take it, so I guess the FBI is going to conduct it in the near future.

44 10-3-07: *** (I identified "Ken" Collinson today, associate of Josiah and Willem Tazelaar) *** I
45 have been trying to identify an associate of Josiah Tazelaar's from 88 Stevens named John Robertson,
46 to no avail (the name is too common). During an earlier interview with Josiah Tazelaar's brother,
47 Willem, he told me that John Robertson is deceased, but there was another friend of Josiah's named
48 Ken Collinson that used to hang around with Josiah at 88 Stevens in Highland Park in the 1970's. Ted
49 Miller (the guy that tried to confess to a priest about killing Tim King in March of 1977, put John
50 Robertson down as an associate of his during an interview in 1977. Miller listed Robertson's address
51 as 88 Stevens in Highland Park). Willem told me that he thought Collinson was alive, around 60 years

1 John Robertson. This is also the same house that ██████████ told police that he met a boy named
2 "Skinny" that was brought to 88 Stevens by "Duffy", Ted's roommate for sex. So here we have a guy
3 trying to confess to the killing of Tim King that is connected to Josiah Tazelaar at the same house
4 where Ted, who failed the polygraph in the OCCK case's roommate "Duffy", was bringing and sharing
5 boys. *** Ted Miller was only cleared because the police in March 1977 interviewed a friend of Ted
6 Miller's named George Richards, who told police not to believe Ted Miller because he gets drunk and
7 makes these types of calls all the time. *****(The police then cleared Miller and never polygraphed
8 him)** *** This may have been a big mistake, because George Richards was a close friend of Josiah
9 Tazelaar's and possibly Francis Sheldon, both of which show connections with Ted Lamborgine that
10 failed the polygraph and possibly made admissions about involvement. This cover-up of Ted Miller by
11 Richards may have possibly been done to disassociate the co-conspirators in the OCCK case. Also at
12 this time, Bob Moore (close friend of Ted Lamborgine) had an apartment above the movie theatre on
13 Woodward Ave. @ 6 mile, a block from 88 Stevens. Remember, according to Lawson, Ted
14 Lamborgine showed him a Polaroid of Timothy King at Bob Moore's house in the Cass corridor, when
15 Moore became upset, knowing that Lawson was a snitch. *** **(See tip on Ted Miller located 2-16-
16 07)...I located Ted Miller, see 2-19-07...I went to his home in Detroit 3-9-07..He was confirmed
17 deceased)**...I believe based on this investigation that **possibly** Ted Lamborgine and Ted Miller are the
18 subjects who dumped Timothy King's body in Livonia. A witness that called Livonia Police dispatch in
19 the evening hours prior to King's body being found, described two subjects on Gill Rd. in a dark colored
20 Gremlin. One supposedly matched the composite and the other had a dark colored small to medium,
21 "afro" type hair. Ted Lamborgine wore fancy wigs and Miller in his 1977 photo has frizzy almost, "afro"
22 looking hair. Ted Miller was familiar with this area and Ted also grew up in Redford.

23 Another interesting possibility is that Josiah Tazelaar is the "#1" subject that Lawson described to Barry
24 King in the 1988 FBI report that we have been trying to identify. We had already known that # 2 was
25 Bob Moore and # 3 was Ted from their descriptions in that report. # 1 had told Lawson in the late 70's
26 or early 80's, that he had seen the King boy in a child porn movie. According to Lawson, #1 was living
27 in the Highland Park area at that time and was named by "Kim" (child porn magazine owner in
28 Amsterdam) to Lawson in 79 when Lawson was in Amsterdam, as having been involved in the killing of
29 Timothy King. We have already confirmed that Lawson did in fact travel to Amsterdam in 1979 and
30 according to Louise Hodgson when interviewed in 1977, Josiah makes trips abroad (indicating out of
31 the country). Josiah is Dutch and Amsterdam is the "Child Porn Capital." This is also where Francis
32 Sheldon fled to in 1976 while under indictment. Francis Sheldon was a millionaire and was involved in
33 financing child porn just like Lawson had told me. Francis Sheldon's activities in Amsterdam and this
34 "Kim" subject were both confirmed by the FBI stationed in Brussels. We had sent a lead to Brussels to
35 check on this for us and received the positive response 2-7-07. *** **(See details from FBI report from
36 Brussels on 2-7-07 for this information about Sheldon and "Kim.")** ***

37 2-14-07: *** **(Identified "David" Shultz today. Real name is Kent Gilbert Shultz, w/m, 11-26-
38 1944.)** *** I was reading over the Francis Sheldon file tonight and observed a Kent Gilbert Shultz, born
39 11-26-1944, who resides at 17 Church St. Highland Park, Michigan. We have been trying to identify
40 the David Shultz that Lawson and Ike McKinnon talked about arresting in 1977 for child molestation in
41 Highland Park. I knew David Shultz had lived in the house on Church Street, near Woodward and
42 Church, behind the Methodist Church. I drove by there and observed that all the houses behind the
43 church are gone. I knew the addresses would possibly be 19, 21, 23...etc. This Kent Gilbert Shultz at
44 17 Church Street matches what Lawson described for David Shultz.

45 2-15-07: This morning I ran a criminal history check on Kent David Shultz and observed an arrest by
46 the Wayne County Task Force in October of 1977 for child molestation. This matches what Richard
47 Lawson and retired Detroit Police Dept. Chief Isiah McKinnon told me about "David" Shultz. I ran a
48 check on Kent Gilbert Shultz through the OTIS system and observed him to be currently in Jackson
49 Prison for Child Molestation. He was sentenced in 1985 to 20-40 years for 2 counts of CSC 1 (child
50 u/13).

51 2-15-07: Today Garry Gray (MSP) and I met with the King family at their home in Birmingham. The
52 purpose of this meeting was to update the family on the direction this lead is taking, and the latest
