Requests for donations and a bulletin would come from the farm and advised that he returned an inquiry to them about their runction. He then became interested in the farm and made several donations himself. He advised that he never visited the farm nor had he ever received any material from them other than the bulletin.

Additional information learned during the interview with was that he was employeed by the Wayne County Dept. of Social Services and that he was presently a foster parent to a male child. He is siggle and lives alone. He expressed shock and dismay at the homesexual implication of the farm. It should also be noted that is listed as one of the farm sponsors.

This information is to be followed-up by an F.B.I. agent to determine if, in fact, FRANCIS SHELDEN is on Antigua.

INFORMATION:

On or about May 22, 1978, the Seventh District Commander CAPTAIN JOHN COSGROVE received information from Grand Traverse County Sheriff RICHARD WEILER that an association known as the Manitou Island Association and the William Angel Foundation were holding meetings in Lansing reference activity on North Manitou Island. Sheriff WEILER felt that it should be investigated to determine if the association or the William Angel Foundation was connected with the activities on North Fox Island. Attached is an intelligence report from MSP, Lansing, completed by D/Sqt. SOELTNER in which information was gathered reference the meeting held at the Hospitality Inn in Lansing, Michigan. A copy of that report will be attached to the post copy of this complaint.

INVESTIGATION:

On 5-24-78 undersigned officer interviewed Leelanau County Undersheriff DAVID GILL. He advised that the Manitou Island Association has been in existence a long time and that it was backed by big corporations. To his knowledge it was a non-profit organization, that the money was donated to colleges and the upkeep of North Manitou Island. He knew nothing of the William Angel Foundation, but stated that he had heard of it.

This date undersigned officer interviewed JACK BARRATT, Magistrate, 86th District Court and long-time resident of Leelanau County. He advised that in the 1930s he was stationed on Manitou Island as a member of the Coast Guard, and at that time the Manitou Island Association existed; that it was in fact a non-profit organization of very wealthy individuals dedicated to the upkeep of North Manitou Island, and felt that it had been an association for the last forty years. He advised that William Angel was either chairman of the board or president of the Continental Motors Corporation of Michigan; that Mr. Angel died in the early '50s, he believed 1953, and that the association donates all their proceeds to hospitals or colleges in the state of Michigan and that in no way was it connected with North Fox Island or activities involving young people. He advised further that a lot of wealthy and influential persons hunt on North Manitou Island.

INTERVIEW PETE JURICA:

Mr. JURICA is owner/ PETE JURICA. operator of Lake Michigan Hardwood Corporation and has been lumbering North Manitou Island for the past 22 years. He stated that the Manitou Island Association was an association of influential people and advised about the same information that JACK

ADDITIONAL INFORMATION:

On 2-26-79, information was received from Assistant Attorney General John Wilson, Chief Assistant AG of the Criminal Division, Lansing, TX 373-1120. AG Wilson advised that the wanted subject, SHELDON, is in France. He further advised that SHELDON has recently married a French citizen in that country and that by French law within three days after the marriage, SHELDON himself will become a French citizen.

Wilson requested to know if the St Clair County Prosecutor's Office would be willing to pay for the extradition of the man from France. Sgt Humbarger, who took the inquiry, referred the Attorney General's Office to the offices of Prosecutor Deegan. It would appear from the conversation with Mr Wilson that as of this typing, the subject SHELDON is now a French citizen which apparently would make him ineligible for an extradition to this country. There is no further information available at this time.




