Detective Williams,

I spoke with [REDACTED] on 2/22/19 at 1500 hours, he called me and stated he had information on the Oakland County Child Killings from the late 1970's. The following is the information he passed onto me in our phone conversation. [REDACTED] gave me the following TX numbers [REDACTED] and [REDACTED] as current.

-He had a neighborhood friend named Jeff [REDACTED] (still alive) who lived on Simco St in Flint, MI in the 1970's. [REDACTED] was hitchhiking on I-75 and was picked up by Greg Green. [REDACTED] introduced [REDACTED] to Greg Green.

-Green drove [REDACTED] out to Grand Ledge, MI and had [REDACTED] perform oral sex on him. Green told [REDACTED] he was doing it wrong and proceeded to choke [REDACTED] unconscious. [REDACTED] awoke to Green holding a lighter to his face attempting to see if he was still alive. Green asked [REDACTED] if he was going to tell anyone about the incident. [REDACTED] told Green he wouldn't, because he didn't want to get into trouble himself. [REDACTED] said after the attack, the blood vessels on his face and eyes were popped, and he had to lie to his family about what had happened. He said Green was a very violent man and forced him into sex by fear and force.

[REDACTED] grew up in Flint with a boy named Vince Gunnells. [REDACTED] stated that Gunnells was easily manipulated by the other kids and adults. He said Gunnells was the type of kid that would do anything if you dared him. [REDACTED] stated that Gunnells was a little slow and "follower".

-Green invited some of the local kids to a movie drive-in and Gunnells was there. [REDACTED] stated Green had sex with Gunnells at the drive-in. [REDACTED] stated Green drove numerous vehicles in the 1970's. He had a 1968 Chevy Impala, Brown and Gold Chevy Van (which [REDACTED] was choked out in), and a blue and white Chevy Nova.

[REDACTED] thinks Green made Gunnells kill Chris Busch, but didn't give details as to why. [REDACTED] said a book writer has been calling him and wants to get [REDACTED] and Gunnells together.

[REDACTED] stated he met Chris Busch through his nephews. He told me that he introduced Greg Green and Chris Busch to each other.

-Chris Busch always carried a black handgun under the seat of his car and always put his wallet on the dashboard of his car.

-Chris Busch drove and picked up [REDACTED] a blue Chevy Vega with a white stripe.

-Chris Busch and Greg Green used [REDACTED] as "bait" to pick up other young boys

-Chris Busch and Greg Green were just into young boys, not girls

[REDACTED] stated that Busch took him and another young boy into the woods. He said the boy was good looking and had longer nice hair. He made the other boy perform oral sex on [REDACTED]. Busch then placed his handgun on a log and made [REDACTED] perform oral sex on him. [REDACTED] told me Busch was "nasty" and smelled like "ass crack", Busch made [REDACTED] swallow his cum, which [REDACTED] stated was nasty and salty. [REDACTED] took them out for fast food after and gave [REDACTED] \$10 for the sex. [REDACTED] stated he never saw that young boy again.

--Green and Busch together, once took [REDACTED] to a run down house in Fenton or Livingston County and an older white male came out. Busch stayed in the car with [REDACTED] and Green did all the talking. The older male looked at [REDACTED] and told Green he was "too old". [REDACTED] remembered the neighborhood looked run down.

[REDACTED] would go out with Green and Busch and he would attempt to lure other kids into the vehicle for them.

-Busch was a fun guy to be around and wasn't violent. [REDACTED] didn't think Busch was a killer. Green was violent, scary, almost killed [REDACTED] and was physically imposing.

[REDACTED] again stated they were into young boys, he never saw them interested in girls
