On 1-28-77 at 0600 this officer and Officer Cattel from the Ferndale Police Department went up to Alma, Michigan reference this complaint. Officers met Sgt. Rivard from the M.S.P. Pontiac and Officer Tom Waldron of the Flint P.D. Officers all met at the Ithica State Police post near Alma. Officers then went to the Alma P.D. and were joined by Officer Robert Lombardi of the Alma P.D.

Officers had an arrest warrant for Christopher Busch for 3rd degree sexual misconduct out of Flint P.D. Officers went to the Scotsmen Restaurant at 315 E. Superior, Alma, Michigan officers observed the suspects vehicle; 1976 GMC black 76/MT parked behind the restaurant. All officers then went into the restaurant and found Busch upstairs. He was placed under arrest by Officer Waldron of the Flint P.D. on their warrant and advised of his rights. He stated he understood his rights and would waive them. He asked if he could go to his home and get a change of clothes and his tooth brush. Officers took him to his home. This officer and Officer Waldron went up to his bedroom with him to get his clothes. Officer asked him if he had anything in his house to hide and he stated "No." Officer then asked if he had any objections to us searching his house and he again stated, "He had nothing to hide and we could search his house." Officers found in his bedroom 1 .45 gauge shotgun and 1 .20 gauge shotgun. In another bedroom was approximately 1/2 lb. of marijuana. In another room was a suit case with money in it. Officers found a suit case in the basement containing numerous books on sexuality involving young boys. Also were several magazines involving young boys and screw books containing cut outs of young boys. All this was confiscated as evidence in the Flint case.

Officers then took the subject back to the Ithica State Police post where he was processed and T.O.T. these officers.

Officers transported the subject to Flint and to Judge Newblatt's home for arraignment on the warrant. Subject was given a \$75,000.00 bond and officers departed Flint P.D.

Interview: CHRISTOPHER BRIAN BUSCH

This officer, Officer Cattel, Officer Waldron and Sgt. Rivard, sat in on an interview of the above subject at 4:30 p.m. on 1-28-77 in the Flint P.D.

Subject again was reminded of his rights and again indicated he would waive his rights.

Subject admitted his involvement in Flint's case involving W/M/15 and Green. He stated he was born in Pontiac, moved to Huntington Woods, and then moved to Europe and lived all over Europe. He was back and forth from Europe to Michigan several times. This was do to his fathers job.

He admits he is a homosexual and strictly likes young boys 10-17 years old. He states approximately 1 1/2 years ago he picked up a young boy at Wine, Wine and Woodward in Ferndale #1

He stated he thinks he was 15 or 16 and did not know his name or remember what he was wearing. He states he did not molest the boy but dropped him off in Royal Oak near 13 mile and #2

Woodward. He states he comes down to the Detroit area to pick up young boys. He states in approximately 1971 he was involved in the Big Brother program and had a little brother in Berkley, W/M/18 who lived in the 12 Mile and Greenfield area.

He states he took him to Hartfields Bowling Alley and also to the W-11 store #3. He states he never sexually molested this boy. He states he is involved in the Big Brother program in Ains and was with the Big Brother in Midland.

Officers advised him Greg Greene told these officers that he, Busch, had killed Stebbins. Officers told him Greene had confronted him with this. Busch denied any involvement with Stebbins, and stated Greene had never confronted him about it.

He states he and Greene had discussed their sexual fantasies together and they were to pick up a young boy, tie him up, and sexually abuse him. One would eat a hot in the day and the other to night the that one would be with him all the time. When asked what would happen when they were through with him, he could not answer.
