Criminal Sexual Conduct 3rd Degree INFORMATION:

On a Saturday, the first part of the summer of 1976, possibly May 29, 1976, a GREG GREENE and CHRIS BUSCH went to the residence of the victim arriving about 4:15pm. BUSCH went to the house and departed the residence and went with BUSCH and GREENE in a blue Vega to a location near Mt. Holly in Oakland County. On this occasion CHRIS BUSCH performed fellatio on and did likewise to BUSCH. Flint F.D. investigating similar complaints involving GREENE and BUSCH.

CONTACT OFFICER WALDRON - FLINT POLICE DEPARTMENT:

Officer contacted Officer TOM WALDRON, Juvenile Division, Flint Police Department and was advised that he and Sgt. FRANCES MILLER have interviewed the victim and on Feb. 22, 1977 accompanied to a location on Tindall Road, 1/10th mile south of Dixie Highway (US-10), Oakland County, Groveland Township, where advised that the offense took place.

INTERVIEW OF BY SGT. FRANCES MILLER, FLINT P.D.: (continued)

At this time, related that he knew both GREG GREENE and CHRIS BUSCH. He knew CHRIS BUSCH for a few weeks about 2 months ago. On a Saturday, the first part of the summer of 1976, GREG GREENE and CHRIS BUSCH came to his house about 4:15pm. CHRIS came to the door and told him GREG was outside and he wanted to see him, so went out. GREG was driving a blue Vega with white interior with a white stripe on the side. stated he got in the car in the back seat. CHRIS got in the back seat with him and GREG was in the driver's seat. asked where they were going and they said they were going out by Dixie Highway and by the field on the dirt road. They didn't tell him why they were going out there, but stated he knew why because the only time they come over is when they like you. GREG drove the car out there as CHRIS told him where to go. They went down Dixie Highway to a dirt road by a hotel by the lake and CHRIS told GREG to turn and they drove for about 1/2 hour riding around on the dirt road; then CHRIS said to stop and GREG stopped the car. After they stopped, they were laughing and talking and CHRIS asked if he, wanted to go walking around and said no. CHRIS told he didn't have to go. stated he didn't want to get out of the car because CHRIS might molest him or kill him. He stated he was afraid. He stated he thought they might molest or kill him because it was out in the woods and on a dirt street and nobody around. He stated he was afraid of them because they were homosexuals. CHRIS asked to pull down his pants and asked him what for. CHRIS said "I want to suck your d---" and went along with this. stated this was for about 15 minutes. CHRIS then had commit an oral copulation on him. stated CHRIS had done this about 3 times before to him. stated he had just turned 13 years old the first time and his birthday is He met CHRIS through GREG GREENE when GREG brought CHRIS over to house. He met GREG GREENE last summer and he owned a 1970 Impala (gray color).

GREG picked up when he was hitchhiking with GREG, on this date, talked about sexual acts to both but they decided MAR 13 not to do as GREG suggested at this time.

One night, GREG, went to the drive-in SE. and GREG bought beer. stated he didn't drink any, but got drunk and that was when it all started with GREG. stated that GREG has had sexual acts with him about 4 or 5 times. He stated GREG lives on stated he saw GREG commit sexual acts on in the back seat while at the drive-in.

On one occasion, GREG GREENE picked up in his van. stated GREG bought 2 bottles of wine and asked if he wanted some and declined. GREG got drunk after drinking the wine and drove the van behind the Rollerhaven on Saginaw Street. GREG turned off the lights and locked the van doors, closed the curtains in the van and started talking with GREG asked if he could suck his "d---" and asked him if he let him, would he take him right home and GREG agreed. During the oral copulation, GREG grabbed by the neck and started choking him until he passed out. GREG later returned to his home. stated this van was a 1974 Chevrolet, brown in color.

stated that CHRIS BUSCH has had sexual acts with him about 3 times. These acts occurred in CHRIS's car in a field up by Northwester High School where the motorcycle trails are at.

stated that GREG GREENE forced him to have anal intercourse. He stated GREG has done this to him once. This occurred when spent the night at GREG's house. stated that GREG had told him that CHRIS BUSCH had killed one kid out in the woods up by CHRIS's house a couple of years ago. GREG had told him this last spring.

stated that CHRIS has never forced him to do any of the things; he did them on his own.

INTERVIEW OF GREG GREENE BY OFFICER TOM WALDRON, FLINT P.D.:

Interview conducted on January 26, 1977, 11:35am. GREENE advised the following: GREG and CHRIS went in CHRIS's car, CHRIS went to address, at this time CHRIS did not know CHRIS gave mother a phony story about a runaway. went to, and got in the car with GREG and CHRIS. GREG being in the front passenger seat in the back and CHRIS started driving out towards Holly. was worried where he was going. At this time CHRIS was still driving out a dirt road off Dixie Highway in the area of Mt. Holly. CHRIS knew that GREG had had relations with and CHRIS asked to go into the bushes. was frightened and CHRIS asked if he could crawl in the back seat with and said yes. CHRIS oraled oraled CHRIS and CHRIS again oraled (three copulations). At this time GREG was driving around on gravel roads, a time of approximately 20 minutes elapsed. CHRIS moved back to the drivers position, GREG to the passengers position and remained in the back seat. The three then returned to Flint where CHRIS and GREG dropped off at his residence.

# Task Force Finds: No Slaying Link in Flint Case

Southfield's State Police task force investigating the deaths of six area youngsters, including the one that led to the arrest of four Flint men on sexual misconduct charges, the Daily Tribune learned today.

The task force found no link between the men charged in Flint and the South Oak and deaths.

Spiritualists they were looking for links with the death of Mark D. Stephens, a 12-year-old identified whose smothered body was found in Southfield a year ago Saturday.

**30 Boys**

The Flint men are charged with illegal sexual conduct with more than 30 boys. Stephens was sexually attacked before his death.

Task force investigators administered polygraph tests to five of the Flint men. The tests were negative, and Stephens' death was not linked to them.

The task force was set up after the deaths of four young men in Flint and one in Southfield in 1970 and was 20 months old.

Task force members were called into the mill case by Flint officers when they noted similarities between the cases and one of the South Oak slayings.

person we're looking for they will notify us," Krease said.

**Aided for 2-3 Days**

He said a Task Force crew journeyed to Flint and spent two or three days there "actively" aiding in the investigation.

Three of the men were arrested on charges of first and third degree criminal sexual conduct, Prosecutor Robert F. Leonard of Genesee County said.

A fourth is being sought on similar charges. The boys were ages 10 to 14. Leonard refused to identify the men.

Police talked to 30 boys and said they plan to talk with 10 more.

**No Physical Force**

Leonard said the boys were not physically forced into relations with the men, but were coerced by implied threats, fear of adult authority and the prospect of receiving gifts, drugs and alcohol.

Leonard said the men met some of the boys hitchhiking or through other men. In several cases the men met the boys through volunteer community service groups which pair men and boys for recreation.

The prosecutor said the eight-week investigation failed to turn up an organized ring. But Leonard said some of the men knew each other.

**Schoolman's Suspicion**

The investigation began in December, when a school principal noticed a man around the school and became suspicious when one of the boys went home with the man. The principal notified Flint police.

Police said that boy led investigators to other youth and men involved.

# Task Force Finds: No Slaying Link in Flint Case

South Oakland's state-police-run task force investigating the deaths of six area youngsters participated in the probe that led to the arrest of four Flint men on sexual misconduct charges. The Daily Tribune learned today.

The task force found no tie between the men charged in Flint and the South Oakland deaths.

Specifically they were looking for links with the death of Mark D. Stebbins, a 12-year-old Ferndale boy whose smothered body was found in Southfield a year ago Saturday.

**30 Boys**  
The Flint men are charged with illegal sexual conduct with more than 30 boys. Stebbins was sexually attacked before his death.

Task force investigators administered polygraph tests to two of the Flint men. The tests were negative, said Sgt. Joseph Krease of the Michigan State Police, who is coordinating task force operations.

The task force was set up after the death of Kristine Mihelich, a 10-year-old Berkley girl. She was the sixth young person who was found dead in South Oakland between Jan. 15, 1976 and Jan. 21 of this year.

Task force members were called into the Flint case by Flint officers when they noted similarities between their case and some of the South Oakland slayings.

involved in the investigation said more men will 'definitely' be charged with the criminal sexual conduct.

Krease said the Task Force will continue to watch the investigation closely.

"We keep in touch, and they know what we're looking for and what we have. If they get a suspect that is the type of

person we're looking for they will notify us," Krease said.

**Aided for 2-3 Days**  
He said a Task Force crew journeyed to Flint and spent two or three days there 'actively' aiding in the investigation.

Three of the men were arrested on charges of first and third degree criminal sexual conduct. Prosecutor Robert F. Leonard of Genesee County said.

A fourth is being sought on similar charges. The boys were ages 10 to 11. Leonard refused to identify the men.

Police talked to 30 boys and said they plan to talk with 40 more.

**No Physical Force**  
Leonard said the boys were not physically forced into relations with the men, but were coerced by implied threats, fear of adult authority and the prospect of receiving gifts, drugs and alcohol.

Leonard said the men met some of the boys hitchhiking or through other men. In several cases the men met the boys through volunteer community service groups, which pair men and boys for recreation.

The prosecutor said the eight-week investigation failed to turn up an organized ring. But Leonard said some of the men knew each other.

**Schoolman's Suspicion**  
The investigation began in December when a school principal noticed a man around the school, and became suspicious when one of the boys went home with the man. The principal notified Flint police.

Police said that boy led investigators to other youth and men involved.

On 1-28-77 at 0600 this officer and Officer Cattel from the Ferndale Police Department went up to Alma, Michigan reference this complaint. Officers met Sgt. Rivard from the M.S.P. He admits he is a homosexual and strickly likes young boys 10-15 years old. He states

approximately 1 1/2 years ago he picked up a young boy at Nine Mile and Woodward in Ferndale #1

He stated he thinks he was 15 or 16 and did not know his name or remember what he was was...

He states he did not molest the boy but dropped him off in Royal Oak near 13 Mile and #2

Woodward. He states he comes down to the Detroit area to pick up young boys. He states in approximately 1971 he was involved in the Big Brother program and had a little brother in Berkley, Mike Boldiyar, W/M/18, who lived in the 12 Mile and Greenfield area.

He states he took him to Hartfields Bowling Alley and also to the 7-11 store #3. He states

he never sexually molested this boy. He states he is involved in the Big Brother program in Alma and was with the Big Brother in Midland.

Officers advised him Greg Greene told these officers that he, Busch, had killed Stebbins.

Officers told him Greene had confronted him with this. Busch denied any involvement with Stebbins, and stated Greene had never confronted him about it.

He states he and Greene had discussed their sexual fantasies together and they were to

Oakland County: Two Charges Criminal Sexual Conduct 3rd Degree, Both Warrants issued, Preliminary Hearing set for March 10, 1977. Bond set at \$6,000.00 each court, which was posted.

Montgomery County: One Charge Criminal Sexual Conduct, 1st Degree, Bond Set at \$10,000.00 and Posted. Arrested in Birmingham Mich, and transported to Atlanta, Mich on March 3, 1977. No date set as yet for Preliminary Hearing.

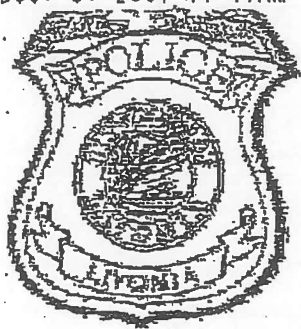
