INTERVIEW WITH LARRY

On Friday November 30, 2007, met with the undersigned and detective Williams at the Metro North Post of the Michigan State Police to discuss the information given by to Sgt Williams. (The interview was recorded on DVD).

INTERVIEW SYNOPSIS:

The majority of the interview was conducted by Sgt. Williams. again adamantly denied knowing the identity of the subject who he spoke with 30 years ago, who claimed to be the OCCK. He also was allowed to review several polygraph reports given by Ralph Cabot thirty years ago when Cabot was a polygraph examiner oreviously stated that he remembered the alleged subject he was referring at the Flint post of the MSP. to, who had taken the State Police Polygraph on the OCCK at the Flint Post, and to the best of his memory, the stated that the information provided for the basis for this dates interview by est was given by Cabot. Detective Williams was not true. (That he made a statement that he knew the identity of this alleged person further stated that in his opinion, (who is virtually who confessed to the OCCK). stated that at no time, did anyone ever confess unknown in the polygraph world), is a bold faced liar. to him about being the OCCK or suggest that they were even involved. stated that had this been the case, and someone actually gave him information, he would have found a way to forward this information onto someone. When asked as to how this information came about in the first place, and why said that he said there was just something he remembered about the guy that and ... spoke about the case. gave him a gut feeling he may have information about the OCCK. To the best of his recollection, s conversation, and it must have that this was the only explanation as to the content of ∇ been about the child killer investigation.

The undersigned asked if it could have possibly been because this subject said he had taken a polygraph about the child killer investigation and passed it. Was this due to the fact that he had taken a test about the OCCK, but most importantly, why did he, , feel he was involved. er stated he really didn't know, but it was just something about this guy that made him feel uneasy.

When was advised of the possible subject being, (Christopher Busch), as being the person he was referring to back in the 1970's, stated the name didn't look familiar with him whatsoever. appeared to be trying to recall by asking additional questions of the officer, (in hopes of jogging his memory), but to no avail. He stated that he just didn't know for sure if it was Busch or not, however adding that he sure seemed familiar. (Regarding Busch's information). When asked if he had any records that he kept from that time period, (1970's) regarding polygraphs he may have given, stated that he had already looked over all of the material he had, and doesn't have anything that far back. He said those polygrams have all but been discarded.

again stated that he didn't know the name of the person he met with many years ago, and when shown the polygraph information on the two subjects Ralph Cabot polygraphed back then, (Busch or Green), wasn't sure if either one was the right guy.

tended to feel that the one subject, Christopher Busch seemed fairly familiar, however wasn't sure if he was the one or not that he spoke with years ago.

The interview ended with saying that if he should remember any additional information which may be helpful in the investigation, he would be sure to pass this on to the officers.

OFFICERS OBSERVATIONS: .

The information regarding private polygraph examiner leach examiner and the interviewed statement of private polygraph examiner, are completely different. Each examiner is pointing the finger of "DECEPTION" at each other. It is told him at a private poligrapher's convention in Las Vegas Nevada a little over a year ago, regarding a man who allegedly confessed to being the murderer of the OCCK. However, when It was interviewed, he stated that the same and he never made any such statements, which now leads the investigators to decide, "WHO DO YOU BELIEVE?"

THE COURT: All right.

Now the issue before me is whether or not who is a licensed polygraph examiner in the State of Michigan, is covered by the polygrapher privilege, which is Michigan Compiled Laws Annotated 338.1728, as well as the attorney-client privilege with regards to the disclosure of the identity of the person who was tested at the direction of Ms. Burgess, as well as whether or not the privilege of the polygrapher or the attorney-client privilege protects from having to produce, as the order indicates, any and all files or records regarding the Timothy King murder.

I believe this question is one of first impression. Here in the State of Michigan in pertinent part the polygrapher privilege as set forth in Michigan Compiled Laws Annotated 338.1728 states:

"Any communications, oral or written, furnished by a professional man or client to a licensed examiner . . . shall be deemed privilege with the same authority and dignity as are other privileged

The last time we were here you indicated that the only issue that you were going to be concerned about is identity, not records, et cetera. So that is the only thing that I filed my subsequent brief on.

The main question is if Ms. Burgess was still alive, could she have been given an investigative subpoena by the prosecutor and be required to reveal the name of her client, who she referred to It is clear she couldn't. That is definitely-attorney client privilege.

THE COURT: Why do you say that it definitely is?

MR. FEINBERG: The identity of a client, unless the attorney is involved in say like in the case involving the bad check that has been cited in both of our Briefs.

THE COURT: Okay.
