Yeah

Was when he tried to do what he did to me, period

Yeah

There was no other time. They keep trying to put that in there, and which doesn't exist, at all. Okay, would you do me a favor. When you get done talking to me, talk to about it. Get into his head and tell him to try to think of one single time, you know, I'd like, I tell you what, I don't wanna put him in this, I don't, but if it comes down to it, he's gonna have to show is face up in court one day to me. He's gonna have to. But, I can tell you what, he would know. You know what I'm saying. He was with me, he was my shadow, you know that.

Well he wasn't there at the time you were

No, he wasn't

Molested

Right. But that was in another town, you know, it wasn't, I'm talking about just, I don't know, I don't know what they're, what to, where they're coming from,

I don't either

My big thing is when I get there, I don't know how I'm gonna get araised with a good court appointed attorney, but I need one, I need one, that's for sure.

And I did bring that up and they said to me that they have nothing to do with that, that that would be the correctional department's area

What

Is what they told us.

What for the attorney

That they would set me up with one, Department of Corrections don't have any

No, no they didn't say that they would set you up with one, they said, isn't that

right

Yeah

That they weren't, um, that wasn't their area of setting you up with a lawyer

Right, well

At this point. And that that would be up to the correctional facility, whatever, whatever. All I know is that, what I do know is that you did not get back there in time.

No I didn't

And you blew it

Yes I

You blew it by not getting there in time

Exactly. We're talking ten minutes, but that doesn't matter to them people.

But that, that's not a big thing any way.

Oh I know it's not believe me. If this wasn't going on, I'm sure that, that would not send me back to Michigan over this Do you understand that?

I hear that, yeah, I do.

Oh, believe that.

But this was

Believe it or not I have a place to move to right now, if this wasn't going on here in Butte.

Then, regardless of, regardless of the parole violation, this would've been coming.

Oh, I realize that. They called Monday, they said. And, and the PO said they didn't know where I was at, that's bull crap. I went in, I went in and dropped Monday,

Listen, I told them that too. I don't get it. How on earth could you not locate him.

Exactly

He's got a PO

I'm going in to, I'm going in to drop urines every single day, seven days a week. Did not miss a single day right up till the day, matter of fact, I was leaving the Rescue Mission to go drop that day, that night when they arrested me at six o'clock, I was leaving there. And I did it the night before the same way

Yeah

So they can't tell me they didn't know where I was at. There's a lot of getting, their not being truthful. There's some things that they've already said to me, man, and I just got pissed at them, you know I did. I said look

Yeah

You should, you know, you done drug me through the coals, my family through the coals, I am done with you people man, you know. So, you know, hey, they wanna go round two with me, they can go round two, but I did make it very clear to them that I am suing these people after this is over with and I'm proven innocent, I will sue them and ain't nobody gonna stop me doing that, period. Mentally I don't know if I can handle this, that's, that's brother, his sister, you hear me

I hear you and it's like I can't handle it either

I know

I can't either

I know

I've had it

I'm sorry, I'm not asking you to stand up with me in this. I'm just telling you I didn't do it, okay.

I don't believe that you did. I don't believe that you did it.

I wasn't there when it happened I know nothing about it.

And I believe that too, but there it is, DNA.

Well there it is God allowed all this to happen for a reason. We'll find out what it is down the road, won't we.

Yes, yes

Okay

Right I know that. I know that.

Regardless of whether I talk to them or not, why not have a lawyer present when I do talk to them.

Right, right

That's only common sense to me.

You know, they're not, anyways, let's just forget about all that, okay, alright. Let's just, I'm not even worried about that, okay. I, I'm not saying I'm not worried about that, my God, but I mean I'll deal with it, okay

Yeah, you will have to. You will have to deal with it.

Yes I will

And they, they've asked me to call them back and let them know if you plan to call them or not.

Vince you know we love you

I know that

We know we love you and, um

I know that. Both of you I love you. I love both you guys.

Well we all know God's with you

Hey, yeah, tell my brothers to pray for me too,

I will do that

Alright

And they are

An inmate at the Butte Silver Bow County Jail. This call is subject to recording and monitoring. To accept charges press 1, to refuse charge, thank you for using Evercom. You may start the conversation now.

Hi honey

Hi, How are you?

Hi, I'm okay.

Are you

Yeah

(Unclear) last time

Yeah, I've been, yeah, thinking of you a lot of course and missing you actually

Me too. I'm missing you -- you know that

Yeah

I'm writing a letter right now, just sat down to do that

Uh huh

(Unclear)

How you feeling, it's where

Better physically, better physically

Uh huh, go ahead

Mentally I'm stressed out of course

Yeah

Had a lot of battles going on with that and don't know what to do about certain things, but I guess I'll just find out when I get to Michigan, you know

Yeah

So much hanging (unclear)

Anything new that you're hearing

No, em em. Haven't spoke to anybody

It's the waiting

Yeah, yeah. As far as that goes there's no time limit they have where they have to come get me, you know

Yeah

I signed a waiver for extradition before I allowed out of prison in Michigan, so that gives them the right to keep me here for indefinitely, huh, you know, just

Which is so crazy, they seemed so urgent, huh

Some, yeah, it gives, it lets my mind run wild too and I'm thinking well they're there, ah, knowing what they're going to do, having all this time to do what they want to do with evidence or whatever they're doing, you know

Yeah, prepare

Prepare and here I am, don't have even a clue of what the charge is gonna be, if there is a charge, you know, or what I need to do to prepare for myself, you know

Yeah

And that's kind of a mental game that I'm playing with myself. I just don't know, so I, actually I have taken it upon myself to write a bunch of stuff down that I think may, may be, you know who knows, I don't know. I don't know if I'll need it, but you know, just different things, you know. What, do you know what date of birth is. This is something

, yeah

It's past, it was in March

Well how

Huh

I'm talking about how old is she, her actually, when was she born

Oh, oh, I think she's 35

So

73 she was born

73 and that was in April, right, or, or

March, March of 73

Okay. Just wondering

That would make her 36

Cause that's something that, that, when she was, she was less than a year old and that's when I talked to about Chris Bush

Oh, uh huh

Yeah

Uh huh

She was living in that garage over there on . And it's just
something I just wanted to get in my mind straight of what year that I brought this to the, you
know, to the police

To the courts whatever

Yeah, exactly, exactly. And I wanted to get

Well all those papers are burned, we had them.

Oh no . . . , don't, you, yeah I wondered about that and I, I got to have faith that
there's nothing in there we need for what I'm coming up against, you know

Yeah, well it's court record, so

Well, a lot of stuff wasn't in court record in there, but that's okay, I have a
memory too, don't I, (laugh) a good one, alright

Yeah, yeah you do

So

You do

I don't remember dates, but I can remember things that happened, so anyway

Yeah

I love your letter and love to hear that everybody's kinda getting back into the
swing of things and there, as far as school and

Yeah

And playing basketball, that excites me to hear that

Yeah, a little bit she has been, yeah

Yeah

She's home sick today, but

Is she, give her may love will you

I will honey

Thanks

Has everything been okay with the family as far, as far as goes

Yeah, she's, um, still going forward with the surgery on the 7th

Doctor (unclear)

She's been working just about, you know, as far as I know every day

Wow

For several weeks now and, um

In Ann Arbor

Yeah, okay

Yeah

And this is to remove the pancreas

As far as I know that's what they'll be doing

Uh huh

I don't know if anything else will be, um, worked on at all at this, you know I

Right

She just had another, you know, long visit with the doctor, so

Okay

I haven't talked with her or learned anything

Uh huh

But, anyway, yeah

Alright, well I, I wrote, I wrote a little letter. I don't know if she's let, let you know that, but it wasn't real descriptive or anything, just let her know that I am on my way back there and got a battle ahead of me and, you know

I've been wondering. I haven't received a letter from you for a few days and just wondering if you were still there and

Yeah, alright. You know somethin_ if, if you write me again any time soon here, can you send me some blank envelopes with stamps on them, postage

They do, they do. My bunkee got ten of them yesterday in the mail

Okay

Vince: His wife just sent them, oh I got a real good bunkee too, I told you, well I didn't tell you, but yeah, real good, so

You mentioned it, yeah

Yeah

And I was wondering if you still had him and

Oh yeah, yeah, he's here for 30 days and he just

Uh huh

He's been here a week and so, he's got four kids, wow

Yeah

I mean for 24, 25 years old, but he's a smart kid and real respectful

So you haven't heard a work back from any of these lawyers, this lawyer you

And, ah, I kinda don't think, I wonder if he even would, you know. Ah, I wrote a letter and asked him if he would, um, call him and, ah, just give him that same number you gave me

And then I also, I mean in that letter I also asked him if he flat out can't do it could he give me any kind of referrals to other good lawyers, you know

Yeah

That may be, that may be interested in taking it, but ah

Yeah

But being that it's a high profile case, I would think that some of these (unclear) that's something that they look for, you know, to keep their name in the media or whatever

Exactly, exactly

Get free advertisement out of it

Yeah

So, not knowing what's going on back there, you know, that, that they haven't charged me for that I have obli, you know, and that's a big concern of mine that they don't even charge me when I get back, that they play the same game they played with me last time, you know

Well I don't understand, if they don't charge you

Right and I don't either, but I mean they wanted me so badly to sit here and talk to them here and I'm like I'm not talking to you people. They couldn't get over, the fact that I wouldn't speak to them the lady and the other guy and the special prosecutor when they read me my rights, this prosecutor was standing in the door, just walked into the off, into this room and as soon as they said, you know, you have a right to a lawyer, I, you know, I said that is what I want is a lawyer and he had to leave, the prosecutor, he had to leave that room.

And did he

Yes

Uh huh

He made it sound like oh I need to go get something, but he never came back in the room, but I know, I know that's the reason why he didn't come in is because I requested a lawyer

Uh huh, uh huh

And the cops stayed there and they tried to continue on and continue on and continue on and got stupid in there, I mean, you know

Uh huh

Put my foot down about that

Uh huh

Didn't want to hear anything they had to say. Say it

Yeah

Say it to me when you get a lawyer beside me, that's what I was telling them

Yeah

You know, whatever

And the, the word from them is I suppose that, you know, they can't provide a lawyer until you're charged with something

Real close tables on me, ah, the

You know the officer

With, with, in what way

In back in . . . I mean he, he rattled off, you know, that, ah, you know, he, he is aware of me getting arrested down there and, and you know that I had a job, he knew everything, okay

Uh huh

Whether it was through) or whoever I don't know

I would suppose

Sure. So anyway that's, ah, you know, that's what that was all about, you know, just like, big deal, you know. Um, but I don't think that, you know, Michigan would extradite me back over being a ten minute late curfew without them pressuring them about it.

Questions about different avenues I have and rights I have, um, whether the ALCU could get involved in this even, if, if, you know it's, if it's the same thing I was up against when I left about me being uncooperative. Can I get a lawyer involved in it because, you know, I don't know

Yeah

Just a lot of what ifs

Well one, one thought that's come to my mind, I don't know if I told you is that, um, the potential, those guys you ran into in prison that you overheard them talking about
