Williams: I could draw that, nah, probably not

I, ah, I'm, I'm not

Williams: When you first looked at it you said I'm not sure if I've seen that before

Well I'm thinking, you know, is it, I'm trying to rec, see if I recognize the face in there, that, if it's somebody I know, ah, and, you know, I'm, you know you're, I'm thinking back, you know, 20, 30 years too, so, um I, it doesn't, I don't recognize that as a, a face that

Williams: Is it possible one of your buddies around your neighborhood drew it?

That I couldn't tell you

Gray: Cause he, cause he did, he did some artist sketching too when he was over near, probably something similar to along your lines. You ever see this person?

Ah, no

Williams: His name is Greg Green

Greg Green, that doesn't ring, ring a bell either

Williams: Okay

Gray: This guy lived just a few blocks over from you. You lived on right

On Tuckahoe, yeah

Gray: , right

Yeah

Gray: And he used to live on 'll show you, see here's a picture of the front of his house right here.

Williams: Remember that house

Ah, no. I mean there's a lot of houses that look the same in there. Ah, can't be specific about, ah

Gray: You ever do any vacationing up in, up in the (unclear) Lake area, um, (unclear) county, Flint area

No, no I never spent any time in Flint

Williams: Hang on for one second

Gray: You looking for (unclear)

Williams: Yeah, pictures I wanna show.

Gray: Remember that picture don't you

Um, this is Timothy King, right

Gray: Uh huh

Alright, and, ah, okay, I, you know, I know I've seen those pictures and I can't remember the names though

Gray: Well this is the young man from Birmingham, right here

Williams: Timmy King

Yeah

Williams: You didn't, you didn't happen to call his father

No, no, did tell you that

Williams: No

Gray: No, no his dad actually asked us to ask you

Williams: He got a call he said years ago, just, just not too long after this and from a young man he said that said he had some information, called him twice actually, and, but never showed up. He was gonna come to his office

Gray: Was gonna meet with him

Williams: And so we wanted to ask you if that was you

No it wasn't me. No, I, ah

Gray: This is back in the 70's also

Yeah, no, no, I never tried to call, ah

Williams: Okay

Mr. King

Williams: Alright. How about this, let me go back for a minute.

Gray: What you looking for

Williams: I got it right here. Recognize that guy

Ah, yeah, that's me

Williams: (Unclear)

Wow, yeah, ah, is that in, in high school

Williams: Yeah

Brother Rice

Williams: Yep, Brother Rice

I recognize the, ah, background there. Looking for my

Williams: Oh, right there, you ever see this kid before

Ah, let me see, jeeze, I don't think so

Williams: No

Ah, that's gotta be a 70's haircut

Williams: Yeah is in 80
80

Williams: But he probably looked similar in the 70's. His name is, they called him

Okay, no I, I don't, I've never come across him

Williams: That's him now

Huh, I don't know him

Williams: Corrections

Corrections

Williams: Uh huh. How about this kid

Ah, jeeze, ah

Williams:

Ah, the name's not familiar either

Williams: Okay. How about this guy, who is that, is that you're son

That's me isn't it

Williams: Yeah

That's

Gray: What the hell happened?

Yeah, I know what the hell happened, man. I, I'm telling you I had heart surgery
in, ah, 03

Gray: Did you really

Yeah

Williams: Well that's the only picture I have of him.

I don't have a picture of
him

I don't, you know, I don't recall any Busch name

Williams: How about the name

Williams:

Williams: Does that look, does he look familiar to you. It's hard to see I know

Ah, no, no he doesn't look familiar. Only I knew was the, let's see,
and, ah, played baseball with him in little league

Williams: Okay, alright. This would've been a different family.

Okay

Gray: Well Chris, Chris drove a, ah, ah blue Vega, which is

Okay

Gray: This right here, remember that old Gremlin and so on that was reported

Yeah, I remember that

Gray: They look, they look pretty similar as far as

Uh huh.

Gray: Wheel, headlights and such, so that's what ol' Chris drove, right down here, actually it was this color here. You don't recall that tooling around the neighborhood, cause here's the thing though, we, kinda semi believe some of the stuff we go and it points the finger to you and it's just as far as having knowledge. We're not looking at hammering you or anything like that. Don't get me wrong

Williams: Yeah we want, we want, the truth is, ah

Gray: You know

Williams: Very hard to assemble. It's

Gray: Yeah

It's always assembled truth. It's, I, you guy, you guys gotta, gotta do your job so

Williams: Well I'll tell you what, you know

I'm just

Williams: The poly the polygraph when you take that will say it all I guess

Gray: And we're not changing the topic of, of if you knew Chris Busch. The bottom line, there are four questions, did you, do you know who

Williams: Did you participate

Gray: Did you participate and are you withholding any information

Williams: Those will be the four questions

Gray: And it's all about the murders of the four children

Yeah, yeah, no, I, ah

Williams: And you'll pass that

Yeah, yeah

Gray: Flying colors

I hope so, I, I stutter. Now that, I remember that. I think that was a problem, they guy, the guy came out of the room and he told me that he, he came up to me and he said you stutter don't you and I said yeah. I have a, a stuttering problem. Um, so I, I, I don't know if that messed up the polygraph or what

Gray: No, you know what I thought about you the other day I know you're of above average intelligence. I know that. Stutters are

You mean that

Gray: No, I do. I, and your school grades weren't the greatest. You hated Brother Rice

Well it wasn't the most pleasant place to be

Gray: I know, you got beat up there a few times

Yeah, yeah, I'll tell you about that if you wanna hear about it, but, ah

Williams: I know you had some things you wanted to share with us, but I want to get through all of our stuff first here.

Yep

Gray: One of, one of the things, can you see the, the connectors that we have as far as the dates of death on those two guys, and I

Yeah

Gray: I'm saying, I'm not saying anything she says is true, but I can't discount things also

Sure, she's just gonna keep coming and coming and coming. And, I just, ah, don't know where she pulls this stuff out of, you know, and the only thing I can think is that she found a file like that, but, but the part about me, ah, reiterating that date in November whatever it was, that, I never, you know, ah, spoke those words or that date, ah, you know, that's a fact right there. Ah, so I don't know where she got that from.

Gray: There, there's, ah, I copied this off her website. Then, bingo, who's that, I know that, I was surprised, I thought, I thought you were, at one time tried to sue her didn't you

I was thinking, you know, I was mentioning it I got so, ah, ah, you know talking to her is like having a one way conversation. And, ah, ah, there's, ah, really nothing I can, you know, do, but, you know, like sue her for slander things, you know or something

Gray: Well she stopped using your name, I know that

I think, I think legally she has to stop using my name, doesn't she, or something like that.

Gray: Well it's, not, not really, (unclear)

Well I tell you what, if, ah, if I get, ah, totally cleared of this, you know, I can sue her I believe.

Williams: You'd have to be cleared first

Ah

Gray: I mean you said something interesting, I listen to words that people use and, you know, if I get cleared. I mean that tells me, it says shit, is there something in the back of your head that you're holding back

We push things to the back of our head

Williams: Yeah, yeah, well, you see at, right at this point, you're not sure, so it's

Gray: Well, but if you are
Yeah I am, I'm sure

Gray: I wasn't sure
I'm sure, you know, I, I'm sure

Oh, I'm not, yeah, but, but, and being realistic you're telling me that I'm not clear

Williams: No we're saying

At this point

Williams: We're saying you, you are

You know

Williams: When you pass that polygraph next, this week or whatever

Yeah

Williams: You pass that, you're officially cleared

Gray: Yeah

Oh, okay

Williams: Until then you're not, you're not

Until then I'm not

Williams: Yeah, that's right

So I, so I'm saying, I'm saying if, you know, because I haven't passed it yet. I have to pass another test

Gray: Okay, okay, that makes sense

I

Alright

Gray: You're a very intelligent man. I know that I can tell by talking to you
I, I

Gray: I read all of transcripts when he talked with you. You speak very well, you're very articulate, you know.

Williams: Are you on any medication right now

Ah, you know, I can't afford health care, ah, I, I, ah, I use natural substances

Gray: Okay

Williams: I mean you're not on any prescription medication

I, I, well they want me to be on, but I don't take anything like Zocor or, ah

Gray: Anxiety type of stuff

Blood pressure stuff. I, I, I take, I take some holicasenal, COQ10 and Magnesium, um, um, degribose. I don't know if you've ever heard of that. It's really heart medicine and the, I have, ah, cardiologist physiologist that, ah, prescribes, ah, he's cured like thirty thousand people

Gray: Good

Ah, I, I need to take some blood tests, you know, but go, go ahead

Williams: Well let's go back, let's go back to 77, were you, were you ever seeing a psychologist or psychiatrist back then

No

Williams: Never did

No

Williams: You were, were you ever at Ardmore Center in Livonia

No

Williams: Okay

Nope

Gray: Does ever try to get a hold of you

Ah, ah, you know, I haven't, I haven't had any contact with her since I went to Alpena

Gary: Oh

But she doesn't know where to get a hold of me, but she has, she has, ah, contacted my family, you know, my, my dad, my sister, my brother, ah, and she hounds them, you know, and I'm really, ah, ah you know, I'm ready to take action against her, you know

Williams: Well you get, pass this polygraph you've been

So, I mean my, my sister calls, has called me and, ah, my sister went to great lengths on the computer to, ah, shut her down on the computer and getting people stop going to her website you know and, and, ah, I, I don't have a computer, so I don't know what it takes to

Gray: You don't, that's

I mean there must have been how many hits came, came across the Oakland County Child Killer, but, um, just, just has to be overwhelming. I mean it's gotta be

Gray: It is

It's a witch hunt, you know. It's a witch hunt

Gray: But here's the thing though. It's a witch hunt, yeah, and I really would rather not come down her to muggy Atlanta

Sure

Gray: But it was necessary, you know. Ah, but see I'm not even gonna, we're not even gonna test you in regards to your knowledge of Chris Busch. All I wanna know is those four questions about the kids. See, cause the last test they gave you, the first once was and I explained to you what that probably was

Uh huh

Gray: They interviewed you that day then they test you, cause that's a big no-no from what I understand, but then you took it and then you

Williams: But the one you was only

Gray: One kid

Williams: One kid

.. .. One kid

Williams: So you haven't really been completely cleared

Gray: See when they, when they asked you about Timmy King, do you remember the troopers name, had an Indian name that give you the polygraph

Trooper, oh yeah, um,

Gray: Proudfoot

I remember t telling me his name, trooper, ah,

Gary: Proudfoot

.. .. Proudfoot

Gray: Yeah

.. .. Up there in, ah, Grayling

Gray: Yeah, absolutely

Okay, okay. Yeah, I remember the guy, kind of a short guy

Williams: The only two relevant questions they asked you that day were did you kill Tim King and did you have Tim King in a car. Well we're asking you more general questions about all of them

Okay

Williams: And knowledge and are you withholding information. You pass those

Uh huh

Williams: We can safely say you've been cleared in the case, but, but not yet. You gotta pass it first

Okay, yeah, yeah, I, I'll be glad to, ah

Gray: Okay

Take it and pass it for you, ah.

Williams: Okay

And then I can, ah, you know, take action

Gray: There you go

Maybe. Ah, this, this is, I'm really sick of this especially after my DNA
has been

Gray: Well that

You know, ah, it's, um, you know, this is going on too long. I, I don't want, this
is gone, it's, it's gone beyond

Williams: Well you end it, you can end it this week

Alright and

Williams: Yep

I don't know, I'll have to think about, I'm not gonna think about it right now, you
know, I'll just pass the test

Gray: What do you mean think about it, you mean just think about what, being upset at
what's going on or

Yeah, yeah with I'm not, I don't wanna think about that

Gray: (Unclear)

Yeah, yeah, I just take this a day at a time

Gray: Well let me go back, let me go back, do, do you see where we're coming, there's
one, that, that one document that she sent to us that said I recall having this conversation, maybe
she, maybe it was just a huck or, I don't know, but it sure, it's too coincidental for us to, to not at
least come down here, personally talk with you. Our department, took us forever, we were
gonna come down three months ago

Williams: April

Gray: God it was just, like, I don't know if you've heard about Michigan, the economic
strike that's on

Yeah, yeah I have

Gray: Well they just laid off a hundred troopers out of my department and they gave me the go ahead and thanks to Livonia, a few calls were made and I got to go, cause they, they denied me at first, but we thought it was important enough, I meant the department saw that it was important enough that this had to be investigated and you had to be talked to because it's just, you know

Uh huh

Gray: The, the, we have a lot of information that points to this man right here

Really

Gray: Yeah, something we're not gonna tell you, it's just not important. The only important part is this, if you're being truthful with us and you don't know him, hey I can't sit there and, and badger you.

Yeah I, I, I don't know him, um

Williams: Well that'll come out in the withholding information

Gray: Yeah, that's withholding information

Williams: Question

Gray: Cause that's gonna be right in the back of your head and that's why we, you know

Williams: If, if it's in the back of your head and you get home tonight and you say you know what I did know that guy

Yeah

Williams: You better call us right away

Hastings: Yeah, no, no, I was gonna say, you know, ah, these, ah, these kind of things that, that, um, just they come at you so fast and then this is a long, this happened over a long period of time and like next week I remember something, you know, or something like that, but, you know, I, I'm sure I don't know that, that guy, you know. Ah, and, ah, and, and these statements that Helen makes I don't know where they, I don't know where she makes this stuff up.

Gray: Oh I know it, it's right here

I, I, ah, you know, actually I never made any kind of a statement, a direct statement to her that was, ah, involving let's say, in, in any of, any of the actions that took place. All, all I could tell her was points of interest and, ah, ah

--- Areas of, of the Birmingham

Gray: And stuff that you knew

Royal Oak area and, ah, you know, and, and explain to here the time table and, ah, how, how, ah, how sick the whole thing was really, because it, it happens over a period of two years, you know, and there was a, ah, ah, there was like an emotional response that was, ah, habit, habituous, you know, in the entire community, you know, where everybody was looking at each other after a while, you know

Gray: Up in Alpena, right

Ah, no, in the, ah,

Gray: Oh, okay

In the area where these killings went on

Gray: Okay

--- And, ah

Williams: I know what you're saying

It was just an eerie feeling. Ah, it was, and everybody seemed to, ah, you know, pick up that, that emotional part of it or, or whatever and it was, ah, it was very like, like down, it was a very down feeling, and, ah, it's hard to describe, you know, because it was an emotional thing that everybody

Williams: In 76 and 77, were you doing drugs at all back then

No, no

Williams: Were you drinking

--- Nope, I don't drink, ah

Williams: How, how old would you have been at that time

--- 16 and 17, no, no 26 and 27

Williams: 26 and 27

----- Yeah

Williams: You weren't drinking or doing any drugs though

No

Williams: Okay. Where were you working at the time of the killings.

Okay, I was in Europe first part of 76

Williams: Okay

And I came, I went to ah, ah, Florida, my brother was there, I was there for a couple of months and then I came to Atlanta and I was here a couple months and then I went back home, so it was like in the Fall I think I came back of 76. I was back in the Fall of 76 and I didn't have a job, let's see

Williams: And you were evicted out of your house when

Evicted out of my house

Williams: Or evicted at some point

No

Gray: Your mom and dad were divorced in March of 77 I think it was

----- Okay, yeah, and I went to work at General Motors in 78. I went to work at Lloyd Carr, downtown the Renaissance Center, ah, and I think it was a detective that came down and talked to me. This was like, ah, 1977 and, ah, I was working as a commodities broker

Gray: Uh huh

Or a

Williams: That was way before ; why

Oh yeah

Williams: Why did they come see you?

Ah, I guess they questioned every single male in the, ah, in the county, you know

Williams: We know that's not true, that's exaggerating

Well, you know what

Williams: Why did they come see you John
Someone must have gave them a tip about me

Williams: Okay, what, why

I, I don't know. You know, I don't know. I, I never did anything to, ah, ah, purport anything as to a kid or something like that. You know I don't know who, how my name turned up. You know that wasn't disclosed to me at all, so I, I don't know who, ah, who ah

Williams: What'd the detective tell you?

He, he just asked me a few short questions like, ah, do you remember where you were, or ah, um, you know this day or this date and

Williams: Uh huh

Let's see what else, I can't remember, it only took a couple minutes. Ah

Williams: Okay

That's all I can remember is do you know where you were on this date or

Williams: Okay. Now is that, is older than you

He, he's younger

Williams: Is older than you

Tom is also younger, three years younger

Williams: Okay, alright. Cause I was trying to think if maybe the brothers knew the Busch brothers or

They might, you know, I don't know, ah

Williams: Okay

My, I don't know if my brothers knew any of them guys

Williams: Ah, you had some things you wanted to tell us about Brother Rice

Yeah I was, ah, you know, ah, Don Stutt and Chief Austin kinda drilled it, you know, into me about, you know anything I could think about you know, the four years I spent there. Ah, in 1964, this is when I was a sophomore in high school

Williams: Uh huh

And I was abducted by two of the brothers there, in a car, ah, against my will in downtown Birmingham. And, ah

Williams: Who were they

Their names were

Gray: Fellow students, right

Teachers

Gray: Oh, teachers

Yeah, the, ah, teachers and they were, they were driving a station wagon and I was walking along the street there in downtown Birmingham, it was on Saturday afternoon and I heard my name, and I looked around and, ah, was looking I walked up about ten more yards and I heard it again. It was coming from a car parked at, stopped at a stop light and I walked over and, and looked in the car and I could see the two brothers that, that I knew

Gray: Yeah

And, ah, they said where you going and I said no, nowhere in particular and, ah, y was driving and he said get in the car, just like that and before he could finish in the driver's seat reached around the back and opens the back door from the inside, you know

Williams: Uh huh

And, ah, the other thing that I was kinda startled, and, ah, I was, you know, I was thinking well what, what's wrong with this picture, but because I knew them I, I got in, got in the car, you know, I got in the backseat.

Williams: What'd they do with you?

They just, ah, drove around and took me back towards my home and dropped me off there. They didn't, ah, say a whole lot, ah, just asked me about my family and, ah, you know they were, ah, I had never seen them in plain clothes before and that's kinda, kinda, kinda startled me and, ah, they were wearing flannel shirts and it was a station wagon and that's all I can remember about that, but I know exactly where they picked me up and where they dropped me off

Gray: Why do you, why do you think that may be important? I know you wanted to tell us something, what

Yeah I

Gray: Is there some other connector there or something

That's really all I know. I don't have any

Williams: Are you

Thing, you know, but, but it was actually, it was a very fast thing and, ah, was kind of, ah, out of character, I was, you know, and I'm thinking, you know, what, what am I don't something wrong here, you know, ah, you know walking down the street. Is, is there a problem. They didn't, you know, mention any

Gray: Well you did what the teachers told you to do, I mean it's, they were teachers and

They were teachers, right

Gray: And they just, they just took you back home, right

Yeah, they took me back home, ah, but, ah, you know, I just though it was probably best that I pass that along to you, ah, so that you know

Gray: We've got their names. What were their full names, do you recall?

Ah, all I know is

Gray: Well now there te, they'd be in the yearbook, no problem

Yeah, they'd be in the yearbook, yeah. I, I believe they were still there when I graduated in 1967

Williams: Okay

So this is, this is

Williams: Let me run a couple names by you, at least one anyway, do you remember a student named Not, not the singer

Yeah,

Williams: Lived on, ah, I think Hine Tree Lane in West Bloomfield. Ah, became a, went to U of M afterwards and became an attorney and he was supposedly involved in a, some type of a gay ring out of and later at U of M

Hmm

Williams: A guy named _____ he disappeared in 1980, never seen again

Wow, ah, wow, I, ah, don't recall that name or face, ah, what, what year did he attend _____

Williams: I'm not, he would've graduated in 68, somewhere around then. Anyways his, one of his closest friends was a teacher, later became a teacher at Walled Lake Western. His name was _____ who committed suicide a month after _____ came up missing and, ah, _____ mother said that she was worried when _____ got involved in the this ring of ex-_____ kids

Wow, you know, I never, I never

Williams: I'm not, I'm not saying it has an absolute connection to the Oakland County Child Killing case

Uh huh

Williams: I don't know

Uh huh

Williams: But you, you attended

Yeah

Gray: So you may have known him

Williams: Yeah. That doesn't do anything for you

Uh, no, no I

Williams: Okay.

Never heard anything about like a gay ring or something like that

Williams: Well it was _____, it wouldn't surprise me if there's a whole bunch of gays over there. There was at Berkley High School that's for sure.

Ah, I, I, ah

Williams: I'm just teasing _____ I'm just teasing.

I, well, you know, today it's really crazy

Gray: Oh yeah

Cause I don't know what to

Williams: You're not gay are you

No

Williams: Okay

I, I, you know, I'm, ah

Gray: I remember, I remember Don Stutt asked you that question, same, same response

I'm, I'm kinda sexually secure and I, I like women, ah

Williams: That's good

It's kinda like a negative territory, you know. It's kinda repulsive really

Williams: Try having a partner that's gay

Gray: Yeah, the coppers, those Livonia coppers, anyway. Make sure that's on the record here. Anyway, but, you know, ah, all, all I'm interested in is just this. Just take the test and pass the test. What I'm gonna do is I'm gonna make arrangements with the Georgia Bureau of Investigation. You're gonna probably have to go to Conyers, okay, use, do it on the company dime, you know, use their gas, but go up, you know, in your limo

Yeah I, if will let me, ah, let me drive it

Williams: Conyers, right there

Yeah, that's a long way. That's ah

Gray: It's not that long

Williams: A half hour

Yeah, if there's not traffic. You don't, you guys don't know what you're, you're going to face this afternoon if you're trying to go to Conyers

Gray: Well, we got to, that's where our hotels at

And, ah

Gray: Unless you give us a ride in your limo
