advised that CHRIS was born in Pontiac, Michigan and prior to the age of ten had lived in Rochester, New York, Short Hills, New Jersey and Germany (in that order). These were all family moves pertaining to their father's career at General Motors. By age ten CHRIS was living in Germany and attending the first grade. While their family was settled in Germany, both \_\_\_\_\_ and CHRIS attended a grade school and high school at a boarding school in Switzerland called Le Rosey. After his graduation from Le Rosey (completion of the twelfth grade) CHRIS stayed at Le Rosey as an instructor. CHRIS then returned to the United States and attended Wayne State University in Detroit for one year. CHRIS then transferred to a Culinary Institute in Midland, Michigan from which he eventually graduated. After this, CHRIS worked as a chef at a retirement community in the Detroit area for approximately one year. After this CHRIS, with the financial assistance of his father, opened his own restaurant in Alma, Michigan called "The Scotsman". During the time period CHRIS was operating this restaurant, which \_\_\_\_\_ advised was in CHRIS' mid to late twenties, CHRIS was arrested for molesting a boy in Birmingham, Michigan. This boy (the complainant or victim in the molestation case) had been mentored by CHRIS in the Big Brother Program, a program CHRIS had become involved in. \_\_\_\_\_ S believes that CHRIS also knew this boy's mother, and that she possibly worked as a cashier at the Fishers Meat Market in Birmingham, Michigan.

\_\_\_\_\_ advised that after CHRIS was indicted for this molestation case (mentioned above) he moved back in with his parents in Bloomfield Hills, Michigan. This was primarily due to the fact that his attorneys and psychiatrists were nearby. It was during this time that CHRIS committed suicide.

\_\_\_\_\_ S described CHRIS overall as a "gregarious and happy guy", who physically was "big and heavy". \_\_\_\_\_ provided the following as hobbies for CHRIS: food, skiing and riding his motorcycle. \_\_\_\_\_ advised that CHRIS also struggled with problems associated with living overseas and returning to America, stating "it is hard to go back to your own country".

At the time of his suicide CHRIS was staying at this house by himself as their parents had traveled to England to visit older brother I with whom they had a "falling out". advised that this "falling out" had to do with David being both a homosexual and "a little bit of an activist".

recalled that on the day CHRIS' body was found he had received a phone call from the maid, named who was at the house and could not gain entrance. was nervous that something was wrong and the dogs inside of the house were barking. went to the neighbors (across the street) who phoned could not recall the name of the neighbor that went to, but described them as a Caucasian couple, with a daughter, who were good friends with his parents. then phoned the police and left work to go to the house. At the house, met up with the police and after entering they found CHRIS' body upstairs in the bedroom CHRIS was staying in. recalled that when they opened the door to CHRIS' bedroom he could see CHRIS' body, which was lying on the bed. recalled a terrible smell and remembered seeing a shotgun and remnants that CHRIS had been drinking. also recalls seeing a painting of a tiger over a chest that had "bullet holes in it". does not recall seeing anything else in CHRIS' room, to include any drawings, ropes or ligatures. did not recall there being any suicide note as well, and has no recollection of the police ever mentioning this to him. advised that he "did not look" at the room or CHRIS' body for very long as he was very traumatized. further advised that any items or belongings that were in the room where CHRIS killed himself belonged to CHRIS.

In regards to why CHRIS would kill himself, advised that he believes it was due to other molestation charges that were about to be filed against CHRIS. seemed to recall a pending case which originated in the Lake Ess area. At the time of his suicide CHRIS was being treated by a local psychiatrist, whose name could not recall. #### TELEPHONIC INTERVIEW WITH

On Monday July 20, 2009, at approximately 3:30 PM, the undersigned was contacted by [redacted] who returned a phone message left earlier by the undersigned. [redacted] was advised that the phone call had to do with the ongoing investigation into the Oakland County Child Murders and the possible connection with his deceased brother, Christopher Brian Busch. [redacted] advised that he understood and stated he would be willing to talk with the officer and cooperate with what he can.

[redacted] stated he and his wife had just returned home and got the message that the State Police in Michigan called. [redacted] was advised that additional information had surfaced regarding his late brother Chris and an old friend of his by the name of [redacted]. [redacted] was further advised that it was also learned that his father, [redacted] also knows the [redacted]. At this time, [redacted] stated the name [redacted] doesn't ring a bell with him whatsoever. The officer repeated the name of [redacted] he was a friend of Christopher's and most likely worked together in the restaurant business. [redacted] again stated he was completely in the dark with the name [redacted] and any association that may have been with his brother or his father. [redacted] stated it was possible they may have known each other, however he has no recollection or any connections the name of [redacted] may have had with Christopher or his dad. [redacted] stated that he was 7 years older than Chris and really didn't pay much attention at all who Chris socialized or hung around with.

[redacted] then spoke with his wife which could be heard by the undersigned, where he asked her if she remembered the name of [redacted]. [redacted] responded by saying she's never heard the name [redacted] and that the [redacted] was further advised that the [redacted] family lived in the neighborhood near his parents. [redacted] stated he's never heard of [redacted] and then advised this officer that he never lived with his parents at the [redacted] location and wasn't familiar with the neighborhood. [redacted] again said it was possible they knew each other, however he nor his wife knew the name.

h stated that his father was high up within the General Motors Corporation and worked for the Cadillac division. i advised that he retired from Chrysler Corporation and in fact had many spirited conversations with his father, a life long GM man and he with Chrysler.

stated that he was well aware of his brother Christopher's problems and never really paid attention to what he did or who he associated with. He added that Chris was very much an embarrassment to his father and to the family. Furthermore, Christopher had a pretty bad drinking problem, and after his sudden suicide which took the family by shock, the family felt guilty for Chris taking his life.

stated his parents were oversea's in London England visiting his other brother when committed suicide. When asked about this trip to London, stated it was sort of a reunion with his parents and because it had been a very long time since they'd seen

In regards to Chris's suicide, said again that it took the family by surprise because no one really saw it coming. He stated he thought it was because of the problems Chris was having and his life-style. On the date when first saw Christopher in his bedroom after committing suicide, stated this upset him very much. When asked if Chris left a suicide note, stated he didn't recall ever seeing one, nor did he have knowledge of the police finding one. He said they may have, however if they had, they never told him and said you'd think they say if they had. stated he only stayed in the room momentarily because of seeing his brother and the terrible smell in the bedroom.

The name of Gregory Greene was again passed by and again he stated he nor his wife had ever heard this name before.

At the end of the phone interview with , he added that he will cooperate with what ever may be necessary and if the police wish to run any further names by them, they'd have no problems whatsoever in trying to assist.

The phone conversation was ended.

first came to the attention of task force investigators when his name appeared on police reports back in 1977, (MSP 27 report # 27-686-77) where he was a victim of CSC's perpetrated by main suspect, Christopher Busch and Gregory Greene. When investigators first learned of it was discovered that he was currently serving time for Larceny from a Person and was incarcerated within the Michigan Department of Corrections, (Camp Ojibway), located in the western upper peninsula.

The investigation with began when Detectives Williams, (Livonia PD), and the undersigned officer, (MSP) first interviewed him on March 6, 2008 at Camp Ojibway.

During the interview of [redacted] certain information was discovered afterwards which indicated that [redacted] was not being truthful, (IE), his knowledge and or involvement with Gregory Greene. After discovering that [redacted] had lied to the officers, the magnitude of this investigation and the current location of [redacted] a request was made through the Department of Corrections to have [redacted] transferred to the Ryan Facility in Detroit, which is a much closer to the investigators for future interviews. After several additional interviews with [redacted] at the Ryan Facility, S.A. John Ouellet and Sean Callaghan convinced [redacted] to take a polygraph test to clear himself.

On October 10, 2008, [redacted] was given a polygraph examination by Lt. Robert Dykstra at the Northville Crime Lab. The results were "inconclusive". Lt. Dykstra advised that [redacted] purposely skewed the examination by holding his breath, fighting and tightening body muscles. Dykstra advised that these are all means in which a polygraph cannot be judged properly and will cause a test to become, inconclusive. [redacted] later confessed to purposely throwing the polygraph after speaking with a prior cell mate named [redacted] was interviewed by Detectives Gray and Williams where he admitted to telling "how to" fail or cause an inconclusive result on a polygraph. [redacted] was eventually paroled and moved to the state of Montana, however, under the supervision of the Michigan Department of Correction.

On March 7, 2009, the undersigned received a mitochondrial DNA match with a hair fragment removed from the shirt of Victim #3, Kristine Mihelich, Q34.1 and the DNA buccal swab that was taken from [redacted]. For the first time in the history of the Oakland County Child Killer Investigation, a piece of evidence has been identified to a certain individual, [redacted]. The analysis indicated that only 1% of the caucasian male population has this mitochondrial DNA sequence and [redacted] was matched to this evidence.

Upon learning of this DNA match, officers made arrangements to travel to the State of Montana where [redacted] is currently on parole, to interview him regarding his possible involvement. The interview in Montana was conducted on March 26th, 2009. Unfortunately, [redacted] would not speak with the officers without having an attorney present. No statements were made at this time. Prior to leaving Montana, [redacted] and his sister, [redacted] were advised that [redacted] DNA had been identified as being discovered on the shirt of Kristine Mihelich victim # 3 of the Child Killing Investigation. Both [redacted] were advised of the seriousness of this recent discovery.

Due to [redacted] parole violations in the State of Montana, he was brought back to the state of Michigan as an absconder and parole violator. Upon his return to Michigan, [redacted] first went to Jackson prison for processing back into the MDOC, afterwards he was then transferred to the Parr Highway Facility located in Adrian, MI. While [redacted] was at the Egeler Center at Jackson Prison pending processing back into the MDOC system, D/Sgt. Robertson and S.A. Callaghan interviewed him. See FBI case report for the interview. [redacted] was eventually transferred to the Parr Highway Facility located in Adrian.

On July 21, 2009, Detective Robertson and SA Callaghan contacted [redacted] at the Parr Hwy Facility, [redacted] interviewed him and requested he take yet another polygraph [redacted] [redacted] agreed to take a second polygraph.

He said he was not with that girl and denied ever know a Kristine Mihelich. As the post test interview continued, ( ) became more and more upset and appeared to speak in a more matter of fact fashion that he wasn't involved.
