

1 age. (We do not at this point in the investigation have any indication of _____ being involved with
2 Busch & Greene).

3 **1-3-08:** I faxed a request today, to the Flint Police Department Records supervisor for any/all
4 reports pertaining to Christopher Busch & Gregory Greene, specifically the arrest-report on Busch
5 from 1-27-1977.

6 _____ pt. After several phone conversations with the records people at the
7 Sheriff's Dept. it was determined that Busch was actually arrested on 1-27-1977 in the case, by Flint
8 PD. Busch was then housed after his arraignment at the Genesee County Jail, until he posted bond
9 on 1-31-1977

10 **1-3-08:** I received an e-mail today from Dave Robertson (MSP). He forwarded a request to the
11 Michigan State Police Intelligence Unit in Lansing today, requesting copies of the reports from MSP-
12 27's arrest of Busch in February of 1977. This request from Robertson also included any/all reports
13 that MSP has on Christopher Busch & Gregory Greene.

14 **1-11-08:** I received a fax today from Flint Police Department, regarding my request for reports on
15 Busch & Greene. The fax stated that they showed no arrest for Christopher Busch,
16 I had requested any/all reports on Busch & Gregory Greene, so I don't know if they even checked on
17 Greene, or for other reports on Busch.

18 **1-15-08: *** (Found possible connection between Lamborgine and Busch & Green) ***** I
19 was reading the report tonight on the Lamborgine investigation, looking for connections between
20 Busch & Greene and Ted Lamborgine. I thought Greg Greene sounded familiar to me from past
21 interviews. While reading the report, I came across a phone interview I conducted with a person
22 who called on 12-13-2006, with information about Ted Lamborgine. This person identified himself
23 as _____ and stated that he had met Lamborgine when he was 14 years old, hitchhiking
24 in Ohio in 1976. _____ stated that Lamborgine fed him, paid him for sex and drove _____ to
Woodward Ave. & Warren Ave. in Detroit. *LATER FOUND TO BE UNTRUE*

26 ******* I noticed when reading the court file on the arrest of Christopher Busch in January of 1977, for
27 3 counts of child molestation, that the victim in this case was _____, whose mother was
28 _____. This could possibly be a connection between the 2 leads, connecting Lamborgine
29 with Busch & Green. This Lamborgine connection, could also possibly explain the MSP tip sheet on
30 Busch, stating that he was involved in a child porn ring.

31 **1-16-08: *** (Identified the _____ in tonight that was the victim of Christopher**
32 **Busch in Oakland County in Busch's January 1977 arrest by MSP 27) ***** I performed a check
33 thru the Michigan Dept. of Correction's Offender Tracking Information System (OTIS) and found
34 _____ . The age matches the victim
35 _____ from 1977. This subject was released from Prison for Burglary in 2006 and is currently on
36 Probation out of the 3rd Circuit Court in Wayne County, until 2010. I performed a criminal history
37 check, which revealed _____

41 called and spoke with a woman, who identified herself as _____ mother. I asked if I
42 was speaking to _____ to which she stated, "yes." This confirms this subject to be the victim of
43 Christopher Busch from Busch's 1977, Oakland County case, when Jane Burgess represented
44 Busch. I left my name and number for her to give to _____, for him to call me. I still need to
45 confirm whether or not this is the same guy that called about Lamborgine and identified himself as
46 _____

47 **1-17-08: *** (Another phone interview with _____; Mother,**
48 I called _____ again tonight in an attempt to interview _____ She told me that he has
49 been hanging around in Detroit. I asked her if he's been staying over on _____ and she

1 stated that she thought that sounded right. I stated that he's reporting the Belleville address to his
2 probation officer, to which stated that he is staying with her in Belleville, but hangs out in
3 Detroit. I asked again about a cell-phone number for him and she stated that she does have a
4 number for him. She stated that he is at 570 Clinton St. in Detroit. I told her that, that is the address
5 for the Wayne County Jail. She stated that he must have gotten in trouble again. I told her that I
6 would go see him to talk to him, but wanted to ask her a few questions about their past. I asked if
7 they used to live in Flint and she told me that they lived at in Flint back in the 70's. I
8 asked her if she knows Chris Busch & Greg Green, to which she stated she did, adding that they
9 used to live on the next street (Later identified as), stating that she thought Green &
10 Busch might be cousins. I talked about Chris Busch being arrested and charged in Oakland County
11 in 1977 for molesting stated they were both arrested, adding that Greg Green was
12 the other one. I asked if spent a lot of time with Chris Busch, to which she stated that he
13 was always with Chris & Greg. She indicated that she knew that Busch & Green were
14 Pedophiles, stating that they were sex offenders. I asked if she knew about Christopher Busch
15 having a place up north, to which she stated she did, saying that he (Chris) & Greg took up
16 there to a cottage a couple of times. When I asked about the cottage, she stated that the only thing
17 she knows about it is that it possibly belongs to a cousin of Busch's. I asked her if she remembers
18 what Green & Busch were driving back then and what they would go up north in, to which she stated
19 it was an older Pontiac. She thought it was blue or dark blue. I asked her to clarify when she said
20 and older Pontiac, to which she stated from the 60's. I asked about being younger than
21 Green & Busch, to which I stated he was a lot younger than them. They were in their mid
22 twenties and was only 13 years old at the time in the mid to late 70's. I asked about
23 spending time with them and she said that they would take everywhere with them.
24 I asked where else they would go to, and she stated that they were always taking to Detroit
25 to see some guys that Busch & Green knew. I asked her if she knew the names of the men that
26 they went to see in Detroit and she stated she did not, adding that I should talk to , about all
27 this, he would be able to answer all your questions about these guys. The men in Detroit could
28 possibly be Lamborgine, and/or others that would explain a note in Busch's 1977
29 tip file, stating that he had connections to a child porn ring. This would also explain
30 calling with information about Lamborgine molesting him in the past. I asked if she knew
31 about Christopher Busch's family being rich, to which she stated that she did. I asked her if
32 ever said anything to her about what Busch said about his family and she stated that Busch hated
33 his parents and said they were "bad" people. kept telling me to ask these
34 questions and he would be able to tell you a lot more about them than she could. I asked if she
35 knew who Busch & Green stayed with on and she stated that she thought it might be
36 Green's Cousin's house.

37 **1-19-08:** I called the Wayne County Jail today to see if was still there for an interview.
38 They had no record of him. I checked his Department of Corrections probation status that showed a
39 "last movement" date of 1-16-08 and showed "transfer between offices." This report gave the phone
40 number (313) 972-3170 to check on the status of the offender.

41 **1-20-08:** I called Wayne County probation Supervisor Kirk McVittie and asked him to please locate
42 for me so I can interview him. McVittie is checking on whereabouts and will call
43 me back.

44 **1-22-08:** Garry Gray (MSP) called me today and stated that he went to the Michigan State Police
45 Forensics lab today and picked up the newly acquired DNA evidence from the clothing of the OCKK
46 victims, that was obtained during the recent re-examination by the State Police Lab.

47 **1-23-08:** Wayne County Probation Officer, Jeaney Cheeks called me today about
48 . She stated that is in the Dickerson Center for OWI 3rd offense. She is his
probation Officer and stated that he will be in Dickerson until March 2008.

1 1-28-08: When I returned from the interview of Lawson tonight, there was a message from
2 indicating that he was currently at "Operation Get Down" in Detroit (Halfway House) and
3 that he heard I wanted to talk to him, stating that I can call him at his counselor's (Mr. Phillips) office
4 at (313) 921-9422, ext. 233. [redacted] stated that his counselor would let him talk to me in his office.

5 1-29-08: *** (1st tape-recorded interview of [redacted] . Today at "Operation Get
6 Down" in Detroit. This is a "halfway house" located @ Gratiot & Harper) *** I went to
7 "Operation Get Down today, interviewed [redacted] about his relationship with Christopher Busch &
8 Gregory Green and to see if he was the same [redacted] that called me a year earlier with
9 information about Ted Lamborgine. I also was attempting to confirm a possible connection between
10 Busch, Green & Lamborgine. I asked [redacted] an right away if he was the same guy I talked to a year
11 earlier about Ted Lamborgine, to which he stated he was. Present at the beginning of the interview,
12 along with [redacted] and myself, was [redacted] counselor Mr. Phillips. I had [redacted] start at the
13 beginning with how and when he met Busch & Green. [redacted] went into detail about his
14 relationship with Busch & Green, how he met them, why/how he was afraid of them, the places they
15 took him and how they used him to lure kids to the car. The details that [redacted] laid out to me
16 about Busch & Greene mirrored the information in the police reports from 1977, when [redacted] n was
17 interviewed about Busch and Greene molesting him and his relationship to these two. These details
18 included the information when Greene molested [redacted] / at the drive-in
19 theatre in Flint in 1976. These details [redacted] gave me about Busch & Green, included
20 descriptions of vehicles they were driving at that time, one of which was a 1977 blue Chevy Vega
21 Hatchback with a white stripe, the fact that Busch was carrying a handgun at that time and
22 threatened [redacted] prior to molesting him, also the story about Green choking
23 unconscious in the back of his van, when Green was attempting to have anal intercourse with
24 [redacted]. These 1977 police reports were from the investigation and interviews conducted by MSP,
25 Flint PD & the OCK Task Force into Christopher Busch & Gregory Greene, including reports of the
26 interviews of the victims/associates of Busch & Greene.

27 [redacted] talked about how Greg & Chris would drive him around in their cars and have
28 "lure" kids closer to the car by talking to them, stating that the kids were more comfortable and would
29 approach the car once they saw he was a kid too. [redacted] talked about Greg driving him around
30 Oakland County having him call-out to boys to come over to the car so that Greg could get a look at
31 them.

32 During the course of this interview, [redacted] made statements about Busch bringing a boy down to
33 Flint from the cottage up north in the spring of 1977 and making him [redacted] perform oral sex on
34 this boy in the woods in Flint. [redacted] stated that he thought the boy was nervous, but did not
35 appear to be scared or being held against his will. [redacted] said that he and Busch then drove the
36 boy to a house somewhere between Flint & Detroit, stating that it could have been Pontiac,
37 Waterford, he wasn't sure. [redacted] then stated that Busch walked the boy up to the door and the
38 man that came to the door appeared to be Ted Lamborgine. [redacted] stated that he knew
39 Lamborgine from the time Ted picked him up while hitchhiking in Ohio in 1977, and from a couple of
40 times when Lamborgine took him to "XXX" places on Woodward in Detroit and molested him.
41 [redacted] stated that he believed that the man Busch dropped this boy off to was Lamborgine, based
42 on knowing him and seeing him on the TV when we arrested him in Ohio in December 2006.
43 [redacted] stated that he believes the boy was the King boy because in the spring of 1977, Flint
44 Detectives Fran Miller and Tom Waldren, showed him pictures of two dead boys, naked, lying on a
45 table and their faces were kind of blue like his was after Green choked him. I asked [redacted] if
46 Chris & Greg used him to lure kids to the car, to which [redacted] stated, "Yes." I asked [redacted] n if
47 he was involved in abducting the kids from the child killings? [redacted] paused for a long time and
48 stated, "Yes." I asked him who else was involved to which he stated Chris. I asked [redacted] who
49 else knew about this and he answered, "Just Chris." [redacted] stated that when these Detectives
50 showed him those photo's, he knew right then that one of the dead boys was the boy Busch brought
51 from up north and had him perform sex on, stating that he is a co-conspirator. I explained levels of

1 culpability to [redacted] and asked him why he didn't say anything to the police back then, to which he
2 stated he was too scared. During this interview, [redacted] talked about Busch buying a blue Chevy
3 Vega hatchback, with a white stripe that he (Busch) purchased at Al Serra Chevrolet in Flint in
4 January of 1977. [redacted] also talked about how Busch and Green took him for a ride in 1976 to a
5 rural area off Dixie Hwy. in northern Oakland County, stating that he thought they were going to
6 molest and kill him that day, stating further that Busch had the handgun under the seat of the blue
7 Vega. Green had told [redacted] in the past that Busch has killed a kid before, in the woods up north.
8 While asking [redacted] about Busch's cottage up north, [redacted] kept saying that he thought it was a
9 house, not a cottage. [redacted] insisted he was never up at Busch's cottage, but during earlier
10 interviews with his mother, she told me that [redacted] was always with Chris & Greg, and that she
11 remembers [redacted] going up to the cottage at least twice with Chris & Greg.

12 We started talking further about his statements regarding Busch, Green & Lamborgine all being
13 involved in the killing of the King boy and possibly others. [redacted] could not say how he knew that
14 for sure, other than saying that he heard they were and kept saying that they had him at Busch's
15 cottage up north before they brought him down to Flint. When I would ask [redacted] if he was
16 hesitant on responding to that question, because he himself was involved he would state "No," but
17 not very convincingly. [redacted] kept saying that he knows that the boy I showed him a picture of
18 (Tim King) was the boy that Busch made him have sex with and the same boy that he later saw a
19 picture of, dead. We kept getting interrupted during the interview by other employee's at the halfway
20 house and had to switch offices. [redacted] also stated that after they dropped this boy off at the
21 house to who he believes was Ted Lamborgine, he never saw the boy again until the police showed
22 him the picture of the boy. Before this interview ended, [redacted] stated that he later saw a Polaroid
23 of this boy who he believes was the King boy in Busch's Vega. [redacted] said that the boy was tied
24 up in the car, in the picture. [redacted] stated that Busch kept a set of handcuffs in the Vega. My
25 time for this interview was cut short by the staff at Operation Get Down and I still had a lot of
26 questions for [redacted], especially about the authenticity of Busch seeing the King boy & how
27 Lamborgine is possibly connected to Busch & Green. I made arrangements with [redacted] and with
28 his counselor, Mr. Phillips, to interview [redacted] further at the Michigan State Police Post in a few
29 weeks down the road, so that we can talk at length without interruptions. [redacted] agreed. *** (For
30 details of this interview, see the transcripts or listen to the disc from the recording) ***

31 **1-29-08:** I called Rob Moran from the Wayne County Prosecutors Office after this interview and told
32 him that I wasn't sure because we kept getting interrupted, but that it's possible this [redacted] was
33 involved in the child killings. I told Moran that Busch & Green used him in the past as a "lure" and
34 that [redacted] feels that one of the boys Busch had may have been the King boy. I told Moran that
35 [redacted] stated while talking about this boy that he called himself a "co-conspirator." I stated to
36 Moran that I felt that it was possible that [redacted] was leaning towards admitting involvement or
37 knowledge after the fact, as possibly an unwitting at the time of the crime, but was hedging based on
38 what might happen to him as a conspirator. I told Moran that we are going to interview
39 [redacted] further to clarify his possible involvement. Moran stated that he was going to look at the law on this,
40 due to the fact that [redacted] was 13-14 years old at that time.

41 **1-29-08:** I called Garry Gray (MSP) right after this and told him about what [redacted] was saying. I
42 gave Garry the details of what [redacted] described about his involvement with Busch & Green in
43 1976 & 77. Garry stated that the details of what [redacted] was saying, is matching, exactly to what
44 he was reading in the state police report he was holding in his hand, from the Busch/Green CSC
45 investigation from 1976 & 77. This is the case that [redacted] was the victim of Busch & Green on
46 that was prosecuted in Oakland County in 1977.

47 **2-1-08:** *** ([redacted] called my cellphone today) *** [redacted] called my
48 cellphone today to tell me that he sent me a letter to the police department about Busch & Green
49 and also to tell me that he is scared about all this, worrying about being charged. I told [redacted], that
50 [redacted] was glad he called and that I did not want him to be scared, stating that our intentions at this point,

1 based on his level of culpability, about what he told me during the first interview, are to make him a
2 witness in this case, but it depends on him. I told [redacted] that when we meet with him next week,
3 he is going to have to be completely honest with us in regards to the information he has about the
4 child killings and about his involvement in the killings and be polygraphed about his involvement and
5 the information he supplies. [redacted] stated that he doesn't know what happened to them after he
6 saw them, but he learned later that those same kids had been killed. I told [redacted] that I talked to a
7 prosecutor named Rob Moran, who is going to attend the next interview and explain the situation to
8 him from a legal stand point, but what he is going to tell you, basically is that you need to be 100%
9 truthful about your involvement and if you saw the kids alive with these adult men, but did not
10 participate in the killings, then you are possibly in a position to be a witness in this case. I told
11 [redacted] that I was not making him any promises, because we have not heard the whole story yet
12 and he would still have to be polygraphed about his information. [redacted] stated, "I'll pass." I
13 informed [redacted] that when we meet next week, he would meet Mr. Moran and Sgt. Gray from the
14 State Police who is my partner and the officer in charge of this case. I reminded [redacted] not to
15 worry, because he just has to tell the truth. [redacted] asked me to just call his counselor next week
16 with which day we are going to conduct the interview and that Mr. Phillips would bring him.
17 [redacted] also asked me to bring a picture of Ted Lamborgine from back then, because he wants to make sure
18 he's referring to the right person. [redacted] stated that he is fairly certain he is, but that he wants to
19 be sure.

20 **2-4-08:** I received two letters today from [redacted] In these letters [redacted] described in
21 more detail, his relationship with Christopher Busch & Greg Green. He also talked a little more
22 about Ted Lamborgine, including the story of how he met and was molested by Ted Lamborgine,
23 while hitchhiking in Ohio in 1977. He is going to have to explain this relationship to us further. It's
24 just too coincidental that he gets picked-up by Lamborgine in Ohio and later he says that
25 Lamborgine is connected with Busch & Green. [redacted] is either not being truthful, and trying to
26 make his own connections, or simply holding back on the entire story right now.

[redacted] wrote in his letters about how Busch, Green and Lamborgine would use him as a lure, to
28 lure kids over to the cars of these Pedophile men, stating that when he [redacted] would call a kid to
29 a car, these children were not afraid when they saw that he was the same age they were. *****(See**
30 **letters from [redacted] in the [redacted] file for details)*****

31 **2-6-08:** I talked to Garry Gray (MSP) today and we decided to interview Lourn Doan about Busch,
32 Green [redacted], before we interview [redacted] next week. Doan is the retired Southfield Detective
33 that was working for the task force in 1977 and conducted an investigation into Busch & Green as
34 possible suspects in the child killings, [redacted] in
35 [redacted] about Stebbins. As I uncovered information about Busch & Green, after the
36 investigative subpoena of polygraph examiner Wasser in 2007, it began to appear that our current
37 investigation was mirroring what Doan was doing 30 years earlier in 1977. It appears that he felt
38 strongly about these two as suspects during the original investigation, but did not have all the
39 information then that we have today about these guys, nor did he know about Ted Lamborgine and
40 his possible connection with Busch & Green.

41 **2-8-08:** Garry (MSP) e-mailed Lourn Doan today to try to set up a meeting or a conference call with
42 him for the beginning of next week. We are waiting to hear back from him.

43 **2-8-08:** We are still waiting for all of the police reports from Flint PD on Busch, Green
44 Dave Robertson sent a formal request last week from the State Police, for archived records on these
45 guys.

46 **2-8-08:** I noticed in the Michigan State Police report from their CSC investigation into Christopher
47 Busch & Greg Green in 1977, that Southfield Detective Lourn Doan & MSP Detective Dyer had gone
48 to Busch's parent's home on [redacted] to arrest Busch on the Criminal
49 Sexual assaults he had committed against [redacted] The Detectives made contact at this

1 home with Christopher Busch's father, who stated that Chris was in "Whitehall" and he would call
2 Chris to have him turn himself in. Detectives instead, had Whitehall Police go to Busch's home in
Whitehall to arrest him. Busch had left Whitehall and a statewide B.O.L. was entered in the law
enforcement computer. Busch was taken into custody in Ionia Michigan.

5 I thought at first that Whitehall, Michigan was a small town near Ess Lake, where supposedly Busch
6 spent time at a cottage and was seen there with juveniles on March 19th, 1977 (While King was
7 missing). I performed a check thru "Mapquest" and determined that Whitehall, Michigan is actually
8 on the west side of the state in Muskegon County, no where near Ess Lake, which is located near
9 Hillman, Michigan in Montmorency County. I performed some computer checks thru the "Lexis-
10 Nexis" system and found that Christopher Busch's parents owned a property in Whitehall at that
11 time, that they were buying on a land contract. It appears that the Busch's had relatives in the area.
12 There were several "Busch" families listed with property in the Whitehall area. The property that was
13 owned by Christopher Busch's parent's, was eventually "Quick Claim Deeded" to

14 _____, who is now deceased. I located Christopher Busch's older brother
15 _____ living in New York City, but am unable to locate _____ (The other brother) so far.

16 **2-11-08:** We still have not heard from Lourn Doan, so we are going to go ahead and interview
17 _____ on Wednesday this week. We will interview Doan about this case whenever we
18 can make contact with him.

19 **2-11-08: *** (Located reports from Montmorency & Identified the cottage on Ess Lake, near**
20 **Hillman, Michigan.) ***** I called Montmorency County Sheriffs office today and spoke to a
21 dispatcher named Mike Juricz who told me that Junior Brandenburg and Charlotte Pelham are both
22 retired, but still live in the area. Brandenburg was the Montmorency Detective that investigated
23 Christopher Busch in the CSC case when Busch was arrested and charged with in their county in
24 1977. Charlotte Pelham was the Sheriffs Dept employee who took the anonymous call from a
25 woman on March 19th, 1977, that stated that she saw Chris Busch in the area with two minor boys.
26 Juricz made contact with Charlotte Pelham who agreed to talk to me and gave Juricz her phone
27 number for me. I called and spoke to her about the report she wrote on the anonymous phone call
28 she took on March 19th, 1977. I read her report to her over the phone and she stated that she does
29 not specifically remember that incident, but the part about Christopher Busch being in town with two
30 minors, "rang a bell" with her. Pelham stated that Juinor Brandenburg would probably know who the
31 anonymous caller was and where the cottage was at, stating that he (Junior) still lives in the area
32 near Ess Lake in Hillman, Michigan. Juricz the dispatcher called me back and stated that
33 Brandenburg's phone was busy, that he would keep trying to call him to either call me or give me his
34 phone number.

35 During this conversation, Juricz stated that a Deputy Shaw, who is trying to help out, found the
36 Busch file and has info if I wanted to talk to him about it. I spoke to Shaw who stated that in
37 Detective Brandenburg's notes, it says that the woman who called on March 19th, 1977 was a "Suzie"
38 from the "A frame" party store. Shaw stated that he is familiar with that store and can call over to the
39 new owners and get "Suzie's" name. Shaw called me back and stated that "Suzie" is
40 who is now deceased, but her widower is _____ who currently owns the Grand Lake Lodge
41 bar near Alpena, with a phone number of _____ Shaw stated that in Det. Brandenburg's
42 report of the follow-up on these calls, it states that "Suzie" stated that the boys with Busch were
43 approximately 16 & 18 years old. Brandenburg also interviewed _____ who had
44 called after seeing Busch with 3 young boys at the IGA on March 19th, 1977. These callers stated
45 that the 3 boys were approximately 13, 14 & 15 years old that were with Christopher Busch. These
46 witnesses all gave statements indicating that they only ever saw Christopher with young boys when
47 he was up north.

48 Deputy Shaw then faxed me a copy of a letter in the file from Detective Waldren at Flint PD to the
49 Chief of the Alma Police Department, March 9th, 1977. In this letter, Waldren tells the Alma Chief
50 that Busch has CSC cases pending in Genesee County, Oakland County, Montmorency County and

1 Midland County. Waldren stated that the strongest cases against Busch are in Oakland and
2 Genesee County, stating that he has hired the best legal counsel to represent him (Jane Burgess).
3 **Waldren also wrote in this letter on March 9th, 1977 (7 days before King was abducted), that**
4 **Busch is currently free on bond on all charges.** I asked Deputy Shaw if he knows who the
5 victim was in the Montmorency case and if he was from that area, to which he stated he did not, but
6 would call the prosecutors office to see if they have the court file on Busch from their cases.

7 Deputy Shaw called me back and stated that he talked to the prosecutor's office, and that they do
8 have the file on Christopher Busch. Shaw gave me the victim's information from this file, stating that
9 a [redacted] was the victim. In Brandenburg's report on this
10 investigation, he writes that all of the boys that Busch would take to the cottage were from down
11 state. I looked at the Flint PD report for the names of the boys that he & Green had molested in that
12 area, and one was a [redacted]. This corroborates what [redacted] said
13 about Busch taking kids up to the cottage, although I [redacted] stated during the first interview, that he
14 himself was never there. [redacted] was not very convincing about this and it's interesting that he is
15 trying to distance himself from this cottage. This report stated that Busch would bring young boys
16 from "down state" to the cottage in the winter for "snowmobile parties" and also in the summer time.
17 It said that Busch would give the boys Marijuana and alcohol before molesting them. This cottage
18 was identified in these reports as being owned by Christopher Busch's father, [redacted] for 12
19 years and is located on [redacted] on Ess Lake. I had been trying to locate this cottage thru
20 computer databases and remember I [redacted] to be a street on the north side of Ess Lake.

21 Deputy Shaw stated that in Brandenburg's interview with Busch on 3-3-1977, Busch stated that he
22 did molest [redacted] at the cottage on Ess Lake, but never used force. Busch would
23 not name any of the other boys from down state that he brought to the cottage and would not make
24 any written statements until he had a chance to speak with his attorney. Busch told Brandenburg
25 that he knew Gregory Green, but at no time did he ever bring Green to Ess Lake. Busch stated that
26 Green was violent and tried to strangle a boy in Flint that he believes was [redacted]. Busch
27 continued about Green, stating that the police have confiscated all of his photographs & movies and
28 are holding them. Busch told Brandenburg that he did not have any Photo's or movies at the
29 cottage. Busch went on to say that his problem (Pedophilia) started when his father sent him to
30 boarding school at 17 years old. Busch said that his father has owned the cottage for 12 years. ***
31 **(See Detective Brandenburg's reports and the Montmorency file on Busch for details of their**
32 **investigation into Christopher Busch) *****

33 **2-11-08:** Deputy Shaw had indicated to me, that he could call the "Equalization Dept. at
34 Montmorency County and locate the information on the address and ownership of the Busch
35 Cottage. I told him to go ahead and do that if he can. Deputy Shaw called me back a few minutes
36 later and stated that the Busch family cottage is located at [redacted] on
37 Ess Lake. Shaw said that [redacted] was the owner for many years, sold it to a family named
38 [redacted] who in turn sold it to the current owners, [redacted]. Shaw stated that the
39 family," that currently own the cottage, live at [redacted]. Shaw
40 then faxed me a copy of the counties paperwork on the property from their tax rolls. This information
41 included the Legal Description, Parcel ID & Location, assessment values, Owners name and
42 address where taxes are sent, ... etc. Shaw then supplied me with Detective Junior Brandenburg's
43 home phone number and stated that Brandenburg was waiting for me to call.

44 **2-12-08:** I met with Garry Gray (MSP) today and we went over the new developments in this lead
45 on Busch & Green and their possible connection to Lamborgine. I filled Garry in on all the
46 information on Busch from Montmorency County, including the identification of the Busch cottage on
47 Ess Lake. We also discussed our interview strategy with [redacted] for tomorrow.

48 **2-12-08: *** (Phone interview with retired Montmorency Detective Junior Brandenburg) ***** I
called and spoke to Detective Brandenburg today about his investigation into Christopher Busch in
1977, for CSC 1. I informed Brandenburg who I was and what we were working on. I told him that

1 Deputy Shaw had located his reports and file on Busch from back in 1977 and that Shaw told me
2 that you had an old Detroit News and/or Free Press newspaper clipping about the disappearance of
3 Timothy King in the Busch file. Brandenburg started out saying that he remembers the case and
4 remembers Busch being a very odd guy, stating that he always felt that Busch might have been
5 involved in the King case, that's why he had the news clippings. Brandenburg said that the dad
6 was rich, owned a home in Birmingham, the cottage on Ess Lake and bought Christopher
7 Busch a big two-story restaurant. I asked if it was the restaurant in Alma, to which he stated he
8 believed it was. Brandenburg said that Christopher Busch always had young boys with him and
9 remembers that the boys were from his (Busch's) area, down state. I asked Brandenburg if he
10 remembers the cottage and he stated that it was a "flat roofed" kind of cottage, that may have been
11 painted in the past, but not much has been done to it over the years. Brandenburg stated that he
12 lives not too far from there and that he was there when they searched it. I asked him if they found
13 any photographs or anything that would indicate someone may have been held there against their
14 will, to which he stated no. Brandenburg then stated that Busch committed suicide not long after
15 their case, but he didn't know how he did it. I told him that Busch shot himself in the head.
16 Brandenburg again stated that he always had a gut feeling that Busch was involved in the child
17 killing case. He said he would contact me if he remembered anything else about the case that might
18 help.

19 **2-12-08:** Deputy "Bud" Shaw called me today and stated that he went over to the old "Busch
20 cottage" on Ess Lake and took pictures of it that he will e-mail to me. Shaw stated that he walked
21 around the cottage and it appears from the foundation and looks of the structure, that it has not
22 changed much if any, over the past 30 years, other than maybe paint, a garage and new deck. I
23 received the e-mailed photos of Busch's cottage from deputy Shaw this afternoon. It appears to be
24 a 60's style structure with a flat type roof on it.

25 **2-12-08: *** (Livonia Polygraph Examiner, Tim Larion, reviewed the Busch & Green
26 polygraph charts from 1977 today, and gave his opinion) ***** Today, I showed Tim Larion
27 (Livonia Polygraph Examiner) the MSP polygraph charts from examiner Cabot, on the polygraph's of
28 Busch & Green from 1977, in regards to the Stebbins/Mihalich abduction/murder. After
29 approximately 30-45 of reviewing these charts, Larion determined that based on their responses to
30 the relevant questions {

36 **2-13-08: *** (Video/audio-taped interview of _____ @ MSP Metro North Post) *****
37 Today we interviewed _____ about his information in regards to Busch & Green's
38 possible involvement and his possible involvement in the child killings. We also wanted to clear up
39 how _____ was connecting Ted Lamborgine to Busch & Green. We felt that this was too much of
40 a coincidence to be true. I also felt after talking to _____ last time that he was holding back
41 information, because he himself was possibly involved in the killings, even possibly as an unwitting
42 at the time. _____ was adamant that the boy that Busch made him have sex with was the King
43 boy.

44 We made arrangements to have Rob Moran present at the beginning of this interview to clear up
45 any concerns _____ may have had in regards to his culpability in this case and his ability to speak
46 freely without the possibility of being charged. _____ indicated during the first interview, that he
47 had been used by Busch & Green, as a "Lure" to get kids to the car for them and that they drove all
48 over Genesee, Oakland & Wayne Counties looking for kids. We felt that _____ may possibly be
49 the witness we were looking for that could put the pieces of the puzzle together and put the King boy
with Busch, Green & Possibly Lamborgine while missing and prior to them killing him (King).

1 Moran talked to [redacted] for a short time and then we read [redacted] his rights. [redacted] was
2 asked if he understood all of his right, to which he stated he did. [redacted] then agreed to waive his
rights and talked with investigators. We then had [redacted] start from the beginning on how he met
3 Busch, Green & Lamborgine. A lot of the beginning of this interview was the same information that
4 he told me during the first interview and was corroborated thru Flint & MSP police reports from 1976
5 & 77. When L [redacted] was talking about how he met Lamborgine and his relationship with
6 Lamborgine, we noticed some discrepancies in his story from the first interview. We began
7 questioning [redacted] about his Knowledge of Lamborgine, his connection to Busch & Green and
8 how he ([redacted] knows that Ted Lamborgine was involved in the child killings with Busch & Green.
9 I also had L [redacted] describe the boy that [redacted] said Busch made him have sex with in 1977, that
10 he [redacted] believes was the King boy. [redacted] physical description and what the boy was
11 wearing, did not match Timothy King. After a time of questioning [redacted] about his information,
12 Detectives determined that [redacted] in was trying to make the pieces of the puzzle fit to connect
13 Lamborgine with Busch & Green. [redacted] believes that the man that Busch & Green stopped to
14 see back then was Ted Lamborgine, because he [redacted] remembered Lamborgine from when he
15 picked him up hitchhiking in Ohio in 1976/77 and molested him at a restaurant. [redacted] said when
16 he saw Ted on the news last year, he knew it was the same guy. [redacted] made some comment at
17 this point, about Lamborgine being a pedophile and needing to go to prison for life, indicating he was
18 possibly trying to make Lamborgine fit into this puzzle. [redacted] cannot say for sure that Ted
19 Lamborgine is connected with Busch & Green, but believes he is. [redacted] cannot say for sure that
20 the boy he had sex with that Busch brought down from up north was the King boy, but he
21 believes it was, stating again that when the Flint police showed him the pictures of the two dead
22 boys lying naked, he knew that the one (identified by [redacted] as King) was the same boy that
23 Busch had. [redacted] also insisted during this interview that he was never up at Busch's cottage in
24 Hillman, Michigan.
25

26 We determined during this interview that it appears, that [redacted] was possibly not, for lack of a
27 better term, the "Home-run hitter" we were looking for in this case, that could put the pieces of the
28 puzzle together. [redacted] is going to have to be polygraphed now, due to the two different stories
29 and the possibility that he may have knowledge or have been involved. [redacted] may have just
30 gotten "cold feet" after possibly attempting to confess during the first interview and got scared while
31 waiting for the second interview. It is also possible that [redacted] learned what he had been involved
32 in after the fact. I asked [redacted] out of the boys that Busch & Green were running with back then,
33 who, were they closest to and had the biggest propensity to be involved in something bad with
34 Busch & Green, to which [redacted] stated [redacted] said that he saw [redacted] s in
35 Jackson prison in the mid 1990's. We then asked [redacted] for his consent to a Buccal Swab for
36 DNA, to which he gave us, but appeared very nervous about it, asking a lot questions and when the

39 2-14-08: ***(I identified another one of Busch, Green & [redacted] associates today named
40 [redacted])*** I performed a check thru the Michigan L.E.I.N. system for a criminal history

1 Lt. Dykstra's opinion on the polygraph charts of Busch & Green from 1977, in regards to their
2 involvement in the child killings, almost "mirrors" the opinion of polygraph examiner Larion. These
3 examiners gave their opinions of the charts, independent from each other and without knowing the
4 opinion of the original examiner: (Examiners, Larion & Dykstra, did not score these charts
5 numerically when reviewing them, but merely looked at the questions and Busch & Greene's
6 responses to the questions, and based on their training & experience, rendered an opinion).

7 **2-20-08:** Cathy King sent me an e-mail today, stating that she ran the Busch name by retired
8 Birmingham Detective Jack Kalbflesch and asked if he remembers the name, stating that Busch
9 committed suicide in Birmingham in the late 70's and was a suspect in the child killings. I expressed
10 concerns with Cathy talking to someone outside the Task Force & Law Enforcement, about what we
11 are working on, and she re-assured me that we could trust him. She stated that he has known about
12 this since _____ y and _____ a year ago and hasn't said anything and she was very vague with him
13 about what she was looking for. Anyways, Kalbfleisch told her that he did remember a suspect in
14 the child killings that killed himself with a shotgun at a home near Maple & Lahser in the late 70's,
15 and the reason he remembers this is because they found a pencil drawing in Busch's room of a boy
16 "screaming" that looked like the Stebbins boy.

17 **2-21-08:** The Task Force met at the MSP Metro North post today and we had retired Southfield
18 Detective Lourn Doan there to interview him about his investigation, back in 1976 & 77, into
19 Christopher Busch & Gregory Green. We gave Lourn a few general facts about the case, as to
20 "jog" his memory, but really wanted him to "fill in the gaps" on his own, without us leading him.
21 Lourn remembered the investigation and remembered Christopher Busch when we showed him the
22 picture. Being that it is such an old investigation, Lourn was struggling a bit, trying to remember
23 details of the case. We showed him the original tips he wrote up on Busch & Green in 1976 and
24 also the tip he wrote on these guys again in 1978. Detective Doan & Detective Roy Itami (Berkley
25 PD) were working together on the Timothy King Homicide, as part of the Oakland County Child
26 Killing investigation.

27 Doan continued to investigate these subjects as suspects. He remembered Busch
28 killing himself at his home in 1978, but stated he thought he hung himself, but stating he did not
29 remember for sure. We called Detective Roy Itami, who agreed to come to the meeting. Doan &
30 Itami looked over the tips they wrote up and began talking about when they took Busch & Green to
31 the polygraph with MSP in Flint. Doan stated that they, along with the "Task Force" were so
32 convinced that these two suspects were involved in the killings that Deputy Oakland County
33 Prosecutor Dick Thompson went along and was present during the polygraph,

34 Doan stated that Thompson also thought they
35 would be issuing charges on these subjects. Both Doan & Itami stated that during the hundreds of
36 polygraphs conducted on suspects during this massive investigation, this was the only time a
37 prosecutor, especially the Deputy Oakland County Prosecutor attended a polygraph. I asked Doan,

42 We then told Doan & Itami that we have recently, based on _____ statements to _____ y about
43 Busch's confession to him and our recent investigation, shown Busch & Green's polygraph charts to
44 two independent examiners, one of which is a very experienced MSP examiner. We told Doan &
45 Itami that both examiners were in agreement, independent of each other,
46

50 Both stated : _____ Doan & Itami were
51 shaking their heads stating this could have been solved 30 years ago. Both Detectives asked where

1 their reports were. All we have is the tip sheets they wrote up and what was attached to the tips.
2 Doan stated that he knows he wrote lengthy reports on this lead. Itami stated that he remembers
3 the amount of writing Doan did at that time on this lead and stated that there should be a large file
4 on these guys. We are going to check further in the state police files for these. Doan stated that if
5 we call Chris Helgert at Southfield PD, he may have a copy of his (Doan's), indicating that he thinks
6 he gave a copy of everything to his agency.

7 **2-22-08:** I was reviewing Polygraph Examiner Cabot's pre-polygraph interview of Gregory Green
8 today, and noticed that Cabot asked Green if there were anyone he wished were dead? Green
9 mentioned his father, a couple of other names and . It's interesting that Green wants
10 dead. It's possible that had information about Green and he (Green) was afraid
11 would tell someone. We are going to take this report with us when we interview (in
12 prison in a couple of weeks.

13 **2-25-08:** We went to Southfield PD today and talked to Chris Helgert about Lourn Doan's old
14 reports involving an investigation Doan conducted at the time of the child killings, regarding two
15 subjects, Christopher Busch & Gregory Green. Helgert had already pulled all of Southfield PD's
16 reports that they had from the child killing investigation. In these reports, we found two tips written up
17 by Detective Doan on Busch & Green in January of 1977. This file from Southfield PD also
18 contained several typed reports by Doan about this investigation into Busch & Green. **The**
19 **following is a short "Time-Line" of the, "one-week" investigation in January 1977 when**
20 **Greene was arrested for multiple CSC's in Flint and told the police Chris Busch killed Mark**
21 **Stebbins. This short time-line includes some highlights of interviews and when & why they**
22 **were cleared and the case was closed:**

23 1-25-1977: OCCK Task Force contacted by Det. Waldren from Flint PD. They have arrested a
24 subject named Gregory Green for CSC 1st Degree, who says that Chris Busch killed Mark Stebbins.

25 1-25-1977: Doan & Lt. Simmons went to Flint PD and interviewed Greene about this information.
26 Greene, according to Doan's report supplies Detectives with all the information about Busch's
27 involvement in the Stebbins abduction/murder. Doan notes that Green is looking more like a
28 suspect in the homicides than an informant.

29 1-26-1977: (the victim in this case) was interviewed. said that he was
30 afraid when Greene & Busch took him into the woods to molest him that they were going to kill him.
31 Greene had choked him unconscious in the past when trying to anally molest him. Greene had told
32 prior to this that Chris Busch had killed a kid before. told the police that Greene
33 had asked him a few months ago, to help him kidnap and kill a boy. went on to say that
34 when Greene anally molested him in the past, Greene used force, was crying, but Greene
35 would not stop.

36 1-26-1977: Flint PD polygraphs Green about his info about Busch Killing Stebbins. Flint PD
37 polygraphed Green about whether he knows for sure who killed Stebbins.

39 1-26-1977: Green was interviewed today by Dick Thompson (Oak County Pros.), Gary Hawkins
40 and Lt. Simmons (Southfield PD).

41 1-27-1977: Warrant obtained today for Christopher Busch, by Flint PD for a CSC 3rd Degree.

42 1-28-1977: Detective Doan, Det. Cattel (Ferndale PD), Sgt. Rivard (MSP) & Det. Waldren (Flint
43 PD) went to the "Scotsman" restaurant today in Alma, Michigan and arrested Christopher Busch on
44 Flint PD's CSC charge.

45 1-28-1977: Detectives conduct a consent search of Busch's home at
Detectives find 2 shotguns, ½ - 1lb. Of Marijuana and 2 suitcases. 1 suitcase contained ropes and

1 **2-15-08:** I received a phone message today from Garry Gray (MSP) who stated that he finally got a
2 call-back from Lourn Doan, the retired Southfield Detective that was "looking hard" at Busch &
3 Green as OCCK suspect back in the 70's. Doan had been on vacation in the Bahama's for the last
4 couple of weeks; but told Garry that he would be more than happy to come in and talk to us about
5 this lead.

6 **2-19-08:** I talked to John Ouelett (FBI) today about trying to get a copy of the report or file from
7 Bloomfield Twp. PD, on the suicide of Christopher Busch. John said that he knows the Chief of
8 Police at that agency and would call him today to request this file or a copy of it. I told John if they
9 locate it to let me know and I would drive over to Bloomfield Twp. and pick-up the file today.

10 **2-19-08: *** (Identified several of Busch & Green's other associates today, including:**
11 **) ***** I performed a check thru the Secretary of State today

33 Busch & Green's polygraphs from January 1977 in regards to the Stebbins case. We are going to
34 also show these charts to the FBI examiner in the area for his independent opinion. We have
35 arrangements to interview Lourn Doan on Thursday this week after Lawson's sentencing.

36 **2-20-08: *** (MSP Polygraph Examiner, Lt. Dykstra reviewed Busch & Greene's charts today)**
37 *** Today, Garry, Dave & I took Busch & Green's polygraph charts from January 1977, over to the
38 Michigan State Police post in Northville, to get Lt. Dykstra's (polygraph examiner) opinion on the
39 charts. We didn't tell Dykstra anything about the case, or anyone's opinions or findings ahead of
40 time, just simply asked him to review the charts and give us his opinion. We left the room, and after
41 approximately 30 minutes or so, Dykstra called us back into his office. Not knowing what the original
42 polygraphers opinion was, Dykstra pointed at the chart for Green and stated

1 the other contained child pornography, including child porn films and scrapbooks. The 2 suitcases
2 found in Busch's home in Alma, were confiscated by Flint PD as evidence in their CSC case.

3 1-28-1977: Doan, Cattel, Waldren & Rivard (MSP) interviewed Busch about his possible
4 involvement in the Oakland County Child Killings. Busch denies involvement in the Stebbins case,
5 but told Detectives about fantasies that he and Green have discussed. Busch said that they have
6 talked about wanting to kidnap a boy, tying him up and sexually abusing him. Busch stated that
7 either he or Green would work at night and the other during the day, so one of them would always
8 be with the boy. When Busch was asked what they would do with the boy when they were done
9 with him, he couldn't answer. While Busch was talking to Investigators about being a pedophile and
10 locations he picked up and dropped off boys in the past, he named the following locations in

17 2-1-1977: Green was polygraphed today by Ralph Cabot, at MSP in Flint. Green was asked about
18 his involvement in the Stebbins abduction/murder and/or his knowledge of it.

19
20 2-1-1977: An article in the Daily Tribune
21 was in this file that stated on the headline that Task Force finds no link between Flint case and child
22 killings in Oakland County. The article stated that two men arrested in Flint were polygraphed about
23 their possible involvement in the child murders in Oakland County, but both were cleared. *** This
24 case was closed. ***

25 2-26-08: We went to Flint PD today to try to get any reports or notes their Detectives might have
26 done on Green's info about Busch, and also copies of the polygraphs Flint PD did on Green. The
27 only file that we could locate at Flint PD was the old CSC cases (reports) on Busch & Green. We
28 already have copies of those. A Detective Greg Hosmer is going to manually go thru the old
29 polygraph files and see if he can locate the polygraphs administered on Green at Flint PD on
30 January 26th, 1977.

31 2-26-08: *** (We got copies of Bloomfield Twp.'s reports today on Busch's suicide at his
32 parents home in 1978) *** Garry & I went to Bloomfield Twp. PD today and picked up a copy of
33 their reports on Busch's suicide. John Ouelett (FBI) knows the Bloomfield Twp. Chief (Kurt Bowden)
34 and asked him to pull their reports for us. Their reports stated the following: On November
35 20th, 1978, Bloomfield Twp. PD was called to Chris Busch's parents home at
36 y Chris's older brother, , who lives in the area at
37 Chris's brother, had been contacted by a neighbor after the
38 Busch Maid () was unable to gain entry into the home and went to the neighbor's
39 house to call . The Maid comes to the Busch home once a week on Mondays to
40 clean the house, but was unable to get in due to the latch being locked at the front door.

41 The police made entry into the home and they found Christopher Busch upstairs in his bed with a
42 gunshot wound to the head. Busch had shot himself between the eyes with a 22 cal. Rifle that was
43 lying next to him in the bed. old the police that Chris lives there with the parents
44 that were currently in England. went on to say that he had not spoken to
45 Chris in the last 3 weeks, but that he did not seem despondent. In this report, old
46 the police that his brother resides in Whitehall, Michigan and his brother resides
47 in England. The maid, (was interviewed and stated that she has a key to let
48 herself in when she comes to clean, but on this date, she could not open the front door because it
49 was latched from the inside. When she became suspicious she called the neighbor.

1 2-28-08: We had retired Detective Lourn Doan (Southfield PD) come to the MSP Metro North Post
2 today, and look over his reports from January of 1977 that we picked up at Southfield PD. Doan
3 read over all of his reports, and he did remember most of what he had read, including remembering
4 that investigation, but could not add much additional information to assist us.

5 2-28-08: *** (We Briefed Detective Lt. Darryl Hill (MSP) today at the District Headquarters in
6 Northville) *** Garry, Dave & I went to the MSP 2nd District headquarters today and briefed Lt. Hill
7 on the developments in this investigation. Based on what we told Lt. Hill, he authorized D/Sgt. Gray
8 make this case top priority at this point and to work full-time on trying to put this case together. My
9 administration at Livonia PD was also brought up to speed on this lead. Chief Stevenson, felt as
10 strongly about the potential of this lead as Lt. Hill, and also authorized me to work full-time with the
11 State Police right now to continue to pursue this Busch & Greene lead. Lt. Hill also authorized us to
12 use the Michigan State Police Aviation Section to fly Garry & I up to Camp Ojibway to interview
13

14 2-29-08: John Ouelett called the Chief of Bloomfield Twp. PD (Bowden) and requested that they try
15 to locate the crime scene photos that they took at Christopher Busch's home on
16 when Busch committed suicide in November of 1978. They are going to call me if/when
17 they find them.

18 2-29-08: Doan's report on the interview of Busch at Flint PD in January 1977, showed the name
19 as the kid Busch Picked up from the 12 Mile Rd. & Greenfield area and took to
20 Hartfields Bowling Alley and the 7-11 store. Busch stated to Detective Doan that was a
21 w/m that Lived in Berkley and would be 18 years old. I grew up in Berkley and thought I
22 remembered a kid named from my neighborhood or school. I called my Brother Mark
23 Williams (retired Berkley Police Lt.). I asked Mark if he remembers a family in Berkley, in the 12 mile
24 & Greenfield area with the last name ! Right away, Mark stated you mean
25 he lives on just north of 12 Mile Rd. This is in the area of 12 & Greenfield
26 in Berkley. Mark said that was a few years younger the he (Mark) was and a few years
27 older than I am. Mark then stated that had many arrests and police contacts in Berkley and
28 surrounding cities. Mark went on to say that he was eating a meal at a restaurant in Berkley one
29 time (on-duty) when the waitress yelled out, hey Mark there's a guy slashing the tires on your police
30 car. My brother observed and arrested ! for Malicious Destruction of Police
31 Property.

32 2-29-08: *** (I identified ! today, an associate of Chris Busch) *** I
33 performed a Lexis-Nexis computer search for ! and found no matches. I performed the same
34 check on the name ! and observed a !
35 ; This check showed this
36 to be a current address for ! I performed a search thru the Secretary of State database and
37 located ! These results also showed o
38 I was also
39 able to obtain photos of ! thru the Secretary of State images. The age, race of
40 and location of his home in Berkley match what Chris Busch told investigators about !
41 I performed a check thru the Michigan LEIN system and found that !

46 ... It's possible this i was more of an associate of Busch's than a victim.
47 was 18 years old at the time of our abduction/murders.

1 **3-2-08:** While working on the "time-line" for the current Green & Busch investigation, I noticed that
2 Busch, when being interviewed on 1-28-77, by Doan & Cattel at Flint PD, described his flight from
3 England to the U.S. Feb. 14th, 1976. Busch told Detectives that he flew from London to New York to
4 Chicago and then into Flint Bishop Airport where his parents picked him up and they went directly
5 home to Birmingham. Approximately an hour or two later, when Busch was telling the MSP
6 polygraph Examiner Cabot, when he arrived back in the U.S. from England, he stated that he flew
7 into Detroit Metro Airport. Cabot has Detroit Metro in his notes and on his report.

8 I also noticed while doing this "time-line," that Green told Cabot during his pre-polygraph interview,
9 that he was released from the mental institution 1-15-76. Green also told Detectives Waldren &
10 Miller, during the interview, after his arrest on 1-25-77, that he was released from Patton State
11 Mental Hospital in California on 1-15-76. Records from California Dept. of Justice, Bureau of
12 Identification and teletypes in the file from 1978, both show that Green was discharged from the
13 mental hospital on 7-21-1975. If Green was in-fact released from the mental hospital on 7-21-1975,
14 then he may have been back in Michigan and possibly associating with Busch, several months prior
15 to the first OCCk victim, Mark Stebbins being abducted, 2-15-1976.

16 One of the other noteworthy items from the "Time-Line," was something Busch mentioned to the
17 Montmorency Detective, during his interview after his arrest on 3-3-77. Busch was talking about the
18 boys from the Flint area that he would bring up to his father's cottage on Ess lake, and he said that
19 he had his first women up to the cottage approximately two weeks ago. This could possibly have
20 been around the time that Kristine Mihelich was missing, found 1-21-77.

21 **3-3-08:** I was talking to John Oulett (FBI) today and told him about: John stated that Ray
22 Anger from Berkley PD conducted extensive interviews of employees at Hartfields Bowling Alley
23 after Kristine Mihelich's abduction. Mihelich's mother, Deborah Ashcroft worked as a bartender at
24 Hartfields at the time of Kristine's disappearance. Kristine used to frequent the bowling alley to visit
25 her mother. John Oulett stated that he thought he remembers that the police were looking at a local
26 18 year-old guy at that time that frequented the bowling alley. We are going to look thru the
27 interview reports to see if the 18 year-old may have been E and if Busch & Green, may also
28 have been mentioned by employees.

29 **3-3-08:** I talked to Jason Bolinger (FBI) today, about getting the lead sent to New York to interview
30 and swab for DNA. This is Christopher Busch's only living family member that we
31 can get DNA from.

32 **3-3-08: *** (Identified () today, one of Greg Green's ex-cellmates from prison)*****
33 We had received a list of Green's cellmates that he was with during his years in prison, from the
34 Assistant Warden of Jackson Prison, Cindy Ackers. One of the people on the list was a guy named
35 , that was doing time for CSC 1st Degree (child u/13), the same thing Green was serving
36 time for. was charged with his CSC in Genesee County. I determined that is from the
37 Flint area and now resides in Flint, where Green grew up. They may have possible had a lot to talk
38 about. I performed a search thru MDOC and located ' i. A
39 search thru the Michigan LEIN system, '-----

40
41 I was able to obtain several photos of thru the Secretary
42 of States imaging system. *** (See) file for further info ***

43 Cindy Ackers also sent us information on Gregory Green's family and about his death. According
44 to Akers, Greg Green died of a heart-attack while watching TV in his cell in 1995. The guards found
45 him sitting up with his eyes open. Because of his position and his eyes being open, his death was
46 not discovered for a long period of time. Cindy Ackers also supplied us with Green's brother's
47 names, who visited Green in December of 1995, shortly before his death. One brother is .

The other brother is '

1 **3-4-08:** I searched thru Berkley PD's (Ray Anger) reports today on the Kristine Mihelich case,
2 knowing that they did an extensive investigation/interviews at Hartfields Lanes in Berkley, because
3 of Mihelich's mother working there and Kristine frequenting that location. I checked to see if there
4 was any mention of Christopher Busch, Greg Green or [redacted], being regulars at the
5 bowling alley. I did not recognize their names or any other names in these reports that would
6 possibly connect the investigations.

7 **3-4-08:** Garry made contact today with the Detective from the Flint MSP post, who is going to
8 contact [redacted] (Green's ex-cellmate) and verify his residence and a good time for us to come
9 interview him. We are waiting to here back from the Flint Detective.

10 **3-4-08:** Garry called the Detective at the Newaygo Michigan post, Scott Rios, who agreed to make
11 contact with Christopher Busch's [redacted] h to verify his residence and to lay the ground-
12 work for us to come interview him about Busch & Green. [redacted] h lived on the next street over
13 from Greg Green and is the one who introduced Greg Green to [redacted] We are going to
14 interview [redacted] to learn more about Busch's background and hopefully learn when Green
15 arrived back in the Flint area and started running with Chris Busch.

16 **3-4-08:** We made contact today with New York FBI Agent Tommy MacDonald. He has agreed to
17 interview Chris Busch's brother [redacted] and swab him for DNA. We talked to the FBI agent working
18 with us on this case, Jason Bolinger and he is going to send the questions to Tommy MacDonald
19 that we want him to ask [redacted]

20 **3-4-08:** Garry took the polygraph charts from Busch and Green's, 1977, Stebbins polygraph to
21 polygraph examiner Wojnarski's office today for their upcoming meeting on 3-6-08. The 3 polygraph
22 examiners that looked at these charts independently are going to meet, discuss their conclusions
23 and see if they can come up with a consensus on the suspect's charts.

24 **3-5-08:** Garry and I met with Captain Steve Cook (Bloomfield Twp. PD) today and discussed the
25 evidence from the Busch Suicide scene. MSP had located a lab report a few days ago that showed
26 that MSP turned over the ropes and the drawing from Chris Busch's back to Bloomfield Twp. PD in
27 1982. Bloomfield went thru their files and evidence room and located the suicide scene photos from
28 Busch's suicide in November of 1978. These photos showed Busch in bed, lying on his side, facing
29 the wall with a rifle lying next to him. Busch's right arm was extended across the bed near the rifle,
30 in a position to pull the trigger. In the bedroom photo's you can see the drawing of what appears to
31 be the Stebbins boy, pinned to the wall that Busch is facing. Also in the crime scene photo's was a
32 couple of pictures of the ropes & ligatures that were found in Chris Busch's bedroom. The ropes
33 were found in the lying on the floor in the middle of the walk-in closet in Busch's bedroom. These
34 ropes look as if they were left where they were used or thrown on the closet floor. Also found in the
35 bedroom was a single shotgun shell casing, on the desk. In the packet of photo's and reports were
36 a number of latent prints that were lifted from the rifle, ammo box and other items in Busch's
37 bedroom. Captain Cook stated that they were unable to find the ropes and that they were probably
38 destroyed years ago.

39 Captain Cook turned over all of the Bloomfield Twp. PD, original photos, latent prints and reports
40 us. They also gave us the entire file that Tobias had brought into Bloomfield Twp. PD before he
41 died. We will be able to go thru this and see if there was any mention of Busch, Green or
42 Lamborgine, by Tobias. He was a retired investigator who had worked on the OCCK case for many
43 years. *** (See Busch Suicide photos and reports for details) ***

44 **3-6-08:** *** (Tape-recorded interview of [redacted] today at Camp Ojibway in the
45 Upper Penninsula of Michigan) *** MSP Aviation flew Garry & I out of Lansing to Ironwood,
46 Michigan, in Gogebic County today, to interview [redacted] MSP Detective Tim Doan picked us up
47 and took us to the prison (Camp Ojibway). We began by reading [redacted] his rights, which he
48 stated he understood and agreed to waive and talk to us. While talking to [redacted], he stated that
49 he knew Christopher Busch from his neighborhood in Flint in the mid-seventies and had been

1 molested by him (oral copulation) several times, in Flint, the cottage on Ess Lake in Montmorency
2 County and also at, what he described as Busch's house in Alpena, Michigan. [redacted] stated that
3 he two times he was at the cottage on Ess Lake there were several boys there, including his brother
4 and other Flint boys, but not [redacted]. [redacted] went on to say that when [redacted]
5 took him to the house in Alpena on a couple of occasions, it was just he and Chris.
6 told us that on one occasion they arrived at the house, Chris rushed him to the bedroom and brought
7 him a beer and some marijuana to smoke. [redacted] said that Chris then had him undress and pulled
8 a movie screen down from the ceiling that was in the room. [redacted] went on to say that Busch then
9 turned a movie projector on (Possibly 8mm) and began showing a movie (possibly a home movie) of
10 a man anally molesting a boy that was tied up. We asked [redacted] if it was Busch molesting the boy
11 in the movie, to which he stated he didn't think so, but did not know for sure. [redacted] s said that
12 Busch then tried to put Vaseline on him so he (Busch) could penetrate him anally and he
13 ran from the room. [redacted] said that Busch chased after him and said something to another person
14 in the house that [redacted] states he didn't see. [redacted] ; said that Busch told the other person in the
15 house, something like, "I'll take care of this." [redacted] stated that he thought they were there alone,
16 but thinking back now, the way Busch hurried him into the bedroom when they got there, he believes
17 there was another person in the house. [redacted] described the house as being just outside of town
18 in Alpena and stated that there were other houses around there, but there was quite a distance and
19 woods between them. [redacted] stated that he thought that the house belonged to Chris Busch, but
20 stated maybe Busch shared that house with another person, adding that he ([redacted]) doesn't know
21 for sure. [redacted] described Christopher Busch's car as being a small Pinto type car, possibly
22 brown in color and stated that Busch also had a full size S.U.V. [redacted] , stated that Busch never
23 performed anal sex on him, nor ever tied him up. When asked about the incident in Alpena,
24 [redacted] ; stated that Busch never threatened him and did not threaten him that day, but only told him
25 that he would not try that again.

[redacted] then told us that later during that time period, Busch's mother pulled up to him in a
limousine in his neighborhood in Flint, and offered him money, not to say anything to the police or
28 testify against her son Chris. [redacted] told us that he and his brother just ran home.

29 While talking to [redacted] ; about Greg Greene, he stated that he did not know Green and did not
30 remember him from the neighborhood. I showed [redacted] a picture of Green from 1977 and
31 [redacted] stated that he didn't know him. I showed [redacted] the police reports from 1977, when he
32 [redacted] all went to the drive-in theatre with Greg Green and
33 Green performed oral sex on the boys, including [redacted] s stated he doesn't remember
34 that and does not know Green. I reminded [redacted] ; that they went to see the movie "The Exorcist"
35 that night. I showed him Green's picture again, and then he stated that he kind of looks familiar, but
36 that he does not remember him. [redacted] then stated that he has done a lot of drugs over the years,
37 as if making an excuse not to remember Green.

38 I asked [redacted] about other places he has been with Chris Busch in the past, like the Detroit area
39 or any of his (Busch's friends in the Woodward corridor). [redacted] said he never went to Detroit or
40 anywhere in that area with Chris, including his house in Birmingham. [redacted] stated that he knew
41 that Chris's parents were rich, but was never at their house. I asked him about Chris's house in
42 Alma or in Whitehall. [redacted] said that he was never in Alma, but was at the apartment in Whitehall
43 in 1982, with [redacted] ; said that this apartment was above a store in Whitehall and that
44 he believes that Jr [redacted] then bought the store and lived upstairs
45 in the apartment. I asked [redacted] he knew Chris to be "into" art, drawing, painting...etc?
46 stated no. I asked if he knew if Chris or his family had any pets and if so which places he saw them
47 at, to which he stated he never saw any pets and did not if they had any.

48 I asked [redacted] if he ever saw a boy with Busch that he didn't recognize, or if Busch ever had him
perform sex on another boy, to which [redacted] stated no to both. We asked [redacted] he ever saw

1 Busch hurt or keep another kid against his will, to which [redacted] stated, no. I asked [redacted] if he
2 ever saw Busch carry any type of a weapon, to which [redacted] stated he thought he carried a knife.

3 The interview was completed at this point. We did not believe [redacted] s about not knowing Greg
4 Green and he appeared to be minimizing his information about Busch also. [redacted] s information is
5 contradictory to what [redacted] told us, when he stated that [redacted] s was the closest to Busch and
6 Green of anyone in their group. We made plans to have [redacted] swabbed for DNA and a possible
7 re-approach of [redacted] after the interview of [redacted] ***
8 **(See MSP transcripts of this interview for details) *****

9 **3-7-08:** I spoke with Livonia Polygraph Examiner Tim Larion today, who told me the results of the
10 polygraph examiners meeting regarding Busch & Green. Larion stated that due to Cabot, not
11 including relevant questions on the final test for each subject, the 3 examiners are unable to conduct
12 a numeric scoring on these charts. Their official conclusion, based on the charts being incomplete,
13 is
14

15 **3-7-08: *** (I identified Greg Greene's brothers today) ***** I was able to identify and locate both
16 of Green's brothers today, [redacted] . I performed checks thru the Lexis-
17 Nexis database for both subjects and located [redacted] s living in [redacted] &
18 living in [redacted] . I check thru Secretary of State, revealed J
19
20

21 [redacted] I obtained photographs of both of these subjects, *** **(See Greg Greene file**
22 **for this information and photo's) *****

23 **3-7-08:** Garry called the MSP Detective (Tim Doan) in Gogebic County, Michigan today. Tim is the
24 Detective that picked us up at the airport and took us to Camp Ojibway to interview [redacted]
25 Tim is going to go see [redacted] , swab him for DNA and tell him that we know he lied about knowing
26 Greg Green and we are going to have him shipped down to the Detroit area so we can polygraph
27 him. Tim Doan is also going to tell him that his potential parole that he was looking forward to in
28 April, 2008, is not going to happen unless he is truthful with us.

29 **3-9-08:** I sent an e-mail today to Deputy Bud Shaw at the Montmorency County Sheriffs Dept. He
30 is the Deputy that helped me locate old reports on their investigation into Busch and also the Deputy
31 that helped me locate and identify Busch's cottage on Ess Lake. I asked him in the e-mail if he
32 could help me possibly identify this house in Alpena that [redacted] ; said Busch took him to a couple of
33 times and tried to anally molest him.

34 **3-10-08: *** (Interview of [redacted] in Newaygo, Michigan) ***** Garry Gray (MSP) & I
35 went to the Newaygo State Police post today to interview [redacted]
36 [redacted] . We began the interview by reading [redacted] his rights, to which he stated, he
37 understood, waived them and agreed to talk to us. We started telling [redacted] that we wanted to talk
38 with him about some things going on in Flint 30 years ago. [redacted] right away asked if this was about
39 Greg Greene, to which I stated it was about Greg Greene and Christopher Busch. I asked [redacted] if
40 he remembers when he first started seeing Greg Greene around his neighborhood in Flint, to which
41 he stated that he believes it was approximately 1974-1975, because he and his family moved to
42 Whitehall late in the summer of 1976, so it was well before that, probably a year or so before they
43 moved. This would match the documented information about Greene actually being discharged
44 [redacted] in California in July of 1975. [redacted] said that he did not know about Greg
45 Greene [redacted] , or about him coming back from California, he simply stated that
46 he remembered seeing him around the neighborhood in 1975. [redacted] said that he did not know how
47 Chris & Greg met. [redacted] said that [redacted] , bought his father
[redacted] a store in Whitehall, Michigan to run. [redacted] said his family moved there from Flint and
lived in an apartment above the store.

1 t said that he remembers when t Chris
2 got arrested for molesting the kids, stating t Chris left Whitehall in a car and
3 were stopped and arrested in the Ionia Michigan area after the police put out an "a.p.b." for Chris.

4 t told us about the other boys in the neighborhood, stating that he was
5 friends with
6 r his
7 matches information that s told us about their families.

8 During the course of the interview, admitted that he had been sexually molested in the past
9 by both Greene & Chris (Chris Busch) in 1975 & 76. talked about how he had spent
10 time with both Busch & Greene alone when they molested him, but stated they were never together
11 when molesting him. started talking about Chris molesting orally & anally and would take
12 pictures of him naked during sex. also said that Chris would have him perform sexual acts on
13 other boys and take pictures of these situations. went on to say that Chris sometimes, would
14 hold the camera up in the air above them while was performing oral sex on him (Chris). We
15 asked if Chris or Greg ever showed him any movies, to which he stated that Chris had shown
16 him some porn movies in the past, but he thought that they were regular adult porn films. We asked
17 if Chris ever filmed him, to which he stated no.

18 t told us that Chris would take he and other boys, like up to his
19 s cottage on Ess Lake and had performed oral sex on while they were there.
20 said that Chris insisted on sleeping on the couch in the living room away from the other boys
21 and eventually that evening, molested him. I asked about a home that Chris had in Alpena, to
22 which stated that he did not know about another house, stating that he was only ever at the
23 cottage on Ess Lake. When we talked to about any other houses Chris had taken him to, he
24 stated that he had been to the house in Alma and to Chris's house in Sanford, Michigan. The house
25 in Sanford was only approximately 50 miles away from his house in Alma where Chris
26 owned/worked at the "Scotsman" restaurant. I asked : how and why Chris owned all these
27 properties, to which stated that h probably bought them for Chris. talked
28 about how much money (Chris's dad) had. t stated, he had been
29 molested by Chris at both of these houses. He said that as far as he can remember or knows, Greg
30 Greene was never at any of Chris's houses or the cottage at Ess Lake, but does not know for sure.
31 He did say that he believed that Chris & Greg, along with having the pedophile bond between them,
32 also had a homosexual relationship going on. We asked about Chris and Greg using force against
33 him or violence, to which t stated that they both forced themselves, anally on him, but that it
34 was never violent or where they hurt him. He also stated that Greg had never choked him or ever
35 indicated that he had ever hurt anyone. said that neither one ever tied him up or asked him to
36 be tied up and said that he never saw any ropes or heard about either one doing that to kids. We
37 asked who he believes was the more violent type between Chris & Greg. stated that he
38 thinks Chris was more violent than Greg. said that he never heard anything about either one
39 hurting/killing a kid.

40 We started talking to about whether Chris or Greg ever took him out in their cars and used
41 him to call kids over to the car as a "lure." stated that neither one ever did that and went on to
42 say that when Greg was with him he (Greg) had no interest in being with another boy because he
43 (Greg) was so "into him."

44 We started talking more about the house in Sanford, Michigan. said that when he was there
45 one time, Chris had brought another boy to the house that he thinks was named t said
46 that he did not know the boy, but stated that he did not think the boy was being held against his will.
47 went on to say that Chris left for the day and left him and this boy home alone. I asked if
48 Chris asked him to keep an eye on the boy why he was gone, to which he stated no. said that
49 the only thing Chris said when he got back was, asking if he and this boy had sex why he (Chris)
50 was gone. stated that he didn't see this boy again and has no idea who he was. stated
