When asked about Chris doing artwork or drawings,

It stated that he never knew Chris to do that, but did not know for sure. We showed crime scene photos from Busch's suicide regarding the ropes found in the walk-in closet. said that he did not know why he had those, but stated that he can imagine why Chris had them and what he did with them. It stated that he had not seen those before at the Birmingham house or any of the houses Chris had access to. We asked about any pets that Chris had at any of the houses, to which he stated that Chris had a tan Labrador type dog and that his parents had a white Scottish terrier dog at the Birmingham house that they brought over from Europe. He did not remember, when asked, seeing either dog at the other houses or cottage with Chris. stated he may have taken them to the other places, but he couldn't say for sure.

\*\*\*\* The task force has white animal hairs recovered from the clothing of our victims from the original investigation

We also have tan/gold carpet fibers on our victims clothing that

could possibly have been from one of the homes or cottage of Busch. The carpets in Chris Busch's bedroom and walk-in closet at his parents home at that time, were tan/gold color. These fibers could also have come from the gold colored ropes/ligatures found in Busch's walk-in closet that he possibly used to bind victims. Some of the fibers we are in possession of were collected from our victim's socks. Two of the victims were determined by the M.E. during their autopsies to have bind marks on their wrist and ankles, possibly from ropes. Therefore, the tan/gold fibers found on the victim's socks, could possibly be from the ropes or ligatures that were used to bind them. Ropes and ligatures were found in Busch's home in Alma and also in the walk-in closet in his bedroom in Birmingham, along with the drawing of what appears to be the Stebbins boy screaming. \*\*\*\*Laboratory Scientist David Metzger from the Michigan State Police Lab in Northville conducted tests in July of 1977 of fibers from Timothy King and fibers from Jill Robinson. Metzger determined the following after these tests: \*\*\* Results: Examination of the fiber from Jill Robinson's socks (#7A) revealed that it was microscopically similar in color and physical construction and possessed optical properties in plane polarized light "identical" to numerous fibers removed from the clothing of Timothy King. Metzger also conducted a comparison of fibers from Jill Robinson's blanket to fibers from the genital area if Timothy King. The results of this test was that these fibers were a different shade of yellow and determined to be of an unusual nature, possibly carpet fibers. showed him a movie of boys being anally molested that were tied up. Busch himself told the police in 1977, that he & Greene have discussed their fantasies about kidnapping, tying-up and molesting a at Busch's home in Birmingham, especially boy. \*\*\*(A crime scene search for t in the walk-in closet where the ropes were found, is forthcoming, along with searches at other known locations where Busch/Greene could have kept the victims. The

We were talking with about where Chris was living at certain times and he stated that after Chris was arrested in January of 1977, he lost his restaurant in Alma and he believes the houses in Alma & Sanford. It stated that Chris ended up living back at his parent's home in Birmingham, where he lived until he killed himself. It told us that Chris's parents were over seas a lot, because of job and because Chris's older brother lived in London, England. Said that he thinks I died s in San Francisco. It told us that Chris had several homes and places to stay and that he had these places alone, being that his parents lived in England for awhile and also in Germany.

We went back to talking to t about Greg Greene and about Greene's relationship with the other boys in the neighborhood. I asked how well, Greene knew ' , to which he stated they knew each other, but I don't remember seeing them together. I asked ' what he would think about ' ; telling us that he didn't know Greg Greene, to which he stated that as far as he knows they knew each other. I read a paragraph to ( ; from the MSP report regarding Greene & Busch's 1977, CSC arrest. The paragraph I read, pertained to the night in 1976 when Greg Greene took I to the drive-in theatre in Flint. In this paragraph, I told police that he observed Greg Greene molest '

Agent Bolinger & I spent some time today formulating questions for the FBI Agent in New York City that is going to be interviewing Chris Busch's brother, and "swabbing" him for DNA. We put together approximately 20-30 questions for Agent MacDonald to ask Busch's brother. We called and spoke to Agent MacDonald and made arrangements to conduct a conference call with him from the MSP Metro North Post on Tuesday 3-18-08 at 12:00pm, to brief MacDonald on the case and the interview and to go over the questions we have for him to ask.

3-13-08: \*\*\* (Tape-recorded interview of / Greg Greene's cellmate in prison for 3 vears before Greene died). \*\*\* Garry Gray (MSP) & I drove to Flint today and interviewed Greene's house is located at " e at his house in Flint. ex-cellmate. Flint, Michigan. We started the interview by explaining to what it is that we are investigating, that he is not in any trouble, and that we were there simply looking for his help. I explained to that we have been investigating this for a long time and that we have interviewed many people surrounding Greg Greene. I also explained to ' ; that some of the questions we are going to ask him, we already know the answers to and we do that to see if he is going to be truthful with us. I went on to say that I know that he was a cellmate of Greg Greene's before he died and that we also know that they were both from Flint & serving time in prison for the same type of offense (CSC on child u/13). I further explained that we know that they had a lot of time to talk in their cell, and that we know from our experience that cellmates in prison share a lot of information with each other. As he stated that he and Greg did not talk much, and never said we were explaining this to was not very convincing when he made that statement anything to him about killing any kids. and appeared nervous. While I was talking to " about the seriousness of what we are investigating, how long it has been and how bad the families of these victims need closure, I handed to look at. had what appeared to me to be a strange the photograph of our 4 victims to reaction to the picture, when he only looked at it momentarily, then turned the picture over, pushing it back at me, hitting my hand with it as he pushed it back. I almost said to , "I told you to look at it," but didn't say anything about his reaction to the picture at that time. said again that Greg never talked about anything like that and that they didn't talk much. We told that we did not think he was "being straight" with us and confronted him with the fact that he appeared nervous and that we did not believe him. We noticed that ! kept looking at his elderly mother who was sitting in the other room. We asked ' if he wanted to go outside to our car and talk and he agreed.

When we got out to the car, we confronted ' a further about possibly lying to us, at which time he broke down crying heavily and holding his head. We told that it was just the three of us . 3 then told us that he and Greg Greene were not only now and he did not have to worry. cellmates, but they had a sexual relationship. After explaining this, appeared to be more truthful after breaking down. We began to ask him questions again about Greg Greene and what told us that Greene told him about kids he had molested Greene said to him about our case. in the past and gotten away with it. He also told us that Greene told him that he got away with killing was visibly upset at this point. His eyes were watering and he was 4 kids in the past. , what else Greene told him about it, to which he stated that he's breathing heavy. We asked trying to remember, it was along time ago. We asked to try to remember when Greene told began telling us about how he found Greg Greene dead in their cell and him this. At this point, performed CPR on him until the guards could get up there. told us that he does not remember exactly when Greene told him about this, but remembers that they were watching TV and talking about molesting kids in the past when Greene told him about getting away with killing the kids. pass. We asked if he remembers Greene talking about another person with him during these killings? stated he didn't think so. I ran the name Christopher or Chris Busch by him? paused for a second, then, said that the name sounds familiar. We told! to start writing down everything he can remember about what Greene had told him about killing the kids, and he stated he would. We told him that we would be in touch with him about taking the polygraph and terminated the interview. \*\*\* (See transcripts from interview for details.) \*\*\*

3-14-08: Garry Gray (MSP) & I went to the Michigan State Police Long-term evidence storage facility today in Lansing, Michigan. We went there to go through the OCCK evidence, to see exactly which packages of evidence contained the hairs & fibers we will need for future comparisons during the course of this lead. We will be conducting crime scene searches of Busch & Greene's homes & cottage for trace evidence (hairs & Fibers) to collect and compare to known evidence found on the victims. We went through, approximately 10 large bags and/or boxes of evidence such as the victims clothing, victims boots/shoes, and other miscellaneous evidence. We found many slides and containers that held fibers, hairs, blood evidence, & DNA swabs. Some of the hairs and fibers, including animal hairs that were tested and compared during the original investigation, were not in this evidence at this storage facility. Documents located at the storage facility, indicate that these items that were tested, were taken from the long-term storage facility in 1995, to the Northville Lab and not returned. We will be checking with the Northville Lab, due to the fact these particular hairs & fibers will be important for our future comparisons.

3-14-08: I received an e-mail today from Deputy "Bud" Shaw from The Montmorency County Sheriffs Department, who stated that he made contact with officials from Register of Deeds at Presque Isle County Michigan and also Alpena County Michigan. Shaw stated that there is no record of property in the name of Christopher Busch or his father in either county. It's possible was at Chris Busch's house in Alma and thought it was Alpena, or Busch's house in Alpena was in another persons name or Busch stayed with someone else.

3-15-08: We are making plans to conduct crime scene searches for trace evidence at several of Busch & Greene's homes/cottage in the near future, especially in light of the information from ... We are going to have the State Police Crime Lab conduct these searches, starting with the

Busch home on n and the cottage on Ess Lake, where Busch was seen while King was missing. Recovery of any physical evidence during these searches, especially hairs & fibers, will result in immediate comparisons to our trace evidence currently at the MSP Forensics Lab in Lansing, and also at the FBI Forensics Lab in Quantico, Virginia.

3-16-08: \*\*\* (See the Greene "Time-Line," for details of his whereabouts, statements and/or actions during a span of time, beginning when Greene was 15-16 years old living on in Flint thru his death in prison in 1995. This time line also includes Christopher Busch and his association with Greg Greene during the time of the child killings from 1976-1977.) \*\*\*

3-17-08: Garry Gray (MSP) called the Michigan State Police Forensics Lab in Lansing today and spoke with a Fingerprint Specialist named Michelle Glasgow. She is in possession of the partial

Fingerprint that was recovered from Kristine Mihelich during the autopsy. We are going to have Michelle Glasgow, compare Busch & Greene's fingerprints to the partial print from Mihelich. We received an e-mail back a short time later from Michelle Glasgow. She stated that she has located the partial print from Mihelich and it looks like it was from Mihelich's parka. **3-25-08:** While we were in Flint today, we stopped by the Genesee County Sheriffs Department records section and picked-up a copy of Gregory Greene's fingerprint cards and a photo of Greene from February 1977. These fingerprint cards will be used for a comparison to a partial fingerprint lifted off of Kristine Mihelich's coat from January 1977.

3-26-08: \*\*\* (MSP Forensics Lab in Lansing today, with Busch, Greene & Lamborgine's fingerprint cards) \*\*\* Garry & I drove up to the MSP lab in Lansing today to give Fingerprint expert, Michelle Glasgow, Busch, Greene & Lamborgines fingerprint cards today to conduct a comparison on the partial latent print from Kristine Mihelich's coat. We spoke with Michelle Glasgow who showed us the partial latent fingerprint. It appeared to be a fairly clear latent print, but Glasgow explained that she may not be able to make an exact identification with our known suspect prints, but the latent is good enough for elimination purposes. Glasgow explained further that she would also be able to determine if the general pattern of our suspects prints match this latent print. She is going to conduct a thorough examination/comparison with our suspect's fingerprints and would contact us afterwards.

While we were there, and discussing the case with her and showing her some photographs, she stated that we could use their technical support unit to possibly enhance the photograph from Christopher Busch's bedroom to determine if the shotgun shell that was on the desk, is in fact a 12 gauge shell and also if it had contained "#2" shot. This was the caliber and the size of the shot used to shoot our victim, Jill Robinson in the face.

\*\*\* If the lab were able to determine that the caliber and size of the shot matched what was used on victim Robinson, this would add credence to the theory that Christopher Busch was possibly laying out clues in his room before he shot himself, as sort of a suicide note. Also found in his bedroom was the drawing of the boy (Stebbins) screaming and the ropes/ligatures laying out in the walk-in closet. Busch knew how much the police in 1977 thought of him as a suspect, and possibly thought these would be enough clues for the police to put "two & two" together. It is also possible that there

was in-fact a suicide note from Christopher Busch in the bedroom, but the brother ( who was at the house that day, picked up the note without the officer seeing it. It says in the police report from Bloomfield Twp. PD, when they responded to the call at n entered the home with the officer and also entered the bedroom where that C his brother Chris was found dead.

Michelle Glasgow called back later this afternoon and stated that she talked to her technical support unit about our photograph, and they stated if we were willing, they would ship the 2 photos to NASA to be enhanced, stating that they have "state of the art" equipment. We agreed and Garry authorized them to go ahead and ship them to NASA.

She stated that the 2-3-77 entry, was when he arrived at the jail, then the charges, then where it says Elliott-CC, was the Circuit Court Judge, indicating that Greene was released after his sentencing on 6-17-1977. She stated that it does not appear as if Greene was ever out of the jail between 2-3-77 & 6-17-77 and the card shows 141 days credit for time served, sentenced to "Life" in prison by Judge Elliott. I asked Donna if it was possible that Greene was out of the jail at any time or bonded out and it just didn't get put on the card, to which she stated it was possible, indicating that the cards were only as accurate as the people typing the entries on them, but more than likely if he was out or bonded out it would say that on the card. \*\*\* (See copy of this card from Genesee County jail in the Greg Greene file) \*\*\*
