CHRIS BUSCH

prior to the age of ten had lived in Rochester, New York, Short Hills, New Jersey and Germany (in that order). These were all family moves pertaining to their father's career at General Motors. By age ten CHRIS was living in Germany and attending the first grade. While their family was settled in Germany, both (and CHRIS attended a grade school and high school at a boarding school in Switzerland called be Rosey. After his graduation from be Rosey (completion of the twelfth grade) CHRIS stayed at be Rosey as an instructor. CHRIS then returned to the United States and attended Wayne State University in Detroit for one year. CHRIS then transferred to a Culinary Institute in Midland, Michigan from which he eventually graduated. After this, CHRIS worked as a chef at a retirement community in the Detroit area for approximately one year. After this CHRIS, with the financial assistance of his father, opened his own restaurant in Alma, Michigan called "The Scotsman". During the time period CHRIS was operating this restaurant, which advised was in CHRIS' mid to late twenties. CHRIS was arrested for molesting a boy in Birmingham, Michigan. This boy (the complainant or victim in the molestation case) had been mentored by CHRIS in the Big Brother Program, a program CHRIS had become involved in. believes that CHRIS also knew this boy's mother, and that she possibly worked as a cashier at the Fishers Meat Market in Birmingham, Michigan.

advised that after CHRIS was indicted for this molestation case (mentioned above) he moved back in with his parents in Bloomfield Hills, Michigan. This was primarily due to the fact that his attorneys and psychiatrists were nearby. It was during this time that CHRIS committed suicide.

described CHRIS overall as a "gregarious and happy guy", who physically was "big and heavy". provided the following as hobbies for CHRIS: food, skiing and riding his motorcycle. advised that CHRIS also struggled with problems associated with living overseas and returning to America, stating "it is hard to go back to your own country".

Advised that he had no recollection of CHRIS taking art classes, or of being particularly interested in drawing as a hobby. Both CHRIS and took art classes at boarding school as part of the normal curriculum.

; had no recollection of CHRIS being involved in hunting, and advised that hunting was not something their father did or introduced to his sons. had no knowledge of how or where CHRIS obtained the shotgun that was found in the bedroom where CHRIS killed himself, or of any ammunition he collected.

THE SUICIDE OF CHRIS BUSCH

advised that he was present when CHRIS' body was found after he had killed himself. stated that this was a very traumatic experience and he admittedly has blocked some of this experience from his memory.

recalled that at the time of his suicide CHRIS was living at his parents residence in Bloomfield Hills (as mentioned above). This was an "affluent" neighborhood, and the Busch house was located on:

At the time of his suicide CHRIS was staying at this house by himself as their parents had traveled to England to visit older brother David, with whom they had a "falling out".

advised that this "falling out" had to do with David being both a homosexual and "a little bit of an activist".

recalled that on the day CHRIS' body was found he had received a phone call from the maid, named , who was at the house and could not gain entrance. Christina was nervous that something was wrong and the dogs inside of the house were barking.

went to the neighbors (across the street) who phoned could not recall the name of the neighbor that went to, but described them as a Caucasian couple, with a described with his nervota

daughter, who were good friends with his parents. . then phoned the police and left work to go to the house. At the house, 'met up with the police and after entering they found CHRIS' body upstairs in the bedroom CHRIS was staying in. recalled that when they opened the door to CHPTE' bedroom he could see CHRIS' body, which was lying on the bed. , recalled a terrible smell and remembered seeing a shotgun and remnants that CHRIS had been drinking.

also recalls seeing a painting of a tiger over a chest that nau "bullet holes in it". ! does not recall seeing anything else in CHRIS' room, to include any drawings, ropes or ligatures.

did not recall there being any suicide note as well, and has

no recordection of the police ever mentioning this to him. advised that he "did not look" at the room or CHRIS' body for very long as he was very traumatized.

'further advised that any items or belongings that were in the room where CHRIS killed himself belonged to CHRIS.

seemed to recall a pending

suicide CHRIS was being treated by a local psychiatrist, whose name
could not recall. When asked if CHRIS could have been
bipoiar,

advised that he never noticed any signs of depression
or mood swings from CHRIS, and that he always seemed "easygoing".

publified this by advising that he was seven years older than
CHRIS and had his own life - with a job, wife and five year old son.
CHARLES further advised that after the molestation charge(s) surfaced
against CHRIS he and his wife kept their distance from CHRIS. CHRIS
was "shielded" by his parents and their relationship (between
and CHRIS) became more "superficial".

advised that CHRIS' attorney at the time of his suicide was Keith Stark who is likely still alive.

ASSOCIATES AND VEHICLES FOR CHRIS BUSCH

advised that in terms of friends for CHRIS he only recalled that he "hung out" with co-workers of his at his restaurant. idid not recall CHRIS being involved in any social organizations, with the exception of the Big Brother program, recalled that CHRIS did have one friend from boarding school in Switzerland. Social not recall the name of this friend, but described him as peing from Middle Eastern descent, and as residing in the state of Michigan for a period of time.

did not recall the name "Greg Greene", nor did he recall CHRIS associating someone by this name.

; advised that he vacuely recalled a maid who worked at his parent's house named ." , described "Christine" as a black female, and stated that CHRIS was likely friendly with her "given his personality".

Regarding female associates or "girlfriends" for CHRIS, advised that he only recalled CHRIS having one girlfriend from boarding school in Switzerland who he brought back to the United States. could not recall this woman's name, and advised that she returned to Europe after she and CHRIS broke up. S could recall no other women who were associates, or involved with, CHRIS.

Regarding vehicles belonging to CHRIS, advised that CHRIS drove a small Chevrolet Vega which was light brown or tan in color. also believes CHRIS likely had another vehicle since he recalled the Vega as being an old car. CHRIS also had a Triumph Bonneville motorcycle.

RESIDENCES ASSOCIATED WITH CHRIS BUSCH

advised that his parents had two houses they utilized. One was their primary residence in Bloomfield Hills, and the other was a vacation type house they owned near Ess Lake, which was located near Atlanta, Michigan.

advised that CHRIS did visit the house on Ess Lake, and was likely to visit it more when he was living in Midland, Michigan (which was closer). CHRIS used to enjoy waterskiing and fishing at Ess Lake. 3 advised that CHRIS was more likely to go to the Ess Lake house with his brother who lived in Flint, Michigan at the time.

advised that he and his wife used to visit the Ess
Lake house often.

3 stated that he and his wife "outfitted"
this house, and would "weekend there" when his parents were overseas.

advised that CHRIS had a house in Alma. Michigan which was the same town his restaurant was located. advised that he never visited this house, and only could recall visiting CHRIS' restaurant on one occasion.

Regarding a residence in Sanford, Michigan, advised that he had no recall of such a place but that it was likely that this was where CHRIS stayed while at Culinary School in Midland, Michigan.

S did recall he and his wife visiting CHRIS one time when he was living in Midland. This was the only time he recalled socializing with CHRIS during this period.

Regarding a residence in Whitehall, Michigan, advised that his brother noved from Flint to Whitehall where he opened and operated a convenience store.

PETS ASSOCIATED WITH CHRIS BUSCH

advised that his parents had a Welsh Terrier with white hair, named "Tabatha", that was at their house at the time of CHRIS' suicide.

further advised that CHRIS had a his own dog named "Sam" who was a "light tan" color. CHRIS had brought "Sam" back from an island off the coast of Spain. "Sam" was an Ibizan Hound Dog. Earlier in his life CHRIS also had a black schnauzer mix. "Sam" was also at 'parents house at the time of CHRIS' suicide. It was "Sam" and "Tabatha" that were barking that alarmed Christina the day CHRIS' body was found.

advised that after CHRIS' suicide "Sam", in addition to "Tabatha", were cared for by his parents. had no idea what happened to these dogs after their death, but advised that his parents were not the type to bury the dogs in their yard.

FEELINGS REGARDING CHRIS BUSCH'S MOLESTATION ACTIVITY

ladvised that other than when the molestation charge surfaced he had no knowledge of any lifestyle CHRIS had with young boys.

advised that he was "concerned" when CHRIS was charged with molesting a boy. stated that it "seemed like it happened" and he and his wife were scared for their own son. After these charges surfaced, and his wife had their son see a psychologist and never allowed their son to be alone with CHRIS.

advised that after CHRIS was charged his brother mentioned to him that he believed CHRIS had molested his own two sons / advised that knew this because his sons had informed him of this. advised that CHRIS never talked to him about molesting children or about him having fantasies of molesting children.

advised that he had no knowledge of CHRIS ever being molested as a child, but that you "just think of boarding school" and think that it could have happened. had no knowledge of any molestation which took place within his immediate family, or by anyone associated with he and his siblings in their earlier years (ie; family member, teacher or coach).

CHRIS BUSCH AND THE OAKLAND COUNTY CHILD KILLING CASE

advised that he is familiar with the Oakland County Child Killing case, and is aware that at one time CHRIS was viewed as a suspect. stated that Timothy King, one of the victims, was from Birmingham, Michigan and disappeared from a supermarket that was

a polygraph in regards to the Oakland County Child Killing case. When asked if CHRIS ever talked to him about this case or his position as a suspect, replied "absolutely not". Was asked if CHRIS was capable of these killings and he replied "that he did not think it was in his nature".

! advised that he graduated from the University of Michigan. is currently retired from the General Motors, Chrysler LLC. and his wife h, currently reside in the C hild. a son. resides with his wife. [Note: This residence is known as J

advised that his tather retired as the Controller of the Cadillac Division of General Motors. h is an artist, and was employed as an advertising executive during the mid 1970s when CHRIS committed suicide.

She also stated that the jail would be able to fax me a copy of their arrest/booking report. I called a "Chris" at the jail and left my name and number requesting copy's of their file # MSO-5651. Sally from records also recommended that I call the prosecutors office at (989) 832-6722 and speak with "Alice" who may have the copies of this case. I called and spoke with Alice at the prosecutor's office and she is attempting to find the file on Chris Busch and will call me back.

5-2-08: I received a call back today from the manager of the jail in Midland County, Scott Stephenson (989-832-6688). Scott stated that he does have a file including mug shots of Busch and would fax it ASAP. I did receive the faxed file from them, which contained their sex-motivated report on Busch. 

mentioned the case against Chris in Montmorency County. I mentioned that it appears that the Busch parents followed Chris around the state posting bonds for him and cleaning up his messes. This hair was collected at the autopsy by Detectives and is listed on the Michigan State Police Lab report that contains all the physical evidence collected from King during his (King) autopsy.

Three days after the autopsy, Livonia Detectives met with personnel from the MSP Crime Lab, including civilian Evidence Technician James Hauncher. Detectives were told that the hair found and recovered from Tim King's scrotum during the autopsy, is suggestive of a human facial hair, but more testing would need to be done. *** This is interesting, due to the fact that it appears that Chris Busch still had his full beard at the time of Tim King's disappearance. The location of this facial hair on King's body could also be explained, due to the fact that Busch was known to perform oral sex on his young male victims.

Greene told police vas also a pedophile and gave Greene a job coaching in ex-change for Greene bringing that 1 for him to molest. . voung boys to

The incident in which Greene was arrested and jailed for, involved a 12 year-old, w/m victim , of Fountain Valley, California. Greene took this boy out to a drive named. in, got him some alcohol and marijuana and then, after dark, told the boy that they were going to go retrieve a bicycle that Greene had stolen earlier and stashed near the baseball fields. Greene took this boy to the wooded area of the fields, near the San Diego Freeway and began to molest him. Greene performed oral sex on this boy then the boy became uncooperative. Based on admissions to the police by Greene, about anally, sexually molesting boys that is probably what Greene was attempting to do when this boy became uncooperative. Greene told the police that he struck the boy in the neck to keep him quiet and then put his hand over the boy's mouth until he was quiet. The doctors determined that the boy had actually been strangled by Greene and showed abrasions on the inside of the mouth where Greene had held his hand over the boy's mouth.

After the boy was unconscious or dead, Greene held a lit cigarette up to the boys nose in an attempt to wake him. When this didn't work, Greene pushed the lit cigarette into the skin on the boys "belly" 3 times attempting to see if the boy would wake up or was alive. Greene, then drug the boy through the woods & field to his car and dumped him face down in the back seat of his car. Greene then drove around L.A. trying to figure out what to do with this boy. Greene eventually drove near an area hospital and dumped the boy, who was still unconscious, on the grass around the corner from the hospital. Greene did not know whether the boy was alive or dead at this time. Greene then drove across the street from the hospital to a payphone and called the hospital about this boy, stating that he found the boy unconscious and he thinks he needs help. Greene did not give his name. After driving around, Greene checked to see if they found the boy and they had not, so he called again. The boy was eventually found, was alive and treated.
