

1 5-29-09: \*\*\* (Located Busch's attorney from 1977, Keith Stark) \*\*\* I performed a search  
2 through the "Google" database and located an attorney that has been practicing in Michigan since  
3 1969, named R. Keith Stark. This is most likely the attorney that was representing Chris Busch in  
4 January of 1977 when he was polygraphed by the state police examiner Cabot at the MSP Flint Post  
5 in January of 1977. Stark shows a current address of 1111 W. Long Lake Rd. Suite 202 Troy,  
6 Michigan 48098. The phone number is 248-641-9955.

8 6-2-09:

11  
12  
13  
14 6-3-09: \*\*\* (Interview of \_\_\_\_\_; at Jackson Prison today) \*\*\* SA Sean Callaghan (FBI)  
15 & Dave Robertson (MSP) went to Jackson Prison today to make contact with \_\_\_\_\_. We had not  
16 spoken with him since he arrived back here from Montana, more than a month ago. We thought it  
17 best if Sean & Dave go, because \_\_\_\_\_ hates Garry & I. The last conversation we had with  
18 \_\_\_\_\_ was in Montana when we advised him of his DNA being on Kristine Mihelich's shirt, and he  
19 stated he would talk to us, but not without an attorney.

20 Sean & Dave had a pretty good conversation with \_\_\_\_\_ stating that \_\_\_\_\_ was receptive and  
21 listened to what they had to say. Sean explained to \_\_\_\_\_ the situation that he is in, including the  
22 DNA evidence, stating that because he has been so uncooperative with Investigators, that they have  
23 not been able to clear him. Sean walked \_\_\_\_\_ through it, telling him that he \_\_\_\_\_ has  
24 maintained from the beginning that he had nothing to do with the killings and doesn't know anything  
25 about it, yet he has made investigators jump through hoops and then he admitted sabotaging the  
26 polygraph. Sean that investigators then still held true to their word and let him parole to Montana.  
\_\_\_\_\_ agreed and according to Sean, \_\_\_\_\_ is starting to see that he has created a lot of this  
himself by being uncooperative. \_\_\_\_\_ mentioned that he wants an attorney. Sean explained  
29 that he has not been charged with anything and that they cannot supply him with one. Sean also  
30 explained that he can hire an attorney and have all the attorneys he wants, but that they are  
31 probably going to advise him, that if he were not involved and do not have any knowledge of the  
32 Child Killings, to simply cooperate with investigators so they can clear him. When they concluded  
33 the interview, \_\_\_\_\_ was going to think about what was said and make some phone calls.  
34

35 6-4-09: \*\*\* / \_\_\_\_\_ \*\*\* Garry Gray spoke  
36 with MSP Lab Scientist Lori Bruski today. She stated that she talked on the phone with the FBI Lab  
37 people in Quantico and that they have begun the analysis \_\_\_\_\_.  
38 They told Bruski that the process would take a little bit of time, but that they are working on it. (This  
39 is Great news).  
40

41 6-8-09: I got an e-mail from Garry Gray (MSP) today, stating that Sue Taylor has been continuing to  
42 work on the power point presentation on this lead, and that it is coming along very nicely.  
43

44 6-9-09: I was looking through some old e-mails from a year ago that Helen Dagner had forwarded  
45 me about a guy named \_\_\_\_\_ that was Debbie Ascrofts (Kristine Mihelich's mother)  
46 boyfriend at the time of Kristine's abduction in Berkley in January of 1977. This (\_\_\_\_\_ was known  
47 to hang out in the bar at Hartfields Bowling Alley where Kristine's mother, Debbie tended bar. I  
48 know the \_\_\_\_\_ name from Birmingham when I was a kid. They were a well-to-do family that had  
49 a road and a lake named after them in the Birmingham/Bloomfield area. \_\_\_\_\_ was a suspect at  
50 the time of the killings and later cleared.

F1 This is interesting, especially knowing that Chris Busch used to frequent Hartfields, was  
about the same age as \_\_\_\_\_ and from the same general neighborhood in

1 Birmingham/Bloomfield. It is also interesting that there is information that I was  
2 possibly friends from the Birmingham/Bloomfield neighborhood with another  
3 big suspect in the Child Killings. We are about to go interview and polygraph I in  
4 Atlanta about information that he is connected to Chris Busch and his possible involvement  
5 in the killings. I will have to be interviewed now about Chris Busch and  
6 and their possible link to each other.

7 First, Debbie Jarvis will have to be interviewed about whether she remembers a friend of  
8 at Hartfields named Chris Busch or if she just remembers Busch frequenting the  
9 bar at Hartfields, and does she possibly know Hastings also?

10  
11 6-10-09: I identified

12 This Lexis-Nexis check shows to have graduated from Northern Michigan University back in  
13 1973 and practices as a Clinical Child Psychologist in Bingham Farms, Michigan at 30300 Telegraph  
14 Rd. suite 125.

15 This is where Northern Michigan University is and would match the information about  
16 attending and graduating from there in 1973.

17  
18 6-10-09: I called and spoke with a Sgt. Steede at the Sheriff's Dept. who looked up the file for me.  
19 He called me back a short time later and stated that the file on I had since been  
20 destroyed, along with the booking photo of I. I'd like to see a picture of from the  
21 70's to see if there is any resemblance to the OCK composites.

22  
23 6-10-09: \*\*\* (Spoke with Kristine Mihelich's mother this evening. She said she not only  
24 never dated I, but has never heard of him) \*\*\* I interviewed Debbie Jarvis tonight  
25 on the phone and asked her about dating I at the time of Kristine's abduction. Not only  
26 did Debbie say she wasn't dating I she said she's never heard of him. I described

27 Chris Busch to her and she stated that he did not sound familiar. She said he kind of sounds like the  
28 owners son, a completely different name. First I told her his name was Chris and she did not  
29 remember a guy like that. I then told her the heavy-set guy with the beard's name was Chris Busch  
30 and he was about 26-27 years old in 1976-77. I told her that we interviewed a guy from Berkley  
31 named I that said that Chris Busch used to hang out at "Hartfields" at that time. She did not  
32 recognize the name Chris Busch and said she didn't know the name I either. Debbie added  
33 that she worked upstairs at the bowling alley and didn't always see or know people that came to the  
34 bar on the first floor. I had a chance to talk to her about our two dad's knowing each other and she  
35 said she remembered her dad I calling my dad the night Kristine disappeared and asking  
36 my dad for help. Debbie told me that my dad came to talk to her at the bowling alley the next day. I  
37 remember the night Kristine's grandpa I called my dad for help.

38  
39 6-11-09: I talked with Garry Gray (MSP) today who said he received recordings of 7 different phone  
40 conversations I has had from prison since being back in Michigan. Garry was going to begin  
41 listening to them today. Garry told me that I sister I was on I visitor list  
42 from the Ryan Facility when I was there back in May/June 2008. This was the time we were  
43 negotiating with I to get him to take the polygraph. We were also talking with I  
44 trying to get her to tell her brother to cooperate with us and take the polygraph so we could clear  
45 him. She never indicated to any of us at that time that she was anywhere but Montana, where she  
46 lives, and never said she was right here in Michigan where we could have met with her in person.

47  
48 6-19-09: Cathy King called today, stating that she had made a call to the Oakland County  
49 Prosecutors Office on behalf of her father Barry King, who wanted to be updated on the status of our  
50 current lead. According to Cathy, her dad is getting up there in years, has health issues, and would  
like to know exactly what is happening on this lead. She said that her dad has seen the video of

1 John Walsh addressing the media about how pleased he and his wife were with the fact that the  
2 detectives in Hollywood, Florida kept them in the loop and didn't keep them guessing.

3 Garry ending up talking with Mr. King and telling him that we are very encouraged with the  
4 prospects of this lead, we now have physical evidence, and are getting very close to resolution.  
5 Garry told Mr. King that we are mainly just waiting on results from the two labs that are processing  
6 the evidence (

7  
8 **6-20-09:** I talked to a retired Flint Officer today named Gary Sanford who is a personal friend of  
9 mine. He had talked with fellow retired Flint Detective Tom Waldron about whether or not he  
10 remembered Chris Busch & Greg Greene. Waldron was the Flint Juvenile Detective that Arrested  
11 Greg Greene January 25<sup>th</sup>, 1977, when Greene told him that he knew who killed Mark Stebbins.  
12 Waldron then contacted the Task Force and they worked together arresting Chris Busch and  
13 interviewing Busch and Greene about the Child Killings. Gary Sanford told me that Waldron did in-  
14 fact remember the case and Sanford gave me Waldron's home number: (

15  
16 **6-22-09:** I talked with prosecutor Rob Moran today about ' . We were discussing the  
17 possibility of offering "Use Immunity" to ; in exchange for information about the child Killings.  
18 Moran wants to wait on the pending lab results before doing so. We also discussed bringing Wasser  
19 in on the Investigative Subpoena asap. Moran has been in contact with Fienberg so hopefully we  
20 will be able to get ' in to the pros. Office in the next couple of weeks.

21  
22 **6-22-09:** I identified ' " today. When we interviewed ; the first time at  
23 Camp Ojibway, he mentioned an associate of his named ' ; that may have known  
24 Busch & Greene back in Flint in the mid 1970's. ' identified as '  
25 currently serving life in prison in Muskegon, Michigan for murder. We may  
26 want to talk with ' The reason I identified ' is because when Busch & Greene were  
27 cleared by a polygraph in 1977, there were two newspaper articles written about this. Both articles  
28 talked about 3 Flint men being charged and a fourth being sought. We have only ever known about  
29 Busch & Greene. I want to find out who the other two men were. ' is the only named  
30 mentioned in the one state police report, but we are not sure if ' is even connected. I thought  
31 maybe ' s might be one of these 4 men, but he was too young back then. Maybe  
32 when I interview Waldron he will remember the other two names.

33  
34 **6-23-09: \*\*\* (I spoke with Flint Detective, Tom Waldron today) \*\*\*** I called and spoke with Tom  
35 Waldron today about Busch & Greene. I couldn't believe how vivid his memory was about Busch &  
36 Greene and the investigation into these two back in January of 1977. Tom was encouraged about  
37 our lead and agreed to meet with me and shed as much light as he could on these guys connection  
38 to the child killings. Waldron told me that he never knew about a drawing of the Stebbins' boy, and  
39 ropes being found in Busch's home in Birmingham and that he had committed suicide in 1978. As  
40 far as the other two adult men that were arrested with Busch & Greene, Waldron stated that they  
41 were just kind of "fringe" players that were arrested after all the interviews of victims in Flint took  
42 place. Tom said he could not say for sure that these other two adult men even knew Busch and/or  
43 Greene.

44  
45 **6-24-09:** I searched through the tip files for any tips on the name " , " and found a tip on a  
46 I remember that ' told the Flint  
47 Detectives in 1977, that Greene had a friend or relative that lived in Ferndale, and thought the  
48 in Ferndale could be Busch & Greene's connect through the ' ' in Flint. Garry Gray  
49 (MSP) pulled this tip on ' and stated that he didn't think this ' , in the tip was  
50 connected with ' in Flint. It does not appear that they are connected, but could be  
distant relatives.

1 6-24-09: I called \_\_\_\_\_ n today to interview him about \_\_\_\_\_ told  
2 me that \_\_\_\_\_ is in prison for murder, stating that he committed one murder in Flint, was  
3 acquitted, and then put a rifle to the back of his brother-in-laws head and killed him, stating that this is  
4 the murder.' \_\_\_\_\_ is now doing "Life" on. He said that \_\_\_\_\_ was very close with the  
5 boys and probably knew \_\_\_\_\_ h, but \_\_\_\_\_ couldn't say for sure. \_\_\_\_\_ also could not  
6 confirm if \_\_\_\_\_ knew Busch & Greene in Flint back in the day, but stated he probably did, because  
7 of his connection with \_\_\_\_\_ told me to call a woman named L  
8 \_\_\_\_\_ that used to live near \_\_\_\_\_ in Flint and told \_\_\_\_\_ recently that she  
9 thought that \_\_\_\_\_ had killed somebody years back.

10  
11 6-25-09: I spoke with \_\_\_\_\_ on the phone today about \_\_\_\_\_ She stated that  
12 \_\_\_\_\_ was in the same grade she was in at Cody Elementary School in Flint back in the 60's and  
13 that \_\_\_\_\_ was a mean/violent person. She told me that \_\_\_\_\_ would torture her and thrown  
14 rocks at her, stating that in the 6<sup>th</sup> grade, he threatened to kill her. She said that she is still scared to  
15 death of him and called him a sociopath. She stated that although she has no evidence that  
16 \_\_\_\_\_ ever killed anyone, she would not put it past him to have done so.

17  
18 6-25-09: I performed some searches through the Lexis-Nexis database for the \_\_\_\_\_ family in  
19 Flint and the \_\_\_\_\_ family in Ferndale, which included relatives for both. I saw no common relatives  
20 listed. It appears as if there is no connection between the two, but I have not confirmed that yet.  
21 There was something strange in the relatives listings section for \_\_\_\_\_ in Ferndale. There was  
22 a \_\_\_\_\_ listed as a relative, that lived on the next street from \_\_\_\_\_ in Ferndale. This  
23 \_\_\_\_\_ lived on \_\_\_\_\_ I called an informant of mine that knew \_\_\_\_\_  
24 back in the 70's named \_\_\_\_\_ She told me that \_\_\_\_\_ is the mother of the  
25 \_\_\_\_\_ boys that Lamborgine and Lawson had molested in the mid 1970's. The  
26 testified against Lawson & Lamborgine at their CSC trials in the spring of 2007.

27  
28 6-30-09: \*\*\* (Interview of Detective Tom Waldron Flint PD) \*\*\* I went to interview Tom Waldron  
29 today about Busch & Greene back in 1977. Garry Gray (MSP) went along and took the notes.  
30 Waldron remembered the case involving Chris Busch & Greg Greene very well and said he and  
31 others were "flattened" when \_\_\_\_\_  
32 Waldron said, "He couldn't believe it, and said he and the others all thought for sure they were the  
33 guys involved in the child killings." Waldron said that he remembers that Deputy Oakland County  
34 Prosecutor Dick Thompson came up to Flint in a snowstorm that day. Waldron added that  
35 Thompson was a "Big-wig" in Oakland County and would not have come up there if they didn't think  
36 they had the killers.

37 I asked Waldron what he thought when I told him \_\_\_\_\_  
38 \_\_\_\_\_? Waldron was shaken by this, hung his head and said, "This should have been  
39 solved 32 years ago." He stated that Busch & Greene met each other in a bar in Oakland County,  
40 which would have been early in 1976, stating further that this is when they probably discussed their  
41 common interests in children. Waldron told us that Busch and Greene were into exchanging kids  
42 and would meet at a gravel pit in Holly, Michigan (Northern Oakland County) to swap the kids. He  
43 said that Greene would bring a boy from Flint and Busch would bring one from who knows where.  
44 Waldron said that this gravel pit is in the same area in Holly that they brought \_\_\_\_\_ when they  
45 molested him, in-fact, \_\_\_\_\_ was the one that pointed out the gravel pit to Waldron. Waldron told  
46 us that \_\_\_\_\_ was a kid that Busch & Greene could really push around, stating that Greene had  
47 choked \_\_\_\_\_ to near death in the past when he wasn't cooperating.

48 Waldron started talking about when he and a couple other Detectives drove to Alma to arrest  
49 Chris Busch. Waldron talked about Busch owning and operating a restaurant in Alma that was  
50 purchased by his father (\_\_\_\_\_. He said that after they arrested Busch, they searched his  
51 house and found ropes, shotguns, marijuana, and a suitcase with child pornography. Waldron  
described the pornography as being 8-10, 8mm type homemade movies involving children having

1 sex in a tent in a wooded area. Waldron said that you could see the arm of an adult male in the  
2 movie, directing the kids on what to do sexually, because they didn't know. He stated that this  
3 suitcase also contained commercially produced child porn magazines, photos and movies. Waldron  
4 said that this property was all confiscated and brought to the Flint Police Department, as part of their  
5 case. He went on to say that he remembers at some point in February or March of 1977, the FBI  
6 came and picked up the suitcase of pornography to analyze the victims involved.

7 Greene told Waldron where he hid a pack of pictures in his backyard on [redacted] t. Greene  
8 said that he wrapped the pack of pornographic Polaroid pictures of kids in tin-foil and hid them under  
9 the snow near the downspout in the rear yard. Waldron said that he went to Greene's house on  
10 Jug through the ice and snow near the downspout and located the pack of pictures.

11 Waldron told us that as far as he can remember these pictures were never given to the OCCK task  
12 force for comparison, because Busch & Greene had been cleared [redacted] Waldron  
13 said that he thinks this pack of pictures was put on evidence at Flint PD. Waldron went on to say  
14 that if we call Gary Alford with the cold case squad at the Genesee County Prosecutors Office, he  
15 might be able to help us locate these pictures. Alford is a former Flint PD Detective.

16 I asked Waldron if he remembers who the other two Flint men were that were mentioned back in  
17 1977 in the newspaper article that talked about 4 Flint men being arrested in a sex-ring, 2 of which  
18 were Busch & Greene. Waldron, without hesitating stated, I

19 Waldron said that of the two, [redacted] was the one that was close with Busch & Greene.  
20 Waldron stated that [redacted] was picked up later, was quite a bit older and not really connected with  
21 the others, stating that [redacted] was in jail in Pennsylvania at that time. Waldron described [redacted]  
22 as being a white male that lived in Flint in the 70's and was probably born in the mid 1950's.  
23 Waldron described [redacted] as also being a white male that resided in Flint on the 1970's, drove a  
24 cab, had red hair, and would be in his 60's-70's today. Waldron stated that [redacted] went to prison  
25 on Flint PD's charges in 1977, for several years.

26  
27 **6-30-09: \*\*\* (Identified [redacted] t today) \*\*\*** I ran a criminal history search today  
28 for [redacted]

29  
30  
31 .. I ran a Lexis-Nexis search on [redacted]  
32 that showed him to currently reside at [redacted] a and to be a  
33 registered Sex-Offender at that address. I located a photo of [redacted] from the Alabama Sex-  
34 Offender Registry that showed that [redacted] victims of choice are 12 year-old white males, just like  
35 the OCCK male victims. It appears from Lexis-Nexis, that [redacted] lives in Russellville,  
36 Alabama with his older brother [redacted]. It was  
37 [redacted] brother [redacted] 20<sup>th</sup> birthday on December 20<sup>th</sup>, 1976 when [redacted] got arrested for  
38 Burglary in Flint.

39  
40 **7-6-09: \*\*\* (I got a mug-shot of [redacted] and his arrest reports today from Flint PD) \*\*\*** I went  
41 to Flint PD today and was able to get a copy of a mugshot of [redacted] from an arrest of his  
42 in Flint in 1975. [redacted] would have been 17 years old in this picture, but looks older & taller for his  
43 age. He could possibly match the composite photo from the King abduction, but I would like to see  
44 his mugshot from June of 1977 when he went to prison. Garry called Jackson prison today and  
45 ordered [redacted] 1977 mugshot.

46 I picked up copies of Flint PD's police reports from the arrests of [redacted] for the Burglary in Flint,  
47 December 20<sup>th</sup>, 1976 and the report from the child molestation arrest of [redacted] on 2-9-1977. Busch  
48 & Greene are not mentioned in either of these reports, and are not mentioned in any of the Flint  
49 paperwork that I have seen. The 1977 newspaper articles talk about 4 Flint men arrested in a ring,  
50 and Waldron said that Busch, Greene & [redacted] knew each other, but there are no reports so far  
51 that corroborate this. I need to go see Waldron again now that I have his old reports from [redacted]  
arrests in Flint in the 70's, and see if he can clear this up.



1  
2 7-9-09: Garry Gray (MSP) called and left me a message today, stating that the Georgia Bureau of  
3 Investigation (GBI) talked with J. [redacted] has agreed to meet and talk with us when  
4 we come to Atlanta at the end of July hopefully.

5  
6 7-13-09: We called and made arrangements today to go interview [redacted] in prison. They have  
7 just recently moved [redacted] from Jackson Prison to the Gus Harrison Facility in Adrian, Michigan.  
8 Garry & I listened to a recording of a phone conversation between [redacted] & his sister that took  
9 place after Sean Callaghan & Dave Robertson talked with [redacted] a month or so ago.

10 In this conversation between [redacted] and his sister, it appears that [redacted] may be ready to talk  
11 to investigators. He told his sister that he thinks he is going to be in prison forever if he does not  
12 cooperate with our investigation into Busch & Greene.

13  
14 7-14-09: I dropped off a packet of materials today for Waldron to look over and refresh his memory  
15 about his investigation into Busch & Greene back in 1977. This packet included Waldron's old  
16 police reports and some reports from 1976-78 that Waldron had never seen before. One of these  
17 reports was the suicide of Christopher Busch, including scene photos.

18  
19 7-16-09: Garry & I went to Lansing today and worked with Sue Taylor from the MSP Intelligence  
20 Unit, on the power-point presentation on our lead. We finished it up until the point where  
21

22  
23 7-17-09: Garry received an e-mail today from the Inspector at Jackson prison whom we had  
24 requested to locate a picture of [redacted] t from June of 1977, when [redacted] was sent  
25 to Jackson for Burglary. If the photo we received is in-fact the June 1977 photo (the date is hard to  
26 read) then [redacted] looks a lot like the composite of the subject seen during the King abduction.

27  
28 7-20-09: We have been making arrangements to fly to Atlanta to interview and polygraph  
29 [redacted] along with driving to Alabama to interview and possibly polygraph [redacted]. The  
30 state police were denied any out-of state travel at this time due to budget constraints, so it appears  
31 that I'll be going along with Sean Callaghan (FBI). I briefed the Chief & Deputy Chief today on the  
32 progress of this case and requested permission to travel out of state to conduct these interviews.

33  
34 7-21-09: \*\*\* [redacted] agreed today to take the polygraph) \*\*\* We went to Parr Highway  
35 Correctional today in Adrian, Michigan and talked to [redacted] Sean Callaghan (FBI) & I (Livonia  
36 PD) and Dave Robertson (MSP) went there. [redacted] talked about being molested by Busch in  
37 January of 1976 at Busch's cottage on Ess Lake (Documented in the Montmorency County reports).  
38 [redacted] said that he and several other Flint boys drove up to Busch's cottage in Busch's Vega,  
39 stating that they were pretty cramped in that car. [redacted] said that he was only molested by Busch  
40 on two occasions. The first time was the trip he just described to Ess Lake and the second time was  
41 in the summer of 1976 at Busch's house in Midland County (See Midland County reports and court  
42 records that support this statement by [redacted] said that he was in Busch's Vega many  
43 times, but was never molested in it.

44 [redacted] was told today, the 3 questions that we want to ask him on the polygraph and asked if he  
45 would take it:  
46

47  
48  
49 These are the 3 questions, and [redacted] agreed to answer these 3 questions on a polygraph.

50  
51 7-27-09: \*\*\* [redacted] : Identified and deceased as of 12-29-2000) \*\*\* I had identified  
[redacted] a week or so ago as being [redacted] with an

1 arrest out of Flint Police Department 10-19-1978 for Sexual Assault. This subject also has red hair  
2 and shows his place of birth to be Pennsylvania. This all matches how Tom Waldron described  
3 during the interview with Waldron. I performed a check on [redacted] or thru the Lexis-  
4 Nexis database and observed him to have died on 12-29-2000. It appears that he had been residing  
5 in Birmingham, Alabama at the time of his death. Birmingham is only an hour from where [redacted] is  
6 living in Russellville, Alabama.

7  
8 **7-29-09: \*\*\*** (

9 [redacted] \*\*\* Lt. Dyktra (MSP Polygraph Examiner) conducted the  
10 polygraph test on [redacted] today. Before the test, Dykstra explained to [redacted] what

11 [redacted] stated he understood all of it [redacted] then took the polygraph today without messing  
12 around and attempting to sabotage the polygraph t  
13 c. [redacted]

20  
21

27  
28  
29  
30  
31 **7-29-09:** I advised Prosecutor Rob Moran (Wayne County Prosecutors Office) today of the results  
32 of [redacted] Polygraph. He is going to meet with investigators next week about this.

33  
34 **7-30-09:** Garry & I and Sean Callaghan booked our flights today for August 10<sup>th</sup>-12<sup>th</sup>, to interview  
35 [redacted] in Atlanta and to interview [redacted] in Alabama.

36  
37 **8-1-09:** We decided to re-interview [redacted] about [redacted], along with  
38 interviewing [redacted] r), to try to put pressure on [redacted] to talk to us.  
39 Garry left a phone message with [redacted] about wanting to interview he & his brother. This must have  
40 struck a nerve with these [redacted] brothers. Garry received a call back from [redacted] who

Thank you so much for that info...but I know ( ) was involved in these cases!...Just a few weeks ago...as I went thru my notes...I found something very interesting... and have been working day and night... on follow up...it may be crazy...but I had a note in my files...that said nothing more than..a discussion ( ) and I had about my Husbands Suicide....We were talking about the day Wally killed himself & the date-Nov. 20th 1983...and ( ) said...that is strange-I knew someone who killed himself the same day 5 years earlier...I thought it important enough...to red flag it. After reading Ms. Dagners reply, there appears to be either a factual or coincidental connection between her  
suspect, ;s and Christopher Busch. If what Ms. Dagner is purporting in her response to the  
undersigned's e-mail advising the DNA was not a match, she is now connecting . to Christopher  
Busch. She stated that while she was talking to J s back in the early 1990's about her late husband,  
(Wally Dagners), death from suicide, and telling hat her husband committed suicide on November 20,  
1983, replied with a very strange answer. Dagner stated after telling of Wally's suicide date, he  
replied that was strange because he knew and individual who also committed suicide the very same day,  
however five years earlier in 1978. She stated that guy who shares Wally's death date was Chris Busch who  
used to live very close to where n Oakland County.

**ADDITIONAL INFORMATION:**

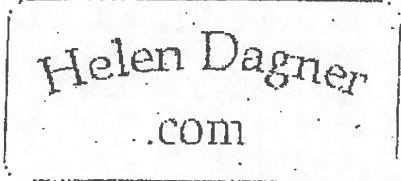

### INFORMATION:

During the course of the Oakland County Child Killer investigation and the tip regarding the two suspects involving Christopher Busch and Gregory Greene, the majority of the case reports/documentations, have been done by D/Sgt. Cory Williams of the Livonia Police department. Detective Williams has been responsible for keeping updated records and reports concerning the case as it proceeded through the investigation.

(See attached notes authored by Detective Williams).

### RE-ANALYSIS OF EVIDENCE:

Since the reactivation of the Child Killer investigation, the undersigned officer has requested the MSP crime lab re-evaluate/re-analyze the clothing of the 4 victims, Stebbins, Robinson, Mihelich and King. As a result, new evidence had been gathered and identified. (See prior reports). One item of interest is the fact that all four of the children's clothing contained some sort of "Animal Hairs".

1. Mark Stebbins had a lone white animal hair that was confiscated from his coat back in 1976, (On record)
2. Jill Robinson bore 5 animal hairs from various locations on or about her body. (On record).
3. Kristine Mihelich during the reexamination in 2007, identified additional hairs. Two human hair fragments, (since sent to the FBI crime lab), and one white animal hair taken from her green shirt. (New evidence).
4. Timothy King had white animal hairs identified and removed from his stocking red hat. (new evidence)

As a result of the above evidence, either from the original days of the investigation or that were recently retrieved during the re-examination of the property in 2007, it has been determined that all children possessed some form of animal hairs. At this time however, it is unknown of what source, or where these animal came from. Many of the hairs removed from the children were consistent in the fact that they were very light colored or white. There were also tan animal hairs.

One plausible explanation as to the possible source of some, if not all of the animal hairs, would be from animals that belonged to Christopher Busch. During the course of the child killer time period, it has been determined that the Busch family owned two dogs. One was a white Welsh Terrier and the other a tan larger dog.

On Wednesday October 15, 2008, the undersigned officer, D/Sgt. David Robertson and Detective Cory Williams of Livonia P.D., met with Assistant Prosecuting Attorney's Edward Cibor, (Chief of Warrants for Oakland County), and APA Gary Tunis.

During this meeting, a rough draft for a search warrant was presented regarding the search of the prior home of Christopher Busch located at [redacted]. The group discussed the investigation involving Christopher Busch and Gregory Greene for approximately 2 hours. The Oakland County Prosecutors office decided the investigation into these two individuals was very compelling and appeared to be a very strong case circumstantially. The presentation also included the numerous reasons why a search of Christopher Busch's home was needed to determine if the two animals that the family owned during the mid 1970's.

**CONTACT MSP CRIME LAB:**

On Monday October 27, 2008, the undersigned officer met with the MSP crime lab personnel who would be conducting said search of the above residence in Bloomfield Twp. The officer discussed the search warrant with lab personnel, Guy Nutter, (trace evidence), Cheryl Lozen, (trace evidence), Lori Bruski, (DNA Biology) and Brandon Good, (trace evidence).

**SEARCH WARRANT:**

On October 28, 2008, the undersigned received the attached search warrant for [redacted] (prior residence of Christopher Busch). The search warrant was signed in front of 48th District Court Judge, Kimberly Small in closed chambers on this date. The search warrant affidavit was sealed and only the cover warrant is to be served.

**SERVICE OF SEARCH WARRANT:**

Due to the subject matter regarding the search warrant, the Oakland County Prosecutor, David Gorcyca and the team of prosecutor's, felt it would be best of Gorcyca and the chief of police of Bloomfield Village, Kurt Bowden personally serve the warrant, as the team of investigators remain outside the residence.

On Wednesday morning, October 29, 2008, at approximately 8:30 AM, prosecutor Gorcyca and Bowden made contact with home owner [redacted]. Shortly after making contact with [redacted], the family attorney, Jonathan M. Jones responded to the home, as well as her husband, [redacted]. Lengthy discussions took place with Gorcyca and attorney Jones. Attorney Jones had Mr. Gorcyca sign several agreements. One in regards to possible damages that may be incurred during the search of the residence and who would be responsible for payments, and the other was an agreement that [redacted] were not suspected of any violations of law.

The detectives involved with the investigations into Christopher Busch and Gregory Greene, only made contact with the group just inside of the resident foyer to explain our responsibility, but "never" entered further into the home to uphold the integrity of the search.


