INFORMATION:

On THURSDAY, 02-06-92 AT 9:07 a.m., PATROLMAN JOEL JETT was working the APD DISPATCH DETAIL and advised that a female caller who would not identify herself, telephoned and requested to talk to DET. LT. SKIBA.

DET. LT. SKIBA identified the caller as _____ She advised that she wanted to talk about _____ and proceeded to relate that she, _____ and HELEN DAGNER, were in the ROUNDTABLE RESTAURANT. This was possibly on SAT. or SUN. 02-01 OR 02-92.

It seemed that DAGNER was pumping _____ for information on the OAKLAND COUNTY CHILD MURDERS. She had asked how someone would lure the children into their custody and he told her with porno books. She asked what a person would do with the children and he replied I KEPT THEM FOR FIVE DAYS. She asked what the person did with them during that time and he said A LOT OF PERVERSE THINGS. He said they or he fed them chicken before they were killed and there were no marks on their bodies. He told them that he had been questioned in regard to the murders and he had worked at the DETROIT REN CEN at the time as a stock broker. He had used the expression I DID several times during the conversation.

_____ advised that she had called the ALPENA POLICE DEPT. before on _____ being a possible suspect in the OAKLAND COUNTY SKI MASK RAPIST CASES and was referred to DET. SGT. BILL HARVEY of the OAKLAND COUNTY SHERIFF DEPT. She said that she gave the number to DAGNER and wondered if or why DAGNER didn't contact the police on the information.

She said that _____ was her boyfriend and that DAGNER was interested in him as a boyfriend. She said that she told DAGNER that she could have him and this relationship developed in reference to the OAKLAND COUNTY CRIMES.

_____ inquired if a book titled "WOLVES IN SHEEPS CLOTHING", existed and was advised, yes, it's on the bookstand or could be ordered.

_____ advised that _____ now resides at _____

DET. LT. SKIBA telephoned DET. SGT. HARVEY and advised of the information. HARVEY advised he is in touch directly with DAGNER daily and will advise if the suspect develops.
