Interview with Helen Dagner. Present is Commander Donald Studt and Chief Edward P. Ostin.

DS When last we talked, you gave us a lot of notes and we made notes and we have since talked to I have some very specific questions that came from our interview with and I'm sure the Chief has some specific questions. Did you bring your notes with you?

HD Yes.

DS I've got some other notes. Let's start with the story...one of the things that has come up and seems to be a very unnerving thing to

EPO We are very interested in right at the moment, and we have to make sure that what you tell us is absolutely accurate. Some things he's told us, you've told us, and he's told it to us in a different way. It's real important..there are lot of other things that we have to look at other than some of the things you told us. We've got to make sure they're absolutely accurate and not embellishing someone. This embellishing is to me like saying a fish is 6 or 8 inches. A lot of people do that. I do it myself to make a story sound better. I just want you to be exact. I think the last couple of times that we talked, I was more interested in what you were about. Now, I'm interested in what about.

DS Ok, let's start with the 3 vibrators in apartment. Tell me about that again.

HD I'm not sure they were vibrators. I'm saying they looked like they were vibrators. OK.

DS How was it that you were in his apartment?

HD I had gone there with because once I had known that was questioned about being the OCKK, somehow was going to get me in with you understand? We went in there on the pretext of selling items, because I can sell anything and can sell anything. So, he was going to go through the different things he had to sell.

DS These are things that was going to sell, and you were going to help him sell them to make some money, because he...

HD Well, he had different types of manuals and stuff on different things. This particular time, I believe it was on makeup.

DS So you went in there to look at some stuff somebody thought that he was going to sell?

HD Ya. We went to the office and got the makeup thing and went back to the apartment complex.

DS What did you see that you thought were vibrators?

HD Containers larger than toothbrush holders.

DS OK, and where were they?

HD I believe on a corner shelf in the bathroom.

DS Were they were plastic containers or metal containers, boxes?

HD I think they were bright. I think they were white, just like

toothbrush holders, only larger. You sectional, that opens up like this...

DS Opens up in the middle?

HD Yes. The only reason that made me think it was vibrators is my daughter had one of these portable hair curlers one time and it looked just like that. Only, it had the ribs like a vibrator would.

DS The holders had the ribs?

HD Yes.

DS So, were they as long as a curling iron? We know how big a tooth brush is, we know how big a curling iron is. How would you say that they fit in that size range.

HD They were about 8 inches.

DS And there were 3 of them?

HD I thought there were of them. The vibrators are the least thing I know about, OK?

DS For some reason, it seemed to strike a chord and we want to be real certain about that.

HD The only reason I thought about the vibrators at all is because when had told me about the one in the plastic bag, and when I was in the bathroom, and I thought hmmm, there's a vibrator.

DS The holders tho were square on the end, or were they shaped in...

HD Domed, I think. I think they were domed.

DS On each end?

HD I didn't look at the other end.

DS How many holders were there?

HD I think there were 3.

DS OK, what colors were they?

HD Cream, ivory, white.

DS Did you ask him about those?

HD No.

DS You just saw them and that was it. Did you ever say anything to him about having vibrators?

HD Yes, we discussed that the boys were sexually molested with vibrators for impact, and that was secondary.

DS What do you mean impact?

HD Because he wanted to make this a shocking thing, yet he didn't want to do a physical thing on these boy, and besides that, he couldn't. So, the vibrators were used for impact. I mean it had to be kidnapping, rape and murder.

DS What i meant, did you ever mention seeing these 3 cases that you thought were vibrators in bathroom to

HD No.

DS The only conversation you had with him about vibrators was in relation to the sexual assault on the boys in this case.

HD Yes, and I brought this up after rather than asking him about the vibrators.

DS No problem. I'm just trying to keep the chain of events as close as I can. Did you ever talk to him about the vibrator incident at

HD No.
DS You never talked to him about any vibrator that he had?
HD No. I asked him how do you think the boys were sexually molested, they weren't done physically and it had to be superficially, and he said the vibrators.
DS He did say that?
HD Yes. And that was because had said to me, I didn't know anything about this, and he said to me "Ask what kind of tool he used." He didn't say it for sexual molesting or anything else...he said what kind of tool did use? And, that's how we got into this conversation. We were playing this mind game with
DS You and he never discussed, either the 3 vibrators in his apartment or the vibrator at
HD That's right, I never discussed it with him. I knew about it, but I didn't discuss it with him.
DS And you knew about it because...
HD had told me when we thought he was the ski mask murder (or the ski mask rapist) that..
EPO I'd like to have Helen's version of what saw, because ours is different from I'd like to see if you can reflect on that.
HD had become suspicious of because would come in and out of her life. He never stayed there on a regular basis. He would leave there for like 3 months and then come. He would do things like he had this sensation in his fingers and when he touched stuff it was like he was having a sexual contact with it. This particular day he had been working on his car and then he was touching the things on the battery and it was like he was having a sexual orgy. When he went in the house to take a shower, she went up to the shower or where ever it was, and she was looking through his stuff. She doesn't know why, she just was looking through his stuff.
EPO And he was taking a shower?
HD Yes. Tied up in a plastic bag was a vibrator. Then she left the room. When she came back in, the vibrator wasn't there, so obviously had it in the shower. Then when he came down after the shower, she said to him.."What about this vibrator and it's got to go.." He told her that he had gotten this for her. That's the end of the story. He'd never tried to use it on her.
DS Did she ever say what happened to it eventually?
HD She made him throw it away. She didn't tell me she saw him throw it away. She told him he had to throw it away or get out.
DS Let's go to collection of books. You told me that you thought he had a collection of serial murder stories, or books about serial murders.
HD Yes, he had several different books, but I talked to about this, who is a book deal...that doesn't mean a collection. A collection is when you have every serial killing book that is. What just had was books of

knowledge that included serial killers.

DS What kind of books of knowledge are we talking about?

HD I don't know, something about Bundy and one that sounds just like a sports star. There's another serial killer about...that would be something I would really have look up in the notes, or you'd have to look up the memos, because it was nothing that in fact. He told me..

DS You never saw this series or these books of knowledge, or did you?

HD I saw all of his books. They were in book shelves at prior to his moving them, and I did see different books, but not a lot. He could have had every books there was there on the subject, but I didn't see all of them. But I did see books.

DS He's got a lot of books?

HD Ya.

DS We saw a lot of books too. How about the maps that he drew you. We spent a lot of time talking about those maps, and they're very precisely drawn. He says that...

EPO Well, let's ask Helen what she said.

HD How would you like to ask them?

DS How did they come to be drawn?

HD We would go for coffee in the evening and I told him I was interested in...I didn't know how to approach him on this..I had already sensed that he was the Oakland County child killer. I didn't know how to get across to him where he would talk with me, so I told him I was writing a book, which was believable, because I'm a writer. Then, I told him I had some little knowledge of it and it would take so long for materials and stuff to come. Then, the first person he talked about was who I didn't even know existed. Then we got to

the girl with the bicycle and that was the first map he drew. He drew this map and put the bicycle behind the store. I don't know if you noticed that or not.

EPO Is it in there?

HD And then he drew me a newsstand where Timmy always went.

EPO That must have been in the first group, because I never..

HD Right. Then he just kept drawing and drawing. I don't know this area at all, and I told him he was a genius...man you can really draw these maps. So he always just drew these maps.

DS Let's go particularly to the last 2 maps that were drawn on the Big Boy place mat. These are the big ones.

EPO We don't know if the other ones were..We don't have the back sides.. We only have copies of..

HD Alright, they were all on Big Boy's. He never drew any that weren't. The very last one he drew me, he did that while he was talking to me. He drew this and if you don't know these places, you have a hard time understanding it. So, then I would ask him a question because I wanted to make sure that I was getting things right, and he said, "I'm going to draw you an enlargement." So, then he drew this. But he did these while he was talking to me.

DS Did you have the book with you when you were going through this?

HD No.

DS Did you ask him, for instance, where was Bruce Lane where Chris was found? And then he put that in there?

HD No, I think that it was this way. He drew Bruce Lane and I couldn't remember who was found there. If you would ask me right now (took all this stuff away) and asked me where these kids were dropped and picked up and everything, I couldn't tell you, because I didn't read the book that good. But if you're asking me did draw these 2 maps after he had access to the book, yes, because he had the book for 4 days. The other maps, which are better than these even, he drew without even having knowledge there was a book. But was the book there...? No. The book wasn't there.

DS So, you weren't going through saying "where is..?"

HD I can tell you this conversation. I said to him that I had to find something that connects all of these, and his quote was "the only connection you're going to find is this man was of the kind that did this." So we were talking of this one of kind man. Then, he mentioned about the physic. He was always interested in the psychic report, because everything in the psychic report ties to . So, then he started at the water towers. Then he started at the police stations. The interesting thing I found is because I had read about already, OK in the book, and no one knew that police station was there. This was probably what perked me up. Then he just started on about..but he was actually talking to me about unrelated items when he drew these maps.

EPO In the book, correct me if I'm wrong, the Franklin Police Chief, whose name escapes me, only had about a mile to come from the police station, where there was only a mile for Robertson to go back to the police station.

HD I don't know, but no human being could remember that. There's only 10 people in the world that have memories that don't quit, and the police station happened to be library at that time. How would know that to locate that police station there.

DS What do you mean the police station was in the library?

HD There was a room they were using in the library.

DS It said that in the book?

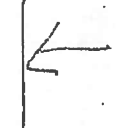
HD Yes, I saw it.
