EPO From what he knew about it, couldn't he remember, not necessarily that he did it.

HD I think there were others and can't remember.

DS He killed other people and can't remember?

HD Yes, I do. has told me a hundred times "You continually make me think about things I no longer want to think about." Let me just read this to you...I had verbatim on it, but crossed it off because I wasn't sure..OK. This is the night that he got so upset with me. He came to have coffee. I had given him a card that said something about (probably the first card he got from a woman)..loving to talk to him, or something, I don't even remember what it said. He got this got this card and he wanted to talk about him and I. There is no him and I.

DS In your mind?

HD That's right. There is definitely a relationship here. I could take a lie detector's test and you can say to me "Do you love ' and I could answer yes and I would pass that. But it is not a sexual type of...He wants to talk about him and I and I want to talk about the book. Let's talk about the book I'm going to write. This is in an aggravated state he says to me "You've asked me all the questions you're going to. Any more and you're harassing me. That was 15 years ago, I told you everything I can remember. I'm not living my life like this. If the authorities want to come and ask me questions, let them. You have no interest in me. It's only the Oakland County child killer. I'm telling you, Helen, life goes on. It went on back in Birmingham. You are not going to invade my privacy. I'm not going to have anyone putting my name through computers. I'm not going to have people looking at me. I just can't remember anymore. Do you understand that? You are just not going to do this to me. Are you in love with? Do you want to marry me? Are you afraid of me? Who the hell are you? Why do you ask so many questions? I'm not going to be this person, do you understand me? You know I'm not stupid. Where is this all going to go? Do you even know what you're asking me to do? If you talk to me one more time about this, I'll get a court order. You're not going to do this to me Helen. Not you, not anyone. I can't tell you about every day in my life. Then, I just don't remember anymore. I don't want to remember it, do you understand? I just don't want to remember. Why do you make me think about these things. You're not interested in me, you're just interested in the killer. I'm not that person anymore, and I'm not going to be." Did you get that, Don? "I'm not that person anymore, and I'm not going to be."

There's no point in even giving you this because I don't even

know what the hell it all says.

DS Before you went to the lady's room he said those things to you? Let me get your impression right about You think  
 is not only responsible for the OCCK cases that were written about in the book, you think there are other killings he is responsible for that he doesn't even remember?

HD You think I don't think he's responsible for the OCCK?

DS No, you do think he is responsible, and others.

HD I do believe there are others.

DS But, he's not discussed those in details yet?

HD No. He even sat in his seat one time when we were talking about it, and I said "I wonder if there's others?" And he goes "others?" and squints his eyes like this, and I say back to earth, back to earth." I know that himself from day one, if you've seen the other map, is responsible for 6 because why would he put 6 on there. Why would he draw these sites where all the bodies were for 6 people if there weren't 6 people?

DS Because he had your interest.

EPO sent you a printout.

DS There's a printout about somebody...

EPO Was there something you wouldn't show that came out on the computer?

HD He thinks there was something. It was nothing. It's a sheet and it has on it something about a fire chief molesting his son and losing his job. I didn't want to see this because I wanted to think I had something he didn't know about. I still have that.

EPO You know what I'm talking about? Have you asked the question?

DS Yes.

EPO We answered how the map was made, we answered about the vibrators. Now, if I understand this right, you're not really sure of the vibrators. This is important.

HD That's right.

EPO That's one of the reasons we wanted you to make the trip down here. Tell us about the patches on the pants. Is it the best you remember the patches on the pants...that conversation, and what type of pants, color, type, underpants, over pants, and who was wearing them?

HD I believe it was Chrissy. It's in my notes.

EPO Christine Mihelich?

HD Ok, she had a bright patch that was not triangle, but similar to a triangle shape on it. It was attached to the pants.

EPO Where did you get that idea?

HD From

EPO Did you describe how large they were?

HD No. We were talking about I needed individual things. Like Mark had no shoes. I needed individual things. The color in the underpants comes in..one girl had white underpants and one girl had a real flowery print underpants. Which girl, I don't know. You have to read my notes.

EPO Please don't be defensive again, because I'm trying...

HD I'm not being defensive, I simply don't know.  
EPO I had the idea they were triangles. Did you say to \_\_\_\_\_ "What was the style of clothing in that era?" And \_\_\_\_\_ said "The girls and kids use to sew different patches on them."  
HD Ya.  
EPO You're sure?  
HD Ya, I'm sure.  
EPO And you're sure they were on the outer pants of Christine Mihelich?  
HD Yes. I don't know why you're saying...  
EPO You've just been shown a picture of a pair of pants on a deceased person. Do they resemble what \_\_\_\_\_ told you about?  
HD I forgot to look to see if they were bell bottoms, ok. The patch, he said, was a triangular type patch and one of them there does look triangular..numbers weren't discussed.  
EPO But the color was orange?  
HD Orange.  
EPO That's what I thought it was. You thought it was too, right?  
DS Yes.  
EPO Who saw the nudist camp book?  
HD I have the book. I took it.  
EPO We spent hours looking for that book. Why didn't you tell us that.  
DS Where is it? Is it here?  
HD No, not in my car. \_\_\_\_\_ impressed on me search and seizure, and I was going to look it up in the book and see what that meant.  
EPO Did \_\_\_\_\_ tell you to keep the book?  
HD No. In fact, \_\_\_\_\_ doesn't know I have it.  
EPO Good. We know you have it.  
DS Will you sent it to us?  
HD Yes.  
DS Describe it.  
HD5 It's some kind of an almanac for all the nudist camps in the world.  
EPO What's in it?  
HD Pictures of nude people and the pictures that have children are folded.  
EPO Who folded them?  
HD How in the hell do I know.  
DS Did you fold them?  
HD No.  
DS You keep surprising me with things that keep falling out of anywhere. You didn't fold...  
EPO You don't know how long we took looking for this book.  
DS You told us about the book, we looked for the book, spent an hour talking to about the book.  
HD The search and seizure thing scared me, because that...  
EPO You're not acting as our agent and not acting as agent, is that correct. You voluntarily...  
HD I saw the book and just took it.  
DS You stole the book?

HD Ya.  
DS This is a good time, and we'll do it again on tape. I've done it 4 or 5 times, I don't want you to talk to I don't want you to go to apartment and take anything. I don't want you to take anything from I'm telling you again, don't fool around with taking stuff from

EPO You understand?  
HD Yes, I understand.  
EPO Have we said this to you from the very beginning?  
HD Yes, that's why I didn't tell you about the book.  
EPO I had the idea that from our first conversation it was some kind of a magazine.  
HD It's a big book.  
EPO Would you say that most of it is verbiage and a few pictures, or...  
HD Lots of pictures.  
EPO How many pages do you estimate it would be?  
HD I don't know. Approximately 3/4 of an inch thick.  
EPO A couple of hundred pages?  
HD At least.  
EPO And how many of those pages would be devoted to pictures of nude groups.  
HD Every picture that is in there is nude.  
EPO The ones that were dog-eared...is that the word you used?  
HD No were folded.  
EPO Did they just show children or children and families.  
HD I have no idea. I'm thinking of one that's an oriental children.  
EPO What gender?  
HD Female. I really don't know.  
EPO So the pictures you're not sure of either?  
HD I didn't spend a lot of time in this book.  
EPO You had seen the book before that according to what you told us. Tell us what happened the first time you saw it.  
HD Nothing happened.  
EPO You described this book to before, I think.  
HD I just took the book. I don't even know when I took the book.  
EPO Do you know if is a Born Again Christian?  
HD No, he's not. His sister would like him to be.  
DS He says he is.  
HD But he's not. He's saying that just because he knows his sister and brother is.  
DS He says about a year ago he became...  
HD That's not true.  
DS Does he go to any Christian meetings that you know of up in Alpena?  
HD No, in fact he just started reading different passages in religious related books in the time that he was thinking about moving into and he's putting some of these entries into a book he's writing.  
DS In his economics book?  
HD Yes.

EPO Have you ever seen an economics book?  
HD Ya.  
DS Did it make any sense?  
HD It made a lot of sense to me when he first explained it to me, but now, I realize that none of it is actually work. It's been taken from other publications.  
EPO Did you actually get to look at it, or from just what he told you?  
HD No, I saw the pages.  
EPO Did he let you look at them?  
HD Ya, I held one and read it.  
EPO When he was around?  
HD Yes. I think that was...  
EPO Was he upset about that, or say go ahead and read it?  
HD He brought it to me.  
EPO Just the one page?  
HD Yes.  
DS Is it some kind of Christian house he's living in?  
HD Yes, a start of a Christian.  
DS He gave us that impression. owns the house and lives there?  
HD Yes, it's like a host home. is losing that house unless they're a month in arrear because it's been through all the grand finales of foreclosure. Within a month and a half..  
DS A nice house?  
HD Yes, and : is a nice person.  
DS Was it : family's house?  
HD wife and his.  
DS Where's his wife?  
HD She's gotten a divorce.  
DS And he can't hold onto the house? He can't make the payments?  
HD No, when he could make the payments, he choice to make his child support rather than make a payment.  
DS said that one of the reasons he got into this...thing we were talking about dislike of homosexuals. He told us about a born again minister who cured homosexuality. It didn't make a connection in my mind until later on. Do you think has a problem about that homosexuality thing?  
HD I think the problem has, and I noticed someplace in my notes today, that when he was 16 years old, he was walking down the street and two brothers picked him up and gave him a ride in the car. I don't remember why I had that down, but I think homosexuality went on at Brother Rice.  
DS Do you think participated?  
HD I don't know if I think participated or if I think didn't. That's why him and this other guy were punished all the time.  
DS So you're tying that all together to that punishment deal that he did or didn't and that's why they got punished? Did he tell you anything to connect that up?  
HD No, he just told me that there had been something that had happened a that school, but I do know that he told me that he

begged his mother from the 10th grade on to get him out of there. I know that's true, because when I talked to his mother on the phone, she had knowledge that I knew that. She told me "He begged me to please take me out of that school" from the 10th grade on.

DS What I'm trying to do, and it's very difficult..

HD not a homosexual..

DS You're sure of that?

HD The reason I'm sure of that is when he told me about using the vibrators on boys because of the homosexual thing. is just the kind of guy that's non-physical, he can't f---and get it up, that's as plain as it is. That doesn't mean that he's homosexual.

DS One of the things that's starting to happen now and always happens when we get into this so much is that we all have our own theories, and I've got half a dozen, you've got some, he's got some, everybody's got theories about this. What we have got to try and do is focus in on exactly what said and I started to get off track on that. He never told you he was Born Again?

HD No, in fact, I know that he's mimicked the fact that his sister and brother...you know they're Born Again Christians.

DS He told us he was. Why do you think he would tell us he was and he told you he wasn't?

HD When you told me that before, something crossed my mind and I can't get it back in there, but...something about Born Again Christians. I know that he also is not a Catholic, even though he was raised that way, but he has said that he's never told me believed in God, but he's told me that this killing is against the law of God.

DS He told you that?

HD  
EPO Ok. Why would he tell us, I'm going to change the subject for a minute, but what I want to do is focus on what he told us and what he told you. Why would he tell us that when he drew those maps (that I showed you earlier) you were sitting across the table from him with that book "Wolf in Sheeps Clothing" and you were saying such and such a location, and he would put it on the map, and then you would say such and such a location and he'd put that on the map, particularly the Jill Robinson body. There's two arrows from her name to either side of the road. He said you said it was on I-75 near the Troy Police Station and he asked you if it was northbound or southbound. You said you didn't know.

HD There is some accuracy there. The book was laying there, not opened. The book always went with me with my file...to irritate to see what attention we would draw to it. When he drew that first arrow where Jill Robinson's body was it was just like he had was drawing this and he said to me, "By the way, did they say whether it was blah, blah, blah or was it blah, blah, blah?" I said I didn't know and he already had it drawn. Before I even opened that book, he immediately

made another mark. So, I know that one of the marks was where she was. I know that.

DS It was either northbound or southbound.

HD One of the marks when he realized that he had made the mark in the proper place, he put another mark on there in an instant.

DS Couldn't it have been that he didn't know if he was right?

HD I don't think so, because he said to me "Helen, it was all grassy there." And I said to him "All grassy in the wintertime?" And he said "Well, was that in the book?" I said "Gosh, I don't remember reading that in the book." So was it grassy?

DS I don't know.

HD Ok, but that grassiness he wished he had never said that. He would have given anything to take those words back.

DS Why?

HD I don't know.

DS I'm not sure that it was grassy at all.

EPO No, it wasn't.

HD I'm telling you that he said it was grassy and that he wished he had never said it. That's when he told me about Jill.

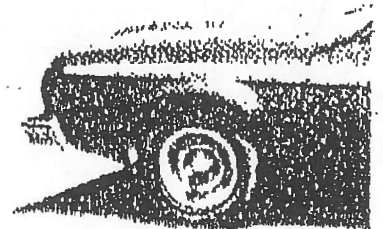

DS Did you make any advances toward at that time that she  
could misconstrue as...  
No, no sexual advances.

DS Maybe even an affectionate thing trying to get next to her or  
anything like that?  
No.

EPO Why would anyone say that you were doing that?  
I don't know.

EPO Why would say that you put her hand across her legs

underneath the covers to get at the other girl? Were you naked?  
No.  
EPO What were you wearing?  
....I was in my underwear but I came out in my bathrobe...  
EPO What were you doing that made them think...  
I wasn't doing anything. I remember walking out there to see if she was asleep. I didn't put my hand across her or anybody.

DS How were you trying to trick her? Did you touch her at all?  
I think so.

DS Is that when she got mad at you?  
Ya.

DS She was still half asleep and you kind of...  
Ya, I touched her to see if she was...

DS Wake up?  
Ya, she did and she got mad.

EPO Did you like to masturbate when you saw breast feeding  
the baby?  
No. She turned me on, but no.

DS turns you on, but the act of breast feeding the baby  
does not.  
No. I was always curious about that when she had to go and do  
it, I would leave the room.

EPO If you were curious, you would...  
Courteous!

EPO Courteous, I'm sorry.  
Sometime she'd be breast feeding the baby and she would just  
come out and be breast feeding the baby there, but she'd  
always cover up. If I was sitting right there in front of  
her, I would turn the other way so we could talk. I don't  
understand that at all.

EPO Did you go behind the curtain one time and jack off?  
No, go behind the curtain and jack off?

EPO Like, were you out on the porch. Do you remember being out on  
the porch sleeping?  
Ya.

EPO Did you jack off there?  
No.

EPO Why would she think you did?  
I might have given her reason to believe that.

EPO Evidently she thinks you did.

DS You and her talked about this didn't you?  
Ya. Not recently though.

DS You did talk about it, because this comes to mind right away  
for you too.  
She might have seen me expose myself out there when she was  
there alone. But I didn't jack off.

DS What did you do out on the porch when she was in their behind  
the curtain that led her to believe that you were out there  
jacking off.  
She might have seen my dick.

DS Well, if she did how did that happen? What was going on.  
When she saw my dick then she had to look out and look for it.

DS Is that one of those game things where you're trying to get  
her attention?  
Ya, there was a little hormone activity since she was there  
alone.



DS When you did that, was she offended?  
Well, she got mad.

DS She gets mad because she wasn't in the mood for sex or because she thought that was an offensive thing to do?  
I don't know.

DS What do you guess? You know much better than I do. It might have an offense thing to do, at that time, but she changes all the time. In one instance it's great, in another instance it's the most evil thing that anybody could do. It's relative.

DS She bounces back and forth? In January when you moved up here to Ossineke when you moved down the street from she would not let you see alone?  
It's always been that way.

DS Since January you have not seen because of the conflict with you and ' Just recently you went over there?  
Just recently I went over there.

DS What was reason not to let you touch Sunday when I went over there...I don't know. She said, "Oh no, you're not."

DS And what did you do?  
When she walked back into the house...(end of tape, side 1)

DS You said, OK, and she walked...  
She was walking back into the house and shut the door and locked it. Then I said ok. When I did first move up here, her and Helen would come over to my place.

DS When you first moved to street?  
Right, they'd come and visit and I go over and visit and one day they wanted to see something in my office and they went in there. Somebody was stuffing her coat with stuff out of my office while I was talked to Helen over in another corner. I couldn't understand what she was doing.

DS Who was that somebody that was stuffing stuff into their coat?  
I didn't know what she was doing and the last time when Helen came in a sat down in the living room, and was walking around my apartment snooping around everything. I went in there and asked what she was doing. She grabbed my hairbrush and says well, If I can't use your hairbrush, I'm leaving. I said get the hell out. I attempted to let her know that there's laws around here, just as in her house. When I go over to her house...her direction. Since that time, I haven't gone over there. It was probably the first week or two of January.

DS Do you think that prior to January you had a good relationship with  
Ya.

DS Do you think she misses seeing you?
