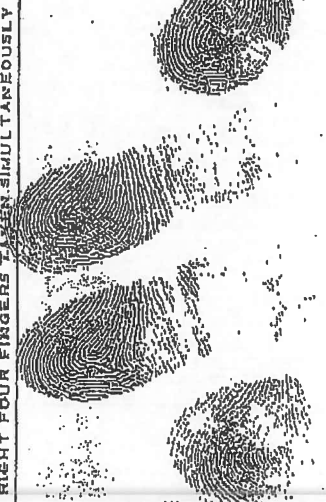
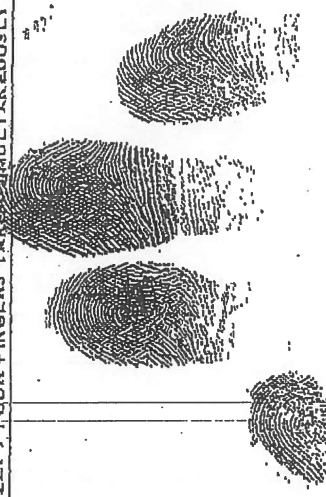

Genesee County: One Charge Criminal Sexual Conduct 3rd Degree, Warrant issued and arrested in Alma Michigan, Bound over to Circuit Court. Bond Set at \$1,000.00 and posted.

Oakland County: Two Charges Criminal Sexual Conduct 3rd Degree, Both Warrants issued, Preliminary Hearing set for March 10, 1977. Bond set at \$6,000.00 each, which was posted.

Montgomery County: One Charge Criminal Sexual Conduct, 1st Degree, Bond Set at \$10,000.00 and Posted. Arrested in Birmingham Mich, and transported to Alanta, Mich on March 3, 1977. No date set as yet for Preliminary Hearing.

Midland County: One Charge Criminal Sexual Conduct 3rd. Degree. Surrendered to Warrant issued on March 4, 1977. Bond Set at \$10,000.00 and Posted. No date set as yet for Preliminary Hearing.

At present, Christopher Busch is free on Bond on all charges, and it appears he is willing to enter into inter County plea-bargaining, if the 1st Degree charge is dropped. He has made full statements and confessions regarding these pending charges, but also has hired one of the best legal counsils to defend him in both Genesee and Oakland County.

It now appears the best cases are the Oakland and Midland charges, where the probable sentences would be the most severe, due to the fact he utilized the Big Brothers to gain involvement with the young boys, with whom he developed a sexual relationship.

When she called her husband would not let her give a name because he did not want to get involved, he was afraid of what the kids in the area would do if they found out that he was involved. His wife stated that she thought that Chris and two boys, one 16 yr & one 18 yr came into store and bought 1 1/2 case of Bush Beer and 5 candy bars. She stated that subj who looked like Busch did not speak, also the two boys were back in store on Sunday alone, they were driving a black type vehicle and she saw the words on the side of Ramcharger or Ranchero. The first time they came in store was on 3-19-77 at 3:00PM, that is when she called.

I checked with [redacted] in ESS Lake and he thought that he saw Busch in the TGA store in Hillman on 3-19-77 at 2:30PM, he stated that he had three young boys with him 13yr 14yr 15yr. He was not sure if it was Busch or not. I showed the Photo at Morrison Store and no one could identify them. I checked the Hillman Area and no one could say that they saw them on the week end.

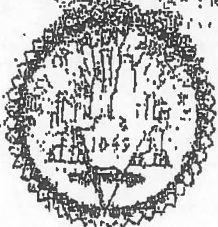
