

1 Deputy Shaw had located his reports and file on Busch from back in 1977 and that Shaw told me
2 that you had an old Detroit News and/or Free Press newspaper clipping about the disappearance of
3 Timothy King in the Busch file. Brandenburg started out saying that he remembers the case and
4 remembers Busch being a very odd guy, stating that he always felt that Busch might have been
5 involved in the King case, that's why he had the news clippings. Brandenburg said that the dad
6 was rich, owned a home in Birmingham, the cottage on Ess Lake and bought Christopher
7 Busch a big two-story restaurant. I asked if it was the restaurant in Alma, to which he stated he
8 believed it was. Brandenburg said that Christopher Busch always had young boys with him and
9 remembers that the boys were from his (Busch's) area, down state. I asked Brandenburg if he
10 remembers the cottage and he stated that it was a "flat roofed" kind of cottage, that may have been
11 painted in the past, but not much has been done to it over the years. Brandenburg stated that he
12 lives not too far from there and that he was there when they searched it. I asked him if they found
13 any photographs or anything that would indicate someone may have been held there against their
14 will, to which he stated no. Brandenburg then stated that Busch committed suicide not long after
15 their case, but he didn't know how he did it. I told him that Busch shot himself in the head.
16 Brandenburg again stated that he always had a gut feeling that Busch was involved in the child
17 killing case. He said he would contact me if he remembered anything else about the case that might
18 help.

19 **2-12-08:** Deputy "Bud" Shaw called me today and stated that he went over to the old "Busch
20 cottage" on Ess Lake and took pictures of it that he will e-mail to me. Shaw stated that he walked
21 around the cottage and it appears from the foundation and looks of the structure, that it has not
22 changed much if any, over the past 30 years, other than maybe paint, a garage and new deck. I
23 received the e-mailed photos of Busch's cottage from deputy Shaw this afternoon. It appears to be
24 a 60's style structure with a flat type roof on it.

25 **2-12-08: *** (Livonia Polygraph Examiner, Tim Larion, reviewed the Busch & Green**
26 **polygraph charts from 1977 today, and gave his opinion) ***** Today, I showed Tim Larion
27 (Livonia Polygraph Examiner) the MSP polygraph charts from examiner Cabot, on the polygraph's of
28 Busch & Green from 1977, in regards to the Stebbins/Mihalich abduction/murder. After
29 approximately 30-45 of reviewing these charts,

36 **2-13-08: ***(Video/audio-taped interview of _____ @ MSP Metro North Post)*****
37 Today we interviewed _____ about his information in regards to Busch & Green's
38 possible involvement and his possible involvement in the child killings. We also wanted to clear up
39 how _____ was connecting Ted Lamborgine to Busch & Green. We felt that this was too much of
40 a coincidence to be true. I also felt after talking to _____ last time that he was holding back
41 information, because he himself was possibly involved in the killings, even possibly as an unwitting
42 at the time. _____ was adamant that the boy that Busch made him have sex with was the King
43 boy.

44 We made arrangements to have Rob Moran present at the beginning of this interview to clear up
45 any concerns _____ may have had in regards to his culpability in this case and his ability to speak
46 freely without the possibility of being charged. _____ indicated during the first interview, that he
47 had been used by Busch & Green, as a "Lure" to get kids to the car for them and that they drove all
48 over Genesee, Oakland & Wayne Counties looking for kids. We felt that _____ may possibly be
49 the witness we were looking for that could put the pieces of the puzzle together and put the King boy
50 with Busch, Green & Possibly Lamborgine while missing and prior to them killing him (King).

1 Moran talked to [redacted] for a short time and then we read [redacted] his rights [redacted] was
2 asked if he understood all of his right, to which he stated he did. [redacted] then agreed to waive his
3 rights and talked with investigators. We then had [redacted] start from the beginning on how he met
4 Busch, Green & Lamborgine. A lot of the beginning of this interview was the same information that
5 he told me during the first interview and was corroborated thru Flint & MSP police reports from 1976
6 & 77. When [redacted] was talking about how he met Lamborgine and his relationship with
7 Lamborgine, we noticed some discrepancies in his story from the first interview. We began
8 questioning [redacted] about his Knowledge of Lamborgine, his connection to Busch & Green and
9 how he [redacted]) knows that Ted Lamborgine was involved in the child killings with Busch & Green.
10 I also had [redacted] describe the boy that [redacted] said Busch made him have sex with in 1977, that
11 he [redacted] believes was the King boy. [redacted] physical description and what the boy was
12 wearing, did not match Timothy King. After a time of questioning [redacted] about his information,
13 Detectives determined that [redacted] was trying to make the pieces of the puzzle fit to connect
14 Lamborgine with Busch & Green. [redacted] believes that the man that Busch & Green stopped to
15 see back then was Ted Lamborgine, because he [redacted] remembered Lamborgine from when he
16 picked him up hitchhiking in Ohio in 1976/77 and molested him at a restaurant. [redacted] said when
17 he saw Ted on the news last year, he knew it was the same guy. [redacted] made some comment at
18 this point, about Lamborgine being a pedophile and needing to go to prison for life, indicating he was
19 possibly trying to make Lamborgine fit into this puzzle. [redacted] cannot say for sure that Ted
20 Lamborgine is connected with Busch & Green, but believes he is. [redacted] cannot say for sure that
21 the boy he had sex with that Busch brought down from up north was the King boy, but he [redacted]
22 believes it was, stating again that when the Flint police showed him the pictures of the two dead
23 boys lying naked, he knew that the one (identified by [redacted] as King) was the same boy that
24 Busch had. [redacted] also insisted during this interview that he was never up at Busch's cottage in
25 Hillman, Michigan.

26 We determined during this interview that it appears, that [redacted] was possibly not, for lack of a
27 better term, the "Home-run hitter" we were looking for in this case, that could put the pieces of the
28 puzzle together. [redacted] is going to have to be polygraphed now, due to the two different stories
29 and the possibility that he may have knowledge or have been involved. [redacted] may have just
30 gotten "cold feet" after possibly attempting to confess during the first interview and got scared while
31 waiting for the second interview. It is also possible that [redacted] learned what he had been involved
32 in after the fact. I asked [redacted] out of the boys that Busch & Green were running with back then,
33 who, were they closest to and had the biggest propensity to be involved in something bad with
34 Busch & Green, to which [redacted] stated [redacted] said that he saw [redacted] in
35 Jackson prison in the mid 1990's. We then asked [redacted] for his consent to a Buccal Swab for
36 DNA, to which he gave us, but appeared very nervous about it, asking a lot questions and when the
37 results would be back. The interview was terminated at this point. *** (See the video or
38 transcripts from this interview for details) ***

39 2-14-08: *** (I identified another one of Busch, Green & [redacted] associates today named
40 [redacted] *** I performed a check thru the Michigan L.E.I.N. system for a criminal history
41 on the name [redacted]

48 [redacted] is the guy that [redacted] stated
49 was the closet to Busch & Green back in Flint in the 70's and the most likely to have been involved
50 in something bad with them.

1 **2-15-08:** I received a phone message today from Garry Gray (MSP) who stated that he finally got a
2 call-back from Lourn Doan, the retired Southfield Detective that was "looking hard" at Busch &
3 Green as OCK suspect back in the 70's. Doan had been on vacation in the Bahama's for the last
4 couple of weeks, but told Garry that he would be more than happy to come in and talk to us about
5 this lead.

6 **2-19-08:** I talked to John Ouelett (FBI) today about trying to get a copy of the report or file from
7 Bloomfield Twp. PD, on the suicide of Christopher Busch. John said that he knows the Chief of
8 Police at that agency and would call him today to request this file or a copy of it. I told John if they
9 locate it to let me know and I would drive over to Bloomfield Twp. and pick-up the file today.

10 **2-19-08: *** (Identified several of Busch & Green's other associates today, including: _____**
11 **_____ r) ***** I performed a check thru the Secretary of State today

14 !. A check thru Lexis-Nexis showed this subject to have several
15 addresses in the past around the Flint/Genesee County area. I obtained 3 photos of Plumley thru the
16 Secretary of State imaging system. A check thru the Michigan LEIN system

17 I performed a check thru the Lexis-Nexis system for _____ and located a
18 living in Newaygo, Michigan. The results of this check, also showed this to be the
19 related to Chistopher Busch. A check thru the Secretary of State, _____

31 **2-19-08:** Garry Gray e-mailed me today about some of our upcoming plans for this case. We are
32 going to meet with Bob Dykstra (MSP Polygraph Examiner) at 09:30 tomorrow to get his opinion on
33 Busch & Green's polygraphs from January 1977 in regards to the Stebbins case. We are going to
34 also show these charts to the FBI examiner in the area for his independent opinion. We have
35 arrangements to interview Lourn Doan on Thursday this week after Lawson's sentencing.

36 **2-20-08: *** (MSP Polygraph Examiner, Lt. Dykstra reviewed Busch & Greene's charts today)**

37 *** Today, Garry, Dave & I took Busch & Green's polygraph charts from January 1977, over to the
38 Michigan State Police post in Northville, to get Lt. Dykstra's (polygraph examiner) opinion on the
39 charts. We didn't tell Dykstra anything about the case, or anyone's opinions or findings ahead of
40 time, just simply asked him to review the charts and give us his opinion. We left the room, and after
41 approximately 30 minutes or so, Dykstra called us back into his office. Not knowing what the original
42 polygraphers opinion was, Dykstra pointed at the chart for Green and _____

1 Lt. Dykstra's opinion on the polygraph charts of Busch & Green from 1977, in regards to their
2 involvement in the child killings, almost "mirrors" the opinion of polygraph examiner Larion. These
3 examiners gave their opinions of the charts, independent from each other and without knowing the
4 opinion of the original examiner. (Examiners, Larion & Dykstra, did not score these charts
5 numerically when reviewing them, but merely looked at the questions and Busch & Greene's
6 responses to the questions, and based on their training & experience, rendered an opinion).

7 **2-20-08:** Cathy King sent me an e-mail today, stating that she ran the Busch name by retired
8 Birmingham Detective Jack Kalbfleisch and asked if he remembers the name, stating that Busch
9 committed suicide in Birmingham in the late '70's and was a suspect in the child killings. I expressed
10 concerns with Cathy talking to someone outside the Task Force & Law Enforcement, about what we
11 are working on, and she re-assured me that we could trust him. She stated that he has known about
12 this since _____ and _____ a year ago and hasn't said anything and she was very vague with him
13 about what she was looking for. Anyways, Kalbfleisch told her that he did remember a suspect in
14 the child killings that killed himself with a shotgun at a home near Maple & Lahser in the late '70's,
15 and the reason he remembers this is because they found a pencil drawing in Busch's room of a boy
16 "screaming" that looked like the Stebbins boy.

17 **2-21-08:** The Task Force met at the MSP Metro North post today and we had retired Southfield
18 Detective Lourn Doan there to interview him about his investigation, back in 1976 & 77, into
19 Christopher Busch & Gregory Green. We gave Lourn a few general facts about the case, as to
20 "jog" his memory, but really wanted him to "fill in the gaps" on his own, without us leading him.
21 Lourn remembered the investigation and remembered Christopher Busch when we showed him the
22 picture. Being that it is such an old investigation, Lourn was struggling a bit, trying to remember
23 details of the case. We showed him the original tips he wrote up on Busch & Green in 1976 and
24 also the tip he wrote on these guys again in 1978. Detective Doan & Detective Roy Itami (Berkley
25 PD) were working together on the Timothy King Homicide, as part of the Oakland County Child
26 Killing investigation.

27 _____, Doan continued to investigate these subjects as suspects. He remembered Busch
28 killing himself at his home in 1978, but stated he thought he hung himself, but stating he did not
29 remember for sure. We called Detective Roy Itami, who agreed to come to the meeting. Doan &
30 Itami looked over the tips they wrote up and began talking about when they took Busch & Green to
31 the polygraph with MSP in Flint. Doan stated that they, along with the "Task Force" were so
32 convinced that these two suspects were involved in the killings that Deputy Oakland County
33 Prosecutor Dick Thompson went along and was present during the polygraph,
34 _____ Doan stated that Thompson also thought they
35 would be issuing charges on these subjects. Both Doan & Itami stated that during the hundreds of
36 polygraphs conducted on suspects during this massive investigation, this was the only time a
37 prosecutor, especially the Deputy Oakland County Prosecutor attended a polygraph. I asked Doan,
38 if he remembers he _____

42 We then told Doan & Itami that we have recently, based on _____ statements to _____ about
43 Busch's confession to him and our recent investigation, shown Busch & Green's polygraph charts to
44 two independent examiners, one of which is a very experienced MSP examiner. We told Doan &
45 Itami that both examiners were in agreement, independent of each other, &
46 _____

50 _____ Doan & Itami were
51 shaking their heads stating this could have been solved 30 years ago. Both Detectives asked where

1 their reports were. All we have is the tip sheets they wrote up and what was attached to the tips.
2 Doan stated that he knows he wrote lengthy reports on this lead. Itami stated that he remembers
3 the amount of writing Doan did at that time on this lead and stated that there should be a large file
4 on these guys. We are going to check further in the state police files for these. Doan stated that if
5 we call Chris Helgert at Southfield PD, he may have a copy of his (Doan's), indicating that he thinks
6 he gave a copy of everything to his agency.

7 **2-22-08:** I was reviewing Polygraph Examiner Cabot's pre-polygraph interview of Gregory Green
8 today, and noticed that Cabot asked Green if there were anyone he wished were dead? Green
9 mentioned his father, a couple of other names and ' It's interesting that Green wants
10 , dead. It's possible that had information about Green and he (Green) was afraid
11 would tell someone. We are going to take this report with us when we interview in
12 prison in a couple of weeks.

13 **2-25-08:** We went to Southfield PD today and talked to Chris Helgert about Lourn Doan's old
14 reports involving an investigation Doan conducted at the time of the child killings, regarding two
15 subjects, Christopher Busch & Gregory Green. Helgert had already pulled all of Southfield PD's
16 reports that they had from the child killing investigation. In these reports, we found two tips written up
17 by Detective Doan on Busch & Green in January of 1977. This file from Southfield PD also
18 contained several typed reports by Doan about this investigation into Busch & Green. **The**
19 **following is a short "Time-Line" of the, "one-week" investigation in January 1977 when**
20 **Greene was arrested for multiple CSC's in Flint and told the police Chris Busch killed Mark**
21 **Stebbins. This short time-line includes some highlights of interviews and when & why they**
22 **were cleared and the case was closed:**

23 1-25-1977: OCK Task Force contacted by Det. Waldren from Flint PD. They have arrested a
24 subject named Gregory Green for CSC 1st Degree, who says that Chris Busch killed Mark Stebbins.

25 1-25-1977: Doan & Lt. Simmons went to Flint PD and interviewed Greene about this information.
26 Greene, according to Doan's report supplies Detectives with all the information about Busch's
27 involvement in the Stebbins abduction/murder. Doan notes that Green is looking more like a
28 suspect in the homicides than an informant.

29 1-26-1977: (the victim in this case) was interviewed. said that he was
30 afraid when Greene & Busch took him into the woods to molest him that they were going to kill him.
31 Greene had choked him unconscious in the past when trying to anally molest him. Greene had told
32 prior to this that Chris Busch had killed a kid before. told the police that Greene
33 had asked him a few months ago, to help him kidnap and kill a boy. went on to say that
34 when Greene anally molested him in the past, Greene used force was crying, but Greene
35 would not stop.

36 1-26-1977: Flint PD polygraphs Green about his info about Busch Killing Stebbins. Flint PD
37 polygraphed Green about whether he knows for sure who killed Stebbins.
38

39 1-26-1977: Green was interviewed today by Dick Thompson (Oak County Pros.), Gary Hawkins
40 and Lt. Simmons (Southfield PD).

41 1-27-1977: Warrant obtained today for Christopher Busch, by Flint PD for a CSC 3rd Degree.

42 1-28-1977: Detective Doan, Det. Cattel (Ferndale PD), Sgt. Rivard (MSP) & Det. Waldren (Flint
43 PD) went to the "Scotsman" restaurant today in Alma, Michigan and arrested Christopher Busch on
44 Flint PD's CSC charge.

45 1-28-1977: Detectives conduct a consent search of Busch's home at
46 Detectives find 2 shotguns, 1/2 - 1lb. Of Marijuana and 2 suitcases. 1 suitcase contained ropes and

1 the other contained child pornography, including child porn films and scrapbooks. The 2 suitcases
2 found in Busch's home in Alma, were confiscated by Flint PD as evidence in their CSC case.

3 1-28-1977: Doan, Cattel, Waldren & Rivard (MSP) interviewed Busch about his possible
4 involvement in the Oakland County Child Killings. Busch denies involvement in the Stebbins case,
5 but told Detectives about fantasies that he and Green have discussed. Busch said that they have
6 talked about wanting to kidnap a boy, tying him up and sexually abusing him. Busch stated that
7 either he or Green would work at night and the other during the day, so one of them would always
8 be with the boy. When Busch was asked what they would do with the boy when they were done
9 with him, he couldn't answer. While Busch was talking to Investigators about being a pedophile and
10 locations he picked up and dropped off boys in the past, he named the following locations in
11 chronological order: 9 Mile & Woodward in Ferndale, 13 Mile & Woodward in Royal Oak, & the "7-
12 11" store on 12 Mile in Berkley. These are the first three abduction sites, in order. The King
13 abduction had not occurred yet.

14 1-28-1977: Busch was polygraphed today by Ralph Cabot, at MSP in Flint.
15

17 2-1-1977: Green was polygraphed today by Ralph Cabot, at MSP in Flint.
18

20 2-1-1977: An article in the Daily Tribune
21 was in this file that stated on the headline that Task Force finds no link between Flint case and child
22 killings in Oakland County. The article stated that two men arrested in Flint were polygraphed about
23 their possible involvement in the child murders in Oakland County, * This
24 case was closed. ***

25 2-26-08: We went to Flint PD today to try to get any reports or notes their Detectives might have
26 done on Green's info about Busch, and also copies of the polygraphs Flint PD did on Green. The
27 only file that we could locate at Flint PD was the old CSC cases (reports) on Busch & Green. We
28 already have copies of those. A Detective Greg Hosmer is going to manually go thru the old
29 polygraph files and see if he can locate the polygraphs administered on Green at Flint PD on
30 January 26th, 1977.

31 2-26-08: *** (We got copies of Bloomfield Twp.'s reports today on Busch's suicide at his
32 parents home in 1978). *** Garry & I went to Bloomfield Twp. PD today and picked up a copy of
33 their reports on Busch's suicide. John Ouelett (FBI) knows the Bloomfield Twp. Chief (Kurt Bowden)
34 and asked him to pull their reports for us. Their reports stated the following: On November
35 20th, 1978, Bloomfield Twp. PD was called to Chris Busch's parents home at
36 _____, by Chris's older brother, _____, who lives in the area at
37 _____ Chris's brother, _____, had been contacted by a neighbor _____, after the
38 Busch Maid _____ i) was unable to gain entry into the home and went to the neighbor's
39 house to call _____ The Maid comes to the Busch home once a week on Mondays to
40 clean the house, but was unable to get in due to the latch being locked at the front door.

41 The police made entry into the home and they found Christopher Busch upstairs in his bed with a
42 gunshot wound to the head. Busch had shot himself between the eyes with a 22 cal. Rifle that was
43 lying next to him in the bed. _____ told the police that Chris lives there with the parents
44 _____ that were currently in England _____ went on to say that he had not spoken to
45 Chris in the last 3 weeks, but that he did not seem despondent. In this report, _____ i told
46 the police that his brother _____ resides in Whitehall, Michigan and his brother _____ resides
47 in England. The maid, _____ was interviewed and stated that she has a key to let
48 herself in when she comes to clean, but on this date, she could not open the front door because it
49 was latched from the inside. When she became suspicious she called _____, the neighbor.

1 During an interview of a close family friend, he stated that he and his wife had both
2 talked to Chris a few days ago and that he seemed fine to them. Newspapers from Friday thru
Monday were found on the porch of the home. The Thursday edition of the paper was found in the
home.

5 Investigators spoke with the manager of the Franklin Club Apartments,
6 _____ where Chris worked as an administrative Chef until he resigned on November
7 4th, 1978, to pursue a new job at the Franklin Terrace Apartments.

8 During an interview of Christopher Busch's father, _____ on November 27th, 1978, he
9 stated that Christopher was due to start his new job on November 20th, the day he was found
10 deceased.

11 Christopher Busch was found lying on his side in his bed facing the wall. Pinned to the wall was a
12 hand-drawn pencil drawing of a boy screaming. The boy was wearing a coat in the drawing that
13 matched the coat Mark Stebbins was wearing when he was abducted and killed. The coat was a
14 "snorkel" type coat with fur around the edge of the hood. Mark was found at Ten Mile & Greenfield
15 wearing that coat with the hood pulled up around his face and zipped up, just like in the drawing
16 Busch had. Also found in the walk-in closet in the bedroom were ropes/ligatures lying in the middle
17 of the floor. This property, along with 3 spent shell casing's, a box of bullets, a vodka bottle and a
18 small amount of Marijuana was confiscated and placed into evidence.

19 **2-27-08: Met with Polygraph Examiner John Wojnarski (retired MSP) today and he looked at**
20 **Busch & Greens charts.** We had Examiner Wojnarski review the charts from Busch & Greene's
21 polygraphs today, without Wojnarski knowing anything about the case or the polygraphs. After
22 reviewing and numerically scoring the charts,
23

30 _____ Wojnarski asked who
31 conducted the test, and we told him Ralph Cabot from the MSP Flint post conducted the test in
32 January of 1977, about the Oakland County Child Killings. Wojnarski stated right away that Cabot
33 had a couple of polygraph problems towards the end of his career, where he got into trouble with the
34 State Police when he screwed up a test on a homicide case. This test was done by Cabot in 1977
35 and he retired in 1980 from the State Police. This info about Cabot, matches what Examiner
36 _____ said about Cabot, when he told me that he had a couple of times in the past, overturned
Cabot's polygraphs on cases.

43 Wojnarski suggested that all three examiners that looked at these charts, he, Larion & Dykstra all
44 get together, score them the same way (numerically) and then compare notes to come up with a
45 consensus on the results of the tests. Arrangements were made for this meeting.

46 **2-28-08: *** Richard Lawson's sentencing today. ******

1 **2-28-08:** We had retired Detective Loun Doan (Southfield PD) come to the MSP Metro North Post
2 today, and look over his reports from January of 1977 that we picked up at Southfield PD. Doan
3 read over all of his reports, and he did remember most of what he had read, including remembering
4 that investigation, but could not add much additional information to assist us.

5 **2-28-08: *** (We Briefed Detective Lt. Darryl Hill (MSP) today at the District Headquarters in**
6 **Northville) ***** Garry, Dave & I went to the MSP 2nd District headquarters today and briefed Lt. Hill
7 on the developments in this investigation. Based on what we told Lt. Hill, he authorized D/Sgt. Gray
8 make this case top priority at this point and to work full-time on trying to put this case together. My
9 administration at Livonia PD was also brought up to speed on this lead. Chief Stevenson, felt as
10 strongly about the potential of this lead as Lt. Hill, and also authorized me to work full-time with the
11 State Police right now to continue to pursue this Busch & Greene lead. Lt. Hill also authorized us to
12 use the Michigan State Police Aviation Section to fly Garry & I up to Camp Ojibway to interview
13

14 **2-29-08:** John Ouelett called the Chief of Bloomfield Twp. PD (Bowden) and requested that they try
15 to locate the crime scene photos that they took at Christopher Busch's home on
16 when Busch committed suicide in November of 1978. They are going to call me if/when
17 they find them.

18 **2-29-08:** Doan's report on the interview of Busch at Flint PD in January 1977, showed the name
19 as the kid Busch Picked up from the 12 Mile Rd. & Greenfield area and took to
20 Hartfields Bowling Alley and the 7-11 store. Busch stated to Detective Doan that Boldiyar was a
21 w/m that Lived in Berkley and would be 18 years old. I grew up in Berkley and thought I
22 remembered a kid named [redacted] from my neighborhood or school. I called my Brother
23 [redacted] (retired Berkley Police Lt.). I asked [redacted] if he remembers a family in Berkley, in the 12 mile
24 & Greenfield area with the last name [redacted] Right away [redacted] stated you mean
25 [redacted], he lives on [redacted] just north of 12 Mile Rd. This is in the area of 12 & Greenfield
26 in Berkley. [redacted] said that [redacted] was a few years younger than he [redacted] was and a few years
27 older than I am [redacted] then stated that [redacted] had many arrests and police contacts in Berkley and
28 surrounding cities. [redacted] went on to say that he was eating a meal at a restaurant in Berkley one
29 time (on-duty) when the waitress yelled out, hey [redacted] there's a guy slashing the tires on your police
30 car. My brother observed and arrested [redacted] for Malicious Destruction of Police
31 Property.

32 **2-29-08: *** (I identified [redacted] today, an associate of Chris Busch) ***** I
33 performed a Lexis-Nexis computer search for [redacted] and found no matches. I performed the same
34 check on the name [redacted] and observed a [redacted] born [redacted] to have an
35 address at [redacted]. This check showed this
36 to be a current address for [redacted]. I performed a search thru the Secretary of State database and
37 located [redacted].

41 I performed a check thru the Michigan LEIN system.

1 **3-2-08:** While working on the "time-line" for the current Green & Busch investigation, I noticed that
2 Busch, when being interviewed on 1-28-77, by Doan & Cattel at Flint PD, described his flight from
3 England to the U.S. Feb. 14th, 1976. Busch told Detectives that he flew from London to New York to
4 Chicago and then into Flint Bishop Airport where his parents picked him up and they went directly
5 home to Birmingham. Approximately an hour or two later, when Busch was telling the MSP
6 polygraph Examiner Cabot, when he arrived back in the U.S. from England, he stated that he flew
7 into Detroit Metro Airport. Cabot has Detroit Metro in his notes and on his report.

8 I also noticed while doing this "time-line," that Green told Cabot during his pre-polygraph interview,
9 that he was released from the mental institution 1-15-76. Green also told Detectives Waldren &
10 Miller, during the interview, after his arrest on 1-25-77, that he was released from Patton State
11 Mental Hospital in California on 1-15-76. Records from California Dept. of Justice, Bureau of
12 Identification and teletypes in the file from 1978, both show that Green was discharged from the
13 mental hospital on 7-21-1975. If Green was in-fact released from the mental hospital on 7-21-1975,
14 then he may have been back in Michigan and possibly associating with Busch, several months prior
15 to the first OCCk victim, Mark Stebbins being abducted, 2-15-1976.

16 One of the other noteworthy items from the "Time-Line," was something Busch mentioned to the
17 Montmorency Detective, during his interview after his arrest on 3-3-77. Busch was talking about the
18 boys from the Flint area that he would bring up to his father's cottage on Ess lake, and he said that
19 he had his first women up to the cottage approximately two weeks ago. This could possibly have
20 been around the time that Kristine Mihelich was missing, found 1-21-77.

21 **3-3-08:** I was talking to John Oulett (FBI) today and told him about John stated that Ray
22 Anger from Berkley PD conducted extensive interviews of employees at Hartfields Bowling Alley
23 after Kristine Mihelich's abduction. Mihelich's mother worked as a bartender at
24 Hartfields at the time of Kristine's disappearance. Kristine used to frequent the bowling alley to visit
25 her mother. John Oulett stated that he thought he remembers that the police were looking at a local
26 18 year-old guy at that time that frequented the bowling alley. We are going to look thru the
27 interview reports to see if the 18 year-old may have been and if Busch & Green, may also
28 have been mentioned by employees.

29 **3-3-08:** I talked to Jason Bolinger (FBI) today, about getting the lead sent to New York to interview
30 and swab for DNA. This is Christopher Busch's only living family member that we
31 can get DNA from.

32 **3-3-08: *** (Identified today, one of Greg Green's ex-cellmates from prison) *****
33 We had received a list of Green's cellmates that he was with during his years in prison, from the
34 Assistant Warden of Jackson Prison, Cindy Ackers. One of the people on the list was a guy named
35 that was doing time for CSC 1st Degree (child u/13), the same thing Green was serving
36 time for. was charged with his CSC in Genesee County. I determined that is from the
37 Flint area and now resides in Flint, where Green grew up. They may have possible had a lot to talk
38 about. I performed a search thru MDOC and located w/m, born I. A
39 search thru the Michigan LEIN system,

43 Cindy Ackers also sent us information on Gregory Green's family and about his death. According
44 to Akers, Greg Green died of a heart-attack while watching TV in his cell in 1995. The guards found
45 him sitting up with his eyes open. Because of his position and his eyes being open, his death was
46 not discovered for a long period of time. Cindy Ackers also supplied us with Green's brother's
47 names, who visited Green in December of 1995, shortly before his death. One brother is
48 . The other brother is , Mi.Ops.:

1 **3-4-08:** I searched thru Berkley PD's (Ray Anger) reports today on the Kristine Mihelich case,
2 knowing that they did an extensive investigation/interviews at Hartfields Lanes in Berkley, because
3 of Mihelich's mother working there and Kristine frequenting that location. I checked to see if there
4 was any mention of Christopher Busch, Greg Green or _____, being regulars at the
5 bowling alley. I did not recognize their names or any other names in these reports that would
6 possibly connect the investigations.

7 **3-4-08:** Garry made contact today with the Detective from the Flint MSP post, who is going to
8 contact _____ (Green's ex-cellmate) and verify his residence and a good time for us to come
9 interview him. We are waiting to here back from the Flint Detective.

10 **3-4-08:** Garry called the Detective at the Newaygo Michigan post, Scott Rios, who agreed to make
11 contact with Christopher Busch's _____ to verify his residence and to lay the ground-
12 work for us to come interview him about Busch & Green _____ h lived on the next street over
13 from Greg Green and is the one who introduced Greg Green to _____. We are going to
14 interview _____ to learn more about Busch's background and hopefully learn when Green
15 arrived back in the Flint area and started running with Chris Busch.

16 **3-4-08:** We made contact today with New York FBI Agent Tommy MacDonald. He has agreed to
17 interview Chris Busch's brother _____ and swab him for DNA. We talked to the FBI agent working
18 with us on this case, Jason Bolinger and he is going to send the questions to Tommy MacDonald
19 that we want him to ask

20 **3-4-08:** Garry took the polygraph charts from Busch and Green's, 1977, Stebbins polygraph to
21 polygraph examiner Wojnarski's office today for their upcoming meeting on 3-6-08. The 3 polygraph
22 examiners that looked at these charts independently are going to meet, discuss their conclusions
23 and see if they can come up with a consensus on the suspect's charts.

24 **3-5-08:** Garry and I met with Captain Steve Cook (Bloomfield Twp. PD) today and discussed the
25 evidence from the Busch Suicide scene. MSP had located a lab report a few days ago that showed
26 that MSP turned over the ropes and the drawing from Chris Busch's back to Bloomfield Twp. PD in
27 1982. Bloomfield went thru their files and evidence room and located the suicide scene photos from
28 Busch's suicide in November of 1978. These photos showed Busch in bed, lying on his side, facing
29 the wall with a rifle lying next to him. Busch's right arm was extended across the bed near the rifle,
30 in a position to pull the trigger. In the bedroom photo's you can see the drawing of what appears to
31 be the Stebbins boy, pinned to the wall that Busch is facing. Also in the crime scene photo's was a
32 couple of pictures of the ropes & ligatures that were found in Chris Busch's bedroom. The ropes
33 were found in the lying on the floor in the middle of the walk-in closet in Busch's bedroom. These
34 ropes look as if they were left where they were used or thrown on the closet floor. Also found in the
35 bedroom was a single shotgun shell casing, on the desk. In the packet of photo's and reports were
36 a number of latent prints that were lifted from the rifle, ammo box and other items in Busch's
37 bedroom. Captain Cook stated that they were unable to find the ropes and that they were probably
38 destroyed years ago.

39 Captain Cook turned over all of the Bloomfield Twp. PD, original photos, latent prints and reports
40 us. They also gave us the entire file that Tobias had brought into Bloomfield Twp. PD before he
41 died. We will be able to go thru this and see if there was any mention of Busch, Green or
42 Lamborgine, by Tobias. He was a retired investigator who had worked on the OCK case for many
43 years. *** (See Busch Suicide photos and reports for details) ***

44 **3-6-08:** *** (Tape-recorded interview of _____ today at Camp Ojibway in the
45 Upper Peninsula of Michigan) *** MSP Aviation flew Garry & I out of Lansing to Ironwood,
46 Michigan, in Gogebic County today, to interview _____. MSP Detective Tim Doan picked us up
47 and took us to the prison (Camp Ojibway). We began by reading _____ his rights, which he
48 stated he understood and agreed to waive and talk to us. While talking to _____ he stated that
49 he knew Christopher Busch from his neighborhood in Flint in the mid-seventies and had been

1 molested by him (oral copulation) several times, in Flint, the cottage on Ess Lake in Montmorency
2 County and also at, what he described as Busch's house in Alpena, Michigan. stated that
3 the two times he was at the cottage on Ess Lake there were several boys there, including his brother
4 and other Flint boys, but not went on to say that when Christopher
5 Busch took him to the house in Alpena on a couple of occasions, it was just he and Chris.
6 told us that on one occasion they arrived at the house, Chris rushed him to the bedroom and brought
7 him a beer and some marijuana to smoke. said that Chris then had him undress and pulled
8 a movie screen down from the ceiling that was in the room. went on to say that Busch then
9 turned a movie projector on (Possibly 8mm) and began showing a movie (possibly a home movie) of
10 a man anally molesting a boy that was tied up. We asked if it was Busch molesting the boy
11 in the movie, to which he stated he didn't think so, but did not know for sure. said that
12 Busch then tried to put Vaseline on him so he (Busch) could penetrate him anally and he
13 ran from the room. said that Busch chased after him and said something to another person
14 in the house that states he didn't see. said that Busch told the other person in the
15 house, something like, "I'll take care of this." stated that he thought they were there alone,
16 but thinking back now, the way Busch hurried him into the bedroom when they got there, he believes
17 there was another person in the house described the house as being just outside of town
18 in Alpena and stated that there were other houses around there, but there was quite a distance and
19 woods between them. stated that he thought that the house belonged to Chris Busch, but
20 stated maybe Busch shared that house with another person, adding that he doesn't know
21 for sure described Christopher Busch's car as being a small Pinto type car, possibly
22 brown in color and stated that Busch also had a full size S.U.V. stated that Busch never
23 performed anal sex on him, nor ever tied him up. When asked about the incident in Alpena,
24 stated that Busch never threatened him and did not threaten him that day, but only told him
25 that he would not try that again.

26 s then told us that later during that time period, Busch's mother pulled up to him in a
27 limousine in his neighborhood in Flint, and offered him money, not to say anything to the police or
28 testify against her son Chris. told us that he and his brother just ran home.

29 While talking to about Greg Greene, he stated that he did not know Green and did not
30 remember him from the neighborhood. I showed a picture of Green from 1977 and
31 stated that he didn't know him. I showed the police reports from 1977, when he
32 all went to the drive-in theatre with Greg Green and
33 Green performed oral sex on the boys, including stated he doesn't remember
34 that and does not know Green. I reminded Gunnels that they went to see the movie "The Exorcist"
35 that night. I showed him Green's picture again, and then he stated that he kind of looks familiar, but
36 that he does not remember him. then stated that he has done a lot of drugs over the years,
37 as if making an excuse not to remember Green.

38 I asked about other places he has been with Chris Busch in the past, like the Detroit area
39 or any of his (Busch's friends in the Woodward corridor). said he never went to Detroit or
40 anywhere in that area with Chris, including his house in Birmingham. stated that he knew
41 that Chris's parents were rich, but was never at their house. I asked him about Chris's house in
42 Alma or in Whitehall. said that he was never in Alma, but was at the apartment in Whitehall
43 in 1982, with said that this apartment was above a store in Whitehall and that
44 he believes that then bought the store and lived upstairs
45 in the apartment. I asked if he knew Chris to be "into" art, drawing, painting...etc?
46 stated no. I asked if he knew if Chris or his family had any pets and if so which places he saw them
47 at, to which he stated he never saw any pets and did not if they had any.

48 I asked if he ever saw a boy with Busch that he didn't recognize, or if Busch ever had him
49 perform sex on another boy, to which stated no to both. We asked if he ever saw

1 Busch hurt or keep another kid against his will, to which stated, no. I asked if he
2 ever saw Busch carry any type of a weapon, to which I stated he thought he carried a knife.

3 The interview was completed at this point. We did not believe ; about not knowing Greg
4 Green and he appeared to be minimizing his information about Busch also. information is
5 contradictory to what I told us, when he stated that was the closest to Busch and
6 Green of anyone in their group. We made plans to have swabbed for DNA and a possible
7 re-approach of s after the interview of F
8 **(See MSP transcripts of this interview for details) *****

9 **3-7-08:** I spoke with Livonia Polygraph Examiner Tim Larion today, who told me the results of the
10 polygraph examiners meeting regarding Busch & Green. Larion stated that due to Cabot, not
11 including relevant questions on the final test for each subject, the 3 examiners are unable to conduct
12 a numeric scoring on these charts.
13

15 **3-7-08: *** (I identified Greg Greene's brothers today) ***** I was able to identify and locate both
16 of Green's brothers today. I performed checks thru the Lexis-
17 Nexis database for both subjects and located ; living in Saginaw, Michigan &
18 living in Grand Blanc, Michigan. I check thru Secretary of State,
19

21 C * (See Greg Greene file
22 for this information and photo's) ***

23 **3-7-08:** Garry called the MSP Detective (Tim Doan) in Gogebic County, Michigan today. Tim is the
24 Detective that picked us up at the airport and took us to Camp Ojibway to interview
25 Tim is going to go see , swab him for DNA and tell him that we know he lied about knowing
26 Greg Green and we are going to have him shipped down to the Detroit area so we can polygraph
27 him. Tim Doan is also going to tell him that his potential parole that he was looking forward to in
28 April, 2008, is not going to happen unless he is truthful with us.

29 **3-9-08:** I sent an e-mail today to Deputy Bud Shaw at the Montmorency County Sheriffs Dept. He
30 is the Deputy that helped me locate old reports on their investigation into Busch and also the Deputy
31 that helped me locate and identify Busch's cottage on Ess Lake. I asked him in the e-mail if he
32 could help me possibly identify this house in Alpena that said Busch took him to a couple of
33 times and tried to anally molest him.

34 **3-10-08: *** (Interview of in Newaygo, Michigan) ***** Garry Gray (MSP) & I
35 went to the Newaygo State Police post today to interview
36 We began the interview by reading his rights, to which he stated, he
37 understood, waived them and agreed to talk to us. We started telling that we wanted to talk
38 with him about some things going on in Flint 30 years ago. right away asked if this was about
39 Greg Greene, to which I stated it was about Greg Greene and Christopher Busch. I asked if
40 he remembers when he first started seeing Greg Greene around his neighborhood in Flint, to which
41 he stated that he believes it was approximately 1974-1975, because he and his family moved to
42 Whitehall late in the summer of 1976, so it was well before that, probably a year or so before they
43 moved. This would match the documented information about Greene actually being discharged
44 from the mental institution in California in July of 1975. said that he did not know about Greg
45 Greene or about him coming back from California, he simply stated that
46 he remembered seeing him around the neighborhood in 1975. said that he did not know how
47 Chris & Greg met said that (his grandpa & Chris's father) bought his father
48 a store in Whitehall, Michigan to run. said his family moved there from Flint and
49 lived in an apartment above the store.

1 that Chris was involved in the "Big Brother" program, indicating that maybe this is where the
2 unknown boy came from.

3) We started talking about the house in Birmingham (Chris's parent's home), to which _____ stated
4 that it was a huge home, approximately 6,000 – 7,000 square feet. _____ said he stayed there on
5 occasion with his grand parents, when his parents in Flint & later in Whitehall; were having
6 problems. His parents later divorced. We asked _____ about Chris committing suicide, to which he
7 stated that he remembers that Chris shot himself in the head. We asked him if he remembers why
8 he did it or if there was any talk about why Chris killed himself. _____ stated that he doesn't know
9 why, but believes that Chris couldn't live with his problem (pedophilia) any more. We showed
10 a picture of the drawing of the kid screaming that was pinned to Chris's bedroom wall when he killed
11 himself and _____ appeared visibly shaken, indicating that he had seen the drawing before.
12 _____ said again that he had seen this picture before, but was not sure when, stating that he stayed in
13 Chris's room many times over the years. _____ said that he stayed there off and on, but believes
14 that he saw the picture between 1976 & 77. _____ stated that he believes he remembers it pinned to
15 the wall in Chris's room, above his stereo. When asked about Chris doing artwork or drawings,
16 _____ stated that he never knew Chris to do that, but did not know for sure. We showed _____ the
17 crime scene photos from Busch's suicide regarding the ropes found in the walk-in closet. _____ said
18 that he did not know why he had those, but stated that he can imagine why Chris had them and what
19 he did with them. _____ stated that he had not seen those before at the Birmingham house or any of
20 the houses Chris had access to. We asked _____ about any pets that Chris had at any of the
21 houses, to which he stated that Chris had a tan Labrador type dog and that his parents had a white
22 Scottish terrier dog at the Birmingham house that they brought over from Europe. He did not
23 remember, when asked, seeing either dog at the other houses or cottage with Chris. _____ stated
24 he may have taken them to the other places, but he couldn't say for sure.

25 **** The task force has white animal hairs recovered from the clothing of our victims from the original
26 investigation along with white animal hairs & hairs/fibers found during the recent re-examination by
27 the MSP Forensics Lab in 2007. We also have tan/gold carpet fibers on our victims clothing that
28 could possibly have been from one of the homes or cottage of Busch. The carpets in Chris Busch's
29 bedroom and walk-in closet at his parents home at that time, were tan/gold color. These fibers could
30 also have come from the gold colored ropes/ligatures found in Busch's walk-in closet that he
31 possibly used to bind victims. Some of the fibers we are in possession of were collected from our
32 victim's socks. Two of the victims were determined by the M.E. during their autopsies to have bind
33 marks on their wrist and ankles, possibly from ropes. Therefore, the tan/gold fibers found on the
34 victim's socks, could possibly be from the ropes or ligatures that were used to bind them. Ropes
35 and ligatures were found in Busch's home in Alma and also in the walk-in closet in his bedroom in
36 Birmingham, along with the drawing of what appears to be the Stebbins boy screaming.

37 ****Laboratory Scientist David Metzger from the Michigan State Police Lab in Northville
38 conducted tests in July of 1977 of fibers from Timothy King and fibers from Jill Robinson.
39 Metzger determined the following after these tests: *** Results: Examination of the fiber
40 from Jill Robinson's socks (#7A) revealed that it was microscopically similar in color and
41 physical construction and possessed optical properties in plane polarized light "identical" to
42 numerous fibers removed from the clothing of Timothy King. Metzger also conducted a
43 comparison of fibers from Jill Robinson's blanket to fibers from the genital area of Timothy
44 King. The results of this test was that these fibers were a different shade of yellow and
45 determined to be of an unusual nature, possibly carpet fibers. _____ stated that Busch
46 showed him a movie of boys being anally molested that were tied up. Busch himself told the police
47 in 1977, that he & Greene have discussed their fantasies about kidnapping, tying-up and molesting a
48 boy. *** (A crime scene search for trace evidence at Busch's home in Birmingham, especially
49 in the walk-in closet where the ropes were found, is forthcoming, along with searches at
50 other known locations where Busch/Greene could have kept the victims. The trace evidence
51 we will be looking for is human hair and/or DNA from our victims, animal hairs match the

1 animal hairs from our victims, similar fibers from carpets or the ropes and any other trace
2 evidence that might assist in the investigation)***

3 We were talking with [redacted] about where Chris was living at certain times and he stated that after
4 Chris was arrested in January of 1977, he lost his restaurant in Alma and he believes the houses in
5 Alma & Sanford [redacted] stated that Chris ended up living back at his parent's home in Birmingham,
6 where he lived until he killed himself. [redacted] told us that Chris's parents were over seas a lot,
7 because of [redacted] job and because Chris's older brother lived in London, England.
8 said that he thinks [redacted] lived c [redacted] in San Francisco [redacted] told us that Chris had several
9 homes and places to stay and that he had these places alone, being that his parents lived in
10 England for awhile and also in Germany.

11 We went back to talking to [redacted] about Greg Greene and about Greene's relationship with the
12 other boys in the neighborhood. I asked how well, Greene knew [redacted], to which he stated
13 they knew each other, but I don't remember seeing them together. I asked [redacted] what he would
14 think about [redacted] telling us that he didn't know Greg Greene, to which he stated that as far
15 as he knows they knew each other. I read a paragraph to [redacted] from the MSP report regarding
16 Greene & Busch's 1977, CSC arrest. The paragraph I read, pertained to the night in 1976 when
17 Greg Greene took [redacted] to the drive-in theatre in Flint. In this
18 paragraph [redacted] told police that he observed Greg Greene molest [redacted] and [redacted]
19 [redacted] in the back seat of Greene's car. I asked [redacted] how about [redacted], knowing Greene, to
20 which he stated, I remember that night and I guess that was [redacted] in the back seat with me & Greg.
21 I just can't picture [redacted] here. *** (See Transcripts of this interview for further details) ***

22 **3-11-08:** Garry & I went to [redacted] today (Cass Corridor) looking for
23 [redacted] This is the subject listed in Greene & Busch's arrest report from January of 1977.
24 [redacted] was listed as a suspect in that case, but there is no mention of him in the narrative of the report. He
25 [redacted] was an adult from St. Clair, Michigan that was charged with Disorderly person. He may possibly be
26 [redacted] the third person charged in the Flint CSC case with Busch & Green that was mentioned in the
27 [redacted] newspaper article when Busch & Greene were [redacted] in the OCK case. The article
28 [redacted] stated two men polygraphed in connection to the OCK case, but said three men arrested.
29 [redacted] may be a pedophile associate of Busch & Greene and needs to be interviewed. This address is the
30 [redacted] Detroit Chapter of Vietnam Veterans building. We spoke with the managers there who had no
31 [redacted] record of [redacted], but stated that many homeless type people come and go from their office.

32 **3-11-08:** We received an e-mail from Cindy Ackers today from Jackson Prison in regards to Greg
33 [redacted] Greene. A couple of guards were interviewed about Greene and both said they do not remember
34 [redacted] Greene being friendly with anyone, stating that they remember him as a loner, but said that
35 [redacted] was his "bunk-mate" at the time of his death.

36 **3-12-08:** I drove by Busch's home at [redacted] this morning.
37 [redacted] The house is situated on the northwest corner of [redacted] the home
38 [redacted] appears to be, structurally, the same as it probably did 30 years ago. There was a burgundy
39 [redacted] minivan in the driveway, bearing Mi. Lic. Plate # [redacted] I had our dispatch "run" the plate
40
41

42 **3-12-08:** I met with Jason Bolinger (FBI) at his office in Troy today. I brought Jason completely up
43 [redacted] to speed on the Busch/Greene lead and what our investigative plans are on this lead. We were
44 [redacted] talking about the interview Doan conducted on Christopher Busch in January 1977; just before his
45 [redacted] polygraph. I told Jason that Busch was talking about being a pedophile and named locations he had
46 [redacted] picked kids up, or dropped them off at in the past year or so. While naming these locations, Busch
47 [redacted] lists chronologically the three abduction sites for our first three victims. I told Jason that I believe he
48 [redacted] was possibly doing that because he thought his car might have been seen at those locations, so

1 he's putting himself at those same locations on "legitimate type" business as an alibi, or he was
2 simply "laying out a road map" or giving clues of his involvement.

3 Agent Bolinger & I spent some time today formulating questions for the FBI Agent in New York City
4 that is going to be interviewing Chris Busch's brother, and "swabbing" him for DNA. We put
5 together approximately 20-30 questions for Agent MacDonald to ask Busch's brother. We called
6 and spoke to Agent MacDonald and made arrangements to conduct a conference call with him from
7 the MSP Metro North Post on Tuesday 3-18-08 at 12:00pm, to brief MacDonald on the case and the
8 interview and to go over the questions we have for him to ask.

9 **3-13-08: *** (Tape-recorded interview of _____, Greg Greene's cellmate in prison for 3**
10 **years before Greene died). ***** Garry Gray (MSP) & I drove to Flint today and interviewed Greene's
11 ex-cellmate, _____ at his house in Flint. _____ house is located at _____
12 Flint, Michigan. We started the interview by explaining to _____ what it is that we are investigating,
13 that he is not in any trouble, and that we were there simply looking for his help. I explained to
14 that we have been investigating this for a long time and that we have interviewed many people
15 surrounding Greg Greene. I also explained to _____ that some of the questions we are going to ask
16 him, we already know the answers to and we do that to see if he is going to be truthful with us. I
17 went on to say that I know that he was a cellmate of Greg Greene's before he died and that we also
18 know that they were both from Flint & serving time in prison for the same type of offense (CSC on
19 child u/13). I further explained that we know that they had a lot of time to talk in their cell, and that
20 we know from our experience that cellmates in prison share a lot of information with each other. As
21 we were explaining this to _____ he stated that he and Greg did not talk much, and never said
22 anything to him about killing any kids. _____ was not very convincing when he made that statement
23 and appeared nervous. While I was talking to _____ about the seriousness of what we are
24 investigating, how long it has been and how bad the families of these victims need closure, I handed
25 the photograph of our 4 victims to _____ to look at. _____ had what appeared to me to be a strange
26 reaction to the picture, when he only looked at it momentarily, then turned the picture over, pushing
27 it back at me, hitting my hand with it as he pushed it back. I almost said to _____ "I told you to look
28 at it," but didn't say anything about his reaction to the picture at that time. _____ said again that Greg
29 never talked about anything like that and that they didn't talk much. We told _____ that we did not
30 think he was "being straight" with us and confronted him with the fact that he appeared nervous and
31 that we did not believe him. We noticed that _____ kept looking at his elderly mother who was sitting
32 in the other room. We asked _____ if he wanted to go outside to our car and talk and he agreed.

33 When we got out to the car, we confronted _____ further about possibly lying to us, at which time
34 he broke down crying heavily and holding his head. We told _____ that it was just the three of us
35 now and he did not have to worry. _____ then told us that he and Greg Greene were not only
36 cellmates, but they had a sexual relationship. After explaining this, _____ appeared to be more
37 truthful after breaking down. We began to ask him questions again about Greg Greene and what
38 Greene said to him about our case. _____ told us that Greene told him about kids he had molested
39 in the past and gotten away with it. He also told us that Greene told him that he got away with killing
40 4 kids in the past. _____ was visibly upset at this point. His eyes were watering and he was
41 breathing heavy. We asked _____ what else Greene told him about it, to which he stated that he's
42 trying to remember, it was along time ago. We asked _____ to try to remember when Greene told
43 him this. At this point, _____ began telling us about how he found Greg Greene dead in their cell and
44 performed CPR on him until the guards could get up there. _____ told us that he does not remember
45 exactly when Greene told him about this, but remembers that they were watching TV and talking
46 about molesting kids in the past when Greene told him about getting away with killing the kids. I still
47 felt that _____ was holding back and told him that I get the feeling that he is holding back because he
48 is worried about something coming back on him, to which _____ agreed, stating that he doesn't want
49 anything happening to him. We re-assured him that he would not get hurt and that he would not be
50 in any trouble. We talked with _____ more about what Greene had told him about killing the kids.
51 _____ stated that Greene told him that he knew the police were looking for those kids while they were

1 missing and in his possession. said that Greene told him that he had molested the kids in a
2 field and killed them. We asked if Greene told him where he kept the kids, to which he stated
3 he doesn't remember. said that Greene told him that he had the kids for a few days. We
4 asked if he remembers Greene mentioning the Oakland County Child Killings, to which he
5 stated he didn't remember hearing that. We told Nikle we intend on polygraphing him on this
6 information. We asked if it was the truth that Greene told you he killed 4 kids, to which Nikle
7 stated, "Yes." We asked how he would do on a polygraph about this, to which he stated he
8 would pass. was stressed and expressed his concerns about telling us this. We asked him if
9 he can remember anything else right now about what Greene told him, to which he stated no. Once
10 again we asked if it was true that Greene told him this information, answered, "yes." We told
11 e again, that we would be polygraphing him on this information, to which he stated he would
12 pass. We asked Nikle if he remembers Greene talking about another person with him during these
13 killings? stated he didn't think so. I ran the name Christopher or Chris Busch by him?
14 paused for a second, then, said that the name sounds familiar. We told to start writing down
15 everything he can remember about what Greene had told him about killing the kids, and he stated
16 he would. We told him that we would be in touch with him about taking the polygraph and
17 terminated the interview. *** (See transcripts from interview for details.) ***

18 **3-14-08:** Garry Gray (MSP) & I went to the Michigan State Police Long-term evidence storage
19 facility today in Lansing, Michigan. We went there to go through the OCKK evidence, to see exactly
20 which packages of evidence contained the hairs & fibers we will need for future comparisons during
21 the course of this lead. We will be conducting crime scene searches of Busch & Greene's homes &
22 cottage for trace evidence (hairs & Fibers) to collect and compare to known evidence found on the
23 victims. We went through, approximately 10 large bags and/or boxes of evidence such as the
24 victims clothing, victims boots/shoes, and other miscellaneous evidence. We found many slides and
25 containers that held fibers, hairs, blood evidence, & DNA swabs. Some of the hairs and fibers,
26 including animal hairs that were tested and compared during the original investigation, were not in
27 this evidence at this storage facility. Documents located at the storage facility, indicate that these
28 items that were tested, were taken from the long-term storage facility in 1995, to the Northville Lab
29 and not returned. We will be checking with the Northville Lab, due to the fact these particular hairs &
30 fibers will be important for our future comparisons.

31 **3-14-08:** I received an e-mail today from Deputy "Bud" Shaw from The Montmorency County
32 Sheriffs Department, who stated that he made contact with officials from Register of Deeds at
33 Presque Isle County Michigan and also Alpena County Michigan. Shaw stated that there is no
34 record of property in the name of Christopher Busch or his father in either county. It's
35 possible was at Chris Busch's house in Alma and thought it was Alpena, or Busch's
36 house in Alpena was in another persons name or Busch stayed with someone else.

37 **3-15-08:** We are making plans to conduct crime scene searches for trace evidence at several of
38 Busch & Greene's homes/cottage in the near future, especially in light of the information from
39 We are going to have the State Police Crime Lab conduct these searches, starting with the
40 Busch home on and the cottage on Ess Lake, where Busch
41 was seen while King was missing. Recovery of any physical evidence during these searches,
42 especially hairs & fibers, will result in immediate comparisons to our trace evidence currently at the
43 MSP Forensics Lab in Lansing, and also at the FBI Forensics Lab in Quantico, Virginia.

44 **3-16-08:** *** (See the Greene "Time-Line," for details of his whereabouts, statements and/or
45 actions during a span of time, beginning when Greene was 15-16 years old living on Baldwin
46 in Flint thru his death in prison in 1995. This time line also includes Christopher Busch and
47 his association with Greg Greene during the time of the child killings from 1976-1977.) ***

48 **3-17-08:** Garry Gray (MSP) called the Michigan State Police Forensics Lab in Lansing today and
49 spoke with a Fingerprint Specialist named Michelle Glasgow. She is in possession of the partial

1 Fingerprint that was recovered from Kristine Mihelich during the autopsy. We are going to have
2 Michelle Glasgow, compare Busch & Greene's fingerprints to the partial print from Mihelich.

3 We received an e-mail back a short time later from Michelle Glasgow. She stated that she has
4 located the partial print from Mihelich and it looks like it was from Mihelich's parka. Glasgow also
5 stated that she has some latent prints from an envelope.

6 **3-17-08:** Garry contacted the evidence room (Property Sgt.) at the Northville Lab who is going to
7 check their property room for the hair & fiber evidence that was taken from Long-Term storage in
8 Lansing, for tests & comparisons in 1995.

9 **3-18-08:** Garry Gray (MSP) & I drove to Grand Blanc today to interview Greg Greene's brother and
10 "swab" him for DNA. We went to the home of Greg Greene's
11 older brother. There was no one home, so we left a
12 note and our business cards to contact us, indicating that we were looking for his help in an old
13 investigation.

14 **3-18-08:** We had the phone conference today with Agent "Tommy" MacDonald (FBI) in New York
15 City, who is going to interview Chris Busch's brother and "swab" him for DNA. Present at the
16 meeting was John Ouellet & Jason Bolinger (FBI), Garry Gray & Dave Robetson (MSP) and myself.
17 We went over the background of the case and the background on this lead into Busch & Greene.
18 We also went over questions that we would like Agent MacDonald to ask about his
19 brother. We e-mailed the Agent pictures of the drawing on the wall in Busch's room when he killed
20 himself, along with a picture of the Stebbins boy alive and a picture of him dead at the scene when
21 his hood with the fur around the edge was up, like in the drawing Busch had. Agent MacDonald is
22 going to conduct this interview next week and ship the DNA swab directly to the DNA lab in
23 Quantico, Virginia where our DNA evidence is.

24 **3-18-08:** While we were all at the MSP Metro North Post today, we had an opportunity to discuss
25 the direction of this investigation and give our opinions on what the priorities are and who needs to
26 be polygraphed. We were all in agreement that [redacted] needs to be polygraphed ASAP. A
27 polygraph for [redacted] is already arranged for April 7th, 2008 at the MSP 2nd District Headquarters, with
28 polygraph examiner Lt. Robert Dykstra. We all agree that the search of Busch's home in
29 Birmingham should be our top priority for Crime Scene searches and we will start orchestrating this.
30 We then began to discuss whether or not [redacted] had been truthful during our earlier
31 interviews with him. [redacted] had told me during my first interview with him that he is a "co-
32 conspirator" and was visibly shaken and scared during this interview, stating that Busch had him
33 perform oral sex on a boy that he (Busch) had brought down from up north. [redacted] stated that it
34 was the same boy that the police showed him a picture of in 1977 that was dead. [redacted] identified
35 this as the King boy from the pictures I showed him.

36 I stated that [redacted] told the police in January of 1977, that Greene approached him and asked
37 him to help him kidnap and kill a boy. [redacted] stated they did not go thru with it. [redacted] told us
38 during an interview in 2008, that Busch & Greene would often use him to lure kids over to his car so
39 Greene could get a closer look at them. If Greene was asking [redacted] (13 year old boy), to help
40 him kidnap and kill a kid, it was probably, based on him using [redacted] in the passed as a "lure,"
41 because he (Greene) needed [redacted] to lure the kid towards the car so that Greene could get his
42 hands on the boy. For Greene to ask [redacted] to kidnap and kill a boy with him there had to
43 possibly be a closer bond between [redacted] and Greene that [redacted] stated to us in 2008. From
44 my training and experience, that's not the type of thing a person asked a casual acquaintance to do.
45 There would have to be a certain level of trust or fear between the two, for Greene to even asked
46 [redacted] We know, that Greene had choked [redacted] unconscious in the past, while molesting him
47 and that [redacted] from his own words was afraid of Busch and Greene killing him. Greene had told
48 that Busch had killed a boy in the past.

1 **** We agreed that [redacted] may be "hedging" on cooperation about his possible involvement and
2 it should be a priority to polygraph him ASAP. [redacted] may have been more truthful during the first
3 interview when he was admitting possible involvement and then got scared and backed off from this,
4 3-4 weeks later during the second interview. He will be polygraphed about his possible involvement
5 and/or his possible knowledge of the crimes and/or Busch & Greene's involvement.

6 It also could simply be that [redacted] saw Lamborgine on the news in 2006 as the possible
7 Oakland County Child Killer, hates Chris Busch & Greg Greene and is trying to connect them with
8 Lamborgine for the child killings. Once again, this is why it will be important to polygraph

9 **3-18-08:** I called [redacted] counselor at "Operation Get Down" tonight and left a message
10 for him to call me, indicating that I want to talk to [redacted] again. I also left a message for Jeneay
11 Cheeks, Bowman's Probation Officer and asked her to call about [redacted] current location and
12 that I wanted to talk to him again.

13 **3-19-08:** We were discussing [redacted] today and talking about how he called himself a
14 co-conspirator during the first interview and about him identifying the King boy as the boy Busch
15 made [redacted] have sex with. We talked about [redacted] calling me a couple of times after that,
16 concerned about telling me these things and stating that he was scared. My phone rang during this
17 conversation with the number for "Operation Get Down in Detroit." I thought it would be [redacted]
18 counselor, Mr. Phillips returning my call, but it was [redacted] calling from Mr. Phillips phone.
19 I asked [redacted] how he was doing and he quickly answered "fine," and asked if the DNA came
20 back [redacted], again seemed very nervous about the DNA asking how much longer? I told
21 [redacted] that it would be a bit yet and stated to [redacted] "you still want to help us out and cooperate,
22 right [redacted] to which [redacted] said yes. I told [redacted] that there are a couple of things we want
23 to talk about with him, and would get in touch with him. I told Kenneth that I spoke with his probation
24 Officer Ms. Jeneay Cheeks today who told me that he [redacted] has been assigned a new probation
25 Officer named Mr. Junious (313-972-4427). I told [redacted] that Ms. Cheeks told me today that you
26 are due to get out of "Operation Get Down" April 25th, 2008. [redacted] stated that is right. I asked
27 [redacted] how long he is on probation, to which he stated January 9th, 2010. I asked [redacted] where
28 he is going to live when he gets out of the halfway house, to which he stated with his mom in
29 [redacted] asked me if I wanted the phone number to his mom's and he stated it's
30 [redacted] I told [redacted] that we know where to find him and would be in touch with him.

31 **** It was very interesting how nervous [redacted] was once again about the DNA. It's possible that
32 due to Greene possibly being in the Genesee County Jail, awaiting sentencing on the CSC 1's when
33 the last boy (King) was abducted in Birmingham that Busch used [redacted] to help him just like
34 [redacted] was trying to say during the first interview, when he was talking about being used as a
35 "Lure" by Busch all over Oakland County and along Woodward Ave. We will ship [redacted] DNA
36 swab ASAP to the DNA Lab in Quantico to compare to the white male body hair that was found in
37 the back of Timothy King's mouth during his autopsy. His reaction again today would indicate that
38 he may have indeed been more truthful during that first interview and may in-fact have been
39 involved.

40 **3-19-08: *** (Conference call to Agent MacDonald in New York City about the interview of**
41 **Chris Busch's brother** ** We called Agent MacDonald today and briefed him over the
42 phone on the background of the child killing case and the background of this lead. We also
43 discussed the approach of Busch's brother to "swab" him for DNA and the questions we want
44 MacDonald to ask. We then e-mailed MacDonald approximately 15-20 questions for
45 along with photographs from the suicide scene of his brother. These photos included pictures of the
46 ropes and the drawing of the boy screaming found in his brother's room, along with photos of our
47 victims. Agent MacDonald is prepared and will interview and swab [redacted] next week in
48 New York. MacDonald is going to ship the DNA swab directly to the FBI, DNA Lab in Quantico, for
49 our comparisons.

1 3-19-08: Garry Gray (MSP) & I drove to _____ today. This is the home of
2 Greg Greene's younger brother, _____ We were attempting to "swab" _____ for
DNA and interview him about his brother. There was no one home.

4 We had three phone messages from Greg Greene's older brother _____ when we got
5 back to the Metro North Post. We called him and he asked if this was about a relative. We
6 indicated that it was indeed about his younger brother Greg who died in prison.
7 agreed to meet with us at 11:30am Tuesday March 25th in Flint. He seemed cooperative and willing
8 to talk to us. We will attempt to get his DNA and will interview him about his brother Greg.

9 3-19-08: *** (Identified the Busch's maid from 1978, named _____) *** I had our
10 dispatch perform a check thru the Secretary of State for the name _____
11 _____
12 _____

13 3-20-08: I met with Livonia Police Chief Stevenson and Captains Caid & LaBerge today to brief
14 them on the development of the Busch/Greene lead, the investigation into the lead, where the
15 investigation currently stands and what our future plans are to exhaust the lead.

16 3-20-08: I called Donna Jones today in the records section of the Genesee County Sheriffs
17 Department, who is going to try to locate fingerprint cards on Greg Greene for me. She has to have
18 someone go to an off-site storage facility to check, and told me to call her on Monday and she
19 should have an answer for me.

20 3-20-08: I performed a check thru the Lexis-Nexis system on the Busch's maid,
21 The check resulted with only 2 _____ in Michigan. The first one is the
22 _____ This subject shows no past addresses in Detroit.

23 The 2nd _____ was born _____ rd shows that she is currently deceased.
24 This subject died in 1995 at 79 years old. This subject shows past addresses in Detroit, and may be
25 the _____ that was their maid. The Busch's maid had an address in 1978 of
26 _____

27 **** After closer review of Bloomfield Twp.'s police reports from the suicide of Christopher Busch, it
28 listed the maid, _____ ; a b/f (black female). The black _____ on record in
29 this area is listed as deceased, and would be 95 years old today.

30 3-24-08: Garry called Camp Ojibway today and spoke with Don Mucharin, the Inspector for the
31 Dept. of Corrections who has been our contact for interviewing _____ We explained to Mucharin
32 that we want to talk to _____ ; again, believing he possibly lied during our first interview with him,
33 about him knowing Greg Greene. We explained that we also wish to polygraph _____ ; about his
34 involvement/ knowledge of our case. Mucharin gave the name of a Mr. Fountain, who is in charge of
35 handling _____ Is upcoming parole for The Dept. of Corrections.

36 Garry called and spoke with Mr. Fountain and explained our situation with _____ and our desire
37 to delay his upcoming parole to allow us to continue to investigate him. Garry requested that The
38 Dept. of Corrections, transfer _____ ; to a facility in the Detroit area to allow us easier access to
39 interview and polygraph _____ Mr. Fountain was very cooperative and receptive to this and
40 requested that we put this request into writing for his office. Garry typed and forwarded this request
41 (e-mail) to Mr. Fountain today.

42 Mr. Fountain called back later in the afternoon today and stated that he received our request, it was
43 approved and _____ would be transferred to a facility in the metro Detroit area on April 1st, 2008.
44 _____ will arrive on April 2nd, 2008.

45 3-24-08: I called Livonia Polygraph Examiner Tim Larion today and requested his assistance in
46 polygraphing _____ ; in the next couple of weeks, if possible, in regards to his possible

1 involvement/knowledge in the OCK case. Larion called me back a short time later and agreed to
2 polygraph on April 2nd, 2008.

3-24-08: I spoke with Donna Jones today, from the records department at the Genesee County
4 Sheriff's Department. She stated that she was able to locate fingerprint cards for Gregory Greene. I
5 asked her for their hard copy of the fingerprints to use for a comparison in our case. She stated that
6 would be fine and that I would just have to sign for them. I told her that we would pick those up
7 tomorrow.

8 3-25-08: I requested that Dave Robertson (MSP) forward and e-mail to the St. Clair County MSP
9 Post requesting any mug shots or reports they might have involving their arrests of Dale Arthur
10 Cooper in MSP St. Clair in 1977 & 78. The request was sent.

11 We also sent an e-mail to the MSP Intelligence Unit in Lansing, requesting information on whether
12 is still alive and if so where he currently resides.

13 3-25-08: *** (Interviewed Greg Greene's Brother today and "swabbed" him for DNA)
14 *** Garry Gray (MSP) & I met Robert Greene at the General Motors Metal Fabricating plant in Flint,
15 Michigan today, where works, to interview him about his brother Greg Greene. We
16 introduced ourselves and explained to why we wanted to talk to him. indicated that
17 he knew it was going to be about his brother Greg's possible involvement in the OCK case.
18 indicated that he was willing to talk to us about it. We explained how Mitochondrial DNA works and
19 asked if he and Greg had the same mother, to which he stated that they did. We requested
20 that consent to a DNA Buccal swab for his saliva so we can eliminate his brother as a
21 suspect asked if we would have to dig his brother up, stating that Greg is buried in a
22 cemetery in Macomb Twp. We told that would not be necessary if we had the saliva sample
23 from him, to which agreed to do and gave his consent. We took 2 DNA Buccal swabs from
24 and placed them into evidence after returning to the Michigan State Police Metro North Post.

25) We then started to interview about his brother Greg Greene started by saying that
26 he knew about his brother's lifestyle (Pedophilia) and explained that Greg struggled with that until he
27 died in prison in 1995 began to talk about Greg getting arrested and charged in California in
28 the mid 1970's and stated that Greg had hurt a boy real bad. We asked what happened and
29 he told us that a boy was trying to get away from Greg in California, jumped out of a moving car and
30 got hurt. told us that Greg then dropped the boy off at the hospital and that's how he (Greg)
31 got caught. told us that Greg was sentenced to a mental institution in California for what he
32 had done and explained that after awhile, California wanted "rid" of Greg and made arrangements
33 for him to complete his parole in Michigan. Robert stated that his father had to agree to take
34 responsibility for Greg and pick him up at the airport, if California Dept. of Corrections released him
35 from the mental institution. told us that he was the one who picked Greg up at the airport
36 and when Greg stepped off the plane, he noticed Greg's eyes right away, stating that he
37 had a glazed over or crazy look in his eyes.

38 *** We knew already from reports and statements from Greg himself in 1977, that he had actually
39 choked the boy out in California in an attempt to keep him quiet and then, when he thought he had
40 killed the boy, dropped him off at an emergency room and got caught. Greg was charged in
41 California with 50 counts of child molestation, kidnapping & false imprisonment, when he was sent to
42 Patton State Mental Hospital as a mentally disturbed sex offender.

43 explained that he knew his brother had been investigated by the police for the Oakland
44 County Child Killings and had been polygraphed about it after his arrest in 1977, for molesting some
45 kids in Flint. We asked if he knew Christopher Busch, to which he stated that he knew the
46 name, but did not recognize him after we showed him a photo of Busch. stated that Greg
47 had told him that he (Greg) was always frustrated with the fact that he told the police back in 1977,
48 that Chris Busch was involved in killing those kids and that the police never believed him.
