3-26-08: *** (MSP Forensics Lab in Lansing today, with Busch, Greene & Lamborgine's fingerprint cards) *** Garry & I drove up to the MSP lab in Lansing today to give Fingerprint expert, Michelle Glasgow, Busch, Greene & Lamborgines fingerprint cards today to conduct a comparison on the partial latent print from Kristine Mihelich's coat. We spoke with Michelle Glasgow who showed us the partial latent fingerprint. It appeared to be a fairly clear latent print, but Glasgow explained that she may not be able to make an exact identification with our known suspect prints, but the latent is good enough for elimination purposes. Glasgow explained further that she would also be able to determine if the general pattern of our suspects prints match this latent print. She is going to conduct a thorough examination/comparison with our suspect's fingerprints and would contact us afterwards.

While we were there, and discussing the case with her and showing her some photographs, she stated that we could use their technical support unit to possibly enhance the photograph from Christopher Busch's bedroom to determine if the shotgun shell that was on the desk, is in fact a 12 gauge shell and also if it had contained "#2" shot. This was the caliber and the size of the shot used to shoot our victim, Jill Robinson in the face.

*** If the lab were able to determine that the caliber and size of the shot matched what was used on victim Robinson, this would add credence to the theory that Christopher Busch was possibly laying out clues in his room before he shot himself, as sort of a suicide note. Also found in his bedroom 48 was the drawing of the boy (Stebbins) screaming and the ropes/ligatures laying out in the walk-in bloset. Busch knew how much the police in 1977 thought of him as a suspect, and possibly thought these would be enough clues for the police to put "two & two" together. It is also possible that there

was in-fact a suicide note from Christopher Busch in the bedroom, but the brother who was at the house that day, picked up the note without the officer seeing it. It says in the police report from Bloomfield Twp. PD, when they responded to the call at entered the home with the officer and also entered the bedroom where that

I asked her to explain what the card said. She stated that the 2-3-77 entry, was when he arrived at the jail, then the charges, then where it says Elliott-CC, was the Circuit Court Judge, indicating that Greene was released after his sentencing on 6-17-1977. She stated that it does not appear as if Greene was ever out of the jail between 2-3-77 & 6-17-77 and the card shows 141 days credit for time served, sentenced to "Life" in prison by Judge Elliott. I asked Donna if it was possible that Greene was out of the jail at any time or bonded out and it just didn't get put on the card, to which she stated it was possible, indicating that the cards were only as accurate as the people typing the entries on them, but more than likely if he was out or bonded out it would say that on the card. *** (See copy of this card from Genesee County jail in the Greg Greene file) ***

advised that CHRIS was born in Pontiac, Michigan and prior to the age of ten had lived in Rochester, New York, Short Hills, New Jersey and Germany (in that order). These were all family moves pertaining to their father's career at General Motors. By age ten CHRIS was living in Germany and attending the first grade. While their family was settled in Germany, both. and CHRIS attended a grade school and high school at a boarding school in Switzerland called Le Rosey. After his graduation from Le Rosey (completion of the twelfth grade) CHRIS stayed at Le Rosey as an instructor. CHRIS then returned to the United States and attended Wayne State University in Detroit for one year. CHRIS then transferred to a Culinary Institute in Midland, Michigan from which he eventually graduated. After this, CHRIS worked as a chef at a retirement community in the Detroit area for approximately one year. After this CHRIS, with the financial assistance of his father, opened his own restaurant in Alma, Michigan called "The Scotsman". advised that after CHRIS was indicted for this molestation case (mentioned above) he moved back in with his parents in Bloomfield Hills, Michigan. This was primarily due to the fact that his attorneys and psychiatrists were nearby. It was during this time that CHRIS committed suicide.

described CHRIS overall as a "gregarious and happy guy", who physically was "big and heavy". provided the following as hobbies for CHRIS: food, skiing and riding his motorcycle. Edvised that CHRIS also struggled with problems associated with living overseas and returning to America, stating "it is hard to go back to your own country".

dvised that he had no recollection of CHRIS taking art classes, or of being particularly interested in drawing as a hobby. Both CHRIS and took art classes at boarding school as part of the normal curriculum.

advised that he was present when CHRIS' body was found after he had killed himself. stated that this was a very traumatic experience and he admittedly has blocked some of this experience from his memory.

In regards to why CHRIS would kill himself, _____ 3 advised that he believes it was due to other molestation charges that were about to be filed against CHRIS. seemed to recall a pending case which originated in the Lake Ess area. At the time of his could not recall. When asked if CHRIS could have been bipolar, advised that he never noticed any signs of depression swings from CHRIS, and that he always seemed "easygoing", qualified this by advising that he was seven years older than CHRIS and had his own life - with a job, wife and five year old son. CHARLES further advised that after the molestation charge(s) surfaced against CHRIS he and his wife kept their distance from CHRIS. CHRIS was "shielded" by his parents and their relationship (between and CHRIS) became more "superficial".

advised that CHRIS' attorney at the time of his suicide was Keith Stark who is likely still alive.

could not recall the name of this friend, but described him as being from Middle Eastern descent, and as residing in the state of Michigan for a period of time.

did not recall the name "Greg Greene", nor did he recall CHRIS associating someone by this name.

CHARLES advised that he vacuely recalled a maid who worked at his parent's house named described "Christine" as a black female, and stated that CHRIS was likely friendly with her "given his personality".

RESIDENCES ASSOCIATED WITH CHRIS BUSCH

advised that his parents had two houses they utilized. One was their primary residence in Bloomfield Hills, and the other was a vacation type house they owned near Ess Lake, which was located near Atlanta, Michigan.

advised that CHRIS did visit the house on Ess Lake, and was likely to visit it more when he was living in Midland, Michigan (which was 'CHRIS used to enjoy waterskling and fishing at Ess Lake advised that CHRIS was more likely to go to the Ess Lake house with his brother John, who lived in Flint, Michigan at the time.

advised that he and his wife used to visit the Ess
Lake house often. stated that he and his wife "outfitted"
this house, and would "weekend there" when his parents were overseas.

advised that CHRIS had a house in Alma. Michigan which was the same town his restaurant was located. Advised that he never visited this house, and only could recall visiting CHRIS' restaurant on one occasion.

Regarding a residence in Sanford, Michigan, advised that he had no recall of such a place but that it was likely that this was where CHRIS stayed while at Culinary School in Midland, Michigan.

did recall he and his wife visiting CHRIS one time when he was aroung in Midland. This was the only time he recalled socializing with CHRIS during this period.

Regarding a residence in Whitehall, Michigan, advised that his brothe moved from Flint to Whitehall where ne opened and operated a convenience store.

advised that after CHRIS' suicide "Sam", in addition to "Tabatha", were cared for by his parents. had no idea what happened to these dogs after their death, but advised that his parents were not the type to bury the dogs in their yard.

FEELINGS REGARDING CHRIS BUSCH'S MOLESTATION ACTIVITY

advised that other than when the molestation charge surfaced he had no knowledge of any lifestyle CHRIS had with young boys.

advised that he was "concerned" when CHRIS was charged with molesting a boy. I stated that it "seemed like it happened" and he and his wife were scared for their own son. After these charges surfaced, and his wife had their son see a psychologist and never allowed their son to be alone with CHRIS.

advised that after CHRIS was charged his brother mentioned to him that he believed CHRIS had molested his own two sons to him that he believed CHRIS had molested his own two sons because his sons had informed him of this. I advised that CHRIS never talked to him about molesting children or about him having fantasies of molesting children.

advised that he had no knowledge of CHRIS ever being molested as a child, but that you "just think of boarding school" and think that it could have happened. I had no knowledge of any molestation which took place within his immediate family, or by anyone associated with he and his siblings in their earlier years (ie, family member, teacher or coach).

When asked if CHRIS ever talked to him about this case or his position as a suspect, replied "absolutely not". was asked if CHRIS was capable of these killings and he replied "that he did not think it was in his nature".
