

1 **4-29-08: \*\*\* (Briefed Deputy Chief Don Studt from Birmingham PD on this lead) \*\*\*** We met  
2 with D.C. Studt today at the Michigan State Police Metro North Post and briefed him on the details of  
3 this lead into Chris Busch & Greg Greene. Don was already aware of the beginning of this lead from  
4 a meeting he had back in the fall of 2007 with the King family, including Cathy King. We brought  
5 Don "up to speed" on the lead and requested that he attempt to locate some reports his agency may  
6 have on a child molestation case possibly involving a victim from Birmingham and Christopher  
7 Busch back in 1977-78. We told Don that when the FBI was interviewing Chris Busch's brother  
8 \_\_\_\_\_ s last week \_\_\_\_\_ mentioned a molestation case that his brother Chris was indicted on prior  
9 to his (Chris's) suicide, involving a boy whose mother worked as a cashier at Fishers Meat Market in  
10 Birmingham, Michigan. We have no record of this incident that \_\_\_\_\_ told the FBI about. Don  
11 stated that there was a Fishers Meat Market in Birmingham for many years, but closed down about  
12 ten years ago. Don is going to attempt to locate any Birmingham reports of this incident. Don also  
13 mentioned that "Mohegan" street where \_\_\_\_\_ resided at the time of the King  
14 abduction/murder was right around the corner from the Krogers and Hunter Maple Pharmacy where  
15 Tim was abducted from.

16 **4-30-08: \*\*\* (Task Force Meeting to make our plans for the up-coming search warrant of the**  
17 **Busch home at \_\_\_\_\_ \*\* Present at the meeting**  
18 today along with myself, was Garry Gray & Dave Robertson (MSP) and John Ouellet & Jason  
19 Bollinger from the FBI. We discussed and all agreed that we should have our search warrant "in-  
20 hand" when we approach the people living at \_\_\_\_\_ with the MSP Crime Lab to  
21 conduct a search of this home for evidence. I am going to type the affidavit (probable cause) for the  
22 search warrant from my report on this lead. We will meet with, brief and have an Oakland County  
23 prosecutor review our information for the warrant. We will also have Rob Moran from the Wayne  
24 County Prosecutors Office present at the meeting. After the sealed/suppressed warrant is approved  
25 and signed by a Judge, we will meet with and brief Chief Kurt Bowden from Bloomfield Twp. Police  
26 Department on the approach and search of the Busch home in his jurisdiction.

27 ) We also discussed some of the things we need to do to "tie-up" this lead prior to conducting the  
28 search. We agreed we would call Connie Fisher at the FBI DNA Lab and request that she move the  
29 Busch DNA to the top of her priority list so we could possible have positive results prior to our search  
30 of the Busch home. The following are the remainder of things that need to be done: Locate and  
31 interview \_\_\_\_\_ about Chris Busch, approach Jane Burgesses husband about a possible  
32 confession/admission Busch may have made to \_\_\_\_\_ in 1977 when Burgess was  
33 representing Busch in a criminal (CSC) case, get reports from Birmingham PD and interview the  
34 victim in that case, swab & polygraph \_\_\_\_\_ get copies of police reports from any other  
35 agencies along with transcripts of interviews and put together the search warrant.

36 **4-30-08:** After the meeting, Jason Bollinger (FBI) called Connie Fisher at the FBI/DNA Lab in  
37 Quantico, Virginia and requested that she move Christopher Busch's DNA to the top of her priority  
38 list. Connie stated that she is working on DNA for an upcoming trial that will take her a few more  
39 days, but told Bollinger that she would make Chris Busch's DNA a priority with a turnaround time of  
40 approximately 4-6 weeks.

41 **4-30-08: \*\*\* \_\_\_\_\_ ) sister called back today) \*\*\*** I finally heard back from  
42 Gunnels sister ( \_\_\_\_\_ that resides in Montana. She stated that \_\_\_\_\_ nas  
43 agreed to supply Detectives with a sample of his DNA and also to take a polygraph about having  
44 information in our case. She stated that \_\_\_\_\_ wishes to speak to an attorney prior to doing this,  
45 simply to make sure his rights are protected. I told \_\_\_\_\_ that was fine and asked her how \_\_\_\_\_ is  
46 going to go about getting an attorney, to which she stated that \_\_\_\_\_ told his counselor at the prison  
47 about the situation and about wanting to speak to an attorney about this, but was not getting any  
48 cooperation from them. I told \_\_\_\_\_ that we could call Department of Corrections and see if they  
49 could assist us in supplying \_\_\_\_\_ with an attorney so we could expedite this process, to which she  
50 agreed would be great.

1 I called A.P.A. Rob Moran today at the Wayne County Prosecutors Office and requested that he  
2 secure the Task Force a copy of the transcripts from these motions heard in Judge Kenny's  
3 courtroom on 10-1-07. Rob stated that he would talk to the court report in that courtroom and  
4 request a copy of those transcripts.

5 **5-8-08:** I received a letter in the mail today from \_\_\_\_\_ at the Ryan Correctional  
6 Facility (MDOC). A copy of this letter was also sent to Col. Munoz (Michigan State Police), David  
7 Gorcyca, (Oakland County Prosecutors Office), along with the Parole Board at the Michigan  
8 Department of Corrections. In this letter \_\_\_\_\_ indicates that he is willing to submit to DNA testing  
9 and a take a polygraph test, but only if he can take both through an independent source.

10 I called \_\_\_\_\_ sister in Montana ( \_\_\_\_\_ ) and left a message with her that we already  
11 have \_\_\_\_\_ DNA through the prison system, so the only issue is the polygraph and taking an  
12 independent polygraph is not an option. I stated that we have cleared hundreds of people in this  
13 case using our polygraph examiners and \_\_\_\_\_ either takes the test through us or he is considered  
14 to be refusing to take it, and in that case I guess he is on his own. \*\*\* (See letter in \_\_\_\_\_ file  
15 for further details) \*\*\*

16 **5-12-08:** Garry Gray (MSP) received an e-mail from the Michigan Department of Corrections  
17 Parole Board today, indicating that \_\_\_\_\_ parole has been denied. The e-mail  
18 stated that \_\_\_\_\_ would be up for review again in February of 2009. \_\_\_\_\_ parole  
19 getting denied and the message I left his sister about our polygraph being the only one he can take  
20 and a private polygraph not being an option, we may get now get a response out of  
21 indicating that he wants to cooperate with us and take our polygraph on the OCCK case.

22 **5-16-08:** I was reading through the Livonia Police Investigative report today on the Homicide of  
23 Timothy King and observed something "interesting" in Detective Sergeant Varajon's notes. During  
24 the autopsy of King, the Medical Examiner recovered a hair on the scrotum of the King boy. This  
25 hair was collected at the autopsy by Detectives and is listed on the Michigan State Police Lab report  
26 that contains all the physical evidence collected from King during his (King) autopsy.

27 Three days after the autopsy, Livonia Detectives met with personnel from the MSP Crime Lab,  
28 including civilian Evidence Technician James Hauncher. Detectives were told that the hair found  
29 and recovered from Tim King's scrotum during the autopsy, is suggestive of a human facial hair, but  
30 more testing would need to be done. \*\*\* This is interesting, due to the fact that it appears that Chris  
31 Busch still had his full beard at the time of Tim King's disappearance. The location of this facial hair  
32 on King's body could also be explained, due to the fact that Busch was known to perform oral sex on  
33 his young male victims.

34 **5-26-08: Investigation continues.**

35 **6-10-08:** I spoke with D/Sgt. Garry Gray (MSP) today about this lead. Garry stated that he  
36 received a phone call last week from Connie Fisher at the FBI/DNA lab in Quantico. She stated that  
37 Christopher Busch's DNA, along with several of the other suspects that we submitted have been  
38 compared to the hair from Timothy King's mouth with negative results for a "match." She also told  
39 Sgt. Gray that she is currently processing the partial human hairs that have been recently submitted  
40 for Mitochondrial DNA (recovered during the recent re-examination of the victims clothing) and once  
41 a profile is developed from these partial hair fragments, she will compare Busch and associates  
42 DNA to the DNA profile of these fragments. \*\*\* Not the news we were hoping for, but not completely  
43 bad news. Our suspects DNA will still be compared to the two hair fragments from our victims  
44 clothing. We also have the white animal hairs from 3 of the 4 victims clothing.  
45  
46  
47

1 **6-16-08:** So far, the State Police have been unable to locate the possible human facial hair that  
2 was recovered from Tim King's scrotum during his autopsy in 1977. This hair was tagged by Livonia  
3 Detective Varajon and turned over to the State Police Crime Lab personnel for processing the day of  
4 King's autopsy. Warner Spitz told Detectives at the time this hair was recovered from King, that it is  
5 more than likely a suspect's hair.

6 I called the Livonia Property Officer (Scott Tar), and asked him to see if he can locate this hair from  
7 King that may have possibly been returned to Livonia by the State Police.

8 **6-17-08:** I went to the home of \_\_\_\_\_ today on Reeck Rd in Woodhaven in an  
9 attempt to show him photos of Christopher Busch, Greg Greene,  
10 and others. Ted Lamborgine took \_\_\_\_\_ with him to meet other pedophiles in the metro Detroit  
11 area in the mid to late 1970's, so if there is a connection between Busch/Greene & Lamborgine,  
12 \_\_\_\_\_ may be able to make this connection, especially since it looks as if Busch may have been  
13 involved in a child porn ring with other pedophiles in the area. There was no one home at the  
14 so I left a card in the door for \_\_\_\_\_ to call me. **The only connection so far between Chris  
15 Busch & Greg Greene is from \_\_\_\_\_ who said he thinks he saw Busch & Greene  
16 with Lamborgine, dropping a boy off at a house in the 70's.**

17 **6-18-08:** Officer Tar called me back today and stated that he was unable to locate any evidence  
18 from the 1977 Timothy King Homicide case that may have been returned to us by the state police.  
19 The only evidence connected to the King Homicide, Case # 77-0006883, located in the Livonia  
20 Police property room was evidence collected by me over the past 4 years, during our recent  
21 investigation.

22 **6-23-08:** \_\_\_\_\_ called me today and gave me \_\_\_\_\_ new address, stating that he no  
23 longer lives with them in Woodhaven. She told me that \_\_\_\_\_ is now living at  
24 \_\_\_\_\_ and that he is willing to meet with me. \_\_\_\_\_ is supposedly living with  
25 \_\_\_\_\_ niece \_\_\_\_\_ who has a cell phone number of \_\_\_\_\_

26 **6-25-08:** I "ran" \_\_\_\_\_ through the "Lexis-Nexis" computer database again today in an  
27 attempt to locate him for an interview. He still shows the Berkley address, which is not a valid  
28 address for him. I also ran him through the Secretary of State & L.E.I.N.  
29  
30

31 **6-25-08: \*\*\* Interview of \_\_\_\_\_ today. \*\*\*** I went to  
32 Michigan today and interviewed \_\_\_\_\_. This interview was an attempt to see if there is any  
33 connection between the "Busch & Greene lead" and the "Lamborgine & Moore lead." I showed  
34 photos of Christopher Busch and Greg Greene, both of which \_\_\_\_\_ right away, stated.  
35 he did not recognize either one. \_\_\_\_\_ said as soon as he looked at their photos, "I never seen  
36 them before." I showed him a photo of \_\_\_\_\_ and as soon as \_\_\_\_\_ looked at  
37 his picture he stated, "Yah I know him, I seen him at \_\_\_\_\_ I asked  
38 \_\_\_\_\_ if he was sure he had seen the guy \_\_\_\_\_ in that photo before, to which he stated, yes  
39 he remembers seeing him several times at \_\_\_\_\_ house. I told \_\_\_\_\_ that \_\_\_\_\_ looks  
40 like a lot of teenage boys that might have hung around with \_\_\_\_\_, to which \_\_\_\_\_ insisted  
41 that he knows \_\_\_\_\_ from Moore's house, again stating that had seen him there several times,  
42 drinking in the mid-late 70's when he and \_\_\_\_\_ were both 16-17 years old. I asked \_\_\_\_\_ if  
43 there was anyone else he could think of that was at Bob Moore's on those occasions when he states  
44 this \_\_\_\_\_ was there, that could verify his story. \_\_\_\_\_ said that  
45 \_\_\_\_\_ night remember \_\_\_\_\_ or seeing him at \_\_\_\_\_ house.

46 \_\_\_\_\_ sister-in-law called me after the interview, and stated that  
47 lives in North Carolina and that his real name is \_\_\_\_\_ last name something like \_\_\_\_\_ but she  
48 wasn't sure how to spell it. \_\_\_\_\_ said that \_\_\_\_\_ went by \_\_\_\_\_, but his real name is  
49 \_\_\_\_\_ The last photo I showed \_\_\_\_\_ was \_\_\_\_\_ photo.

1 stated he thought he remembers seeing him at couple of times, but wasn't sure.  
2 " did say that he thought the name sounded familiar too.

3 was present at the interview and took photos of the pictures I showed to so  
4 she can run them by her husband and others that may know these guys. She is going  
5 to call me after she shows the pictures around. \*\*\* No "solid" connection was made during the  
6 interview with today, between the Lamborgine Lead and the Busch & Greene lead,  
7 but reaction to the photos of was interesting. " insisted he  
8 had seen house several times. \*\*\* I didn't get the impression that  
9 was trying to make fit. right away stated he did not recognize  
10 Busch or Greene when shown the photos. We have determined that Busch was into child  
11 pornography, films, magazines, boys being tied up and anally molested. Busch would have  
12 to have a source to obtain this child porn, especially in those days. Just a possibility, but  
13 was someone who would supply area pedophiles with child porn movies & with  
14 boys.

15 **7-2-08: Task Force meeting today at the MSP Metro North Post.** Present at the meeting today,  
16 along with myself was Garry Gray (MSP) and John Ouelett & Sean Callahan (FBI). Callahan took  
17 Jason Bollinger's spot on the Task Force after Bollinger was transferred to FBI Surveillance. We  
18 discussed the Busch/Greene lead today and what we want to do next. Prior to executing the search  
19 warrant at the Busch Home or " we are going to bring in on the  
20 investigative subpoena he is still under and question him further under oath. Ouelett & Callahan  
21 are going to go speak with at the Ryan Facility to see if they can get him to cooperate  
22 further and take the polygraph. I am continuing to type the affidavit for the search warrant. We are  
23 also going to set-up an informational meeting with the prosecutors from Oakland County who will be  
24 reviewing the search warrant, to brief them on this lead and bring them up to speed on our  
25 investigation and plans.

26 **7-7-08: Possible connection.** Garry Gray called me today, and stated that in  
27 response to his e-mail to about the DNA of , he received an e-mail from her  
28 stating the following: She stated that she found in her notes from an interview of in  
29 1991, that when she told him that her husband (Rogers City Policeman) committed  
30 suicide on November 20<sup>th</sup>, 1983 stated to her, "That's interesting, because a friend of mine  
31 killed himself November 20<sup>th</sup>, 5 years earlier." This is the day that Christopher Busch killed himself.

32 This may explain the house near Alpena that were all  
33 referring to that Busch was staying at. It may also be that committed suicide  
34 because of his involvement with Busch & the killings and Helen has been covering for him all  
35 these years. Maybe owned the house outside of town where was  
36 molested by Busch. stated that there was another person in the house and that he  
37 didn't know if it was Busch's house or if Busch just stayed there. Garry Gray told me today,  
38 that he confirmed that did in-fact commit suicide November 20<sup>th</sup>, 1983.

39 **7-22-08:** Garry Gray told me today that had the name Chris Busch "Flagged" in her  
40 notes from the interview and also stated that maybe was telling her someone  
41 else's story when he was discussing the OCKK cases with her during those interviews in the early  
42 90's. Over the years has been very adamant about s being the Oakland  
43 County Child Killer, based on supposed circumstantial information that she developed through  
44 interviews with She has maintained that , has details about the killings that only  
45 the killer could know. The task force investigated in the 90's and  
46

47 \*\*\*\* The current Task Force is going to investigate this possible connection/friendship  
48 between Busch & s independent of \*\*\*

1 7-22-08: I went to The Oakland County Medical Examiners Office today to try to get a copy of the  
2 Autopsy Protocol on Christopher Busch. The death certificate showed that an autopsy was in-fact  
3 conducted by Oakland County M.E. Robert Sillary. This is the same Medical examiner that did Jill  
4 Robinson & Kristine Mihalich's autopsies. The only record that they had in the Busch file was a very  
5 basic Autopsy type cover sheet that said general information, along with a toxicology cover sheet.  
6 The autopsy sheet had Busch's name, M.E. case # 78-2221, 27 year-old white male, the date of the  
7 autopsy, Nov 20<sup>th</sup>, 1978 at 1:00pm, Cause of death (Gunshot wound to the head), manner of death  
8 (Suicide) and was signed by Robert Sillary. The Toxicology report stated that Christopher Busch's  
9 blood alcohol level was a 0.41%, signed by Robert Sillary. I spoke with several employees at the  
10 M.E.'s office and asked about the rest of the report or a more detailed report of the autopsy. I was  
11 told that M.E. Robert Sillary had been fired from the M.E.'s office and his report's or lack there-of  
12 was one of the problems Sillary had there. I was told that the cover sheets are all they have on the  
13 autopsy of Chris Busch. \*\*\* (See copies in Busch file) \*\*\*

14 7-23-08: I identified \_\_\_\_\_ today, who was the next-door neighbor boy of the Busch  
15 family in the 1970's \_\_\_\_\_ was approximately the same age as Chris Busch, but a few  
16 years younger. \_\_\_\_\_ mother still lives in the same house at \_\_\_\_\_  
17 \_\_\_\_\_ had an older brother named \_\_\_\_\_ that died in 1992. These  
18 boys may have known Chris Busch and/or \_\_\_\_\_ s from the neighborhood and \_\_\_\_\_ may be  
19 able to connect Busch & \_\_\_\_\_ through an interview and/or photographs of Busch,  
20 Greene..etc \_\_\_\_\_ is an Opthamologist that lives in Bloomfield hills and practices in Rochester  
21 Michigan. According to the Secretary of State, \_\_\_\_\_  
22 \_\_\_\_\_ a check or \_\_\_\_\_ hrough the  
23 Lexis-Nexis database shows the Mitchell Court address current through July of 2008. This check  
24 also shows another address for \_\_\_\_\_ in at \_\_\_\_\_ It shows  
25 this to be a good address for \_\_\_\_\_ through July of 2008 and shows that this address is a  
26 hospital in Cook County Illinois. There is also a current address as of January of 2008 in this report  
27 that could be his medical practice in Rochester, Michigan. This address is  
28 \_\_\_\_\_  
29 **\*\* Hopefully an interview with this subject will help us  
identify and confirm associates of Christopher Busch and the Busch family. \*\*\***

30 7-25-08: Garry Gray (MSP) had information that Chris Busch and \_\_\_\_\_ may have both  
31 worked at one time, together at either "Biff's" restaurant in Bloomfield or the "Maple-House" in  
32 Bloomfield. Both guys were either cooks or chefs. I performed a "Google" search and a "Lexis-  
33 Nexis" search on both restaurants, neither of which resulted with a positive response.

34 8-13-08: I called and spoke with \_\_\_\_\_ today about meeting with him to discuss  
35 some old neighbors on \_\_\_\_\_, from back in the 70's. \_\_\_\_\_ right away said  
36 you must be talking about the Busch's whose son killed himself back then. I told him that I was  
37 looking for his help in an old case and wanted to meet with him to look at some pictures.  
38 \_\_\_\_\_ stated he would help in any way he can, stating that he moved out of the home on  
39 \_\_\_\_\_ at age 18, in 1974 and doesn't really remember much about the Busch family.  
40 \_\_\_\_\_ stated that his mother who still lives on \_\_\_\_\_ might know more about  
41 them than he does. \_\_\_\_\_ asked if the son who killed himself was a "big guy," to which I  
42 stated he was a heavy-set guy \_\_\_\_\_ said that he kind of remembers him but wasn't sure.  
43 \_\_\_\_\_ stated that he is off work and will be at his home in West Bloomfield next week if  
44 investigators wanted to come by. The \_\_\_\_\_ supplied a home phone number of \_\_\_\_\_ cell  
45 number of \_\_\_\_\_

46 8-18-08: \*\*\* (identified where \_\_\_\_\_ is possibly staying) \*\*\* I have periodically  
47 been checking \_\_\_\_\_ a name in the Lexis-Nexis database and through the Secretary of State to  
48 try to locate him for an interview about Chris Busch. I checked his name in the Secretary of State  
49 Computer today

I performed a check through "Mapquest," which



1 showed this address to be located on the west side of Manistique Lake in the Upper Peninsula  
2 near Curtis, Michigan.

3 **8-20-08:** Garry Gray sent me a copy of an e-mail today that he forwarded to FBI Agent, "Tommy"  
4 McDonald, the agent that interviewed \_\_\_\_\_ for us. Garry is requesting that Agent  
5 McDonald re-approach \_\_\_\_\_ with a few more questions we want to ask him.

6 **8-20-08:** I called and spoke with \_\_\_\_\_ today about possibly interviewing him tomorrow at  
7 his house. \_\_\_\_\_ agreed to speak to us tomorrow morning at 9:00am at his house in  
8 Bloomfield Hills. Garry & I will be going to interview \_\_\_\_\_ and show him some pictures of  
9 Busch, Greene \_\_\_\_\_ etc. \_\_\_\_\_ house is at \_\_\_\_\_  
10

11 **8-21-08: \*\*\* (Interview of \_\_\_\_\_ about Busch) \*\*\* Garry Gray (MSP) & I**  
12 interviewed \_\_\_\_\_ at his home today on \_\_\_\_\_  
13 grew up across the street from the Busch Family, but was 4-5 years younger than Christopher  
14 Busch. \_\_\_\_\_ didn't remember much about Christopher Busch's physical appearance  
15 except that Busch was a heavy-set guy. I asked if he remembers what Chris Busch was driving  
16 back in the 70's, to which he stated he thinks it was a small, blue, older car. \_\_\_\_\_ then told  
17 Detectives that his mother might be able to help us more, being that she was a "stay-at-home" mom  
18 and had dealings with the people in the neighborhood. \_\_\_\_\_ stated that his sister recently  
19 told a story about coming home one day, when she was a little girl, with a Polaroid photo of a man's  
20 genitals and showing their mother. \_\_\_\_\_ did not know where the photograph came from,  
21 but stated that his mom might be able to tell us if she got it from Christopher Busch.  
22 \_\_\_\_\_ also told Detectives about a couple of other mom's in the neighborhood that stayed home during the  
23 day that may have had a closer connection with the Busch family than his family did. He mentioned  
24 the "Savoie" family that own Mike Savoie Chevrolet. \_\_\_\_\_ also mentioned the \_\_\_\_\_  
25 family that lived directly across the street from the Busch's. \_\_\_\_\_ stated that he thinks Mrs.  
26 \_\_\_\_\_ was fairly close to Chris Busch's mother and that \_\_\_\_\_ had boys the same age as the  
27 Busch boys and might be worth us talking to. \_\_\_\_\_ also stated that he believes Mrs.  
28 \_\_\_\_\_ still resides on Morningview Terrace across from the old Busch home. **Even if**  
29 **mother isn't willing to talk to us, maybe the sister would, about whether or not**  
30 **Chris Busch gave her that photograph back in the 70's.**

31 **8-22-08; \*\*\*** I was reviewing the Christopher Busch suicide report that Bloomfield Twp. PD wrote on  
32 November 20<sup>th</sup>, 1978, when I noticed that a neighbor couple, at the time of the suicide, told police,  
33 that they were close with the Busch family and Chris Busch. This was \_\_\_\_\_  
34 that resided at \_\_\_\_\_ right down the street from the Busch family. I  
35 performed a check through the Lexis-Nexis computer database and located both \_\_\_\_\_  
36 \_\_\_\_\_ the results of this check, showed **both of these people to now be DECEASED.**

37 **8-22-08:** I went to \_\_\_\_\_ today in Bloomfield Twp with Livonia Detective Greg  
38 Abraham, and took a few photos of the former "Busch" residence.

39 **8-25-08: \*\*\* Identified \_\_\_\_\_ today possibly living in Texas..**  
40 **criminal history**

41 \_\_\_\_\_ I began searching today, trying to identify \_\_\_\_\_  
42 \_\_\_\_\_ This subject is listed as also being arrested, in the State Police report from 1977, when  
43 Busch & Greene were arrested for multiple counts of Criminal Sexual Conduct in Flint. After Busch  
44 and Greene were \_\_\_\_\_ of involvement in the OCCK case, the newspaper reported  
45 that the 3 Flint men have been cleared. The State Police report has \_\_\_\_\_ listed as arrested, but  
46 does not explain his involvement/connection to Busch & Greene or anything about his charges. This  
47 subject appears to be alive, living in Texas and **needs to be interviewed about his connection to**  
48 **Busch & Greene. \*\*\* (See \_\_\_\_\_ file for Criminal history records and current addresses) \*\*\***  
49

1 **5-1-08:** Garry sent an e-mail today to the MDOC Parole board in regards to helping \_\_\_\_\_ get an  
2 attorney to talk to prior to taking the polygraph and swabbing him for DNA in the OCCK case. Dave  
3 Kleinhardt from the parole board sent an e-mail back stating that he confirmed with the Michigan  
4 Department of Corrections Administrator of Legal Affairs, that they do not provide attorneys or legal  
5 advice to prisoners in such cases.

6 I called \_\_\_\_\_ sister \_\_\_\_\_ and explained this to her. She stated that she is absolutely  
7 going to attempt to retain legal counsel for her brother prior to him taking our polygraph or collecting  
8 her brothers DNA.

9 **5-1-08: \*\*\* (Request made to Midland County Sherrifs Dept. for police reports on Busch) \*\*\***  
10 I called the Midland County Sheriff's Dept. (989-839-4600) today and spoke with "Sally" in records,  
11 in an attempt to get copies of police reports on Busch's CSC case in Midland County in 1977. Sally  
12 stated that they do not keep police reports past 10 years, explaining that they get shredded after  
13 that. She referred me to the Midland County Jail, stating that they may be able to get me a copy of  
14 Christopher Busch's booking photo from 3-4-1977 when he was arrested. She also stated that the  
15 jail would be able to fax me a copy of their arrest/booking report. I called a "Chris" at the jail and left  
16 my name and number requesting copy's of their file # MSO-5651. Sally from records also  
17 recommended that I call the prosecutors office at (989) 832-6722 and speak with "Alice" who may  
18 have the copies of this case. I called and spoke with Alice at the prosecutor's office and she is  
19 attempting to find the file on Chris Busch and will call me back.

20 **5-2-08:** I received a call back today from the manager of the jail in Midland County, Scott  
21 Stephenson (989-832-6688). Scott stated that he does have a file including mug shots of Busch and  
22 would fax it ASAP. I did receive the faxed file from them, which contained their sex-motivated report  
23 on Busch. This report showed that Busch was arrested on 3-4-1977 in Midland County on their 3<sup>rd</sup>  
24 Degree Criminal Sexual Conduct charge, which occurred in Midland County in 1976. This report  
25 shows Christopher Busch, was represented by Attorney Jane Burgess in this case. The victim in  
26 their case was \_\_\_\_\_. The report also shows that Busch, at the time of the offense  
27 was driving a 1975 blue/blue Chevrolet Vega. **\*\*\* (See the Midland County file for further details)**  
28 \*\*\*

29 **5-2-08:** Garry Gray (MSP) called today and stated that he located a receipt that indicates that some  
30 of the physical evidence from the Child Killing case, i.e. Hairs, fibers...etc., may have been sent to  
31 the FBI Lab in 1997 for future DNA processing.

32 **5-5-08:** I received the packet of reports and court/jail information in the mail from the Midland  
33 County Jail today on the arrest of Christopher Busch for Criminal Sexual Conduct in their county on  
34 3-4-1977. This file also contained an original booking photo of Christopher Busch.

35 **5-5-08:** Garry Gray (MSP) called today and stated that he received a lab report from the FBI Lab in  
36 Quantico, Virginia. This report stated that the two partial human hairs found/submitted after the  
37 recent examination of the victims clothing by the Michigan State Police Lab, were not suitable for  
38 microscopic comparison, but have been forwarded to the DNA Lab at Quantico for Mitochondrial  
39 DNA analysis and comparison.

40 **5-6-08: \*\*\* (Interview of \_\_\_\_\_ He is the husband of Jane Burgess (deceased) who**  
41 **represented Chris Busch back in 1977.) \*\*\*** Garry Gray & I went to 535 Griswold St. in Detroit  
42 today (Buhl Building) to the offices of Burgess & Burgess and interviewed \_\_\_\_\_. After  
43 introducing ourselves \_\_\_\_\_ indicated that he knew why we were there because James Feinberg  
44 who represents \_\_\_\_\_, is a partner in their law firm. I explained to \_\_\_\_\_ anyways, why we  
45 were there, the seriousness of the case, the age of the case and the importance of this case to the  
46 families of the victims, whom we, the Task Force, remain in close contact with \_\_\_\_\_. \_\_\_\_\_ stated  
47 that he had discussed this with Mr. Feinberg, could not find any files on this and all he can  
48 remember is that the subject's name was Chris. I explained to \_\_\_\_\_ how I  
49 statements led us to his office, but that it was not his statements alone that brought us there today,

1 as much as the circumstantial case that we have developed on Christopher Busch about the child  
2 killings, since statements, that corroborate what said to the Polygrapher  
3 indicated that he does not have the "Smoking Gun" type statement that we're  
4 hoping for, but stated that if he did he would definitely try to supply us with that information, but  
5 would have to consider is ethical responsibilities in doing so then mentioned that even though  
6 his wife Jane Burgess and her client Chris Busch are deceased, there remains an attorney client  
7 privilege. I explained that Chris Busch was charged in 4 counties in Michigan at one time in  
8 1977 for child molestation agreed to talk with us and help us if he could. I asked how  
9 his wife or law firm came into contact with Christopher Busch, to which he stated that another  
10 attorney friend of his referred Busch to their firm. Mr. Burgess indicated that he normally would have  
11 handled the Busch case, but stated that he was tied up on another case at the time so his wife Jane  
12 represented Chris Busch. stated that his wife did an excellent job representing Chris, stating  
13 that she kept him out of prison, even though Chris was facing some very serious charges.  
14 told us that the Busch family was very wealthy, indicating that Mr. Busch was in a very high  
15 position in the General Motors Corporation. He stated that Mr. & Mrs. Busch paid his firm a lot of  
16 money to represent their son, including flights for Jane Burgess to all the different counties in  
17 Michigan where Chris was charged in stated that the reason Mr. & Mrs. Busch spent so much  
18 money representing their son was not because they cared about him, stating that they were "very  
19 cold" people, but that they were embarrassed by Chris and were only concerned about their  
20 reputation in the community. stated that his wife (Jane) went to the memorial service in 1978  
21 after Chris committed suicide and that Chris's parents would not even approach or acknowledge  
22 Jane's presence because they were afraid others would make the connection to her.

23 mentioned the case against Chris in Montmorency County. I mentioned that it  
24 appears that the Busch parents followed Chris around the state posting bonds for him and cleaning  
25 up his messes. Agair stated that they were concerned about their reputation and did not like  
26 Chris, stating that they old did those things to keep it quiet. I told that Mrs. Busch even  
27 approached one of the boy victims one time and tried to "Pay the boy off" to not testify against her  
28 son. asked if that was the boy from Montmorency, which I stated it was  
29 then started to talk about the cottage the family owned in Montmorency County on a lake,  
30 stating that Chris had offered the cottage to their family to use. Larry stated that he, Jane and their  
31 boys went up and stayed at the Busch cottage (Ess Lake). told us that while they were  
32 at the cottage, Chris stopped over to visit and was staying somewhere in the area. told us that  
33 he had some concerns about Chris being there due to knowing what Chris had been charged with,  
34 but added he didn't feel Chris was the type that could hurt someone. stated that  
35 he thinks that Chris stayed and cooked a meal for his family because Chris loved to cook and was a  
36 chef stated that Chris did not say much to him stating that Chris was uncomfortable around  
37 him and most adults, but remembers that Chris would talk to his wife Jane and really liked her. I  
38 asked if he remembers where Chris was staying at the time and if it could have been in  
39 Alpena, to which he stated, "No, he doesn't remember." I asked if he remembers what Chris  
40 drove to the cottage in that day, to which he stated, "No."

41 began talking again about how much his wife grew to like Chris; stating that because Chris  
42 was a chef and enjoyed cooking, he made a gingerbread house for their family that his wife would  
43 put out at Christmas time stated that his wife was really upset when the kids accidentally  
44 broke it one day after Chris had died. also stated that Chris worked as a chef for the elderly  
45 somewhere in the area where he lives s talked about Chris being a nice guy, kind of  
46 quiet and appeared to be a mild tempered guy, But. Added that he didn't know Chris very well.  
47 Garry asked Mr. Burgess if he knew about Chris being looked at by the Child Killer Task Force at the  
48 time of the killings, to which stated, "No." I asked if he remembers his wife (Jane)  
49 mentioning to him that Chris had been polygraphed about the child killings by the State Police in  
50 Flint a few months prior to Burgess & Burgess getting Chris's case, to which stated, "No."



1 Larry stated that he and his wife Jane definitely had conversations about clients and discussed their  
2 cases, but stated that he just doesn't remember much about their conversations involving Chris.

3 We asked [redacted] if his law firm was using [redacted] polygraph services a lot back then,  
4 to which he stated that yes they were using [redacted] then, stating further that their Law Firm would  
5 never allow a client to take a police polygraph prior to taking a private polygraph. I asked [redacted] if he  
6 remembered his wife telling him that [redacted] had called to tell her that  
7 [redacted] had made mention during the pre-polygraph interview that about possible  
8 involvement in the Oakland County Child Killings, to which [redacted] stated, "No." I told  
9 that during a phone conversation with [redacted] a few months ago, I asked [redacted] how he  
10 knew that Chris Busch had committed suicide approximately a year and a half after he had  
11 polygraphed him? [redacted] stated that he had a conversation with Jane Burgess, shortly after  
12 Busch's death, at which time [redacted] inquired about Busch, to which Jane Burgess told [redacted] that  
13 he [redacted] didn't have to worry about it anymore because the guy killed himself. I asked Mr.  
14 Burgess if he remembers this or his wife discussing this with him, to which he stated, "No." After  
15 some conversation off the subject, I asked [redacted] if he thought that, based on what he knows about  
16 Chris Busch, his family situation and the circumstances of his cases, could he see Chris Busch,  
17 having possibly been involved in the Child Killings? Before I could complete the question  
18 spoke up and stated, "Yes, he could." We terminated the interview at this point and asked  
19 [redacted] to call if he remembers any other information about Chris Busch, to which he stated he  
20 would.

21 Approximately [redacted] and hour after we left the Burgess & Burgess law firm. [redacted] called me and  
22 stated that one of his son's [redacted] remembered what Chris Busch was driving the day he came over to the  
23 cottage on Ess Lake to visit the Burgess's, stating that Busch was on a motorcycle.

24 \*\*\* The information about Chris Busch staying somewhere else in the area of the cottage and  
25 driving a motorcycle over to the Busch, cottage, corroborates what  
26 [redacted] had told us during earlier interviews. [redacted] told us that Chris Busch took him to a house  
27 near town, not too far from the cottage on Ess Lake, where Busch showed [redacted] child pornography  
28 films of boys being tied up and anally molested. [redacted] told us that Busch gave him Marijuana and  
29 beer, undressed him and tried to tie him up and anally molest him. [redacted] stated that he ran from  
30 the bedroom at this house and Busch told another subject in the house that [redacted] did not see, "I'll  
31 take care of this," as Busch ran after [redacted] told us that after Busch caught up with him,  
32 Busch did not force himself on [redacted] also stated that he remembers that Busch had a  
33 lot of "toys" at this house, referring to snowmobiles, motorcycles...etc. When we interviewed [redacted]  
34 [redacted] about the cottage on Ess Lake [redacted] kept saying that he was never at a cottage,  
35 stating that he thought it was a house that Busch lived in with another guy.

36 **5-7-08:** Garry Gray (MSP) and Jason Bollinger (FBI) went to the Detroit office of the FBI today to  
37 research their files regarding the MSP report Sgt. Gray found indicating that some of the physical  
38 evidence (hairs, fiber..etc.) from the child killing case had been forwarded to the FBI for future DNA  
39 analysis and comparison.

40 **5-7-08:** While I was writing the Affidavit for the search warrant today for the upcoming search of  
41 Busch's home in Birmingham, I was reviewing my report from the fall of 2007, when I noticed  
42 something that contradicts what [redacted] has been maintaining about not taking a confession from  
43 Busch during the pre-polygraph in 1977. According to my notes on 10-01-07, in the Livonia report  
44 on this lead, I wrote that [redacted] attorney, while arguing his motions on the record in front of Judge  
45 Kenny, stated that in 1977, when Jane Burgess brought her client to [redacted] for a private polygraph,  
46 it was in regards to a separate CSC charge unrelated to the child killing case. Attorney Feinberg  
47 went on to say that it was during the pre-polygraph interview on this separate CSC that this subject  
48 confessed to the child killings. My notes also indicate that Feinberg's statements about his client  
49 were made on the record.

1 **8-28-08:** \* was re-approached today about taking the polygraph. \*\*\* John Ouellet &  
2 Sean Callahan (FBI) went to see today at Ryan Correctional, about taking the  
3 polygraph in the OCCK case sister, a few months ago, talked out of taking the  
4 test. needs to be polygraphed about possible having information from Busch and/or  
5 Greene about the OCCK case. After a brief discussion with , he agreed to take the  
6 polygraph, but stated he was going to talk to his sister in Montana first. Until he can be cleared by a  
7 polygraph, he will still be considered a possible suspect in the OCCK case and his parole will  
8 continue to be denied.

9 **9-15-08:** I have spent the last 6-8 weeks, typing the template that we will use for the affidavit to  
10 search Busch's home on ( pulled out the most important information from the  
11 70-page report on this lead and put it into a 15-page affidavit to use as a guide while constructing  
12 the final draft of the affidavit & search warrant.

13 **9-23-08:** The Task Force met today and, using this template, we put together a brief, 6-page  
14 search warrant & affidavit to present to the Oakland County Prosecutors Office for approval to  
15 search Busch's home on . Garry Gray (MSP) is going to make arrangements  
16 with the MSP Forensics Unit (Crime Lab) to conduct the search of Busch's former home. Present at  
17 this meeting, along with myself, was Garry Gray & Dave Robertson (MSP) and John Ouellet & Sean  
18 Callahan (FBI).

19 **9-29-08:** As of today's date, we have not yet heard back from or his sister in  
20 regards to taking the polygraph. John Ouellet (FBI) is going to call sister and return  
21 to the prison to talk to about this.

22 **10-1-08:** As of today's date, we still have not heard back from or his sister about taking the  
23 polygraph. Meanwhile , remains in prison and will continue to have his parole denied until  
24 he can be cleared in the OCCK case. Because of his refusal to take the polygraph, the task force  
25 cannot clear him, so he remains a suspect in the case and could remain in prison until his maximum  
26 "out-date" which is 2027. If he takes the polygraph and is cleared, he is no longer a suspect and can  
27 be immediately paroled. \*\*\* It's interesting, because he claims to have no involvement or  
28 information about the case, yet he won't take the polygraph to clear his self and be released  
29 from prison spent a lot of time with Busch & Greene in the late 70's. He was a  
30 victim of both men and was the only one, of all the children they molested, that was  
31 approached by Busch's mother, attempting to pay to keep quiet about her son.\*\*\*

32 **10-2-08:** \*\*\* More physical evidence was located today at the FBI storage facility in Detroit,  
33 including the human hair recovered from King during the autopsy \*\*\* Garry Gray (MSP) &  
34 John Ouellet (FBI) went to the FBI office in Detroit today to pick-up some trace evidence that has  
35 been stored at this facility for many years. While recovering this property, they found packages  
36 containing animal hairs that had been recovered from Jill Robinson's jacket during her autopsy  
37 during the original investigation. \*\* This means that animal hairs have now been found on ALL  
38 four victims clothing. Prior to finding these hairs, it was thought that only 3 of the 4 victims  
39 clothing had animal hairs (white dog hairs) on them. Garry & John found more evidence at  
40 FBI lab in Detroit. Along with the animal hairs, they found the human hair that had been recovered  
41 from the genital area of Timothy King during his autopsy March 23<sup>rd</sup>, 1977. The M.E., Warner Spitz,  
42 stated in his report that he believed this to be a suspect hair, due to the fact that the victim did not  
43 yet have hair in his genital area. This hair had, originally been collected at the time of King's  
44 autopsy by State Police Crime Lab personnel. On March 28<sup>th</sup>, 1977, Livonia Detectives received a  
45 report from the State Police Crime Lab, stating they believe this hair to be a human facial hair. Until  
46 today, we have been unable to locate this hair. It does not appear at this time that this hair has  
47 been processed for DNA and may be the single piece of physical evidence needed to solve  
48 this case.

1 **10-6-08:** I met with Rob Moran from the Wayne County Prosecutors office today and picked up  
2 copies of the transcripts from the motions with Attorney Feinberg involving his client  
3 back in October of 2007. These transcripts had been previously ordered sealed by the court of  
4 appeals. Judge Kenny signed an order to release a copy of the transcripts for investigators for  
5 investigation purposes.

6 **10-6-08:** John Ouellet called me tonight and stated that he spoke with  
7 who resides in Montana. John said that \_\_\_\_\_ told her that her brother has been approved  
8 for parole by the parole board. As far as the task force knew, \_\_\_\_\_ would not be paroled until he  
9 cooperated in the OCK investigation into Busch & Greene and took a polygraph to clear him. John  
10 stated that the sister indicated that she still might have \_\_\_\_\_ cooperate and take the polygraph,  
11 prior to leaving Michigan. I called and left a message for Garry Gray (MSP) to see if he can contact  
12 the parole board in Lansing and find out if \_\_\_\_\_ has in-fact been paroled and will be leaving the  
13 state soon?

14 **10-7-08:** I spoke with Garry Gray. He confirmed that \_\_\_\_\_ is due to be paroled in approximately  
15 3 weeks. \_\_\_\_\_ contacted Lt. Dykstra (MSP Polygraph Examiner), who agreed to administer the  
16 polygraph to \_\_\_\_\_ on Friday October 10<sup>th</sup>, 2008. \_\_\_\_\_ taking the polygraph also depends on  
17 whether or not his sister in Montana allows him to take it. She is still acting as his attorney and  
18 advising him on this matter. Garry contacted the inspector at the Ryan Correctional facility, where  
19 \_\_\_\_\_ is housed and requested that the inspector asked \_\_\_\_\_ if he's willing to take the  
20 polygraph on Friday. The inspector called Garry back and told him that \_\_\_\_\_ said he would  
21 consider taking the test on Friday, but wanted to run it by his sister first and would let the inspector  
22 know tomorrow.

23 **10-7-08:** I then called \_\_\_\_\_ on her cellphone and left a message about this. To make sure  
24 she heard it from us first, so she didn't think we were trying to trick her brother or go around her on  
25 this. I informed her that we have a polygraph scheduled for Friday Oct. 10<sup>th</sup> and when her brother  
26 passes and cleared, he can be paroled in just a few weeks afterwards.

27 **10-7-08: \*\*\* Notified Oakland County Prosecutor's Office today about this lead & requested to**  
28 **meet with them \*\*\*** Garry Gray, contacted Assistant Oakland County Prosecutor "Ed" Cybor today  
29 to set a time for the Task Force to come in and meet with, brief them and get approval for this  
30 search warrant for Busch's home. Garry gave Cybor a few details about what this search warrant  
31 has to do with. A meeting was scheduled for Tuesday October 14<sup>th</sup>, 2008 at 1:00pm.

32 **10-8-08: \*\*\*** \_\_\_\_\_ agreed to take the polygraph \*\*\* John Ouellet (FBI) called me today and  
33 stated that he spoke with \_\_\_\_\_ and \_\_\_\_\_ sister, \_\_\_\_\_ and that \_\_\_\_\_ as  
34 agreed to take the polygraph scheduled for 10:00am Friday October 10<sup>th</sup>, 2008. I talked to Garry  
35 Gray (MSP) today who stated that he has already obtained a "writ" for \_\_\_\_\_ to take the  
36 polygraph.

37 **10-10-08: \*** \_\_\_\_\_ took the polygraph today at the MSP Northville post \*\* \_\_\_\_\_ ook  
38 the polygraph today at the MSP 2<sup>nd</sup> District Headquarters in Northville, Mi. D/Lt. Robert Dykstra was  
39 the polygraph examiner that conducted the test. During the pre-test interview and some pre-test  
40 questioning, \_\_\_\_\_ was acting very nervous and asked Agent John Ouellet (FBI) 3 times, "what  
41 happens if the test is inconclusive?" **Inconclusive is a police term. He's been talking to**  
42 **someone prior to the tes** \_\_\_\_\_ kept holding and reading the bible in the room during breaks,  
43 prior to taking the test and looking back at the bible in the room while answering questions. At one  
44 point during the pre-test, Gunnels was shown a photograph of the 4 victims from the OCK case  
45 and became very upset, asking, "how do I know whether or not these are the same four kids?"

46 Lt. Dykstra showed \_\_\_\_\_ a photo of Greg Greene, but never told \_\_\_\_\_ who it was in the  
47 picture. \_\_\_\_\_ has maintained all along that he doesn't know Greene. \_\_\_\_\_ became upset  
48 about these photos and demanded to talk to Agent Ouellet who was in the other room, along with  
49 other Task Force members, observing the pre-test questioning on CCTV. When Ouellet entered the

1 room, upset, stated, " what are they doing showing me a picture of Greg Greene, indicating  
2 he does in-fact know Greene.

3 ) Lt. Dykstra then administered the polygraph to about his involvement in, and/or having  
4 information about the child killings. After the test was completed, Lt. Dykstra reviewed the polygraph  
5 charts and determined the  
6  
7  
8

9 Prior to receiving the results of the test, Agent Ouellet, "swabbed" the inside of  
10 cheek for DNA. This swab was then packaged, initialed and turned over to Sgt. Gray (MSP), to be  
11 shipped to the FBI Lab in Quantico Virginia for analysis and comparison.

12 After the test, when reviewing the results with he denied purposely holding his breath  
13 and sabotaging the test, but later told Agent Ouellet and Sgt. Gray that his cellmate had talked to  
14 him about how to beat a polygraph. This would match using the term "inconclusive" prior to  
15 taking the test. **\*\*\* It's interesting that after all this time of insisting he had nothing to  
16 do with the child killings or held any information about them**

17  
18 at this

19 point, is still not "cleared" in the child killing case and is considered a co-suspect.

20 **10-13-08: \*\*\* Garry Gray & I briefed the State Police Crime Lab director and scientist today**  
21 **on the upcoming search of Busch's home \*\*\*** We met today with the director of the lab, D/Lt.  
22 Charlie Morden, Heather Vitta from the DNA unit and Guy Nutter from the Trace Evidence unit. We  
23 briefed them on this lead, showed them pictures of Busch's home and explained what type of  
24 physical evidence it is we are looking for and why. They explained some of the methods they would  
25 use to collect hairs & fibers in the home and the possibilities of finding and recovering this evidence.  
26 They are going to purchase a vacuum to be used specifically for the search of this home, which will  
27 include vacuuming the air-duct system of the home, pulling back carpeting & baseboards... etc.

28 **10-14-08: \*\*\* Today it was determined that Greene was possibly out on bond at the time of**  
29 **King's abduction \*\*\*** Garry Gray was reviewing some old notes today from Task Force Detective  
30 Doan (Southfield PD) and observed where Doan had written the following statement: "Greene was  
31 sent to Jackson Prison on 6-17-77. "Out on bond till then." This means that Greene may have  
32 posted bond sometime between February of 1977 and when he went to prison in June of 77. King  
33 was abducted and killed in March of 1977.

34 **10-14-08: \*\*\* Met with Oakland County Prosecutors today, presented our case and requested**  
35 **approval to search Busch's home. \*\*\*** The Task Force met with Assistant Oakland County  
36 Prosecutors Ed Cybor & Gary Tunis today. Present from the Task Force, along with myself was  
37 Garry Gray & Dave Robertson (MSP) and John Ouellet & Sean Callahan (FBI). We briefed them on  
38 this lead, what we've developed, how it was developed, showed them pictures and explained why  
39 we want to search the Busch's home. They were very interested and stated they would look it all  
40 over and get back to us. Tunis indicated that he didn't see any reason that they wouldn't approve  
41 the search warrant, but simply indicated that a few changes and additions would have to be made to  
42 it first. Tunis further stated that it sounded like plenty of probable cause existed to search this home.

43 **10-15-08: \*\*\* Kym Worthy offered today, to convene a Grand Jury in this case to compel**  
44 **those like Cabot and maybe others to answer questions**  
45 **truthfully in regards to this case or face jail time. I relayed her offer to Sgt. Gray (MSP).**

46 **10-16-08: I was reading through some of the reports on Busch from 1977, and found the sex**  
47 **motivated report that was filled out by Midland County Sheriffs when Busch was charged. In this**  
48 **report it states that Busch's parents attempted to "buy off" the victim in this case. The victim in this**



1 case was \_\_\_\_\_ This matches what \_\_\_\_\_ told Sgt.'s Williams & Gray during an  
2 interview with \_\_\_\_\_ at Camp Ojibway in March of 2008 \_\_\_\_\_ told investigators that Busch's  
3 mom came to Flint in a limousine, called him over to the car and tried to pay him off.

4 **10-17-08:** I called Huntington Beach PD in California today and spoke with a Yolanda in the  
5 Records Bureau. She looked up Greg Greene's case from 1974, when he was charged with  
6 Kidnapping, False Imprisonment and numerous counts of Child Molestation. Yolanda stated that  
7 due to the seriousness of this case they did save it and have the originals files available. I faxed a  
8 written request for the entire file on Greene. She stated that a detective at their department would  
9 look over my request and make contact with me about getting a copy of their files.

10 **10-20-08: \*\*\* (Received the Huntington Beach PD reports today, on Greene's arrest in 1974,**  
11 **for multiple CSC's in Huntington, California) \*\*\*** This police report, outlined the investigation into  
12 the incident that led to Greene being arrested, charged with 45-50 counts of Child Molestation, False  
13 Imprisonment, attempted murder and then being sent to a state mental hospital where he did only 6-  
14 12 months and was released. During the interview of Greene, after his arrest, he named at least 15  
15 young male victims that he had molested and sodomized many times, adding that he had molested  
16 children over 200 hundred times while in California. Greene told police he worked with a pedophile  
17 friend named \_\_\_\_\_ who ran the baseball league that Greene coached in. Greene told police  
18 that \_\_\_\_\_ was also a pedophile and gave Greene a job coaching in ex-change for Greene bringing  
19 young boys to \_\_\_\_\_ for him to molest.

20 The incident in which Greene was arrested and jailed for, involved a 12 year-old, w/m victim  
21 named \_\_\_\_\_ of Fountain Valley, California. Greene took this boy out to a drive  
22 in, got him some alcohol and marijuana and then, after dark, told the boy that they were going to go  
23 retrieve a bicycle that Greene had stolen earlier and stashed near the baseball fields. Greene took  
24 this boy to the wooded area of the fields, near the San Diego Freeway and began to molest him.  
25 Greene performed oral sex on this boy then the boy became uncooperative. **Based on admissions**  
26 **to the police by Greene, about anally, sexually molesting boys that is probably what Greene**  
27 **was attempting to do when this boy became uncooperative.** Greene told the police that he  
28 struck the boy in the neck to keep him quiet and then put his hand over the boy's mouth until he was  
29 quiet. The doctors determined that the boy had actually been strangled by Greene and showed  
30 abrasions on the inside of the mouth where Greene had held his hand over the boy's mouth.

31 After the boy was unconscious or dead, Greene held a lit cigarette up to the boys nose in an  
32 attempt to wake him. When this didn't work, Greene pushed the lit cigarette into the skin on the  
33 boys "belly" 3 times attempting to see if the boy would wake up or was alive. Greene, then drug the  
34 boy through the woods & field to his car and dumped him face down in the back seat of his car.  
35 Greene then drove around L.A. trying to figure out what to do with this boy. Greene eventually drove  
36 near an area hospital and dumped the boy, who was still unconscious, on the grass around the  
37 corner from the hospital. **Greene did not know whether the boy was alive or dead at this time.**  
38 Greene then drove across the street from the hospital to a payphone and called the hospital about  
39 this boy, stating that he found the boy unconscious and he thinks he needs help. Greene did not  
40 give his name. After driving around, Greene checked to see if they found the boy and they had not,  
41 so he called again. The boy was eventually found, was alive and treated. **This M.O. of Greg**  
42 **Greene's (or handling of the victim) is very similar to OCK case, in regards to the age of the**  
43 **boy, anally molested, strangled/suffocated and dumped in an area where they would be**  
44 **found. (See Huntington Beach Police Department's report for details. Busch has also put his**  
45 **hand over a boy's mouth to keep him quiet when he was screaming. Busch did this t**  
46 **\_\_\_\_\_ at Busch's house in Alma when Busch was trying to anally molest \_\_\_\_\_ (See**  
47 **interview transcripts of \_\_\_\_\_ interview at Camp Ojibway for details.**

1 **10-21-08: \*\*\* Briefed Oakland County Prosecutor David Gorcyca on upcoming search**  
2 **warrant \*\*\*** Garry & I met with Oakland County Prosecutor David Gorcyca today, briefed him on  
3 this lead and discussed how the search warrant was going to be handled. Also at this meeting was  
4 Assistant Oakland County Prosecutors, Gary Tunis & Ed Cybor. Gorcyca was very encouraged by  
5 this lead and said that it was the best lead he has seen in the OCKK case in the 13 years he's been  
6 around Oakland County.

7 **10-21-08: \*\*\*** sister, I, called me today about the results of the  
8 **polygraph test) \*\*\*** She stated that she spoke with and he told her that no one at the prison  
9 is doing anything to get paroled. I explained to that did not keep his end of the  
10 bargain by taking the polygraph. I explained that he purposely sabotaged the test by moving,  
11 holding his breath and taking short, quick breaths during the questions. She asked how we know he  
12 did this on purpose. I explained that the examiner is a seasoned veteran examiner and that the  
13 charts revealed had done this on purpose. I also explained that himself told Detectives  
14 after the test that his cell-mate had schooled him on beating a polygraph by getting an inconclusive.  
15 I told that it's interesting that he would need to learn how to beat a polygraph after he insisted  
16 for months that he has no information, nor was he involved in the OCKK case and that's solely what  
17 the test is in regards to. I explained that we are not going to assist in getting paroled until he  
18 can take the test and answer the questions properly. She said okay and that she would be in touch.

19 **10-22-08: \*\*\* (Re-interviewed Greg Greene's brother today) \*\*\*** I spoke on the  
20 phone today with Greg's brother and asked him again if he, Greg and their other brother  
21 all had the same mom & dad, to which stated they did. He said that their family lives  
22 in Detroit until the late forties/early fifties when the family moved to Flint. I mentioned Greg telling  
23 the police in 1977, that he and his father would go visit relatives and friends in  
24 Detroit. stated that their father's brother (their lived in the Farmington Hills  
25 area, but stated that it could have been Farmington, Livonia, stating that he wasn't sure but would  
26 check and call me back s stated that they would visit their uncl. and his sor. ....  
27 ) occasionally and gave me the route they took to get there from Flint.  
28 said that they would come down 23 to eastbound I-696 into Farmington Hills to get to the house. I  
29 asked if they came down I-275, to which stated he didn't think that that highway was  
30 complete at that time stated that their mother had relatives in the area too, named  
31 " I asked about any friend that Greg or their family might have had in the  
32 Ferndale area, to which stated he doesn't remember anything like that. I asked if he  
33 remembers the long letter that Greg sent them from prison, outlining his life, to which stated  
34 he did, stating further that his brother had thrown it away after Greg died stated that  
35 his brother told him that he threw it away because he didn't want his own kids to see  
36 the contents of the letter. I asked to talk to and see if he remembers anything in the  
37 letter Greg wrote, stating that he had information about our killings or that Busch told him he did it,  
38 anything like that. stated he would talk with and call me back.

39 **10-23-08: \*\*\* Faxed request to Patton State Mental Hospital in California for Greene's**  
40 **records. (See copy of faxed request in Greene's file and in binder under section for Greene).**

41 **10-24-08: \*\*\* (Received a copy of Greene's records from Patton State Hosp. Today) \*\*\*** The  
42 woman I spoke to at Patton State Hospital ( ), informed me that the file they sent  
43 me on Greene is what they call a "skeleton file." It is called this because it was an old case and  
44 had since been cleaned out, except for the basics, for storage purposes. This file did include intake  
45 and discharge information along with a detailed case summary on Greene. (See this record in  
46 Greene's file or section in Binder on Greene). This file, showed that Greene had been sentenced to  
47 Patton State Hospital on 1-28-75, by Judge Kenneth E. Lae.

48 **10-27-08:** Garry Gray, Dave Robertson (MSP) & I, met with Oakland County Prosecutor Dave  
49 Gorcyca today to discuss the plan for notifying the family in the home we are going to search on

1 Wednesday, October 29<sup>th</sup>, 2008. Also present at this meeting was Deb Carly, Gary Tunis & Ed  
2 Cybor from The Oakland County Prosecutors Office.

3 **10-28-08: \*\*\* Got the search warrant for Busch's home, signed today in 48<sup>th</sup> Dist. Court \*\*\***

4 Garry & I met with Oakland County APA Gary Tunis today and reviewed the search warrant for  
5 in Bloomfield Township. Once the search warrant was finalized, and approved  
6 by the prosecutor, we took it to the 48<sup>th</sup> District Court to be approved and signed by Judge Kimberly  
7 Small. Judge Small read the warrant and we gave her a brief overview of our case and the probable  
8 cause that we have to search the Busch home. She approved & signed the search warrant. Judge  
9 Small also approved the sealing of this warrant, along with the tabulation due to this being an on-  
10 going investigation. Judge Small was excited about what we had developed in this old case and the  
11 potential to possibly, finally solve it and bring closure to the families of the victims. She agreed that  
12 more than enough probable cause existed to search this home, even though the crimes were  
13 committed more than thirty years ago.

14 **10-29-08: \*\*\* Executed the Search Warrant today on Busch's home on Morningview Terrace  
15 in Bloomfield Twp. \*\*\*** We met at 0830 this morning at 15 Mile Rd. & Lahser for a pre-search

16 warrant meeting. The following were involved in this warrant execution: D/Sgt. Williams (Livonia  
17 PD), D/Sgt.'s Gray & Robertson (MSP), David Gorcyca (Oakland County Prosecutor), Chief Kurt  
18 Bowden (Bloomfield Twp. PD), Capt. Steve Cook (Bloomfield Twp. PD), Det. James Hoffman  
19 (Bloomfield Twp. PD), Agent Sean Callahan (FBI), along with 4 Crime Scene (Forensic) specialists  
20 from the Michigan State Police Northville Forensics Lab. Gorcyca spoke with Jonathon Jones, the  
21 attorney for the family that currently owns the home at

22 Gorcyca informed Jones that the Task Force is in possession of a valid search warrant,  
23 signed by Judge Small of the District Court in Bloomfield Twp. Jones wanted Gorcyca to sign an  
24 agreement that the Michigan State Police would pay for any damage that is sustained during the  
25 search, and would make the arrangements for these repairs to be made in prompt fashion. Gorcyca  
26 & the State Police agreed to this and signed the agreement at the house prior to the search. The  
27 homeowners agreed to give consent to search the home and signed a consent form. The  
28 homeowners then took the State Police Forensics people on a tour of the residence to show them  
29 what changes have been made structurally and what area's of the house has not been touched.

30 The trace evidence & DNA lab personnel then searched the home at

31  
32 All three floors of this home  
33 were completely searched for the Lab personnel used  
34 brand new clean vacuums to conduct this collection of evidence during their search. For integrity  
35 reasons, Gray, Robertson along with myself remained outside the home until the search was  
36 complete and the lab personnel had exited the home. Inside the home, with the lab personnel  
37 during the search were Special Agent Sean Callahan (FBI) and 2 officers from Bloomfield Twp. PD,  
38 Captain Cook & Detective Hoffman.

39 After the search of this home was complete, the Lab personnel had collected numerous bags of  
40 assorted hairs, fibers, animal hairs...etc. This evidence was all collected, packaged separately from  
41 different locations in the home, sealed and marked. At the Northville Laboratory, the evidence  
42 removed from this home will be separated, sorted and compared to

43 A tabulation or "Return to search warrant" was completed, listing all  
44 items removed from the home.

45 **11-14-08: \*\*\* Update on evidence from** \*\* Garry Gray (MSP) called me  
46 today to update me on the status of the evidence from the search warrant on  
47 Garry said that he received a "price-list" from the lab in California (Gen-Quest). This is the lab that is  
48 going to process our s for Mitochondrial DNA. It supposedly is going to costs thousands  
49 of dollars to produce the DNA profiles and do the comparisons. Garry said that his command at  
50 MSP has discussed this and agreed to proceed with the testing, even though it may be costly down

1 the road. Garry told me that he has been in contact with the lab people that did the search and that

2  
3 Garry stated that they have two brand new microscopes at the lab that they will be using to  
4 microscopically examine the \_\_\_\_\_; from the Busch home. The lab personnel are still sorting  
5 and separating this evidence and will soon begin comparisons. If they find \_\_\_\_\_ that are  
6 microscopically similar in nature to the animal hairs found on our victims clothing, they will be  
7 forwarded to the Gen-Quest lab for Mitochondrial DNA typing. Dr. Joy Halverson, who is world  
8 renowned, will be the scientist at Gen-Quest performing the DNA work on the animal hairs.

9 **11-17-08:** I forwarded \_\_\_\_\_ address to Garry today at MSP so he can send a lead to  
10 the State Police Detectives in the Upper Peninsula. They are going to go to make contact with  
11 \_\_\_\_\_ at his home and see if he is willing to meet with Garry & I to talk about Chris Busch &  
12 possibly Greg Greene. I also asked Garry about whether or not \_\_\_\_\_ DNA Buccal Swab had  
13 been shipped to the FBI Lab in Quantico yet. Garry stated that \_\_\_\_\_ DNA Buccal swab has in-  
14 fact been shipped to Quantico for testing.

15 **12-2-08:** I spoke with Garry Gray (MSP) today. He said that there has been a change of plans and  
16 that the \_\_\_\_\_; are all going to go to the FBI Lab in Quantico, Virginia for microscopic  
17 comparison now instead of their lab doing it. The MSP Lab personnel in Northville will package-up  
18 all the \_\_\_\_\_; and ship it all to the FBI Lab in Quantico. Garry said that any \_\_\_\_\_; FBI  
19 determines are similar in nature, will be packaged and sent to Gen-Quest in California for DNA  
20 analysis.

21 **12-4-08:** I had a brief conversation today with \_\_\_\_\_; She sent me an e-mail that said that  
22 she found an interview she had done in the past with \_\_\_\_\_; father. She had asked him if he  
23 knew any of the rich auto executives that live in his neighborhood, to which he stated, "well, I knew  
24 \_\_\_\_\_; This is Chris Busch's father, \_\_\_\_\_; The Busch family lived in the same  
25 neighborhood as \_\_\_\_\_; just a short distance away on Tuckahoe. If this statement is true,  
26 it substantiates a possible connection between \_\_\_\_\_; & Chris Busch. Earlier this  
27 year, \_\_\_\_\_; told Sgt. Gray that \_\_\_\_\_; told her that he had a good friend that  
28 committed suicide November 20<sup>th</sup>, 1978 (The day Chris Busch died). The task force has  
29 theorized the possibility that \_\_\_\_\_; , when describing any details about the OCCK  
30 case, was telling someone else's story.

31 **12-4-08:** I spoke with John Ouelett (FBI) today. He is going to have Sean Callahan (FBI) forward  
32 an e-mail to Agent "Tommy" MacDonald in New York to re-interview Chris Busch's brother,  
33 We are going to have MacDonald ask \_\_\_\_\_; some more questions about a possible suicide  
34 note and if he would be willing to take a polygraph. We are also going to ask him if he, Chris or any  
35 of the other brothers or parents were connected to or knew the \_\_\_\_\_; family, specifically  
36

37 **12-10-08:** I spoke with \_\_\_\_\_; today, with some more questions about Christopher Busch.  
38 Dr. Garretson stated that his mom and sisters \_\_\_\_\_; have information about the Busch family  
39 and Busch boys and stated that they were "creeped-out" by them. He suggested I call his mother  
40 and set-up an interview with her and the sisters, stating they would be glad to try and help. The  
41 mom \_\_\_\_\_; ) still lives across the street from the Busch home and has a number of \_\_\_\_\_;  
42 \_\_\_\_\_; s sister \_\_\_\_\_; lives in the Detroit area and has a number of \_\_\_\_\_;

46 **1-08-09:** I was searching through the MSP tip file disc today, checking to see if Busch or Greene  
47 were listed as associates of any other suspects called in on tips to the State Police back in the 70's.  
48 I found both Busch & Greene were listed 1 time each as associates of someone called in on a tip.  
49 There is no suspect name listed on either one of these tips, but the person that called them in was



1 the same person, a  
2 n. I found a 73 years old, living at  
3 no phone number listed at that address. These tips were #'s 23423  
4 & 23487. I ran this which showed  
5

6 1-12-09: I talked with Garry Gray (MSP) today about these two tips associated with Busch &  
7 Greene. Garry searched the actual tip files and stated that the numbers for actual files that were  
8 investigated & written-up only go as high as the 18,000 range. These tips must have come in, in the  
9 late seventies or early eighties.

10 1-12-09: I found a couple of possibly old phone numbers for Ward T. Chapman in the Flint area  
11 and called and left messages for Mr. Chapman to call me. These numbers are listed  
12 for an to at  
13 Michigan. Later this afternoon, I spoke with a who called and stated her dad  
14 was at a funeral, but she would pass the message along and have him call me. She  
15 asked what this was in regards to, and I told her it was about some old information her dad supplied  
16 the police back in the 70's. She stated that I was in luck because her dad has a fantastic memory.

17 1-12-09: I spoke with today on the phone. He stated that he was a Prosecuting  
18 Attorney for Genesee County at the time he called in those tips to the Task Force.  
19 believed that it was approximately 1977 when he called the tips in. He said that an anonymous  
20 caller called their prosecutors office stating that they know who is killing the kids in Oakland County  
21 and gave some information about this. I told him that Chris Busch & Greg Greene are mentioned on  
22 his tip and that they were both charged with child molestation in Genesee County in 1977.  
23 could not remember the name or names given and stated that Busch & Greene does not  
24 "ring a bell" with him, but that it has been a long time. He stated that he remembers something  
25 about the people involved were going to be at a flower show or something like that at Cobo Hall in  
26 Detroit, but he wasn't sure about this. told me that Detectives from the Task Force  
27 came to his office, because they thought the caller would call back. He remembered that these Task  
28 Force Detectives showed him photos of the victims. was going to think about this  
29 overnight and call me if he can remember more.

30 called me back later in the evening and stated that he called and spoke with an  
31 Assistant Prosecuting Attorney, named Don Kuebler at the Genesee County Prosecutors Office  
32 about this information stated that Kuebler was at the prosecutor's office back in 1977.  
33 told me that Kuebler, who is now the Chief of the Appellate Division, did not recall this  
34 incident or information, but said he would be happy to order the Prosecutors file out of storage for us  
35 on Busch & Greene. Kuebler supplied a phone number of

13 Scientist Connie Fischer called Sgt. Gray (MSP) on this date and informed him that there is a  
14 Mitochondrial DNA sequence match to one of the suspects we had swabbed for DNA in this lead.  
15 Dr. Fischer stated that the DNA Sequence developed from one of the two hair fragments removed

9 **3-10-09: \*\*\* (Interview of [redacted] cellmate) \*\*\*** Sgt's Williams & Gray went to the "Gus  
10 Harrison" Correctional Facility (MDOC) in Adrian, Michigan to interview the cellmate of  
11 [redacted] that was his cellmate at the time of [redacted] polygraph in October 2008. Detectives  
12 interviewed cellmate, [redacted], who stated he knew why Detectives were there, stating it's  
13 probably about [redacted] told Detectives that he had several conversations with  
14 [redacted] for the 4 months they were cellmates, about polygraphs and specifically about  
15 inconclusive polygraph results. [redacted] said that he explained to [redacted] what inconclusive  
16 meant, but did not tell him how to obtain an inconclusive result on a test [redacted] told Detectives

29 Michigan to interview [redacted] about his connection to Christopher Busch. [redacted] was the  
30 boy mentioned in the police report by Busch when the Task force was interviewing him in January of  
31 1977 after his (Busch's) arrest for CSC 1. Busch mentioned [redacted] in his 77 interview as a boy  
32 he picked up in the 12 mile & Greenfield area that he took to Hartfields bowling alley and the 7-11.  
33 This was the third of the 3 places Busch named in this report as the places he has picked up kids in  
34 the past. **While doing so, Busch named the 3 OCKK victim abduction sites in chronological**

36 [redacted] admitted knowing Chris Busch, stating that Busch was a "Big Brother" of his, from the  
37 "Big Brother" program in the early 70's, in the Birmingham, Berkley area. [redacted] stated that  
38 Busch would take him to and frequented the "Tiny Tim's" hobby shop at 13 mile & Woodward and  
39 also Hartfields bowling alley on 12 Mile Rd. in Berkley. **These are both abduction locations of**  
40 **OCKK victims. Jill Robinson, was believed to have been abducted from the area of the "Tiny**  
41 **Tim's" hobby Shop near 13 Mile & Woodward in Royal Oak. Kristine Mihelich was abducted**  
42 **near the Hartfields bowling alley and the 7-11 on 12 Mile Rd. In Berkley** [redacted] told  
43 Detectives, that Busch took him to the Busch cottage one time, where Chris Busch attempted to  
44 molest him. [redacted] stated that he fought off Busch's attempts to molest him at that time, and that  
45 Busch was never successful at molesting him. [redacted] also said that while at the Busch cottage,  
46 Chris Busch taught him how to shoot a 12-gauge shotgun. **It was determined during the original**  
47 **investigation, that victim Jill Robinson was shot with a 12-gauge shotgun.**

49 **\*\*\* As of March 13<sup>th</sup>, 2009, arrangements are being made for Task Force members to go to**  
50 **Montana and question [redacted] about his connection to the Child Killings, his**  
51 **connection to Christopher Busch & Greg Greene, and to explain [redacted]**

2 **3-20-09: \*\*\* (The fibers from the victims clothing was located today) \*\*\*** Garry Gray (MSP)  
3 went to the Michigan State Police Long Term Storage Facility today with MSP Northville, Lab  
4 Scientists Cheryl Lozen & Lori Bruski to search for the slides containing the fibers from the OCK  
5 victims clothing. These fibers were removed from the victims during the original autopsies in the  
6 70's and also during the more recent forensic examinations. The slides containing these fibers were  
7 located and will be compared

8 During examination of this evidence, it was determined there is also some  
9 unknown human hairs that will have to be processed.

10  
11 **3-23-09: \*\*\* (The trip to Montana was cancelled today, ; absconded from parole) \*\*\***  
12 All flights and arrangements were made for 5 of us to go to Butte, Montana on 3-24-09 to interview  
13 The following were scheduled to go on this trip: Garry Gray (MSP), Cory Williams (Livonia  
14 PD), Shelley Holloway (Livonia PD), Sean Callaghan (FBI) & Rob Moran (Wayne County  
15 Prosecutors Office). Garry called today and said that the trip for tomorrow is cancelled because  
16 absconded on Friday evening and his parole people in Butte, Montana were not exactly  
17 sure where he was is due to report on Tuesday March 26<sup>th</sup> for a hearing regarding  
18 being expelled recently from the homeless shelter across from the parole office. This  
19 hearing is to decide whether or not he can return to the shelter. The Montana parole officers are not  
20 sure if is going to show up for that hearing or not. Sean Callaghan (FBI) made a call to  
21 sister, who stated she new about ; not reporting and also knew his whereabouts;  
22 but was not going to tell Callaghan.

23  
24 **3-24-09: \* warrant for "Full Extradition" was entered today by the Lansing,**  
25 **Michigan tether unit) \*\*\*** At 9:56am this morning, the warrant was entered into N.C.I.C. for  
26 for parole absconding. Garry called me this morning and stated that he has  
27 contacted all the local law enforcement agencies in the Butte, Montana area for assistance in getting  
28 locked-up on this warrant.

29  
30 **3-25-09: \* arrested on the MDOC warrant in Butte, Montana on 3-24-09. He is in-**  
31 **custody at the Silver Bow County Jail in Butte) \*\*\*** Garry Gray(MSP) called me this morning  
32 stating that he just received a call from . Parole Officer (Ted Barry) in Butte, stating that  
33 had been picked up on his warrant. showed-up at one of the other nearby  
34 shelters in Butte during the evening of 3-24-09, and was arrested.

35  
36 **3-26-09: \*\*\* (The Task Force flew to Butte, Montana today to interview**  
37 The following Task Force members went to Butte for the interviews of & his sister  
38 /Sgt. Cory Williams (Livonia PD), D/Sgt. Garry Gray (MSP), D/Sgt. Shelley  
39 Holloway (Livonia PD) & A.P.A. Robert Moran (Wayne County Prosecutors Office). During the early  
40 evening hours on today's date, we interviewed , at the Butte/Silver-Bow  
41 Sheriff's Department in Butte, Montana. Sgt. Gray started the interview talking with  
42 reading him his rights and explaining that the Task Force is now in possession of his ' DNA  
43 that was located on the shirt of Kristine Mihelich. Sgt. Gray tried to show a picture of  
44 Mihelich while explaining the DNA would not look at the photo and continued to sit back in  
45 his chair with his eyes closed, listening. ; did not deny anything, but simply said he wants an  
46 attorney and he's not saying anything without one. Any questioning of ; stopped. Sgt.  
47 Holloway explained to , that he could have an attorney, she would not ask him any  
48 questions, and asked, would he simply listen to what she had to say; agreed. Sgt.  
49 Holloway explained that he was only 14/15 years old when he was associating with Busch & Greene  
50 in 1976-77 and that he was a victim of theirs. Sgt. Holloway explained to , that his DNA  
51 coming back as a positive match on the Mihelich girl's shirt could be another example of those guys  
52 (Busch & Greene) continuing to victimize you even though they are dead. Sgt. Holloway explained



1 that the Detectives involved in this investigation want to charge him , with Murder and that  
2 he needs to think about cooperating and telling his side of what he knows and/or his  
3 involvement in the Child Killings. asked Sgt. Holloway to call his sister , explain the  
4 situation to her because he doesn't do anything without talking to her. Sgt. Holloway agreed to talk  
5 to his sister and the interview was terminated. \*\*\* (See Sgt. Gray's interview narrative report for

8 **3-27-09: \*\*\* (The Task Force talked with ; sister ; her home in Dillon,**  
9 **Montana today) \*\*\*** The Task Force drove down to Dillon today and Sgt. Holloway & APA Moran  
10 spoke with , sister and her husband . They explained to the , the  
11 situation with her brother DNA being found during a recent examination, on the shirt of the  
12 third victim (Kristine Mihelich) and he, potentially being charged with murder. Sgt. Holloway  
13 and APA Moran explained to the that if had any knowledge of the Child Killings it  
14 would be in his best interest to talk to investigators. understood the severity of the  
15 situation and agreed to call her brother to stress to him the importance of speaking with  
16 investigators. \*\*\* (See Sgt. Holloway's interview narrative report for further details) \*\*\*  
17

18 **3-27-09: \*\*\* ; phone call from the county jail in Butte to his sister in Dillon) \*\*\***  
19 Detectives made arrangements for .o call his sister from the "Silver-Bow" County Jail in Butte.  
20 Calls from the jail are recorded. Sgt. Holloway contacted about this incoming call and  
21 she agreed to accept it when. calls. ; had approximately a 10-15 minute phone  
22 conversation with his sister. The Task Force then had an opportunity to listen to the recording  
23 of their conversation. began the conversation with his sister by explaining how and why he  
24 was violated on his parole and that he was never missing he was only 10 minutes late for the shelter  
25 curfew. He went into a long story about how he did not understand why anyone would be saying  
26 that they couldn't find him a few days ago, when he was right around the corner at one of the  
27 shelters and had been speaking with his parole officer. After several minutes, told  
28 that Detective Holloway & the Prosecutor were out at the house today and explained that his  
29 s) DNA was found on one of the victims shirts. After lengthy discussions about  
30 violating his parole and not talking to Detectives about the Child Killings unless he has an attorney  
31 present. I said your DNA was on one of the victims. said, "I wasn't there when it  
32 happened." That was an interesting statement for to make to his sister. \*\*\* (See  
33 transcripts of this recorded phone conversation for further details. Also 2 other  
34 conversations with his sister after this.) \*\*\*
