45 4-22-09: *** (Task Force Meeting today at MSP Metro North Post) *** Present at the meeting
46 were the following: D/Sgt. Williams (Livonia PD), D/Sgt's Gray & Robertson (MSP), Special Agent's
47 John Ouelett & Sean Callaghan (FBI) and A.P.A. Rob Moran (Wayne County Prosecutors Office).
48 Garry Gray had talked with MSP Lab Scientist Cheryl Lozen, she said that she has begun the fiber
49 comparisons and would let us know about any positive results.

1 We discussed interviewing and swabbing _____ for DNA. I am going to contact the Police in
2 Montana to assist us with that. We discussed interviewing _____ h further about
3 being in the Detroit area with Chris Busch and/or Greg Greene at the time of the killings. We are
4 also going to swab _____ or DNA and polygraph him on knowledge and participation _____ was
5 very close with Chris Busch in 1976-77, was orally & anally molested by him and told Garry &
6 I during an earlier interview that Chris would hav _____ molest other young boys while Chris
7 would take pictures.

8 Garry is going to talk to Lt. Hill to get approval, based on Moran's recommendation, that we travel
9 to Atlanta and interview and polygraph _____ in regards to his association to Chris Busch
10 and his (Hastings) possible involvement in the Child Killings.

11 We talked about bringing _____ r in on his subpoena and having him testify under oath
12 about the polygraph he conducted on Chris Busch back in 1977. Based on the fact that _____ ex-
13 polygraph partner, John Wojnarski told us that _____ r is a very meticulous records/files keeper and
14 that _____ r has kept every polygraph file he has ever done, Moran believes we may be able to get
15 a search warrant for _____ home or office for the records of his _____ polygraph of Chris
16 Busch in 1977. Wojnarski's statement to us about Wasser keeping all of his files including old
17 polygraph files, is another contradictory statement _____ r made to us when he stated he doesn't
18 keep old files. Moran is going to research the possibility of a search warrant in this matter prior to us
19 bringing Wasser in on the subpoena.

20 We are still waiting on Gene Aldrich from MSP's Intelligence Unit in Lansing, who is working on
21 getting General Motors records of _____ r travel dates out of the country in 1976-77. Garry
22 talked to Gene and the request has been made through G.M. and he is just waiting for the results.

23 MSP is still attempting to locate the partial print and/or the photograph of the partial print from
24 Kristine Mihelichs parka, to compare to _____ r prints. Garry and I looked at the photo of this
25 print at the MSP Forensics Lab in Lansing back in March of 2008. Now they are unable to locate it
26 at the Lansing Lab.

28 **4-22-09: *** (I called Lt. Ed Lester in Montana about interviewing _____ r ** This**
29 afternoon I called and spoke with Lt. Ed Lester from Butte-Silver Bow Police Department in Montana
30 today. He is going to have a Detective friend of his on Bozeman PD interview
31 younger brother _____ r for us and swab him for DNA. Lt. Lester said that as soon as I can
32 send him an e-mail with all the info for the interview in it, he will forward it to the Bozeman Detective.
33 Lt. Lester is also working on getting us a copy of the jail phone call between _____ r and his
34 sister _____ r when the Task Force was in Butte, Montana in March.

36 **4-22-09: *** _____ r was shipped back to Michigan today on his parole violations) *****

37
38 **4-23-09:** I spoke with Lt. Lester today. He said he has two recent phone conversations recorded
39 between _____ r and his sister _____ r, and that _____ r was making plans to come to Butte and
40 visit _____ r before he gets shipped to Michigan, but _____ r was shipped on 4-22-09, before _____ r could
41 come to Butte to visit _____ r. Lt. Lester is going to call _____ r and see if he is willing to come
42 to Butte from _____ r to be interviewed, at which time Lt. Lester will swab him for DNA. Lt. Lester
43 also said that he is going to e-mail me the conversation between _____ r and his sister _____ r while
44 we were in Montana in March, and also the two recent conversations between _____ r
45 _____ r I will be able to download the conversations onto a CD for transcribing.

46
47 **4-23-09:** It appears through interviews with _____ r and other witnesses along with police
48 reports from 1976-77, that the Busch brothers _____ r and the
49 _____ r) were the boys that were the closest with Chris Busch at the time of the child
50 killings, along with _____ r. All five boys lived in the same neighborhood in Flint
51 and also knew Greg Greene. _____ r has been cooperative, although he worries
52 about DNA because of his close association to Busch & Greene. _____ r has been

1 uncooperative and his DNA (Hair) matched a hair fragment found on the shirt of Kristine
2 Mihelich, found during the re-examination of the victims clothing in 2006. _____ has
3 been cooperative, but we have not asked him YET, to take a polygraph or for DNA
4 _____ is about to be interviewed and swabbed for DNA by authorities in Montana and
5 _____ will also have to be interviewed.

7 4-24-09: I attempted to locate the _____ boys mother _____ in Lexis-Nexis and located
8 _____ She had resided on Cedar St. in
9 Lansing, Michigan, _____ old address. I attempted to locate the Busch boys mother
10 _____ in Lexis-Nexis, and found that she is also deceased. _____ was
11 born, _____ and died, 7-18-2001. She was married to Chris Busch's older brother
12 _____ who is also deceased.

14 4-27-09: *** _____ is now back in Michigan at Jackson Prison) *** I spoke with
15 Garry Gray (MSP) today. He talked to Cheryl Deushane from Michigan Department of Corrections
16 who told him that _____ is now back in Michigan from Montana and currently at Jackson
17 Prison.

34 4-28-09: I talked to APA Rob Moran today who told me that he spoke with _____ attorney
35 James Fienberg, who was asking Moran about releasing his client _____ from the Investigative
36 Subpoena from 2007. Moran told Fienberg that he was unable to do that right now because there is
37 a problem that he (Moran) wants to talk to Fienberg about pertaining to his client, _____ Fienberg
38 wanted to know what problem? Moran told Fienberg he would be giving him a call about it. I'm sure
39 Fienberg called _____ right away. This brief conversation Moran had with Fienberg was
40 just enough information to get Wasser thinking and/or worried about what Investigators have
41 developed over the past year or so. It also, "laid the ground work," prior to bringing
42 in to question him under oath about his polygraph with Chris Busch in 1977.
43

44 4-29-09: *** (Met with Polygraph Examiner John Wojnarski) *** Garry & I, along with Dave,
45 met with Polygraph Examiner John Wojnarski (MSP Retired) to discuss his (Wojnarski's) old
46 polygraph partner, _____ r. We (The Task Force) had discussed with A.P.A. Rob Moran, the
47 possibility of executing a search warrant at _____ home for his old polygraph files,
48 specifically Chris Busch's file from 1977. Wojnarski had told us during an earlier interview that
49 _____ had a number of large file cabinets in his basement containing old polygraph files back to
50 when _____ began in 1972. Wojnarski had told Detectives that _____ was a meticulous records
51 keeper, is a "pack-rat" sort of guy and doesn't get rid of anything. _____ had told me in
52 2007, that when _____ discussed Busch with him at the convention in 2006, he _____ told

1 when he comes to Michigan he would show him the person later identified as Chris Busch's
2 polygraph file. Wojnarski told Detectives today that the last time he was in [redacted] basement and
3 saw these files was approximately 1999 and that he has had little to no contact with [redacted] since.
4 Wojnarski, knowing [redacted] stated that it would not surprise him if [redacted] has moved the Busch
5 polygraph file since this all came to light in July of 2007.
6

7 5-1-09: Garry sent an e-mail to Gene Aldrich at the MSP Intelligence Unit in Lansing to see what
8 Gene found out about [redacted] employee records from General Motors. We are trying to
9 ascertain the files that will show when [redacted] was out of the country on business in 1976-77.
10

11 5-4-09: We are still waiting to here from Detective Scott Rios at the MSP Newaygo Post in
12 Newaygo, Michigan. He is going to make contact with [redacted] about us re-interviewing him
13 about [redacted] and Chris Busch. We are also planning to swab [redacted] for DNA.
14

15 5-4-09: Garry talked with Gene Aldrich this afternoon, who stated that he (Gene) is still working on
16 getting the General Motors employee records of Chris Busch's father, [redacted] from 1976-77.
17

18 5-6-09: Detective Scott Rios from the Newaygo MSP Post called Garry today stating that he made
19 contact with [redacted] who stated he would talk to us and supplied two phone numbers for us to
20 call him and set-up an interview.
21

22 5-6-09: Garry sent me an e-mail today that stated that Cheryl Lozen and 3 other Lab Scientists
23 from the Michigan State Police Lab in Northville are coming to the MSP Metro North Post on 5-7-09
24 to go thru all the files to attempt to locate the partial fingerprint and fingerprint evidence from the
25 case, along with files they will need for future reference.
26

27 5-7-09: APA Rob Moran called me this morning and stated that [redacted] attorney, James
28 Fienberg was at the prosecutor's office wanting to talk with Rob about [redacted] situation under our
29 investigative subpoena. I advised Moran to tell Fienberg that investigators have uncovered a lot of
30 information since we last spoke with [redacted] that leads investigators to believe that [redacted] has
31 been less than cooperative in this investigation and that there are questions that need to be asked of
32 [redacted] under oath. Also that based on what [redacted] told investigators earlier about not
33 remembering pertinent information, but having a vivid memory of other events surrounding this case
34 from the 70's, along with what investigators have uncovered, investigators believe that [redacted] has
35 not been completely honest about his information in this case.
36

37 5-7-09: I spoke with APA Moran later this afternoon about his meeting with
38 attorney. Moran stated that he explained the situation to Mr. Fienberg who felt that his client had
39 already cooperated with investigators. Moran explained that based on their investigation,
40 investigators believe that [redacted] has not been completely cooperative and has not yet testified
41 about this information. Moran advised Mr. Fienberg that he would call him with a date for
42 [redacted] to testify.
43

44 5-8-09: Garry e-mailed me today, that [redacted] was arraigned on his parole violation here in
45 Michigan on 5-1-09 and pled guilty to one count, "Failing to report." [redacted] pled not guilty to
46 moving residences without permission. MDOC offered him a plea bargain in which they would
47 dismiss the moving without permission and recommended a 6-month continuance. At this time,
48 [redacted] parole has been revoked for 6 months. [redacted] accepted and signed the plea offer. The
49 plea will be placed on the formal record on 5-21-09. [redacted] is still located at the Egler Center at
50 Jackson Prison.
51

1 5-8-09: *** (Interview of [redacted] *** [redacted] had called wanting to come in this
2 afternoon and talk to me about what he had overheard in regards to the OCCK case [redacted] is the guy
3 that was in the next booth at the Big Boy Restaurant in Alpena in December of 1991, that overheard
4 the conversation between [redacted] [redacted] was telling [redacted] details
5 about his involvement in the Oakland County Child Killings. [redacted] was raised in Alpena and
6 currently resides at [redacted] I stated that he
7 has a master's degree and is currently employed as an engineer at the General Dynamics
8 Corporation.

9 [redacted] stated that he sat behind [redacted] for quite along time that evening with a friend
10 of his name [redacted] listening to [redacted] give details about the killings and drawing maps for
11 [redacted] said that he didn't know who either of those people were at that time. [redacted] I told me that
12 he thought their conversation was so bizarre and thought they were talking about some murder
13 investigation from the news or a movie. He said he never dreamed at that time, that it may have
14 been something that [redacted] was actually involved in. [redacted] said that [redacted] was crying during
15 their conversation and he felt that she was really upset and hurt over what [redacted] was telling her.
16 [redacted] told me that he knew they weren't talking about any murders or abductions around Alpena
17 because it would have been all over the news. He told me that he then heard [redacted] mention
18 Troy. [redacted] told me he remembers thinking that he [redacted] lived in Sterling Heights at this time,
19 near Troy and there hadn't been any news about any abductions or murders of children at that time
20 (1991) [redacted] told me that it wasn't until 2004 when he was on the internet after the BTK Killings,
21 that he observed [redacted] website and saw people talking about [redacted] giving details
22 about the OCCK case and drawing maps for [redacted] at a Big Boy Restaurant in Alpena in
23 1991, that [redacted] realized what exactly he had overheard being discussed in the Alpena Big Boy that
24 night.

25 [redacted] then told me the following highlights of the things he remembers overhearing
26 telling [redacted] that night in Alpena about the OCCK case:

- 27 1. "I gave the children a bath before I killed them."
- 28 2. He told [redacted] he wanted to live with the children before he killed them.
- 29 3. He talked to [redacted] about the victims as if he were friends of theirs, saying "Lucy in the sky
30 with diamonds" in reference to a song that one of the kids liked.
- 31 4. [redacted] said, "I played games and watched T.V. with the children in a room upstairs."

32
33 [redacted] took my card and is going to e-mail me any other information that he can remember
34 overhearing [redacted] talking to [redacted] about in 1991. [redacted] told me that he wished he would
35 have known 13 years earlier that what [redacted] was talking about was a real crime with real victims
36 because he is sure he would have been able to supply more information. The interview was
37 terminated.

38 *** The Task Force is going to continue to investigate the possibility of [redacted] being
39 connected or involved in the Child Killings until we can get to Atlanta, interview, polygraph
40 and either connect or clear him once and for all of knowledge and/or involvement in the
41 OCCK case. As of this date a possibility exists that Busch & [redacted] were associates of
42 one another at the time of the Child Killings. ***

43
44 5-12-09: *** (2nd interview of [redacted] in Newaygo, Michigan [redacted] supplied more
45 information about Chris Busch) *** Garry Gray (MSP) & I had [redacted] meet us at the
46 Michigan State Police Newaygo Post today so we could interview him further about his relationship
47 with Chris Busch & Greg Greene, and what he could tell us about [redacted] association with
48 Busch & Greene. A lot of the information that [redacted] supplied to Detectives was information that he
49 had given during his first interview.

50 During this interview, [redacted] went into more detail about the Busch Family at the time of the Child
51 Killings, the [redacted] and more about Chris Busch & Greg Greene. [redacted] it talked about how much
52 time he spent with his Uncle Chris and how many times Chris molested him [redacted] stated that Chris

1 was molesting him between the ages of 12-15 years old, which would have been between 1975
2 through 1978, up until Chris Busch Committed suicide told Detectives that Chris molested
3 him approximately 20 times between those years and that these molestations took place at all of the
4 different houses that Chris or the Busch's were in possession of. talked about staying and
5 being molested by Chris at the home in Birmingham, Alma, Sanford and the cottage on Ess Lake.
6 (See transcripts from recording of this interview for further details).
7

8 **5-13-09: *** (Task Force strategy meeting @ the Metro North Post) ***** Present at the meeting
9 today along with myself, was: D/Sgt's Gray & Robertson along with Sean Callaghan (FBI). We
10 discussed our desire to get to talk to us, and the different approaches we could use to get
11 him to cooperate with our investigation, including having the Prosecutors Office authorize "Use
12 Immunity" in exchange for his cooperation. I ran this idea by APA Moran. He liked it, but wanted us
13 to further investigate this lead and attempt to talk to again first before he considered any
14 type of immunity for Gunnels.
15

16 **5-19-09:** Garry & I are going to meet with D/Lt. Hill on Friday May 29th, at 1:00pm to discuss and
17 hopefully get approval for the upcoming trip to Atlanta to interview and polygraph
18

19 **5-26-09:** Garry & I went through the files and pulled out more police reports and documentation we
20 will need to put into the power point presentation for the Prosecutors on this lead. We are going to
21 present only facts and support everything with police reports and other official reports from the
22 1970's.
23

24 **5-27-09:** Sue Taylor came to the MSP Metro North Post today to assist us in putting together the
25 power point. She is from the MSP intelligence Unit in Lansing and specializes in power point
26 presentations. We continued to input and update the power point and are probably two-thirds of the
27 way through it.
28

29 **5-27-09:** S.A. Sean Callaghan (FBI) called "Al Serra Chevrolet" today in Flint. We wanted to see if
30 they have old sales records that might show the sale of the 1975 blue Chevy Vega hatchback with
31 white stripes to Chris Busch in 1976. told police about this car in 1977 and told me that he
32 knew Busch had purchased it at "Al Serra" in Flint. They had no records back that far and stated
33 that they only keep sales records back 5-10 years or so.
34

35 **5-27-09:** Garry Gray called Jackson prison today and made arrangements for Sean Callaghan
36 (FBI) and Dave Robertson (MSP) to go and attempt to get talking and cooperating
37 with the investigation. They are going to see where he stands with all of this and what his attitude is
38 toward the news we gave him in Montana about his DNA being on one of our victims.
39

40 **5-27-09:** We put a call into Trace Evidence Scientist Karry Oien at the FBI Lab today to have him
41 update us on his progress on processing
42

43
44 **5-29-09:** Garry & I and Dave met with F/Lt. Hill at the MSP 2nd District HQ today and explained why
45 we need to travel out of state to interview The trip was approved by Hill who wanted
46 a write-up thru channels to get official approval from the MSP command in Lansing. According to Hill
47 he should be able to get us official approval to go. We spoke with Lab Scientist Cheryl Lozen while
48 we were at District HQ. She stated that she has put the processing of the fibers on-hold, just for a
49 short period of time while a handful of new lab employees are being trained. Her plan is to utilize
50 several of the new Scientist to assist her in
51 and stated that these new Scientist are aware of the case and excited about assisting her with this.
52

1 5-29-09: *** (Located Busch's attorney from 1977, Kelth Stark) *** I performed a search
2 through the "Google" database and located an attorney that has been practicing in Michigan since
3 1969, named R. Keith Stark. This is most likely the attorney that was representing Chris Busch in
4 January of 1977 when he was polygraphed by the state police examiner Cabot at the MSP Flint Post
5 in January of 1977. Stark shows a current address of 1111 W. Long Lake Rd. Suite 202 Troy,
6 Michigan 48098. The phone number is 248-641-9955.

14 6-3-09: *** (Interview of _____ at Jackson Prison today) *** SA Sean Callaghan (FBI)
15 & Dave Robertson (MSP) went to Jackson Prison today to make contact with _____. We had not
16 spoken with him since he arrived back here from Montana, more than a month ago. We thought it
17 best if Sean & Dave go, because _____ hates Garry & I. The last conversation we had with
18 _____ was in Montana when we advised him of his DNA being on Kristine Mihelich's shirt, and he
19 stated he would talk to us, but not without an attorney.

20 Sean & Dave had a pretty good conversation with _____ stating that _____ was receptive and
21 listened to what they had to say. Sean explained to _____ the situation that he is in, including the
22 DNA evidence, stating that because he has been so uncooperative with investigators, that they have
23 not been able to clear him. Sean walked _____ through it, telling him that he _____ has
24 maintained from the beginning that he had nothing to do with the killings and doesn't know anything
25 about it, yet he has made investigators jump through hoops and then he admitted sabotaging the
26 polygraph. Sean that investigators then still held true to their word and let him parole to Montana.
27 _____ agreed and according to Sean, _____ is starting to see that he has created a lot of this
28 himself by being uncooperative. _____ mentioned that he wants an attorney. Sean explained
29 that he has not been charged with anything and that they cannot supply him with one. Sean also
30 explained that he can hire an attorney and have all the attorneys he wants, but that they are
31 probably going to advise him, that if he were not involved and do not have any knowledge of the
32 Child Killings, to simply cooperate with investigators so they can clear him. When they concluded
33 the interview, _____ was going to think about what was said and make some phone calls.
34

35 6-4-09: ** _____ ** Garry Gray spoke
36 with MSP Lab Scientist Lori Bruski today. She stated that she talked on the phone with the FBI Lab
37 people in Quantico and that they have begun the analysis. _____

41 6-8-09: I got an e-mail from Garry Gray (MSP) today, stating that Sue Taylor has been continuing to
42 work on the power point presentation on this lead, and that it is coming along very nicely.
43

44 6-9-09: I was looking through some old e-mails from a year ago that _____ had forwarded
45 me about a guy named _____ that was _____ (Kristine Mihelich's mother)
46 boyfriend at the time of Kristine's abduction in Berkley in January of 1977. This _____ was known
47 to hang out in the bar at Hartfields Bowling Alley where Kristine's mother, _____ tended bar. I
48 know the _____ name from Birmingham when I was a kid. They were a well-to-do family that had
49 a road and a lake named after them in the Birmingham/Bloomfield area. _____ was a suspect at
50 the time of the killings and later cleared.

51 This is interesting, especially knowing that Chris Busch used to frequent _____ was
52 about the same age as _____ and from the same general neighborhood in _____

1 Birmingham/Bloomfield. It is also interesting that there is information that _____ was
2 possibly friends from the Birmingham/Bloomfield neighborhood with _____ another
3 big suspect in the Child Killings. We are about to go interview and polygraph _____ in
4 Atlanta about information that he is connected to Chris Busch and his possible involvement
5 in the killings. _____ will have to be interviewed now about Chris Busch and

15 Drugs. This is where Northern Michigan University is and would match the information about
16 attending and graduating from there in 1973.

18 6-10-09: I called and spoke with a Sgt. Steede at the Sheriff's Dept. who looked up the file for me.
19 He called me back a short time later and stated that the file on _____ had since been
20 destroyed, along with the booking photo of _____. I'd like to see a picture of _____ from the
21 70's to see if there is any resemblance to the OCKK composites.

22
23 6-10-09: *** (Spoke with Kristine Mihelich's mother this evening. She said she not only
24 never dated _____ but has never heard of him) *** I interviewed _____ tonight
25 on the phone and asked her about dating _____ at the time of Kristine's abduction. Not only
26 did _____ say she wasn't dating _____ she said she's never heard of him. I described
27 Chris Busch to her and she stated that he did not sound familiar. She said he kind of sounds like the
28 owners son, a completely different name. First I told her his name was Chris and she did not
29 remember a guy like that. I then told her the heavy-set guy with the beard's name was Chris Busch
30 and he was about 26-27 years old in 1976-77. I told her that we interviewed a guy from Berkley
31 named _____ that said that Chris Busch used to hang out at "Hartfields" at that time. She did not
32 recognize the name Chris Busch and said she didn't know the name _____ either. _____ added
33 that she worked upstairs at the bowling alley and didn't always see or know people that came to the
34 bar on the first floor. I had a chance to talk to her about our two dad's knowing each other and she
35 said she remembered her dad _____, calling my dad the night Kristine disappeared and asking
36 my dad for help. _____ told me that my dad came to talk to her at the bowling alley the next day. I
37 remember the night _____ grandpa _____ called my dad for help.

38
39 6-11-09: I talked with Garry Gray (MSP) today who said he received recordings of 7 different phone
40 conversations _____ has had from prison since being back in Michigan. Garry was going to begin
41 listening to them today. Garry told me that _____, sister _____ was on _____'s visitor list
42 from the Ryan Facility when _____ was there back in May/June 2008. This was the time we were
43 negotiating with _____, to get him to take the polygraph. We were also talking with
44 trying to get her to tell her brother to cooperate with us and take the polygraph so we could clear
45 him. She never indicated to any of us at that time that she was anywhere but Montana, where she
46 lives, and never said she was right here in Michigan where we could have met with her in person.

48 6-19-09: Cathy King called today, stating that she had made a call to the Oakland County

13 interviewing Busch and Greene about the Child Killings. Gary Sanford told me that Waldron did in-
14 fact remember the case and Sanford gave me Waldron's home number: (

16 **6-22-09:** I talked with prosecutor Rob Moran today about We were discussing the
17 possibility of offering "Use Immunity" to in exchange for information about the child Killings.
18 Moran wants to wait on the pending lab results before doing so. We also discussed bringing
19 in on the Investigative Subpoena asap. Moran has been in contact with Fienberg so hopefully we
20 will be able to get ... in to the pros. Office in the next couple of weeks.

22 **6-22-09:** I identified "Woodrow Bruce Weeks" today. When we interviewed the first time at
23 Camp Ojibway, he mentioned an associate of his named , that may have known
24 Busch & Greene back in Flint in the mid 1970's. , is identified as
25 w/m, born. , currently serving life in prison in Muskegon, Michigan for murder. We may
26 want to talk with . The reason I identified is because when Busch & Greene were
27 there were two newspaper articles written about this. Both articles
28 talked about 3 Flint men being charged and a fourth being sought. We have only ever known about
29 Busch & Greene. I want to find out who the other two men were. is the only named
30 mentioned in the one state police report, but we are not sure if is even connected. I thought
31 maybe night be one of these 4 men, but he was too young back then. Maybe
32 when I interview Waldron he will remember the other two names.
33

34 **6-23-09: *** (I spoke with Flint Detective, Tom Waldron today) ***** I called and spoke with Tom
35 Waldron today about Busch & Greene. I couldn't believe how vivid his memory was about Busch &
36 Greene and the investigation into these two back in January of 1977. Tom was encouraged about
37 our lead and agreed to meet with me and shed as much light as he could on these guys connection
38 to the child killings. Waldron told me that he never knew about a drawing of the Stebbins boy, and
39 ropes being found in Busch's home in Birmingham and that he had committed suicide in 1978. As
40 far as the other two adult men that were arrested with Busch & Greene, Waldron stated that they
41 were just kind of "fringe" players that were arrested after all the interviews of victims in Flint took
42 place. Tom said he could not say for sure that these other two adult men even knew Busch and/or
43 Greene.

45 **6-24-09:** I searched through the tip files for any tips on the name , and found a tip on a
46 I remember that told the Flint
47 Detectives in 1977, that Greene had a friend or relative that lived in Ferndale, and thought the
48 in Ferndale could be Busch & Greene's connect through the " in Flint. Garry Gray
49 (MSP) pulled this tip on and stated that he didn't think this s in the tip was
50 connected with ; in Flint. It does not appear that they are connected, but could be
51 distant relatives.

2 me that _____ is in prison for murder, stating that he committed one murder in Flint; was
3 acquitted, and then put a rifle to the back of his brother-in-laws head and killed him, stating that this is
4 the murder _____ is now doing "Life" on. He said that _____ was very close with the
5 boys and probably knew _____, but _____ couldn't say for sure. _____ also could not
6 confirm if _____ knew Busch & Greene in Flint back in the day, but stated he probably did, because
7 of his connection with _____ told me to call a woman named _____
8 _____) that used to live near _____ in Flint and told _____ recently that she
9 thought that _____ had killed somebody years back.

11 6-25-09: I spoke with _____ on the phone today about _____ She stated that
12 _____ was in the same grade she was in at Cody Elementary School in Flint back in the 60's and
13 that _____ was a mean/violent person. She told me that _____ would torture her and throw
14 rocks at her, stating that in the 6th grade, he threatened to kill her. She said that she is still scared to
15 death of him and called him a sociopath. She stated that although she has no evidence that
16 _____ ever killed anyone, she would not put it past him to have done so.

17
18 6-25-09: I performed some searches through the Lexis-Nexis database for the _____ family in
19 Flint and the _____ family in Ferndale, which included relatives for both. I saw no common relatives
20 listed. It appears as if there is no connection between the two, but I have not confirmed that yet.
21 There was something strange in the relatives listings section fo, _____ There was
22 a _____ listed as a relative, that lived on the next street from _____ in Ferndale. This
23 _____ lived on Flowerdale in Ferndale. I called an informant of mine that knew
24 back in the 70's named _____ She told me that _____ is the mother of the
25 _____ that Lamborgine and Lawson had molested in the mid 1970's. The
26 testified against Lawson & Lamborgine at their CSC trials in the spring of 2007.

27
28 6-30-09: *** (Interview of Detective Tom Waldron Flint PD) *** I went to interview Tom Waldron
29 today about Busch & Greene back in 1977. Garry Gray (MSP) went along and took the notes.
30 Waldron remembered the case involving Chris Busch & Greg Greene very well and said he and
31 others were "flattened" when Cabot _____

32
33 _____ Waldron said that he remembers that Deputy Oakland County
34 Prosecutor Dick Thompson came up to Flint in a snowstorm that day. Waldron added that
35 Thompson was a "Big-wig" in Oakland County and would not have come up there if they didn't think
36 they had the killers.

37 I asked Waldron what he thought when I told him that Busch & Greene
38 _____ Waldron was shaken by this, hung his head and said, "This should have been
39 solved 32 years ago." He stated that Busch & Greene met each other in a bar in Oakland County,
40 which would have been early in 1976, stating further that this is when they probably discussed their
41 common interests in children. Waldron told us that Busch and Greene were into exchanging kids
42 and would meet at a gravel pit in Holly, Michigan (Northern Oakland County) to swap the kids. He
43 said that Greene would bring a boy from Flint and Busch would bring one from who knows where.
44 Waldron said that this gravel pit is in the same area in Holly that they brought _____ when they
45 molested him, in-fact _____ was the one that pointed out the gravel pit to Waldron. Waldron told
46 us that _____ was a kid that Busch & Greene could really push around, stating that Greene had
47 choked _____ to near death in the past when he wasn't cooperating.

48 Waldron started talking about when he and a couple other Detectives drove to Alma to arrest
49 Chris Busch. Waldron talked about Busch owning and operating a restaurant in Alma that was
50 purchased by his father _____ He said that after they arrested Busch, they searched his
51 house and found ropes, shotguns, marijuana, and a suitcase with child pornography. Waldron
52 described the pornography as being 8-10, 8mm type homemade movies involving children having

1 sex in a tent in a wooded area. Waldron said that you could see the arm of an adult male in the
2 movie, directing the kids on what to do sexually, because they didn't know. He stated that this
3 suitcase also contained commercially produced child porn magazines, photos and movies. Waldron
4 said that this property was all confiscated and brought to the Flint Police Department, as part of their
5 case. He went on to say that he remembers at some point in February or March of 1977, the FBI
6 came and picked up the suitcase of pornography to analyze the victims involved.

7 Greene told Waldron where he hid a pack of pictures in his backyard on f . Greene
8 said that he wrapped the pack of pornographic Polaroid pictures of kids in tin-foil and hid them under
9 the snow near the downspout in the rear yard. Waldron said that he went to Greene's house on
10 dug through the ice and snow near the downspout and located the pack of pictures.

11 Waldron told us that as far as he can remember these pictures were never given to the OCK task
12 force for comparison, because Busch & Greene . Waldron
13 said that he thinks this pack of pictures was put on evidence at Flint PD. Waldron went on to say
14 that if we call Gary Alford with the cold case squad at the Genesee County Prosecutors Office, he
15 might be able to help us locate these pictures. Alford is a former Flint PD Detective.

16 I asked Waldron if he remembers who the other two Flint men were that were mentioned back in
17 1977 in the newspaper article that talked about 4 Flint men being arrested in a sex-ring, 2 of which
18 were Busch & Greene. Waldron, without hesitating stated, Douglas Eugene Bennett & Hiram "Red"
19 Becker. Waldron said that of the two, Bennett was the one that was close with Busch & Greene.
20 Waldron stated that Becker was picked up later, was quite a bit older and not really connected with
21 the others, stating that Becker was in jail in Pennsylvania at that time. Waldron described
22 as being a white male that lived in Flint in the 70's and was probably born in the mid 1950's.
23 Waldron described Becker as also being a white male that resided in Flint on the 1970's, drove a
24 cab, had red hair, and would be in his 60's-70's today. Waldron stated that Bennett went to prison
25 on Flint PD's charges in 1977, for several years.

36 Alabama with his older brother _____, white male, born _____. It was
37 brother _____, 20th birthday on December 20th, 1976 when _____ got arrested for
38 Burglary in Flint.

40 **7-6-09: *** (I got a mug-shot of _____ and his arrest reports today from Flint PD) ***** I went
41 to Flint PD today and was able to get a copy of a mugshot of _____ from an arrest of his
42 in Flint in 1975 _____, would have been 17 years old in this picture, but looks older & taller for his
43 age. He could possibly match the composite photo from the King abduction, but I would like to see
44 his mugshot from June of 1977 when he went to prison. Garry called Jackson prison today and
45 ordered _____; 1977 mugshot.

46 I picked up copies of Flint PD's police reports from the arrests of _____ or the Burglary in Flint,
47 December 20th, 1976 and the report from the child molestation arrest of _____ on 2-9-1977. Busch
48 & Greene are not mentioned in either of these reports, and are not mentioned in any of the Flint
49 paperwork that I have seen. The 1977 newspaper articles talk about 4 Flint men arrested in a ring,
50 and Waldron said that Busch, Greene _____ knew each other, but there are no reports so far
51 that corroborate this. I need to go see Waldron again now that I have his old reports from
52 arrests in Flint in the 70's, and see if he can clear this up.

29 **7-20-09:** We have been making arrangements to fly to Atlanta to interview and polygraph

31 state police were denied any out of state travel at this time due to budget constraints, so it appears

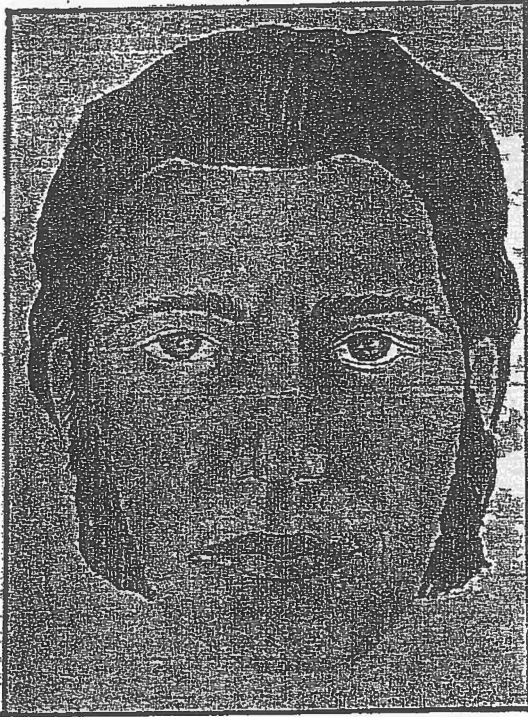

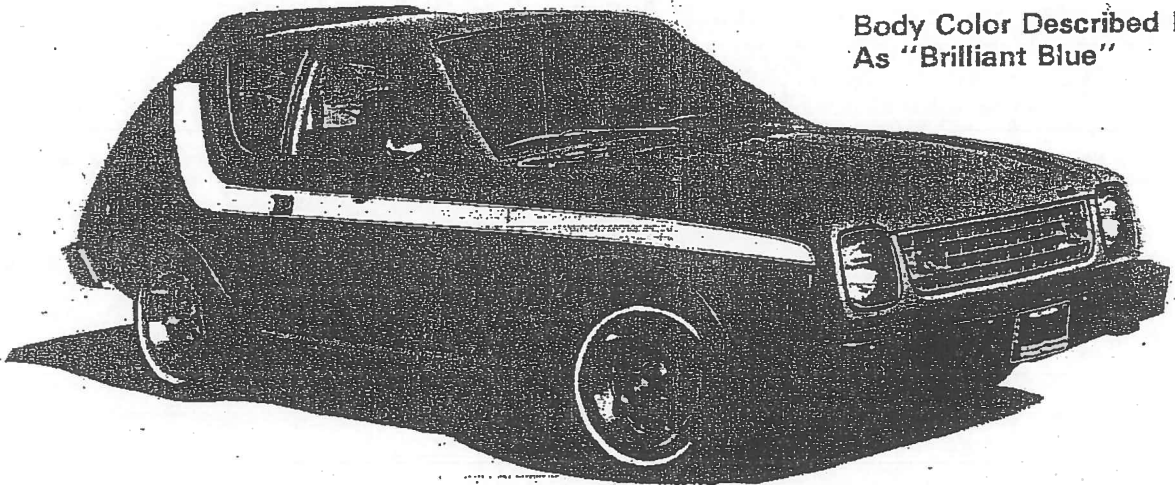

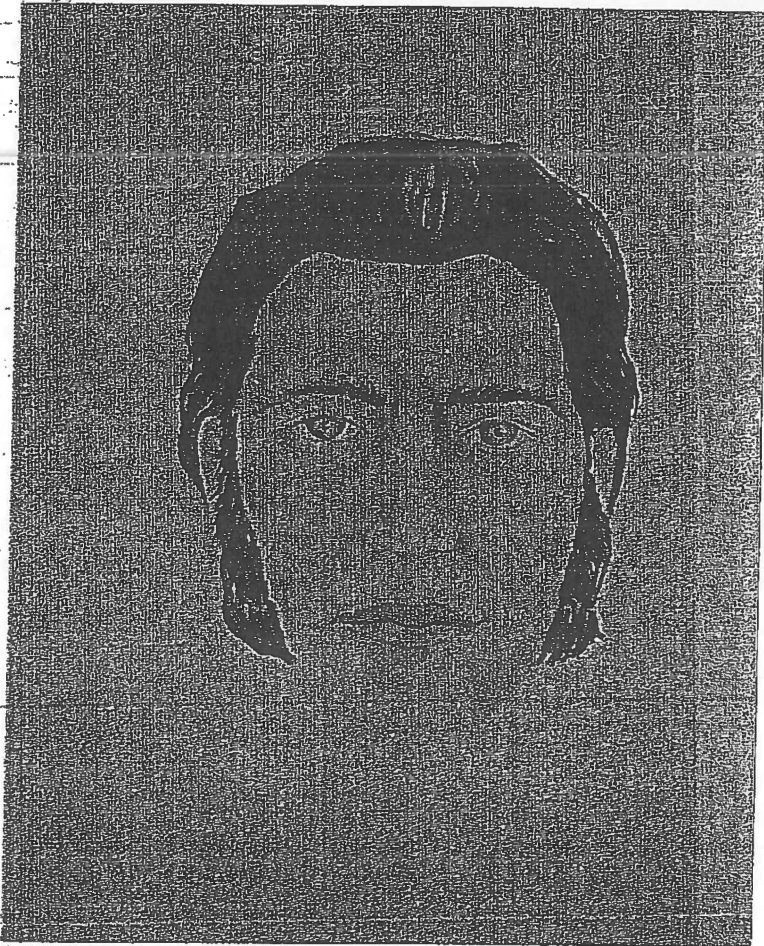
