HISTORY OF CASE:

On November 9, 1976, Officer Tom Waldron was contacted by Mr. Thomas Duty, who is the principal of Donovan North Middle School, 530 W. Pierson Road. Mr. Duty related to Officer Waldron that he had been contacted this date by \_\_\_\_\_ the mother of \_\_\_\_\_ M/W/12, at which time, \_\_\_\_\_ related \_\_\_\_\_ had run away and that \_\_\_\_\_ had made Runaway Complaint #34476 with the Flint Police Department.
