Dear Ms. Cooper:

This letter is not written in my professional capacity but as the Father of Timothy King, a victim of the Oakland County Child Killer. I would like to meet with you and/or the prosecutor in charge of the case. It might also be helpful to invite Detective Sergeant Garry Gray of the Michigan State Police and Detective Sergeant Cory Williams of the Livonia Police Department.

While the investigators have been open with my family regarding some matters, they have been reluctant to share all of the information with us. In this regard, you may wish to review statements made by John Walsh, the father of a murdered child in Florida, when a 26-year investigation was finally closed on December 16, 2008 (see <http://www.youtube.com/watch?v=boykA1E3UZA>). He was very complimentary for the information provided to him by the prosecutor and the police during the investigation.

As your records will indicate, this investigation has now centered on one or more deceased individuals due to a lead fortuitously provided by my family. Detective Sergeant Gray has advised us that certain trace evidence has been submitted to the Michigan State Police Laboratory and perhaps another laboratory for examination, but he cannot advise us of the status of this examination and whether or not any results have been received. If any positive preliminary results have been received, we would appreciate any combined efforts to expedite the completion of this examination.


Detective Sergeant Gray has advised us that the Michigan State Police plan to put together a Power Point presentation similar to that used in the Adam Walsh case. We request an opportunity to review this Power Point presentation prior to its public display and an opportunity to be present when the presentation is made.

Detective Sergeant Gray has advised us that he plans to examine a witness in Atlanta, Georgia the week of July 25, 2009. If the case is proceeding as we suspect, my family would be willing to pay the expenses if it can be accelerated to close the case.

All,

I spoke with Mr. King this afternoon and explained to him why I canceled the meeting. He understands, but requested an estimated time frame on the result of the lab analysis being conducted at the MSP lab. His understanding is that a simple analysis of fiber has to be conducted, which should take not more than a month if priority has been placed on it. However, he is not aware of the specific issues the analysts has faced with this particular case and that one month is not realistic.

D/F/Lieutenant Morden, lab director, advised me that he will speak with Lieutenant Losen and provide me with a target date tomorrow morning.

It appears that Mr. King knows much more about the particulars of this investigation than any investigator would typically divulge to someone not involved with the investigation. However, I believe it is clear to everyone that this investigation is far from typical and the fact is his family has provided and been privileged to quite a bit of information. It is also clear that they have kept the info to themselves or within closed circles, which reduces the risks or concerns we should have over disclosing that status of the investigation to him.

This needs to be considered when the task force members meet to discuss this issue. I have not yet spoken with Corey Williams or Prosecutor Worthy.
