Garry,

I have left messages for Kym Worthy that the meeting scheduled for Wednesday October 7, 2009 has been canceled and requested her to call me. Her assistant advised me that Ms. Worthy is scheduled for another event during that date and time, but she will forward the message of the cancellation. I also left messages for Corey Williams and Mr. King to call me regarding the meeting (I want to explain to them why I have canceled the meeting).

I also spoke with Chief Bob Stevenson of Livonia P.D. and explained to him our concerns. He agreed that there should not be a meeting called unless all members of the task force have discussed and agreed upon what will be discussed in advance. However, he believes there should be a presentation of the facts and evidence to Mr. King to give him some measure of peace; given his current age and what he already knows about the case. He has spoken with Corey Williams over the past few days and has received a different version of how the scheduling of this meeting came about.

We agreed that we will schedule a meeting of the task force members (including Corey Williams) in the very near future to discuss this issue and final game plan for wrapping up the case. Please let me know if there are any other concerns.

The meeting scheduled for this Wednesday, I thought was going to brief with the Kings to bring them up to date on why this particular lead has taken as long as it has. Mr. King advised that Prosecutor Kym Worthy will be attending the Wednesday meeting and she feels there is sufficient evidence (at this time), to charge this case. Mr. King seemed somewhat perplexed that it was Wayne County and not Oakland. I know that we're at this juncture for prosecutorial review of the case yet.

Items still under investigation:

1. Friday, October 2nd, FBI laboratory report from Quantico,
2. 4 human hairs were found during the above analysis and have been sent to their Mitochondrial DNA

unit.

3. I placed a call to our Lab, (Charlie Morden), several days ago regarding the final analysis of the carpet fibers. Cheryl Lozen has been assigned the task and is currently working on it.

4. Pending two additional polygraphs.

5. Pending investigative subpoena regarding

6. Pending results of above, for inclusion into the power-point presentation.

7. Oakland County Prosecutor's haven't been kept up to date on the investigation at their request. Until we're ready to present.

Subject: Contact with the Brother of Christopher Busch, New York

Lt. Hill

This morning at 8:00 AM, I telephonically contacted the brother, [redacted] of deceased suspect, (Christopher Busch), advising him about the Detroit News article that was printed yesterday. I advised him that I was honoring the agreement that was worked out between the FBI in New York and he, when they interviewed him and obtained a sample of his DNA for comparison purposes back in April of 08. (Which by the way was negative to our evidence).

At that time, [redacted] made certain stipulations to the FBI prior to agreeing to giving his DNA. One of those agreements is the following:

FBI report: 4-25-08 Agent Thomas McDonald, case # 306-DE-80444

Verbatim: [redacted] requested that the following be executed should positive results be obtained with his DNA, and/or any public announcement naming Chris Busch as the Oakland County Child Killer.

This morning while speaking with [redacted] he was further advised that at no time did the MSP approve, authorize or even have knowledge of the News Paper article until after it was released. He was further advised that when the MSP was contacted by reporters, the MSP had no comments. I did not discuss the article or the contents of same with [redacted]

[redacted] was very appreciative of the heads up and thanked me for the call. I once again gave him my direct TX and D/F/Lt. Hills direct #, if he should have further questions regarding this matter.
