

1 4-6-06: *** (I identified Donald [REDACTED] today) *** Donald [REDACTED] was a guy that, according to [REDACTED]
2 [REDACTED] was real close and had a sexual relationship with Ted Lamborgine back in the Cass Corridor
3 and southwest Detroit in the 1970's. I performed a check through the "Autotrack" computer system and
4 located Donald [REDACTED], born [REDACTED] 1960. This subject shows many Detroit addresses
5 associated to him and several in the southwest Detroit area back in the late 70's or early 80's. It shows
6 an address for [REDACTED] in 2006 at [REDACTED] Waldo St. in Detroit. I performed a computer check of this
7 subject, through the Michigan LEIN system, which showed him to have no recorded criminal history. A
8 check in the Secretary of State Computer system, showed him to have a valid drivers license in Detroit.
9 I obtained a photo of [REDACTED] from the Secretary of State imaging system.

10 4-6-07: The two Parma Heights detectives, Scharschmidt and Mockler, at my direction, went to Ted
11 Lamborgine's apartment tonight to check up on him. Ted invited the detectives into his apartment and
12 they talked for approximately 30 minutes. Steve Scharschmidt told me that Ted was trembling and
13 shaking the whole time, indicating to them that he has a lot of anxiety in his life right now and that his
14 mother is putting a lot of pressure on him. Steve told Ted that the interview of him in the Ford's parking
15 lot in Cleveland, by the Detroit media last week, when they confronted him about "flunking" the
16 polygraph, is going to be on the "Geraldo" show in Cleveland on Friday night. Ted became upset,
17 stating that he might have to move. Steve & Wayne earned Ted's confidence and told him that he
18 could just re-take the polygraph and the media "blitz" on him would go away. Detectives also told Ted
19 that he should talk to his pastor, indicating that his pastor wants to talk to him. Steve told me that Ted
20 said he's too embarrassed. Steve & Wayne told Ted that his pastor would not judge him and that he
21 should talk to him when he is feeling pressure. *** (Detective Wayne Mockler, tape recorded this
22 interview. See transcripts from the tape for more details of interview) ***

23 4-7-06: *** (Interview of Terry [REDACTED] *** John Oulette (FBI) and I went and interviewed Terry [REDACTED]
24 today down on Flora street in Detroit. Sharon [REDACTED] answered the door. We interviewed Terry for
25 approximately 45 minutes at his kitchen table. We didn't tell Terry that we had talked to [REDACTED] a
26 few days prior to him. During the course of this interview, [REDACTED] identified Ted Orr right away,
27 when I showed him a known photo of Lamborgine. Terry admitted a sexual relationship between he
28 and Bob Moore, but said that it took place on 14th St. in Detroit and not on Henry St. [REDACTED] also said
29 that Moore prostituted him out when he was a young teenage boy, stating that Moore drove him to a
30 home on a lake in Pontiac, Michigan and the older white man (Bill) that he had sex with, had a large
31 boat docked in front of the house. [REDACTED] went on to say that the homeowner paid Moore the money and
32 Moore in turn gave him some money for letting the homeowner perform oral sex on him. This matches
33 information from Lawson, who had stated in earlier interviews that he and Moore took a young boy to a
34 Chrysler executives home on the east side (possibly in Warren) back in the mid to late 70's and the
35 executive paid Moore to have sex with the boy. This also matches information from Tony Kawalcek
36 (See his interview). *** (See John Oulette's interview supp. on Terry [REDACTED] interview for more
37 details). ***

38 4-7-06: John Oulette (FBI) & I went to the home of Alan [REDACTED] at [REDACTED] Beech Daly in Redford Twp.
39 to interview him about Bob Moore and Ted Lamborgine. A woman answered the door and stated that
40 [REDACTED] must have moved a year or two ago and that she still gets mail for him. She stated that she
41 didn't know him.

42 4-7-06: "Geraldo at Large" showed the story in Cleveland tonight, that Scott Lewis ran on Ted
43 Lamborgine on Fox 2 News two weeks ago here in Detroit. Hopefully this will put more pressure on
44 Ted to cooperate.

45 4-11-06: I talked to Steve Scharschmidt (Parma Heights PD) on the phone today and asked he and
46 his partner Wayne Mockler to go back to Ted's apartment on Wednesday night to get his reaction on
47 the "Geraldo at Large" show in Cleveland Friday night. Steve is also going to, based on Ted's reaction,
48 remind him that he has another option other than quitting his job and moving and that is taking the
49 polygraph again. Steve & Wayne are then going to offer to drive him to Michigan to take the test,
50 indicating that he doesn't even have to talk to Williams or Gray, that they will just take the test and head
51 back to Ohio. I told Steve, that if Ted turns that down, we'll have you guys tell him that the test can be

1 set up in Cleveland by the FBI if he wants to do that. Scharschmidt agreed and told me that he would
2 call me on 4-12-06, after they run this by Ted.

3 4-12-06: I received calls today from John Oulette (FBI) & Garry Gray (MSP). Garry told me that he
4 was pulling out a tip at random from the tip file today, and noticed that the tip he pulled out was in the
5 name of Charles Flizer. This tip on a, Charles Flizer was called in by George McMahon. Included in
6 this tip information were three photographs of a funeral, with a note to Jerry Tobias from George
7 McMahon stating, hope these are helpful. George McMahon never mentioned any of this to
8 investigators when we interviewed him earlier this year and was real reluctant to talk about his
9 relationship with Chuck Flizer, even though Flizer had stabbed him. (Time to talk to McMahon again).

10 4-12-06: Dave Robertson (MSP) received and forwarded to the South Carolina state police, my e-mail
11 that included the signed search warrant for a "Buccal swab" for collection of a saliva sample for DNA
12 comparison on John W. Moore (Bob Moore's brother). Dave also e-mailed 9-10 questions that I
13 formulated for the state police in South Carolina to ask John Moore about his brother Bob.

14 4-12-06: Scott Lewis had called Garry & John today, with a tip he had received from a guy named
15 [REDACTED] who told Lewis that he was a child victim of Richard Lawson's back in the mid 1980's, when
16 Lawson was arrested living in a trailer park in Warren, Michigan. [REDACTED] phone numbers are:

17 I have the Warren Police Department reports of this incident, which involved
18 four children that were molested by Lawson at his trailer in Warren. In the Warren Police reports, the
19 child victims mention a boy that was staying with Lawson named "Jack" that had invited them to
20 Lawson's trailer. From the reports the children thought "Jack" was Lawson's son.

21 4-12-06: I called and spoke with [REDACTED] on the phone today who said that he saw Lawson on T.V. and
22 thought he should call. [REDACTED] said that he wasn't sure if his information would help at all, but said that
23 Lawson used a boy named "Jack" to lure them (he & the other victims) to his trailer back in the 80's and
24 that Lawson would buy them food (pizza) and take them to the movies and eventually molested them.
25 [REDACTED] told me that he and the other boys were hanging out at that time at the "Boys Club" at 9 Mile Rd.
26 & Van Dyke in Warren and that this "Jack" was coming in there and invited them to Lawson's trailer.
27 [REDACTED] told me that he thought "Jack" was Lawson's son at first and then realized that "Jack" was the
28 son or grandson of a woman he thought was named "Beth." [REDACTED] told me that he thought Lawson
29 was driving a green or brown Ford LTD at that time.

30 4-12-06: I called and spoke to George McMahon's wife tonight and asked her to have George call me.
31 I told her that I just have a few questions to ask him over the phone and that it wouldn't take long. She
32 said that George was teaching at Madonna University tonight and couldn't call right now, but she would
33 call him and leave a message for him to call me.

34 4-12-06: I called [REDACTED] tonight and asked him if he knew where Sarah Whipple is and told
35 him that I talked to Jimmy Whipple and asked him if Sarah is his sister. [REDACTED] said at first that he
36 thought Sarah was his wife. I told him that a Sarah Whipple used to hang around with Chuck Flizer
37 years ago and I would like to talk to her if he can find out where she is. [REDACTED] told me that he would
38 make a phone call and call me back.

39 4-12-06: Scott Lewis from Fox 2 News e-mailed two more photographs of Bob Moore that he got from
40 Detroit Police Dept. I only had the photograph of Moore from 1992. One of the new photos is from an
41 arrest of Moore in Detroit in 1978.

42 4-14-06: I called George McMahon today and spoke with him about the letter he sent to Jerry Tobias
43 back in the late 70's when George called in another tip on "Chuck" Flizer. I told George about the three
44 photographs that he (George) sent in to the Task Force. I asked George what the significance was
45 with those photos and told him that he had indicated in his letter to Tobias that he hoped these photos
46 would help. George stated that he didn't remember the photos and asked me what they are photos of?
47 I told him that there are three photos taken of a funeral, from what appears to be from the upstairs of a
48 building looking down on the funeral. George indicated to me that he does not remember the pictures
49 and thought maybe they were photos of "Chuck" Flizer that he was trying to get to the Task Force. I
50 asked George if there is another reason that he believes "Chuck" was involved in the killings of the kids,

1 indicating to George that he thought enough about it to call "Chuck" in to the Task Force on two
2 occasions. George said, "No, it's just a feeling I had about Chuck." George said that he had a vision
3 about a young child's body found in a gully near some railroad tracks years ago, but that "Chuck" was
4 not in this vision. I asked George if it was possible that he went along or if "Chuck" made him go along
5 on something that matched his vision, to which George stated "No." I asked George if we could get
6 together next week so I could show him the three photos from the funeral in the 70's, to which he
7 agreed to do.

8 **4-16-06: Easter Weekend 2006.**

9 4-17-06: *** (Interviewed McMahon & showed him photo's of Fliger) *** I went to George
10 McMahon's house today on Brainard Street to interview him about Chuck Fliger, Francis Sheldon and
11 to show him the photographs that he mailed to the Oakland County Task Force back in June of 1977.
12 George looked at the photos and said that he sent these particular photos in because Chuck Fliger is in
13 all three pictures, but he does not know whose funeral it is. Patsy McMahon also looked at the photos
14 and at first, disagreed with George about the guy in the photos being Chuck Fliger, due to the beard,
15 glasses and the nose being wrong for Chuck. Patsy then looked at the pictures longer and said that
16 she thinks now that it is Chuck Fliger. Patsy said that she wasn't sure whose funeral that is. I asked
17 George if he recognized the photographs of Francis "Frank" Sheldon, to which he stated he didn't. I ran
18 the name by him and the information about Sheldon teaching at Wayne State from 1967-77, being a
19 millionaire and owning an island near Charlevoix, Michigan. George said that he thought that the name
20 sounded familiar but that he wasn't sure. We talked more about Chuck Fliger today. At first George
21 told Detective Donnelly (Livonia PD) when asked, that he didn't think Chuck had ever been in the
22 Catholic seminary. When I pointed out that he (George) had called the information in back in 1977,
23 about Chuck, attending the seminary, George right away said, "that's right he was in the seminary."
24 George went on to say that Chuck Fliger ran the program at "Alexandrine House" (a halfway house) in
25 the Cass Corridor back in the 70's. I ask George whom Chuck worked for at "Alexandrine House," to
26 which George stated, "Father Kern." George gave me a picture of Chuck Fliger working at "Alexandrine
27 House." In this photo of Fliger, it does not look like the same person in the three photos George mailed
28 to the Task Force in 1977. I asked Patsy about Chuck Fliger's demeanor, to which she stated that he
29 was like two people, to which I asked her to explain. Patsy said that he could be calm and nice as can
30 be and then all of the sudden he would explode into a rage if he became upset about something. I
31 asked George and Patsy about the Pontiac Tempest that Chuck used to own. At first, both of them
32 denied that it was a Tempest and said they are bad with car models. They did both agree that it was a
33 grayish-blue Pontiac and that Chuck only had it for a short time. I ask George and Patsy if they knew
34 why Chuck had sold it, to which they stated that they didn't know, stating further that Chuck had bought
35 the car from George's mother. I asked George if Chuck used to confide in him about his life, to which
36 George stated that Chuck kept to himself and only talked about trivial things with him. I mentioned that
37 they were business partners in Cass-Temple Construction Co. George said they were indeed partners
38 in the "Cass Construction" co., but Chuck never talked to him about personal things. I pushed George
39 on this issue, stating that he lived with you didn't he George? George minimized this, stating that
40 Chuck only lived with them for a few months. George said that if I want to talk to someone who Chuck
41 may have confided in, it would be Fran Dorn on 2nd Ave., Pat Dorn's wife. George told me that Chuck
42 was close with Fran Dorn. I asked George again today about his involvement and relationship with Bob
43 Moore. George said that he used to go over to Moore's on Henry St. occasionally to take bikes in for
44 repair and were friends with Bob, although not close friends George added. I asked George about Bob
45 Moore working on cars at his house on Henry, to which George acted surprised, stating that he never
46 saw Bob working on cars in the driveway there. I mentioned that he worked on them in the alley at the
47 rear of the house on Henry, to which George stated that he wouldn't know about that. I asked George if
48 he knew any of the boys that lived or hung out at Bob Moore's on Henry St. back in the 70's, to which
49 he stated he might recognize a few of them. I showed George pictures of [REDACTED], [REDACTED],
50 [REDACTED] and ran the names of [REDACTED] and the [REDACTED] boys by him, to which George stated
51 that he didn't recognize any of the photos or names. A couple of times during the interview, George
52 brought up the guys that used to own "Birdtown" pet shop, stating that they were known in the
53 neighborhood to be pedophiles and to have hurt kids in the past (1970's). George said that there was

1 not much that he could add about these guys at "Birdtown." I asked George if a woman that has lived
2 in the Cass neighborhood for 40 years named Lilith Cunningham would know about Chuck Fliger, to
3 which he stated she would, stating further that "Lilith" knew about everyone and everything going on in
4 that neighborhood back then. This matches what [redacted] had told me about her. I asked
5 George about any family that Chuck Fliger might have in the area or out of state, to which George
6 began to talk about Chuck being raised in the St. Francis home in Detroit, indicating that he didn't think
7 he had any real parents and was later adopted. George said that Chuck must have had some kind of
8 good upbringing because Chuck was familiar with operas and classical music. I asked George about
9 Chuck being thrown out of the seminary years earlier, to which he stated that he thought there was a
10 story like that but he wasn't sure. I mentioned the "Precious Blood" seminary in Marion Ohio, to George
11 and got no response. George mentioned that he thought Chuck's real name might have been Charles
12 "Fligermeister" and that Chuck changed it later in life. I mentioned to George about Chuck living in
13 Birmingham at one time and George said that he thought that Chuck lived in Grosse Pointe years ago.
14 As the interview was coming to an end, I told George that the clothing from the child victims in the
15 OCKK case is now beginning to be processed by scientists at the Michigan State police lab for DNA
16 evidence and that investigators feel that there is a good possibility of positive results. George asked
17 me if they could get DNA from things so long ago, to which I told him they could. George asked me if
18 they can match DNA to people who have been dead for years, to which I told him, that they could. This
19 interview with George was then terminated.

20 4-17-06: I called and left a message today with Dave Robertson (MSP) to check on whether or not he
21 submitted a request to the Michigan State Police Intelligence unit in Lansing for records on Chuck
22 Fliger's death. I would like to have Fliger's body exhumed or obtain a DNA sample from a living relative
23 if possible.

24 4-17-06: I received a letter from the new Detective First Lt. of the MSP Second District today (Darryl
25 Hill). This is Garry Gray's new "boss." The letter is an invitation to attend a meeting regarding the
26 OCKK investigation, to bring all departments who have a direct connection with these homicides up to
27 date on what has transpired over the past year in this case. Investigators from all the different
28 departments involved are asked to prepare and give an overview on the investigative efforts they have
29 made on their leads in this case over the past year.

30 4-17-06: John Oulette called me today and we made arrangements to re-interview [redacted] at the
31 Livonia Police Department on Wednesday 4-19-06. Clark lied to investigators during the earlier
32 interview about his involvement with Bob Moore. Dave Robertson (MSP) did some checking and Clark
33 [redacted] is currently in registry violation as a Michigan Sex Offender for reporting the wrong address.
34 This is a felony. Clark is going to have to be cooperative with investigators to clear this up.

35 4-18-06: Tonight, the Parma Heights detectives (Scharschmidt & Mockler) are going to re-approach
36 Ted Lamborgine at his apartment in Parma Heights, Ohio and see if he would like to re-take the
37 polygraph test in this case, if they drove him up to Michigan to take it. If Ted does not want to come to
38 Michigan to take this, they are going to offer him a chance to take the polygraph in Cleveland with the
39 FBI. This has been pre-arranged by John Oulette (FBI Detroit).

40 4-18-06: I received an e-mail today from Detective Robertson (MSP). This e-mail contained Chuck
41 Fliger's death certificate from the State of Michigan Department of Health. This certificate was for
42 Charles Edward Fliger, white male, born [redacted] 1931. Died, 7-5-2005 at St. John's Hospital, County of
43 Macomb, City of Warren, Michigan. This certificate showed that Fliger died of natural causes while in
44 the hospital and his body was cremated. This certificate listed a Jean Hagopian as a "Friend" and
45 showed an address at [redacted] Statler in St. Clair Shores, Michigan. The certificate also showed that
46 Fliger had served in the Armed Forces. I will get a subpoena signed by a judge to fax to the National
47 Archives in St. Louis for these military records.

48 4-18-06: I went to the home of Jean Hagopian in St. Clair Shores today and spoke with her about
49 Chuck Fliger. I told her what I am working on and that Fliger's name came up in this investigation. She
50 acted surprised about this. I asked her how well she knew him, to which she stated that she did not
51 know him very well, because he was very tight lipped about his past. Jean said that Fliger told her that

1 he had spent time in prison in the past for "fraud" and that he has worked counseling ex-cons in the
2 past. Jean said that when she asked him what he used to do for a living, he said that he was self
3 employed, but never mentioned any specifics. I ask Jean if Fliger ever mentioned George McMahon or
4 that he was a partner with McMahon in the "Cass Construction Co." She said that Fliger never
5 mentioned McMahon or the business he was in. She told me that she became friends with Fliger in the
6 past 5-6 years after he began attending her church. When Fliger became ill in the past couple of years
7 before he died, she took care of him and his affairs. She said that Fliger was very active in the church
8 and with helping the "homeless" before he died. When Fliger died last year she took possession of his
9 van and donated it to a charitable organization. Jean told me that she is the person who cleaned out
10 Fliger's apartment when he died and that she has his property in boxes at her home still. Jean then
11 gave me a plastic tub full of all of Fliger's financial and personal records. I asked her if Fliger ever said
12 anything to her when he was dying, about being involved in anything criminal or bad, or specifically the
13 Oakland County Child Killings, to which she stated no and added that if he did, she would have told the
14 police right away. Jean took me into her basement and showed me five boxes of belongings that she
15 said belonged to Fliger and that she had not gone through yet. She told me that I am welcome to go
16 through the boxes or to take them with me, adding that she was going to get rid of the stuff anyway.
17 Jean also said that she had clothes of Fliger's in her upstairs closet if I wanted those. I took the tub of
18 financial records and Fliger's clothes for now. I told Jean that we would be back to pick up the other
19 boxes. I put several sport coats, pants and over coats of Fligers into plastic bags to preserve them. I
20 transported this property to the Livonia Police Department for processing. Being that Fliger's body was
21 cremated, there may be a possibility that his hairs are on his clothing that we could process to develop
22 a DNA profile on Fliger.

23 4-18-06: Detective Steve Scharschmidt from Parma Heights PD called me this evening and told me
24 that he and his partner Wayne Mockler had made contact with Ted Lamborgine at Ted's apartment. I
25 had asked these detectives to talk to Ted about possibly re-taking the polygraph test. Ted indicated to
26 them that he is not going to take the test again. Steve told me that they made the offer to Ted to drive
27 him to Michigan to take the test and he turned that down too. Steve said that they made the offer to
28 Ted to take the test in Cleveland and that the FBI would administer it. Ted told Steve and Wayne that
29 he would think about it. *** (See Parma Heights notes for details of this interview) ***

30 4-20-06: *** (2nd interview of Clark [REDACTED]) *** Today Garry, John & I interviewed Clark [REDACTED] at
31 the Livonia Police Department. We wanted to confront him with his relationship to Bob Moore and his
32 involvement with Moore on Henry St. in Detroit. We believe that [REDACTED] minimized this to detectives
33 during the initial interview. During the course of this interview, [REDACTED] indicated to detectives that he
34 had a conversation with his mother ([REDACTED]) who said something to Clark about her believing that
35 Herbie [REDACTED] probably cut up the car (Gremlin) for Bob Moore. Clark consented to a Buccal swab for
36 collection of a saliva sample for DNA comparison. The buccal swab from Clark was placed in an
37 evidence envelope, sealed & initialed by me, evidence tag# 9022 attached. *** (See Special Agent
38 John Oulette's interview supplement for further details. This report is in file marked "FBI
39 Reports"). ***

40 4-21-06: Today Capt. LaBerge & I went to the MSP Metro North Post to the meeting of detectives
41 involved in the Oakland County Child Killings, to update each other on the leads that each Dept. on the
42 Task Force has been working on for the last year. This meeting was also to get the status, of the
43 physical evidence (victim's clothing) in this case that is currently being processed at the Michigan State
44 Police Forensics Lab in Lansing, Michigan.

45 4-21-06: I made contact today with the producer (Ed Galick) of CBS channel 19 in Cleveland, Ohio.
46 Steve Scharschmidt had Ed Galick call me after I indicated to Steve that we wanted to keep "the heat"
47 on Ted in Ohio by using the local media. Ed Galick told me that he wants to confront Ted with cameras
48 for an interview and wants to do a story on this case in Cleveland. Channel 19 is coming to Michigan
49 on Wednesday this week to meet with Garry and I to get some background on this case for their story.
50 The meeting is set for the MSP Metro North Post.

1 4-24-06: I faxed a subpoena today to the National Personnel Archives Center in St. Louis, Missouri for
2 Charles "Chuck" Fligers military Records. The subpoena was signed by Judge Robert Brzezinski of the
3 16th Dist Court in Livonia, Mi.

4 4-24-06 I talked to Ed Galick today from Channel 19 in Cleveland, who advised that his station is
5 going to send a producer and a camera crew to Detroit on Thursday, to interview Garry & I for the show
6 they are going to air next week on this case in Cleveland. They are going to meet us Thursday, at the
7 MSP Metro North Post to do the interviews and film photos of the kids and the composites of possible
8 suspects. Galick has plans on asking Ted, if Ted will talk, why he killed those kids? I told Galick he
9 may also want to ask why he won't cooperate with authorities in this case? Galick is going to try to
10 confront him outside and see what his responses are to these questions. Galick is going to get with
11 Scharschmidt & Mockler in Parma Heights for the best time and place to confront Ted.

12 4-24-06: I called Jean Hagopian today and asked her about Garry & I coming to her home in the
13 morning tomorrow to go through the boxes of "Chuck" Fligers that she removed from the Fliger's
14 apartment when he died last summer. A time of 10:00 AM was set for tomorrow morning at her house
15 on Statler in St. Clair Shores.

16 4-24-06: Dave Robertson (MSP) e-mailed me today with information from South Carolina State Police.
17 Dave said that he got an email from the Lt. in South Carolina that has been assisting us who told Dave
18 that he had a death in his family recently and has not had a chance yet to execute our search warrant
19 in Myrtle Beach for the Buccal Swab on John W. Moore (Bob Moore's brother). The Lt. indicated to
20 Dave that they were going to talk to a prosecutor to try to get a simple court order, based on our
21 affidavit, to swab John Moore, rather than a search warrant.

22 4-24-06: I talked to John Oulette today from the FBI. John said that he has been in contact with the
23 FBI Profilers from Quantico, Virginia who are going to be at the University of Michigan in Ann Arbor
24 between the 1st and 4th of May. John has arranged for him, Garry & I to meet with these people for an
25 hour or so, dedicated solely to the Lawson, Lamborgine, Moore lead on the Oakland County Child
26 Killing case, on Tuesday May 2nd, 2006 @ 10:00am. John talked to them on the phone and we are
27 going to present the case to them and the background on this lead to get their opinion on the case and
28 suggestions for us on how to approach Lamborgine.

29 4-25-06: Garry Gray (MSP) & I went to St. Clair Shores today, to the home of Jean Hagopian. I made
30 arrangements with her to go through "Chuck" Fliger's belongings that she had gathered from his
31 apartment after he died last year. Garry and I went through about 5-6 large boxes that contained
32 mainly books and workbooks that Fliger had collected while in a federal prison in Kentucky. The only
33 piece of property that we took out of the house was a camera of Fliger's that had some undeveloped
34 film in it. Unknown whether or not it is of any value.

35 4-25-06: I talked to Ed Galick from Channel 19 News (CBS) in Cleveland today. He is sending his
36 producer ("Stanny" Grimes) and a camera crew to the MSP post to interview Garry & I at 11:30 AM on
37 Thursday April 27th. They talked to Scharschmidt in Ohio, interviewed him and plan on approaching
38 Ted as early as tonight for an interview. They will "air" this next week in Cleveland. 4-25-06: I talked
39 to Scott Lewis today from the Fox News (Channel 2) in Detroit. He called his Fox affiliate in Cleveland
40 and they also want to "air" a news story in Cleveland about Ted Lamborgine's involvement in the
41 Oakland County Child Killings.

42 4-25-06: I talked to Bill Sheils from the Fox News Channel in Cleveland. He said that he wants to try
43 and get this story on the news in Cleveland by the end of this week and is going to have Scott Lewis do
44 the interview with Garry & I tomorrow afternoon, rather than him coming to Detroit.

45 4-25-06: *** (Phone interview of ██████████) *** I talked to ██████████ today, the mother of
46 Clark, "Herbie," "Jimmy" & Donna ██████████. Jane said that she remembers Bob Moore and Ted Orr very
47 well from the neighborhood on 14th St. She said that if there were anyone that she can think of or that
48 would have been capable or committed a crime like this with the kids, it would have been "Bob" Moore.
49 I asked her why she says that, to which she stated that it's hard for her to put her finger on it exactly,
50 but that she remembers a 6-7 year old boy coming up missing on 14th Street one time and someone

1 saw this boy go into Bob Moore's house. Jane went on to say that the parents of the boy knocked on
2 the door and Moore would not open it until the police from the 3rd precinct arrived and demanded that
3 Moore open the door. I asked Jane if the boy was "Tommy" , to which she stated she didn't
4 remember the name. I told her that several other people told me a story like that, but that it took place
5 at Bob Moore's house on Henry Street in Detroit. She responded with it probably happened at both
6 places. I asked her if she remembers a Saturday in the spring of 1977, when her and her husband
7 along with two daughters stopped by the alley behind Bob Moore's house on Henry and her husband
8 helped Ted Orr, Bob Moore and "Red" push Moore's Gremlin into the back of a truck, with Clark Lankey
9 steering it. Jane asked me if Clark said he did that. I told her that Clark said that he probably did, but
10 that he doesn't remember for sure because he was high on glue all the time that Bob Moore would give
11 him. Jane acted surprised about Clark getting high all of the time. Jane said that she does not
12 remember her husband pushing a Gremlin or seeing a car being pushed into a truck at Bob Moore's.
13 She said that Bob Moore did own a Gremlin back then but she doesn't remember what color it was.
14 She also said that her best friend lived in the apartments next to Bob Moore's house on Henry and that
15 she remembers a large trailer from a tractor trailer in the rear yard of Bob Moore's house on Henry in
16 the late 70's. I began to talk to her about "Herbie" and his involvement with Bob Moore in the
17 1970's. She said that Herbie was another one of her sons that was close with Bob Moore. I asked her
18 if she made a statement to Clark that she believed Herbie probably did cut-up the Gremlin for
19 Bob Moore. She said that she didn't say that and continued with the fact that she thinks Herbie would
20 have done that for Bob Moore if Moore wanted him to. She also said that the young boys would do
21 everything that Bob Moore asked them to do. She added that Herbie was into all that stuff with cars
22 (referring to stealing and chopping-up cars) and got into trouble with the police over it. Jane appeared
23 to me to be semi-protective of Herbie, especially when I talked to her about the fact that Herbie left
24 Michigan because he "fire-bombed" his sister Donna's house in the early 80's. Jane said that Herbie
25 had nothing to do with that and as a matter of fact, he was sitting on her front porch when that
26 happened, so I know he didn't do it. I asked Jane if she thought Herbie would talk to me about possibly
27 "cutting-up" the Gremlin for Bob Moore, to which she stated no. She told me that Herbie lives in
28 Tennessee with her brother and sister-in-law. I asked Jane if she could call and have Herbie call me, to
29 which she stated she would try. I had to hang up at this point, but called her back approximately one
30 hour later and talked to Jane about Ted Orr. At first she said she knew him very well from the
31 neighborhood and used to see him all of the time on 14th St. and on Henry St. with Bob Moore. She
32 said that Bob and Ted both liked the young boys and that she got real upset with Ted one time when
33 she came home and found Ted at her house with her son "Jimmy" whom Ted had gotten drunk. Jane
34 said that Jimmy was about 15 at the time and that she told Ted "to get the hell out of her house." I
35 asked Jane if she recognized Richard Lawson on the TV, to which she stated she wasn't sure about the
36 face, but the name was real familiar. When I described Lawson 30 years ago and said that they called
37 him "Rich" or "Big Rich" she said she remembered him now. I asked her where she would see Lawson
38 at, to which she stated that she saw him with Ted and Bob at Bob's on 14th St. and on Henry St. several
39 times. I began to talk to Jane about how she could approach Herbie to call me, when she said she
40 already called down to Tennessee. I asked her what he said, to which she stated that Herbie said that
41 he knew what was going on up here in Detroit, he had nothing to do with it and doesn't want to hear
42 about it anymore. This interview was terminated for now.

43 4-26-06: Today is a meeting at the Oakland Sheriffs office with the Task Force and a retired Oakland
44 County Detective Lt. John Taylor, who is going to supply us with some information that he says he has
45 about the investigation in the late 70's into the OCKK case, including the Timothy King murder. Lt.
46 Taylor presented about an hour and a half worth of information on his investigation, all about suspect
47 Paul Johnson. It was interesting information with a lot of circumstantial evidence that would point
48 toward Paul Johnson, but nothing concrete or enough to get a warrant. Also there is no evidence that
49 Paul Johnson was a pedophile and almost no evidence that he was a homosexual. Taylor said that
50 Johnson had told him during interviews early in this investigation that he dressed Timothy King before
51 he dumped his body in Livonia. Taylor told us that Johnson had told him that Timothy King rode in the
52 front seat of the car with him when he went to dump the body and that he thought he was still breathing
53 on the way there. Johnson has tried to confess in the past to killing all four kids but has been

1 discredited. Johnson has been in an out of psychiatric hospitals, has a bad past drug problem and has
2 been treated for schizophrenia with medication for years. Johnson was given a polygraph about his
3 truthfulness with this information he gave Lt. Taylor and failed. The Oakland County Sheriffs Dept. (Lt.
4 A'Hern & Sgt. Wurtz) have agreed to look into this lead a little further and possibly swab Paul Johnson
5 for DNA comparison. Some of the evidence matches the information in this lead and some does not.

6 4-26-06: I talked to Jane [REDACTED] today and asked her to call her brother in Tennessee and see if he
7 would give Herbie [REDACTED] my phone number to call me. I told her that we don't believe that Herbie was
8 involved in the killings and that he is not in any trouble, indicating to her that all I want to do is ask him
9 one question about the "chopping-up" the car to fill in a small piece of the puzzle. I told Jane that we
10 could go to Tennessee and talk to Herbie, but that it would be easier for us, and him to take five
11 minutes on the phone. She told me that she agreed and would try to get this info to Herbie, to call me.
12 I'm waiting to hear back.

13 4-26-06: I received a call this morning from Ed Galick at Channel 19 News (CBS) in Cleveland that
14 told me that they had confronted Ted Lamborgine in the parking lot of his apartment last night. Ed
15 stated that he and his camera crew had set-up in the parking lot of Ted's apartment and waited for him
16 to come home. Ed said that when Ted pulled in and began to get out of his truck, he (Ted) noticed Ed
17 and the camera crew coming toward him and Ted began to run for the common entrance door of his
18 apartment building. Ed stated that when Ted got to his outside door and "keyed" his way in, he began
19 to pull the door closed behind him when Ed and the crew caught up to Ted. Ed said he told Ted that he
20 wanted to talk to him about killing those kids in Michigan 30 years ago. Ed told me that Ted, with a
21 vicious look on his face, used two hands and viciously pulled the door out of the hands of the news
22 people, at which time it locked. Ted then ran down the hallway away from the news crew. Ed told me
23 that they filmed this incident with Ted.

24 4-26-06: Scott Lewis interviewed Garry and I today, on camera for their Fox affiliate in Cleveland who
25 is going to "air" this story there tonight in the Cleveland area. This should "keep the heat on Ted."

26 4-26-06: Pastor Richards called me last night and wanted to talk about Ted's behavior at church lately.
27 The Pastor said that Ted for the past month or more has been very quiet and avoiding contact with the
28 Pastor while at church. Pastor Richards noticed in the past two Sundays that Ted has began to talk to
29 people again and talk to the pastor at church. This matches what Detective Scharschmidt told me
30 about Ted seeming more comfortable and relaxed last week when they talked to him. Ted told
31 Scharschmidt last week that he is beginning to sleep again and Ted thought that no one saw the
32 Geraldo Story in Cleveland a few weeks ago. Scharschmidt had told me that a month ago Ted was a
33 nervous wreck about this case, but last week began to relax because he thought he had made it
34 through the rough spots. This is just like Ted to "hunker down" and try to "ride out the storm."

35 4-27-06: Today Garry & I did an on camera interview with the Channel 19 (CBS) News out of
36 Cleveland about our lead in the OCCK case, into Ted Lamborgine. They are supposed to "air" this on
37 Monday May 1st.

38 4-27-06: Scott Lewis from Fox 2 in Detroit called me this afternoon and told me that Bill Shields from
39 his Fox affiliate in Cleveland called him and wanted to know if we (The Task Force) knew about the
40 unsolved abduction/murder of an 11 year old girl in Bay Village outside of Cleveland in 1989. I told
41 Scott that I was familiar with that and that I had talked to a Detective Elish at Bay Village PD in July or
42 August of 2005, about this murder. Scott told me that Bill Shields said that the girl was molested, fed a
43 meal shortly before she was killed, and a jogger found her body on a rural road outside Cleveland. I
44 asked Scott Lewis to check with Bill Shields and confirm his facts on this information. This is different
45 from the information I obtained from the Bay Village Detective in August of 2005. (See this report on 8-
46 9-05 for details of info I received from Bay Village). Based on the information that I received today from
47 Scott Lewis, I called Detective Jay Elish at Bay Village PD and left a message requesting that he fax
48 me a copy of their reports and file on this case if possible. A lot of the facts in their case sound
49 different, but maybe worth a look.

1 4-27-06: I talked to Dave Robertson today about whether or not the South Carolina State Police have
2 contacted him and have they executed the search warrant yet, that I E-mailed to them a couple of
3 weeks ago. Dave said that they did receive the e-mail and have talked to their prosecutor about it.
4 They are going to "cut-n-paste" my affidavit onto their search warrant form, have their judge sign it and
5 should be executing it shortly.

6 5-1-06: Jean Hagopian called me today and said that she is now in possession of "Chuck" Fliger's
7 ashes if we want them for evidentiary reasons. I told her that I would check with MSP & FBI and get
8 back to her on that tomorrow. Fliger was cremated and this may be our only possible avenue to
9 develop a DNA profile for Fliger.

10 5-2-06: Today, The Task Force (Me, Garry & John) met with criminal profilers from the FBI's
11 Behavioral Analysis Unit in Quantico, Virginia. Present at the meeting was Gerard Downes, Robert
12 Morton and Kirk Mellecker from the FBI. Also at this meeting were Peter Collins and Jim Van Allen
13 from the Ontario Provincial Police (OPP) Behavioral Science Section. We presented the background
14 on the OCKK case and the information on this lead into Lawson, Moore & Lamborgine. We discovered
15 during the meeting, that some of the autopsy reports on the victims were possibly incorrect information
16 on "Times of Death" and inconsistencies between the autopsy reports and the photographs in regards
17 to the victim's injuries, Ante-Mortem & Post-Mortem. We talked a lot about our lead. The profilers
18 believe that the suspect in this case is one person, even though John, Garry & I still believe there were
19 possibly two people involved. The profiler's think that this person may have had something traumatic
20 occur in his life just prior to these crimes beginning and maybe they were resolved after a while and
21 these crimes stopped. The profilers said that they could have stopped when the suspect got his life
22 back on track. They liked Ted as a suspect and said that the polygraph and Ted's actions is a good
23 indicator of his involvement or knowledge, but that they don't think we should get too locked in on Ted
24 and not look at other leads. They said Richard Lawson is a "psychopath" and said that he could have
25 passed that polygraph once a week if he wanted to. They said that this lead into Ted, Bob Moore and
26 Lawson is a possibility, but that it would be rare. They added that only 3-4 cases in their FBI serial
27 killing files, out of 300-400, involves the serial killings of children and that it is very rare. They also said,
28 that we need to concentrate on why the killings started and forget about why they stopped.

29 5-2-06: Pastor Richards called me today and said that he met with Ted at Ted's request, at Ted's bank
30 and he took the Pastor off of all his bank accounts, telling the Pastor that he is probably going to have
31 to move because of what the media is reporting about him. Ted told the Pastor that fellow employee's
32 at Fords have told Ted that he better burn his Ford hat. I had instructed the pastor to encourage Ted to
33 stay where he's at and not to make a quick decision about moving because there are people at the
34 church, including the pastor those cares about Ted. I had the pastor tell Ted that this media stuff is
35 going to go away eventually. The pastor told me that Ted listened to what he had to say, but only
36 responded with "ok" and didn't say much else. We are going to have Steve Scharschmidt try to befriend
37 Ted even more than he has and tell Ted that that he (Ted) has said in the past that he hasn't done what
38 we think he has, so tell us what it is you've done so the detectives in Michigan can forget about you and
39 move on. We are going to have Steve tell Ted that they are not interested in anything he has done in
40 his past that is not connected with this case. Maybe Steve can get Ted to at least tell him what it is he
41 is holding back that made him fail that polygraph.

42 5-3-06: I called Jean Hagopian today about Chuck Fliger's ashes. Jean told me that her and the
43 pastor from their church, the church Chuck attended, dug up Chuck's ashes that they had buried at the
44 church in a box. I asked her to hang on to Chuck's ashes for me for now and that we would pick them
45 up next week, she agreed.

46 5-4-06: I packaged up the "Chuck Fliger" evidence today that had been recovered from Jean
47 Hagopian, the homeowner at Statler in St. Clair Shores, Michigan. The evidence was tagged
48 and placed in the downstairs property room of the Livonia Police Dept. Chuck Fliger had lived with
49 Hagopian for a while and Hagopian cleaned out Fliger's apartment and collected his property (personal
50 belongings when he died).

1 5-4-06: I talked to Steve Scharschmidt from Parma Heights PD today and we went over their
2 approach to Ted Lamborgine for tonight.

3 5-4-06: I talked to Shane Liddick today from the San Diego Magazine. This is the guy that wrote a
4 story about Richard Lawson's alien smuggling days in San Diego. This story was in last years, April
5 issue. I knew Liddick is writing a book about Lawson's life and had probably been in contact with
6 Richard over the phone. I asked Liddick if he has talked to Richard lately, to which he stated he talked
7 to Richard yesterday. I asked Liddick how Richard is doing, to which he stated that he seemed okay,
8 maybe a little down in the dumps. Liddick said that he is continuing to write stories that are follow-ups
9 to the smuggling stories and does plan on writing a book about Richard and possibly about the Giller
10 murder and Oakland County Child Killing case. Liddick indicated to me that it would be a difficult
11 project due to the fact that access to Richard Lawson is limited. Liddick told me that Lawson talked to
12 him a year or so ago about the OCKK case and he's done some reading on his own to learn about it
13 since then. Liddick said he thought that it is a very interesting case. I told Liddick to keep in mind that
14 maybe we can help each other out. Maybe we could assist him with access to Lawson in exchange for
15 us receiving information from Lawson through him, about the OCKK case that may assist in solving the
16 case. I reminded Liddick that if he mentions this to Lawson, we would not get the info we wanted and
17 he would not have the story he was looking for. Liddick said he understood what I was suggesting and
18 that he would have to think about it. I asked Liddick to keep in mind that there are several families and
19 hundreds of friends and associates that were affected by these killings that he may be able to assist
20 with resolution. Liddick indicated to me that he would have to think about this and think about his moral
21 obligation to Richard as a source of his and a friend. I told Liddick to think about it and get back to me.

22 5-4-06: Detective Steve Scharschmidt from Parma Heights PD called me tonight and told me that the
23 meeting with Ted went fine. Steve said that his partner Wayne Mockler went with him to Ted's
24 apartment and that they tape-recorded the conversation. Steve stated that Ted was now officially done
25 at Ford Motor Company and is currently on vacation status until he begins his retirement in three
26 weeks. Steve said that he and Wayne played up the fact that the Michigan detectives are the "bad
27 guys" and that they (the Parma Heights detectives) are his friends and the "good guys." Steve said that
28 Ted liked the fact that they were able to keep the second Cleveland local news story off the air about
29 Ted. Steve said that Ted invited he and Wayne out for dinner next week and Ted said he was buying
30 for his retirement. One of the most interesting statements made by Ted during this meeting was made
31 when Steve was asking Ted about failing the polygraph test. Ted said to Steve and Wayne, something
32 like I'm not bragging or anything, but I think I've made it through the worst of what the Michigan
33 detectives can throw my way. ***** (See transcripts of tape recorded conversation from Parma
34 Heights PD for more detail of this meeting) ******

35 5-9-06: Still no word from the South Carolina State Police of the "Buccal Swab" from Bob Moore's
36 brother in Myrtle Beach.

37 5-9-06: I received a package in the mail today from the Parma Heights, Ohio detectives. It was the
38 transcripts from the meeting that Scharschmidt and Mockler had at Ted's apartment, with Ted on April
39 6th, 2006. Detective Mockler had recorded the conversation. Ted made some interesting statements to
40 these detectives during this meeting. ***** (See highlighted transcripts of tape-recorded
41 conversations from Parma Heights PD from April 6th, 2006 for details).**

42 5-11-06: I talked to a woman named Holman today from the National Archives in St. Loius. She said
43 that she had received the subpoena I had faxed her for Chuck Fliger's military records. She said she
44 has already processed my request and had mailed Fliger's records to me.

45 5-12-06: Jim Murphy called me today with some information related to our lead into the Cass Corridor.
46 Jim said that he remembered the name of the Detroit Officer that was a pedophile and owned
47 apartments with another pedophile named John Fonville in the 70's. Murphy said that in the mid to late
48 70's, when they raided Fonville's apartment and found child porn, DPD Officer "Ron Getta" was part
49 owner of that building. The place that DPD raided was at 389 W. Grand Blvd. Detroit, Michigan. Jim
50 said that he thought that "Getta" used to work at the old 2nd Precinct that later became #3. Murphy
51 went on to say that he got the name from talking to George McMahon, who Murphy ran into at a party

1 at Pat Dorn's house a week or so ago. Murphy said that McMahon was talking about how the police
2 won't leave him alone and made him take a polygraph test. Murphy told me that he got McMahon
3 talking about John Fonville and Fonville's partner and McMahon said, "You mean Ron Getta." I got
4 talking with Jim about his wife Cindy and her having been to Bob Moore's house in the late 70's and
5 seeing Moore and some young boys chopping up a small car in the rear yard on Henry Street. Murphy
6 said that Cindy said there was a "step" type van in the rear yard at Moore's house when they were
7 chopping that car up, but she didn't remember what type of car it was. She told Jim that Clark or
8 Charles [REDACTED] was in the rear yard that day cutting up that car with other boys. Jim told me during an
9 earlier interview, that Bob Moore chased the girls away from the rear yard that day because of the car
10 they were cutting up. Murphy's wife told him that her friend Maria went back to Moore's house that day
11 after being chased away by Bob Moore with a baseball bat. Murphy said that Maria was friends with
12 Clark [REDACTED] and that is why she went back over there. I asked Murphy to get me some info on Maria
13 so I could locate and talk to her, he agreed, stating he would call me back. Murphy began talking about
14 George Seltana that owns the 3rd Ave. Hardware store in Cass Corridor. Murphy said that Seltana
15 owned the "Hollywood" hotel on Henry St. in the 70's. This hotel was located right next door to Bob
16 Moore's house. Murphy also said that Seltana owned the Ansonia hotel in the Cass Corridor back
17 then, which Murphy said was a hotel known for child prostitution. We got talking about "Tommy Bright"
18 (the guy that found Moore's body when he died) and I asked him to try to get info on Bright's
19 whereabouts or get me some info on him so I could locate him, Murphy agreed to try to do this.

20 5-12-06: We still have not received word from the detectives at the South Carolina State Police in
21 regards to them executing a search warrant at Bob Moore's brother's house in Myrtle Beach to collect
22 saliva for DNA analysis. Dave Robertson talked to them on the phone several weeks ago and they said
23 that they had to put the information from the affidavit into their own search warrant form to get signed
24 and that they would be taking care of that as soon as they can. ITS BEEN WEEKS.

25 5-12-06: The Michigan State Police Forensics Lab in Lansing is continuing to process Jill Robinson's
26 clothing for DNA material. The lab has had this victims clothing for several weeks now and will
27 completely finish Robinson's before beginning to process the next victim's clothing.

28 5-12-06: *** (Obtained old photos of The Boys from Faye [REDACTED] *** Faye [REDACTED] and her
29 sister Betty came into LPD tonight for an interview. Faye brought pictures of the two [REDACTED] boys
30 (Bobby Lee & Charles) from 1982. Faye said that she and Richard Lawson were taking care of those
31 two boys then and that Richard is the one who bought the clothes for those boys to wear in the picture.
32 Faye said that Richard bought Charles a suit & tie and bought Bobby Lee a shirt only for the picture.
33 Faye said that this is because Richard was closer with Charles [REDACTED] at that time (meaning closer
34 sexually). I asked Faye about living at Ted Orr's apartment and she stated that it was at Junction and
35 Porter and that she and Richard lived there together, after Ted moved out and before her and Richard
36 moved into a house on Rademacher. Faye also said that it was after her and Richards house burned
37 down on 23rd St., (Faye said she believes Richard and his step-brother burned it on purpose) that they
38 moved into Ted's apartment. I told Faye that Ted denied that her and Richard ever lived in his
39 apartment, to which she stated that she doesn't understand why he would do that. Faye said that it
40 would have been approximately 1982 when her and Richard moved into Ted's apartment. She went on
41 to say that Richard began to have financial problems at that time and that they both had their cars
42 repossessed then because Richard wasn't making the payments. During this conversation, Betty
43 (Faye's sister) said that she thinks that Richard and Jim Tippett were involved in the Oakland County
44 Child Killings. I asked her why she thinks that, to which she stated that Tippett was a pedophile, was
45 kind of secretive and because he was such a "neat freak" (Obsessive Compulsive). She had nothing
46 else to add other than she just feels that way about Tippett.

47 5-15-06: Today we received the "Buccal Swab" in the mail from the South Carolina State Police from
48 Bob Moore's brother, John W. Moore. They (S.C.S.P.) executed the search warrant and collected the
49 saliva/DNA sample on May 2nd, 2006. We received the swab at the Michigan State Police, Metro North
50 Post. Garry Gray or Dave Robertson will take care of shipping it ("Buccal Swab") to the FBI, DNA lab in
51 Quantico, Virginia for processing and comparison.

1 5-16-06: Dave Robertson (MSP) informed me that he shipped the "Buccal Swab" from Bob Moore's
2 brother to day, to the FBI Lab in Quantico, Virginia. Dave said that he also left a message for the DNA
3 Lab Director there, informing her of the shipment and requesting that they expedite the process and
4 comparison.

5 5-22-06: I put the two photographs from Faye [REDACTED] of the two " " boys, in the black LPD
6 binder, in the Richard Lawson section. We still have not heard anything from the Michigan State Police
7 Lab in reference to the DNA processing they are currently conducting on Jill Robinson's clothing.

8 5-23-06: I received the transcripts back today from the tape recorded conversations, during the 2nd
9 meeting between the Parma Heights, Ohio detectives and Ted Lamborgine. They will be in the
10 Lamborgine file. I also talked to John Oulette (FBI) today and we are planning to try to locate an
11 associate of Ted Lamborgine's from Detroit in the 1970's, named Donald Fritsch on Thursday this
12 week. Fritsch shows a current drivers license and addresses in the southwest Detroit area.

13 5-24-06: Jim Murphy called me today and gave me the name of the girl that was with his wife Cindy
14 Murphy at Bob Moore's house, the day Moore was "cutting-up" a car in the rear yard near a large box
15 truck. Jim said her name is Maria Ann Wilbert w/f, born [REDACTED] -65 or [REDACTED] 35. Jim told me that this was
16 the girl that his wife said, went back to Moore's house after Moore chased them away with the baseball
17 bat. Maria Wilbert was dating one of the [REDACTED] or [REDACTED] boys at that time and she was returning to
18 Moore's house on Henry St. to see one of those boys that was there, working on the car that was being
19 cut up.

20 5-25-06: Today I identified Maria Ann Wilbert. She moved to Oklahoma in March of 2006. Her age
21 matches almost exactly to what Murphy's wife Cindy gave for Maria Wilbert. I also thought I had
22 Tommy Bright identified today, so I called and left a message for Jim Murphy with the info on Bright in
23 an attempt to confirm, whether or not this is the right Tommy Bright. I received a message back from
24 Murphy who stated that the Maria Wilbert is right but that he didn't think the Tommy Bright I had found
25 was the right one. Murphy further stated in his message that he heard Tommy Bright moved to the
26 Jackson, Michigan area, possibly in Hillsdale County.

27 **5-27-06: Memorial weekend 2006**

28 5-31-06: [REDACTED] left a message on my phone today, stating that if I was not aware of it and
29 for what it is worth, the guys from the "Birdtown" pet-shop in Cass corridor, are packing, closing up the
30 shop and supposedly moving out of state.

31 6-1-06: I never received a response back from the "Free-Lance" reporter from the San Diego
32 Magazine (Shane Liddick), that has written stories about Richard Lawson and was going to consider
33 my offer to him to sit down in prison with Lawson and get him talking about his involvement in the
34 Oakland County Child Killing case, in exchange for easier access to Lawson for his book he is writing
35 about Lawson's life. Liddick indicated to me that he might have a moral dilemma with this agreement,
36 considering that he has become friends with Lawson. I told Liddick exactly whom it is, that he is
37 becoming friends with. Liddick said that he understood, but has yet to call back.

38 6-15-06: I talked to John Oulette from the FBI today, who stated that the results of the DNA
39 comparison from Bob Moore to the hair from Timothy King, came back negative for a match. This
40 information on the comparison is from Connie Fisher (DNA Lab Director at the FBI Lab in Quantico),
41 who performed the work in this case. John is going to fax me the written report with this information for
42 the file. Moore's profile will be kept on file at the FBI Lab for possible future comparisons to evidence
43 from the victims clothing that is being processed now by the MSP Forensics Lab in Lansing. (See Bob
44 Moore file for a copy of the FBI/DNA report from Quantico)

45 6-15-06: John Oulette told me today that Garry Gray had a conversation with Rob Moran last week
46 about possibly charging Ted Lamborgine with CSC's from the 1970's & 80's, based on admissions
47 made by Lamborgine about his involvement in child molestations back in the 70's & 80's. According to
48 John, it sounds like Moran would be inclined to sign the warrants for Lamborgine based on this
49 information.

1 6-19-06: Garry Gray (MSP) sent me an e-mail today stating that he has not heard from the DNA "gal"
2 at the Michigan State Police lab in Lansing yet. She is supposedly still processing Jill Robinson's
3 clothing. Garry has left several messages for her to call him.

4 6-20-06: I talked to Rob Moran today from the Wayne County Prosecutors Office. We discussed the
5 possibilities of charging Ted Lamborgine with past CSC's on young boys from the 1970's. Moran
6 indicated that the statute states that there is a ten-year window to file charges on old CSC cases, but
7 the "clock stops ticking on the 10 year time frame, if the suspect moves out of state." I told Moran
8 about the admission's that Ted has made in the past to Parma Heights detectives, about his past
9 sexual relationships with minor boys and the fact that we have interviewed some of those victims from
10 years ago that have corroborated this. I informed Moran that we are continuing to investigate this and
11 talk to Ted and other victims from years ago and that we would meet with him after we put it all
12 together. Moran said that from what I have told him so far, that he would be inclined to approve a
13 warrant for Ted for the old CSC's, once we have it put together.

14 6-20-06: *** (Interview of [redacted]) *** Today, John Oulette (FBI) & I interviewed [redacted] in
15 front of his house on Waldo street in southwest Detroit. We talked to [redacted] about his past
16 relationships with Ted Lamborgine & Bob Moore. [redacted] said that he knew these guys from the
17 neighborhood back in the 70's, but hasn't seen them for many years. [redacted] stated that it was common
18 knowledge in the neighborhood around 14th street & Seldon that Ted Lamborgine and Bob Moore were
19 homosexual pedophiles. [redacted] said that Ted payed him \$10.00 several times if he let Ted perform
20 oral sex on him. [redacted] said that he remembers that he was about 15-16 years old at that time and
21 that Ted drove him to school afterwards [redacted] stated that Ted had taken him and some of the
22 neighborhood boys ([redacted] & [redacted]) to see the movie "Warriors" the one time before Ted performed
23 oral sex on him. [redacted] said that he thought this was approximately 1976 when Ted was paying him
24 for sex and that Ted was living in an apartment at the Shady Lane Apartments in Detroit at the time.
25 [redacted] described this complex as being off W. Grand Blvd. & Shadylane in Detroit. Fritsch said that he
26 thought Clark [redacted] was closer to Ted than he was, but that a w/m named Terry Jones was with Ted
27 more than anyone. [redacted] described Jones as being a w/m in his 20's at that time [redacted] went on to
28 say that the boys in the neighborhood all knew that Ted and Bob would pay for oral sex on the young
29 boys, but that no one talked about it. [redacted] said that he knew that the [redacted] boys were very close
30 with Ted, especially Mike [redacted] who is now deceased. I asked [redacted] what kind of car Ted was driving
31 back then, to which he stated a Lt. Blue Ford Pinto, hatchback with a red & blue stripe. [redacted] said that
32 Ted never asked him to have anal sex or tried to force him to, but that Ted did become very angry &
33 violent with a young boy one time and that someone had to hold Ted back. [redacted] did not know exactly
34 what happened, but that the boy said something to Ted, who became enraged. [redacted] said that he
35 thought Ted was a very well built strong man. [redacted] appeared to recall being afraid while describing
36 that incident to us. *** (See FBI agent Oulette's report for more details of this interview). *** (In
37 FBI reports folder)

38 6-21-06: I talked to Pastor Richards on the phone today, who said that he has not seen or heard from
39 Ted in approximately 1 ½ months or more. Pastor Richards told me that he was in fact taken off all of
40 Ted's accounts and removed as the Power of Attorney for Ted. Pastor Richards stated that he is going
41 to try to contact Ted either in person or on the phone to let him know that he and the people at the
42 church are concerned about him and that they would like him to start attending church again. The
43 Pastor is going to call me after he has contact with Ted.

44 6-21-06: *** (Today I identified Ronald and Robert [redacted] a.k.a., "Skinny" & "Fats") *** Using the
45 information obtained during the interview of Terry [redacted], about his twin brothers, Robert & Ronald, I
46 performed a check through the LEIN system on Ronald & Robert [redacted] and located a Ronald Edward
47 [redacted], born [redacted]-1962 & a Robert Edwin [redacted], born [redacted]-1962. A check through Secretary of State
48 revealed a State of Michigan P.I.D. for Ronald Edward Eads (whose disabled), and a state of Michigan
49 Drivers license for Robert Edwin [redacted]. This check showed both subjects to be born [redacted] 1962.
50 The check also showed both subjects to reside at [redacted] Reeck Rd. in Woodhaven, Michigan. I
51 requested and received photographs from Secretary of State of both subjects.

1 6-22-06: *** (Today we interview [redacted]) *** Today, Garry Gray (MSP) and I went
2 to [redacted] in Woodhaven, Michigan and interviewed [redacted] s about his past involvement
3 with Ted Lamborgine, a.k.a. Ted Orr, Richard Lawson and Bob Moore. [redacted], who is physically and
4 mentally disabled, was at the house with his sister-in-law ([redacted] Ronald's
5 caregiver). The twin brother, Robert [redacted] was at work. I told [redacted] that we were there to talk to him
6 about Ted Lamborgine and he said he doesn't know whom that is. I said how about Ted Orr and
7 Ronald responded with, I haven't heard that name in years. Ronald and Tammy both indicated that
8 they knew why we were there, stating that they saw the news stories about Ted and Bob Moore and it
9 really "shook them up." We began talking to Ronald about past sexual encounters with Ted Orr.
10 Ronald told detectives that the first time Ted paid him to perform oral sex on him (Ronald) was when he
11 was 13 years old in 1976. Ronald said that it was a real hot day in late June or July of 1976, Ted took
12 him and two other boys to Belle Isle for the day in Ted's teal green Ford Pinto with a brown stripe on it.
13 Ronald stated that the other two boys, were friends of his, one, he described as being a black male
14 named "Day-Day" that lived on Wabash Street in Detroit and was approximately the same age as
15 Ronald. He described the other boy as being a white male, about the same age, but does not
16 remember his name. Ronald told detectives that he remembers when it was, because it was after
17 school was out for the summer and before his birthday in July. Ronald said that after they returned
18 from Belle Isle, Ted dropped off the two other boys and took him (Ronald) to his (Ted's) apartment on
19 Vinewood in Detroit. Ronald said that Ted gave him \$20.00 and performed oral sex on him. I asked
20 Ronald if Ted tried to have anal sex with him or asked him about that on that day or any other time, to
21 which Ronald stated "no." I asked Ronald if Ted ever became violent or tried to force him to have sex,
22 to which Ronald stated "no." [redacted] indicated to detectives that Ronald attended Special
23 Education classes when he was a boy and a young teenager, and has approximately a 6th grade
24 education. I asked her if that was common knowledge in the neighborhood and if Ted would have
25 known that, to which she stated, absolutely he would have, everyone knew that.

26 Ronald stated that there were several other occasions when he was a teenager, when Ted would pay
27 him to perform oral sex on him. Ronald said that it was common knowledge in his neighborhood that
28 Ted would pay young boys to perform oral sex on them. Ronald said that when he was 17 years old,
29 (1980) Ted who had moved to Ohio recently, came to pick him up in Detroit and took him to his
30 apartment in the Cleveland area for the night. Ronald told detectives that Ted paid him for oral sex and
31 then drove him back to Detroit the next day. Ronald went on to say that when Ted moved from Detroit
32 to the Cleveland area, his brothers David "Bo" [redacted] William "Bill" [redacted] and a guy named [redacted]
33 that Ted was real close with, helped Ted pack up and move to Cleveland. Ronald stated that Ted had
34 paperwork that he carried from Ford Motor Company that he showed to people that indicated his
35 transfer to the Cleveland Foundry. Ronald said that there were two other kids that Ted used to spend a
36 lot of time with named [redacted] and [redacted] Ronald talked about all the large families that
37 lived in his neighborhood back then that had migrated from the south (Kentucky & Tennessee) to get
38 jobs at the auto plants. He talked about the [redacted] and how Ted was with the [redacted] boys quite a
39 bit and was probably paying them for sex. We terminated the interview at this point and I left a card for
40 the brother [redacted] to call me.

41 6-22-06: Detective Steve Scharschmidt called me this evening and stated that his partner, Sergeant
42 Wayne Mockler, had talked to Ted at Ted's apartment building a day or so ago. Steve told me that
43 Wayne had a casual conversation with Ted, asking him how he was doing and what he has been up to.
44 Steve indicated that Ted stated he is enjoying being retired and having a lot of free time to do the things
45 he wants. Wayne told Ted that he and Steve still want to meet him for dinner to celebrate his
46 retirement, to which Ted stated that he was looking forward to it.

47 6-26-06 *** (Phone interview of [redacted] *** [redacted] called me today and I interviewed him
48 about his past relationship with Ted Lamborgine and Bob Moore. Robert said that he did not know who
49 Richard Lawson was. Robert stated that he knew Ted Orr from his neighborhood back in the mid
50 1970's and that everyone called him "Pinto Ted" because he drove a green Ford Pinto. Robert said
51 that it was common knowledge in their neighborhood that Ted was a homosexual, was "into young
52 boys" and would pay kids to allow him to perform oral sex on them. Robert indicated that he didn't

1 really know Ted very well, stating that his brother [REDACTED] was with Ted more than he was, adding that
2 Ronald was always getting into trouble and was kind of the "wild" one of the two. [REDACTED]
3 [REDACTED] I asked Robert if Ted ever paid him for sex, to which Robert stated "no." I asked Robert
4 about the other boys that Ronald had stated, hung around with Ted. Robert said that "Day-Day" a
5 black boy in their neighborhood, did in fact hang around with Ronald, stating that "Day-Day's" dad or
6 uncle drank with their father. Robert indicated that he knew Bob Moore and worked for Bob at his bike
7 shop on Cass north of Henry. Robert said that he worked there for two years with Mike [REDACTED] and other
8 boys. He said that he knew that Bob Moore was also a homosexual and would pay kids for sex, but
9 that he never had sex with Moore and was never approached by Moore for sex. I asked Robert to write
10 down everything he knew about Ted Orr, Bob Moore and what was going on in his neighborhood with
11 these guys.

12 6-26-06: Attempting to locate the [REDACTED] boys, [REDACTED] and [REDACTED]. I drove to
13 the area of [REDACTED] in Sterling Heights. It appeared as if a young couple with children had just
14 moved into the home. I ran three plates on cars in the driveway that all came back registered to people
15 other than [REDACTED]. One of the vehicles had an Ontario plate on it. I obtained this address when I
16 ran [REDACTED] through the Secretary of State system, which showed the Gibson address as
17 being his current address when he renewed his driver's license in November of 2004.

18 6-27-06 *** (Phone interview of Faye [REDACTED] about Ted Orr & The [REDACTED] Boys) *** I called Faye
19 [REDACTED] today and asked her specifics about the past sexual relationships with Richard Lawson & the
20 [REDACTED] Boys and between Ted Orr & the [REDACTED] boys. Faye told me that the [REDACTED] boys first
21 began hanging around at her and Richard's apartment when they lived on Clarkdale in southwest
22 Detroit in approximately 1976-77. Faye said that her and Richard then bought a house on 23rd street
23 that they moved into in 1977. Faye said that this is when the [REDACTED] Boys started living with her and
24 Richard most of the time, even though the parents were in the area. Faye told me that Richard was
25 real close with both boys but especially [REDACTED]. Faye said that both boys knew Ted Orr
26 (Lamborgine) from coming over to the house on 23rd. Faye went on to say that the house on 23rd Street
27 is the house that Richard eventually burned down and was charged with arson. In approximately 1980,
28 Richard, Faye & the [REDACTED] Boys went to live at Ted's apartment on Junction & Porter in southwest
29 Detroit. She said that Richard, Ted, Bob Schuler & Tippet would have what they called, "Boys night
30 out," with the young boys. Faye said that Ted Orr would come back from Ohio on the weekends for
31 this. Faye talked again about a kid named [REDACTED] that used to "be with Richard" before the
32 [REDACTED] Boys, back in the mid 1970's. I have been unable to locate a Blake [REDACTED] so far. I ran an
33 "Autotrack" check on [REDACTED], but this did not reveal a lot of information.

34 6-28-06: *** (Today I identified the whereabouts of [REDACTED] and a city and state for
35 Robert Lee [REDACTED] *** Today, I drove to the area of southwest Detroit, checking two other
36 addresses for [REDACTED]. One address was at [REDACTED] Vernor Hwy. in Detroit (Apartment
37 Bldg's.) and the other was a house at [REDACTED] in Detroit. I didn't locate any vehicles registered
38 to the [REDACTED]. [REDACTED] has also used the Vernor Hwy address.

39 When I returned today, I began doing some more computer work on the [REDACTED] boys in an attempt to
40 locate them. I located [REDACTED], born [REDACTED]-69, currently in Mississippi Department of
41 Corrections, serving the beginning of a 10-year sentence for what appears to be aggravated assault.
42 [REDACTED] has a tentative release date of 9-29-13. I found [REDACTED], born [REDACTED]-1971,
43 in Florida Department of corrections. He was just released from prison after serving approximately one
44 year for aggravated assault with a deadly weapon. He is scheduled to participate in the Supervised
45 Release program until 8-13-2006. He reports an address of [REDACTED] Woodville, Florida
46 32305.

47 6-29-06: I talked to John Oulette (FBI) & Garry Gray (MSP) today about possibly traveling to Florida
48 and Mississippi to interview the [REDACTED] Boys. We had originally thought about putting out a lead to
49 the FBI in Florida & Mississippi to conduct these interviews, but decided against it. I then put in a
50 request to travel out-of-state to conduct the interviews, which was denied by the Chief because of
51 manpower issues right now. We are going to put off these interviews until early fall and the request

1 them again. I informed Rob Moran from the Prosecutors Office. These interviews will eventually be
2 crucial in obtaining information and witnesses to prepare the CSC case against Ted Lamborgine. Rob
3 Moran, Kym Worthy, Garry Gray, John Oulette and myself, are all in agreement, that these interviews
4 are important enough not to have the FBI or anyone but us conduct them, due to our background on
5 this case and especially this lead. We are going to conduct other interviews in the Detroit area right
6 now and continue to put our case together against Lamborgine in the meantime.

7 **7-04-06: Fourth of July, 2006 break.**

8 7-7-06: Steve Scharschmidt from Parma Heights PD called me tonight and said that he was working
9 his side job at Ted Lamborgine's apartment complex on the 6th and observed Ted out in the parking lot
10 at 11:00 PM, just looking all around. Scharschmidt felt that Lamborgine was looking to see if we still
11 had surveillance on him. Scharschmidt works part-time as security at the apartment complex where
12 Ted currently lives.

13 7-10-06: I talked to Faye [REDACTED] today and asked her again about "Blake" [REDACTED] to which she said that
14 she thinks he lives on Springwells in southwest Detroit. I asked her about an interview I conducted with
15 her and her sister Betty back in May of 2006. Betty talked a lot about how she always thought that
16 Richard was involved with Jim Tippett in the killing of the kids from Oakland County. I asked Faye
17 again, why she thinks her sister was pushing Tippett so much. Faye said that she thinks because he
18 and Richard were so much alike and did a lot together. Faye went on to say that when Tippett's wife left
19 him, she married his brother and that she (Faye) thinks that they live up north somewhere. Faye also
20 said that Tippett had two sons that she thinks still live in the Detroit area. Faye told me that there was
21 always something that bothered her about Tippett. Faye went on to say that he and Richard had a lot
22 of secrets that they would discuss privately and that she used to get upset about Richard buying Tippett
23 a car when they couldn't afford it. I asked Faye to explain. She said that in the late 1970's - early
24 1980's, Richard bought or leased a Red Ford Escort for Tippett to drive. Faye said this upset her
25 because Richard would take her "S.S.I. check," cash it and pay Tippett's car payment at Ford Credit
26 Corp. She always felt this was some type of "hush money" for Tippett. Faye said that Tippett was
27 staying in an apartment at Warren & Trumbull in Detroit at the time, above her friend Dolly Coleman
28 [REDACTED]'s mother).

29 7-10-06: *** (I identified "Blake" [REDACTED] today) *** I was looking through the "Autotrack" report that I
30 ran on Blake [REDACTED] back in June and saw that there was a possible relative listed as Arthur B.
31 born [REDACTED]-67. Believing this to possibly be Arthur Blake [REDACTED] I performed a check through the LEIN
32 system for a Michigan Criminal History on this subject, which did in fact reveal this to be Arthur "Blake"
33 [REDACTED], w/m, born [REDACTED] 1967. This subject showed two different arrests for delivery of drugs and a
34 current address on Springwells in southwest Detroit with Secretary of State (S.O.S.). This information
35 matches what Faye [REDACTED] had given me. I also obtained a photograph of "Blake" [REDACTED] through the
36 S.O.S. image system.

37 7-31-06: I returned from vacation today. While I was gone, Garry Gary and John Oulette had gone
38 and interviewed "Blake" [REDACTED]. He told them about his past sexual involvement with Richard Lawson
39 and indicated that he used to live with Richard Lawson & Faye [REDACTED] in Detroit. [REDACTED] told
40 investigators that he had sex as a minor with Richard Lawson more than 150 times while living with
41 him. He told investigators that he thought he remembered Ted Orr but he wasn't sure. [REDACTED] indicated
42 that he would not testify against Lawson but was willing to be videotaped about his involvement
43 sexually with Lawson. *** (See John Oulette's report on this interview for details. Report is in FBI
44 reports binder). ***

45 7-31-06: *** (Info from David Taylor, in Jackson Prison) *** Garry Gray (MSP) called me today and
46 said that he received a phone call and then a letter from the Oakland County Prosecutors Office,
47 addressed to David Gorsyca from an inmate in Jackson Prison named David Taylor. Supposedly this
48 Taylor subject, who fancies himself as a "jailhouse lawyer" has become friends with Richard Lawson
49 over the past few months. Taylor stated in his letter that Lawson has made statements/admissions to
50 him about killing the kids from Oakland County years ago and that he (Taylor) believes this information
51 and wants to meet to give the information to a detective. Taylor supposedly did not ask for anything in

1 return, but states that you have to draw a line when it comes to killing kids and that he can't sleep at
2 night. Taylor also said that Lawson told him about a plan he has to put the whole case on someone
3 else. John, Garry & I are going to meet on Wednesday to talk about this information from David Taylor
4 and get a copy of the letter. I found him in the Michigan Department of Corrections database. He is
5 identified as David Alan Taylor, w/m born 11-04-1949. Taylor is currently serving 40-200 years for an
6 armed robbery he committed in Rochester Michigan back in 1985. Taylor had a long criminal history
7 prior to that. *** (Copy of the letter from David Taylor is in Taylor file). ***

8 7-31-06: I talked to Steve Scharschmidt from Parma Heights PD today about Ted Lamborgine. Steve
9 told me that Ted has recently renewed his lease at the apartments in their city for another year, but that
10 he has had no contact with Ted, even though he has called Ted's phone several times. I asked Steve
11 & his partner Wayne Mockler, under my direction, to go interview Ted, in an attempt to obtain an
12 admission or confession from Ted about his sexual involvement with several young, boy, victims in the
13 Detroit area back in the 1970's. I faxed Steve a list of names of young boys that we have interviewed in
14 the recent past, that have told investigators that Ted paid them for sex when they were minors in the
15 1970's in Detroit. I directed the Parma Heights detectives to record this interview with Ted Lamborgine.
16 The Parma Heights detectives agreed to conduct and record the interview. At approximately 10:00 PM
17 this evening, Detective Scharschmidt called me and stated that during the course of their interview with
18 Ted, he admitted to having sex with several of the approximately 13 young boys (minors) named from
19 the list that I had faxed to Detective Scharschmidt. Steve told me that Ted said he thought several of
20 the young boys he had sex with were 14-15 years old. *** (See the transcripts from Parma Heights
21 recorded interview of Ted Lamborgine for details. Transcripts and tape in Lamborgine file). ***

22 8-1-06: I talked to Garry Gray (MSP) today about interviewing David Taylor in Jackson Prison. Garry
23 made contact at the prison and is in the process of arranging the details of this interview with
24 Department of Corrections personnel. The interview is scheduled for Thursday August 3rd @ 12:30 PM

25 8-2-06: Today the "Task Force" had a meeting at the MSP Metro North Post. Present were Garry
26 Gray (MSP), Dave Robertson (MSP), and John Oulette (FBI), Ray Anger (Berkley PD), Gene (MSP
27 Intell Unit) & me. We discussed our strategy involving charging Ted Lamborgine with old CSC's & the
28 information from David Taylor in Jackson Prison.

29 8-3-06: Today we interviewed David Taylor at Jackson Prison. Investigators that were present during
30 the interview were Garry Gray (MSP), John Oulette (FBI) & me. Taylor began by telling us about his
31 background, stating that he has been in prison since 1983. Taylor said that over the course of many
32 years in prison, he has become involved in assisting other inmates with their legal matters. Taylor
33 stated that he is known in the prison system for doing this and that the inmates trust and confide in him,
34 the information about their criminal cases. Taylor said that Richard Lawson approached him in the
35 prison yard on July 1st, 2006, about helping him with his current appeal. Taylor stated that Lawson told
36 him he is currently serving a life sentence for a murder in Wayne County and that he was "railroaded" in
37 that case. Taylor indicated to investigators that he knows he is in prison for another 14 years, doesn't
38 expect any consideration for his cooperation and is only talking to investigators about Lawson because
39 of the seriousness of the case and the fact that children were the victims. Taylor said that he was
40 married years ago and had a four-year-old boy that's grown now. Taylor went on to say that, yes he is
41 a prisoner and a criminal, but he draws the line when it comes to hurting children.

42 Taylor told investigators that he talked to Lawson for approximately one week before they became
43 separated. Taylor said that he was working with Lawson on his appeal and talked with Lawson every
44 day that week for approximately 2-3 hours. Taylor said that Lawson began talking to him about his
45 involvement in the OCCK investigation as an "investigator" (informant). Taylor said that Lawson told
46 him about having paperwork from Judge Gillis in Detroit that gave him "Carte Blanche" to molest kids in
47 the course of his investigation into the OCCK. Taylor said that Lawson talked a lot about the case, at
48 which point Taylor asked him why he knows so much about it. Taylor stated that Lawson lowered his
49 voice and stated, because I was the one who killed those kids after I molested them. Lawson went on
50 to say that he has the perfect person in mind to blame the murders on.

1 We asked Taylor if Lawson gave him any details about the crime, to which he stated that Lawson said
2 that he talked the kids into the car by saying things like "your dad sent me to pick you up." Lawson also
3 told Taylor that he would take the kids home once he got them, feed them, watch TV with them, and
4 take them to the bedroom where they would fondle each other. Garry & I then began questioning
5 Taylor closely about this information. Taylor seemed to add more information about Lawson as we
6 went along, even though he first stated that he hadn't got that far with Lawson yet, referring to getting
7 more details about this crime. We questioned Taylor about adding more details as we went along, to
8 which he explained that our visit was a surprise to him today and that he is remembering things Lawson
9 said as we go along. Towards the end of this interview, Taylor became defensive and crossed his
10 arms. We asked Taylor if he would be willing to take a polygraph examination concerning this
11 information from Lawson, to which he stated he would have no problem doing that. The interview was
12 terminated. All three investigators agreed that Taylor would have to be polygraphed about this info.

13 8-7-06: Today, Garry Gary & I met with Rob Moran and James Bivens from the Wayne County
14 Prosecutors Office and played the tape-recorded conversation between detectives from Parma Heights,
15 Ohio and Ted Lamborgine at Lamborgines apartment. We also obtained a writ today to get David
16 Taylor out of Jackson Prison for a polygraph. The writ was signed by Judge Timothy Kenny, of the 3rd.
17 Circuit Court, of the State of Michigan (recorders court/ F.M.H.J.).

18 8-7-06: Garry Gray (MSP) called Lt. Bob Dykstra (MSP Polygraph Examiner) and made arrangements
19 to polygraph David Taylor at the Jackson MSP Post this week or next. We are just waiting to here back
20 from Cindy Akers at Jackson Prison.

21 8-9-06: Today Det./Sgt. Garry Gray & I went to 1565 Temple in Detroit to try an interview Robert
22 "Donny" about his relationship with Theodore Lamborgine a.k.a. Ted Orr. We eventually got
23 "Donny's" mother to come to the window and take one of my business cards to have "Donny" call me.
24 The woman who identified herself as "Donny's" mother through the window told detectives that "Donny"
25 would be home between 9:00 – 10:00 AM tomorrow morning, the 10th.

26 Garry Gray (MSP) called me this evening and stated that the polygraph of David Taylor is now
27 scheduled for Tuesday August 15th at 10:00am and the Michigan State Police Post in Jackson
28 Michigan.

29 I called Dave Robertson (MSP) today and gave him the social security number for Robert [REDACTED]
30 Robertson is going to attempt to identify Robert [REDACTED] place of employment so we can interview him
31 there, away from his wife and brother.

32 8-10-06: Garry Gray (MSP) & I went to Temple in Detroit today to try once again to interview
33 Robert "Donny" about Ted Lamborgine. Rose [REDACTED] ("Donny's" mother) answered the door
34 and said that "Donny" had just left for an appointment prior to going to work. Mrs. [REDACTED] stated we
35 could come in and look around for "Donny" if we didn't believe her. I took her home phone number
36 [REDACTED] and told her I would call "Donny" this evening. She told me to call back after 5:00PM
37 tonight to reach him.

38 8-10-06: John Oulette (FBI), faxed me a copy of his "Lead" (request) he sent to the FBI in Tallahassee
39 Florida and Jackson Mississippi to conduct interviews of Robert and Charles [REDACTED]. We decided
40 that John could get the FBI agents that are going to conduct the interviews for us, up to speed enough
41 to do a good job and get the info we want.

42 8-10-06: I called "Donny" home tonight and attempted to discuss with him, his possible
43 cooperation as a witness against Theodore Lamborgine a.k.a. "Ted Orr" for Criminal Sexual Conduct
44 (CSC). *** (See Det. /Sgt. Cory Williams (Livonia PD) narrative report on phone interview of
45 "Donny" Houser for further details. Report in [REDACTED] file) ***

46 8-15-06: Today Garry Gray (MSP) & I took David Taylor (on a writ) out of Jackson Prison, to the State
47 of Michigan building in downtown Jackson, Michigan, for his polygraph about the supposed admissions
48 Lawson made to Taylor about being the Oakland County Child Killer. Lt. Robert Dykstra, the Michigan
49 State Police Polygraph Examiner from Northville, Michigan, administered the test. After the test, Lt.

1 Dykstra and two other Michigan State Police Polygraph Examiners who were present at the polygraph
2 test; reviewed the charts and determined that David Taylor was not being truthful about Lawson's
3 admissions to him.

4 8-17-06: I talked to Detective Steve Scharschmidt today from Parma Heights PD. He told me that the
5 apartment manager at Ted Lamborgine's apartment, overheard Ted talking to another resident about
6 fighting cancer and that the apartment manager believed Ted was possibly talking about himself.

7 8-18-06: Over approximately the past month, I have been compiling the information from our past
8 interviews of the victims of child molestations that occurred in Detroit in the 1970's & 80's, committed by
9 Lamborgine, Lawson, Moore, Schuler & Tippett. I put this information into a narrative report for Sgt.
10 Gray to use as a guide or reference while putting his request for warrant together for the arrest of
11 Lamborgine and Lawson in connection to these molestations. I turned the report over to Sgt. Gray
12 today.

13 8-22-06: We are still trying to find out where Robert [REDACTED] is employed so that we can do a follow-up
14 interview with him, about his past sexual relationship with Ted Lamborgine. Detective Dave Robertson
15 (MSP) is in the process of working with the MSP Intelligence Unit in Lansing to get this information on
16 Eads.

17 8-31-06: Today Garry Gray (MSP) & I interviewed "Jimmy" [REDACTED] at the St. Louis correctional facility
18 in St. Louis, Michigan. During the course of this interview "Jimmy," told detectives that he remembers
19 "Ted" from his neighborhood on 14th St. in Detroit in the 1970's. "Jimmy" told detectives about "Ted"
20 performing oral sex on him, on at least 3 different occasions, stating that he (Jimmy) was approximately
21 9 years old at that time. ***** (See transcripts for further details of this interview of "Jimmy" [REDACTED]
22 about his past sexual contacts with Ted Lamborgine). *****

23 9-7-06: Today we (The Task Force) had a meeting at MSP Post 21 about our ongoing CSC
24 investigation that we are putting together against Lamborgine and Lawson. We are continuing to
25 identify, locate and interview many victims that were sexually molested by Lamborgine and Lawson in
26 Detroit in the 1970's & 80's. This is being done, to not only charge these guys with these 30, year old
27 crimes but, to pressure Lamborgine into being truthful as to why he failed the polygraph about the
28 Oakland County Child Killings. We are concentrating all of our efforts into this right now in an attempt
29 to exhaust this lead and solve the OCCK case.

30 9-8-06: Today, Garry & I went back down to Temple & Trumball in Detroit to interview Donny [REDACTED]
31 about his past sexual contacts with Ted Lamborgine. Ted had made earlier admissions to Parma
32 Heights detectives about sexually molesting Donny [REDACTED] when he was approximately 14 years old.
33 We observed [REDACTED] riding his bike down Trumball near Temple and [REDACTED] agreed to stop and talk to
34 us. [REDACTED] denied any past sexual contact with Ted, when he [REDACTED] was a boy, but again made
35 tacit admissions about this past sexual contact. ***** (See narrative report of this interview for
36 details. Report in Donny [REDACTED] File) *****

37 9-12-06: Today, Garry & I interviewed [REDACTED] at his place of employment in River Rouge
38 (Contract Towing). [REDACTED] was open with detectives about knowing Bob Moore and his past sexual
39 relationship with Moore when [REDACTED] was approximately 14 years old. [REDACTED] said that Moore would
40 perform oral sex on him, in exchange for money, drugs or whatever he needed at that time (food).
41 [REDACTED] told detectives that Moore performed oral sex on him approximately once a week for a year.
42 [REDACTED] told detectives that he lived with Bob Moore at Moore's house located at 458 Henry in Detroit.
43 [REDACTED] went on to say that he worked for Bob Moore at his bicycle shops in the Cass area of Detroit.
44 ***** (See narrative report in McCoy file for details of this interview) *****

45 9-13-06: Today, Garry & I conducted a follow-up tape-recorded interview of Charles "Chuck"
46 [REDACTED] at his place of employment ([REDACTED] in Waterford, Michigan). [REDACTED] was
47 cooperative again with detectives and talked openly about being sexually molested by Richard Lawson
48 when he [REDACTED] was approximately 13 years old. [REDACTED] told detectives that during that time
49 (approximately 1980-81) Lawson had performed oral sex on him approximately a dozen times. ***** (See**
