Garry Gray:

...we've had kids that he's done that to. Now, I'm...

Cory Williams:

No, did you know he did that Bowman?

Garry Gray:

Yea!

James Gunnels:

No!

Cory Williams:

You never knew Bowman got choked?

James Gunnels:

No! I didn't know nothin' about him until after the police had came to

me.

Cory Williams:

Okay.

James Gunnels:

You know, his contact with him; put it that way. I didn't even know

about that. Umm...

Cory Williams:

Let me show you a picture of a guy, let, just tell me if you've seen him

before.

James Gunnels:

Um-hmm. Don't remember him.

Cory Williams:

No?

James Gunnels:

No.

Garry Gray:

UNCLEAR

Cory Williams:

We're gonna have you look at Greene one more time. Wish I had a

better picture of him. I just, just...

James Gunnels:

Let me look at him.

Cory Williams:

We give, yea, that's what I wanted to do. I wanted to give you a few

more little hints about him, that may trigger something; while you're

lookin' at the picture.

Garry Gray:

You know what, let me tell you something,...

James Gunnels:

Something is comin' back about him, I, I d...I don't know, you know

what I mean; it what it, was uh...

Cory Williams:

He uh, he had, he had come back from California had been in a mental

institution out there; seventy-five, came back to Flint. Does that ring a

bell with ya?

James Gunnels: Not that part about him.

Cory Williams: For molestin' kids, he molested kids?

James Gunnels: Yea. No, that well...

Cory Williams: He, uh, went to hang out in the dirt trails behind Northwestern? Molest

kids, had a van, he had a...

James Gunnels: You mean Southwestern?

Cory Williams: Southwestern?

James Gunnels: Yea.

Cory Williams: Had a brown van; drove around. Umm, he had a dirt bike; he also had

what kind of car...

James Gunnels: He looks familiar, you know what I mean, it's just that...

Garry Gray: I kn...I know.

James Gunnels: ... do I remember him we...that well or not, but, there's somethin'

about him I, I think I remember about him, I don't know UNCLEAR.

Garry Gray: See, there's one thing you got right here with us, you got a freebie here.

You can set, set it up, I did not honestly, you can just say; yep, I

remember UNCLEAR.

James Gunnels: I'm sayin' I, I, I don't know what it is.

Garry Gray: UNCLEAR Chris, or I'm sorry, uh, Jim, even if you were to say to us

right, this second, hey would I go do that, 'cause I'm bull-shittin'.

That's cool?

Cory Williams: You know, look, Jim...

James Gunnels: I, whatever, I don't remember what, what's goin' on.

Cory Williams: I've walked out of interviews and had guys stop me afterwards and say,

listen, I didn't, I lied to you but, I was afraid to tell you I lied; and I

said, you could've stopped me anytime.

James Gunnels: Right.

Police get lied, we've been lied to our whole life.

James Gunnels:

I understand that.

Cory Williams:

What I'm sayin' is, I get this, I get the feeling that somewhere I'm feeling that you're holdin' somethin' back on us here. I'm, I'm just

gettin' the feeling...

James Gunnels:

Uh, that's, well I don't, I don't know what I'm holdin' back, I mean, that guy right there, he brings, he bring, I'm thinkin', you know,

do I know this guy, d...he looks familiar.

Garry Gray:

But he never had sex with you, you'd remember that?

James Gunnels:

Oh, obviously not!

Garry Gray:

UNCLEAR

James Gunnels:

That's, I mean, no I'm serious, I'm, umma be for real. No! That never

happened!

Garry Gray:

Okay. Alright.

James Gunnels:

Umm, UNCLEAR back on the UNCLEAR.

Garry Gray:

Well, that's gotta UNCLEAR.

James Gunnels:

Umm...

Cory Williams:

Take a look at those, see...see if you think they look like anybody; that

you know; from back down.

James Gunnels:

Alright, no.

Cory Williams:

You said, as far as you know, Chris always had a beard, huh?

James Gunnels:

Um-hmm.

Cory Williams:

He's always?

James Gunnels:

Um-hmm.

Garry Gray:

He always been a little chunky – wunky, huh?

James Gunnels:

Fat.

Garty Gray:

(Giggle) Yea.

Cory Williams:

Alright, out of the group of kids there, you, Plumley, Bowman, Bush, who would you say was the, was the closest with Chris Bush and with

Greg Greene? Who spent the most time with him?

James Gunnels:

I don't know what...I...I didn't even know Chris Bush knew these

other people.

Cory Williams:

Well, (sigh) they were all...

James Gunnels:

I mean, maybe UNCLEAR, maybe...

Cory Williams:

...drinkin' and smokin' dope and went to a drive-in together.

James Gunnels:

N...N...No, I didn't. That's what I told you earlier. I don't remember ever goin' to a b...to a drive-in with none of these, these other people.

Cory Williams:

Okay.

James Gunnels:

I mean, I don't remember it; personally.

Cory Williams:

Everyt...everything Bowman said in this statement...

James Gunnels:

Right.

Cory Williams:

...this statement, this report's from thirty years ago.

James Gunnels:

I d...understand, I understand.

Cory Williams:

Everything he said in there...

James Gunnels:

Yea.

Cory Williams:

...is true.

James Gunnels:

Well, I, then, but I don't remember that.

Cory Williams:

Okay.

James Gunnels:

I don't remember a trip to the, you say a drive-in?

Garry Gray:

Yea, the kids were jumpin' over the front seat and back seat

UNCLEAR.

Backseat, and it was, uh, The Exorcist. You guys were seein' The

Exorcist

Garry Gray:

UNCLEAR

Cory Williams:

Remember that?

James Gunnels:

No!

Cory Williams:

When it first came out.

Garry Gray:

UNCLEAR it scared the shit out of you.

James Gunnels:

Obviously.

Garry Gray:

(Laugh)

James Gunnels:

I mean, no, I don't remember see...I know I'm, matter of fact, I'm thinkin' m...'bout...I didn't even see it in a, in a movie theater.

Cory Williams:

Yea, 'cause if, if I go back to...

James Gunnels:

The first time I seen it was like on T.V.

Cory Williams:

If I go back to Bowman right now.

James Gunnels:

Um-hmm.

Cory Williams:

...I know where he's at...

James Gunnels:

Okay.

Cory Williams:

UNCLEAR is he gonna say that you're bull-shittin', you're lyin' to us?

James Gunnels:

I don't know. I really don't know. Don...I don't, personally I don't care, okay, about that. Whe...whether he, what he thought thirty or whatever years ago happened. You know what I'm sayin'? I don't, I

don't know.

Cory Williams:

Now I'm tell, sayin' about Greg Greene, is he going to say you're

bullshitting?

James Gunnels:

I don't know! I don't remember the guy, I honestly don't. I'm, I'm sittin' here thinkin' I r...I recognize the face it seems familiar to me; but as far as like I said earlier, if I had s...this guy s...gave me a BJ, felt me up or felt me and my friend up and I'm in a vehicle...

Let me tell you somethin'...

James Gunnels:

...UNCLEAR

Cory Williams:

...I'm gonna tell you somethin' right now, say for, say just for an example, that you knew Greene, you knew Greene, you knew Bush, you knew they were involved in somethin' bad, you learned about it either accidentally and you saw 'em involved in somethin', you came across somethin', you came across a kid, but you're afraid to say somethin' 'cause maybe you were thinking, you know what, I'm a co-conspirator in this thing.

James Gunnels:

It never happened. And eh, eh, eh, eh, uh...

Cory Williams:

Okay, but let me, let me finish.

James Gunnels:

Continue on.

Cory Williams:

But, just so you know, you were a juvenile at the time. Even if you were a guy that was involved in it, in something...

Garry Gray:

UNCLEAR

Cory Williams:

or, you, you are good to go, 'cause you were a kid...

James Gunnels:

Continue on, 'cause I, I, nothin' like this even comes close to the way it was, with me personally. Nothin'.

Garry Gray:

Well UNCLEAR...

James Gunnels:

There was four times, there was, listen, there was four times that I went, out of c...out of the city with that guy; two times I believe Brent, Scottie, my brother Paul was with us. The other two times, I was with, personally, only one man, in the vehicle. Never had no contact with any other kids in the city, until after, and I'm talkin' about, they weren't present, they were locked, er, I won't say they, he was; Chris Bush. 'Cause I don't even remember this guy, other than maybe seeing him in a, you know, he could've pulled up, he could've pulled up at a party I was at, or something and Kenny Bowman, he was there, or Jeff Plumley, 'cause Jeff Plumley, like I said, I was a lot closer to him. Maybe he was there; but as far as actually doin' somethin' with these guys...I've never been to a movie with 'em. None of 'em. I know that, I'm not tryin' to be scandalous with you guys er, er be secretive. I'll tell ya flat out. If I could help you guys out, to help...stop...whatever,

you know what I'm sayin'? You guys, this is it. This is, you're drawin' from thirty somethin' years of drug infested, uh brain...

Garry Gray:

(Giggle) UNCLEAR

James Gunnels:

...I'm gonna put that on the record real quick.

Garry Gray:

UNCLEAR Okay, did you ever list out what kind of drugs you do back

then; do you remember?

James Gunnels:

Do 'em recently, too. Uh...

Garry Gray:

Okay.

James Gunnels: "

...back then it was marijuana and acid. I mean, I c...c...not at that

age I didn't do acid. I think I didn't start 'til I was like, well, about

seventeen.

Cory Williams:

Yea, and what are you doin' now?

James Gunnels:

Was doin' crack, cocaine and crack, up until four years ago and I got

locked up on this case.

Cory Williams:

Was it a purse snatching?

James Gunnels:

Huh?

Cory Williams:

Was it a purse?

James Gunnels:

Yea, yea, larceny from a person; at a store.

Cory Williams:

Um, how 'bout Dale Cooper? Does that name do anything for ya?

James Gunnels:

Cooper? I remember the Coopers. There's more than one though.

Cory Williams:

Okay, you remember Dale Cooper? Was a...he was all over

UNCLEAR.

James Gunnels:

I don't know.

Cory Williams:

Member him, you remember any Coopers runnin' with Bush in Flint?

But Dale Cooper doesn't do anything for ya?

James Gunnels:

Nope.

Cory Williams:

You're just say...you're just rememberin' the name?

James Gunnels: Yea, I remember the name. It was a, it was a bunch of Coopers I

thought.

Cory Williams: Think of anything else?

James Gunnels: Can I pop you guys some names?

Cory Williams: Yea.

Garry Gray: Sure!

James Gunnels: Out of curiosity...

Garry Gray: Absolutely.

James Gunnels: ... Woodrow Weeks; he's in prison; St. Louis right now for a murder

case.

Garry Gray: Okay.

James Gunnels: Whether he's...connected with these other people, well I mean, he

knew.

Garry Gray: Woodrow Weeks?

James Gunnels: Yea.

Garry Gray: W-E-A-K-S?

James Gunnels: I don't know how it's spelled. He's in prison. He's in St. Louis for

murder right now. Umm, and I'm not just puttin' his name out there, you know, you know what I, me and him had beefs before but he was

in that neighborhood and he hung out with us a little bit. Uh...

Garry Gray: About your age?

James Gunnels: Oh, same age.

Garry Gray: UNCLEAR

James Gunnels: Exact same age. He grew up on Lincoln Avenue, um, further on down

the street towards Grand Traverse; and there was one other person that

I was trying to think of that, umm...oh, (sigh) Dane Powers?

Garry Gray: Dan?

James Gunnels:

Dane.

Garry Gray:

Dane?

James Gunnels:

Dane Powers and Sheila Powers they were, they were cool with Brent

Bush. Real cool; real tight.

Cory Williams:

Oh that's what I want to talk to you a little bit about.

James Gunnels:

And the parents were...

Cory Williams:

And, was Brent Bush, just so I have it straight, Brent's, Brent's dad

was Chris' Uncle?

James Gunnels:

Chris' Brother.

Cory Williams:

Oh Brent was his...

James Gunnels:

Nephew.

Cory Williams:

...his nephew, right.

James Gunnels:

Yea.

Cory Williams:

Brent, was his nephew.

James Gunnels:

Yea.

Cory Williams:

Okay.

James Gunnels:

Yea.

Cory Williams:

And so, oh, that's Chris' older brother. What was his name, the dad?

James Gunnels:

John Bush.

Cory Williams:

That was John?

James Gunnels:

Yea, that's the one lives in White Hall.

Cory Williams:

Okay.

James Gunnels:

Yea.

Cory Williams:

Well...John was in White Hall and in Flint at the time?

James Gunnels: No, this, that's what I tried to say that after this case broke out, they

moved up to White Hall.

Cory Williams: Okay.

James Gunnels: And I think to avoid problems with people in the neighborhood; come

on.

Cory Williams: Yea, but that's not true because when Chris was arrested, when

the...when they got the warrants for Chris...

James Gunnels: Right.

Cory Williams: In your case.

James Gunnels: Right.

Cory Williams: In other cases...

James Gunnels: Right.

Cory Williams: ...at that time...

James Gunnels: Right.

Cory Williams: ...in January of seventy-seven...

James Gunnels: Right.

Cory Williams: ...they knocked on his parents' door in Birmingham.

James Gunnels: Okay.

Cory Williams: Dad answered the door, that was, remember the dad's name? Did you

ever meet him?

James Gunnels: No; no.

Cory Williams: The dad said, "Oh he's out at Whitehall."

James Gunnels: Who, Chris? Who Chris was?

Cory Williams: Yea!

James Gunnels: Well, I, I...

Cory Williams: So who was, so who was livin' out there in Whitehall at that time? John

UNCLEAR.

James Gunnels: I don't know.

Cory Williams: John was in Flint raisin' his kids.

James Gunnels: No, I, obviously, I don't know. All I know is later on John Bush owns

a beer and wine store in Whitehall...

Cory Williams: Yea, but that was eighty-two.

James Gunnels: Okay, that's when I went out to Whitehall; was in eighty-two then.

Cory Williams: Alright.

James Gunnels: And that was just to be with, be, to hang out with Brent Bush.

Cory Williams: Is it possible Chris just had a place out there in Whitehall?

James Gunnels: I don't know.

Cory Williams: Owned a store, you said they owned a store?

James Gunnels: They owned a store with a part, it was a brick, block building, you

know what I mean or whatever, and they had an apartment above it.

(Sigh) So I don't know if he, uh...

Cory Williams: UNCLEAR John...

James Gunnels: Did they own it previously before that, I don't know. You know if it

was still in the fam...if the store was in the family, that type of thing or

whatever. I don't know. I just know that John Bush moved there.

Cory Williams: Okay. What kind of guy was Brent?

James Gunnels: Partier; you know what I mean? I mean that's all we, pretty much all

we, all we did back then.

Garry Gray: When was the last time you...saw Brent?

James Gunnels: Whitehall.

Garry Gray: Back when you was a kid?

James Gunnels: Yep. My brother Paul tried to make contact with him like through

the...

Garry Gray: Internet?

James Gunnels: Internet type thing, or whatever, and I don't know. He saw, he said

somethin' about he might've been working for Oldsmobile or something in Lansing, a while back, though, we're talkin' early nineties, mid-nineties or something like that. You know and, whether he got in contact; my mom now, she tried to stay in contact with Connie and I know C...that's his friend's mom; Connie Bush; and from

what I understand, she ended up moving to Whitehall and b...and sobering up and doing, you know what I'm saying, and doing better, you know. My mom sobered up, went to Glass House in Lansing and

never drank again; some point.

Cory Williams: Okay, here's John and Connie Bush; this uh, Chris' phone book...

James Gunnels: Um-hmm...

Cory Williams: ...it was in his room...

James Gunnels: Um-hmm.

Cory Williams: ... when they found him dead? He got John and Connie Bush

on...Bole...Boler, no?

James Gunnels: Bloer.

Cory Williams: What was it?

James Gunnels: Bloer street.

Cory Williams: Bloer?

James Gunnels: Yea.

Cory Williams: That's it.

James Gunnels: Couple streets over from Simcoe...

Garry Gray: UNCLEAR

James Gunnels: ...and all them other streets.

Cory Williams: That, that was Chris' brother, John, older brother, right?

James Gunnels: Right, Brent's dad.

Cory Williams: Brent's, that's Brent's mom and dad?

James Gunnels: Yea.

Cory Williams: Alright, I just wanna get this straight.

James Gunnels: Looks like he had that UNCLEAR.

Cory Williams: Yea.

Garry Gray: Just, just sayin' his goodbyes before he UNCLEAR himself off.

Cory Williams: Right, right. And then uh, did you ever meet his older brother, Charles.

James Gunnels: No.

Cory Williams: Or Chuck, Joe Bush?

James Gunnels: No; no.

Cory Williams: Okay. And then here's John Bush residence, it's his residence...

James Gunnels: Uh-huh.

Cory Williams: ...six one six area code. Well that's probably Whitehall out there.

James Gunnels: That could be, I don't know.

Cory Williams: So, is there another John Bush?

James Gunnels: I don't know.

Cory Williams: Okay. You know did uh, was Chris into pets? Did he have dogs or

cats, 'er? Do you remember anything like that?

...ankle biter?

James Gunnels:

Not that I remember.

Garry Gray:

Big dog, little dog? Cats?

James Gunnels:

Not that I remember any pets.

Cory Williams:

What do you think about him havin' that picture?

James Gunnels:

'It's a trip.

Garry Gray:

Did he, you know...

James Gunnels:

I mean, that reminds me of somethin', somethin' out of a horror movie.

Garry Gray:

UNCLEAR did Chris, was Chris a hunter at all with you?

James Gunnels:

A hunter?

Garry Gray:

Yea.

James Gunnels:

Don't remember. And I am, I love hunting...

Garry Gray:

UNCLEAR

James Gunnels:

Hunting and fishing is my whole thing so...

Garry Gray:

Did he have any guns?

James Gunnels:

No, not that I remember.

Cory Williams:

You ever see him with any guns?

James Gunnels:

No.

Shot guns?

James Gunnels:

Uh-uh.

Cory Williams:

Mini guns?

James Gunnels:

No.

Cory Williams:

Take, take a look at that picture UNCLEAR. The boys, look at...

James Gunnels:

Not really. I...

Cory Williams:

They're right here.

James Gunnels:

I know. I'm lookin' at this and I'm lookin' at that.

Cory Williams:

Okay.

James Gunnels:

Not really. I mean, I can't tell if it's a lightness to it, you know what I

mean. I mean there's a certain light to, lightness to it, you know what I

mean, or whatever.

Cory Williams:

To which one?

James Gunnels:

I'd have to say to one of UNCLEAR the bangs and the hair or

whatever. You know what I mean?

Cory Williams:

Yea.

James Gunnels:

Okay. Okay.

Garry Gray:

Anything else? Hey, you know what?

James Gunnels:

What's up?

Garry Gray:

I wish you were, I, I, appreciate your, your honesty. I hope that you

shared with us UNCLEAR...

James Gunnels:

I have.

Garry Gray:

...you are.

James Gunnels:

I have.

Garry Gray:

You know, um, so when are you getting' out of here? What's your

date?

James Gunnels: Uh, uh...April fifteenth.

Garry Gray: Is that what's chiseled in stone, you mean?

there was somethin' wrong way before I talked to her about it.

Garry Gray:

So, when your parents died, they didn't let you out to go to the funeral,

or you just...

James Gunnels:

No. No. I could have went to my mom's, well no I couldn't go to my mom's from the County Jail because she died when I was in the County Jail and that's not a bond type thing. So when I got up North up to, uh, I was across the street UNCLEAR went to my dad's but it would cost me UNCLEAR money. You gotta pay two officer's salaries for the whole day, for a twelve hour day, you know. It wasn't worth it.

Garry Gray:

Okay.

James Gunnels:

UNCLEAR

Cory Williams:

One more question I forgot to ask, um, did you ever go up to his house

in Alma, Michigan where they had a restaurant; or did he talk about

that? Did you know what he w...cooked at a restaurant?

James Gunnels:

No.

Cory Williams:

Never UNCLEAR.

James Gunnels:

I don't remember...

Cory Williams:

Okay.

James Gunnels:

No.

Cory Williams:

Alright.

Garry Gray:

UNCLEAR

Cory Williams:

Uh, it's twelve forty-five.

Garry Gray:

Okay, the interview's concluded. It's twelve forty-five.
