Okay. I am going, definite.

Karen:

Yeah

I talked to Cadbury yesterday and I'm having a hearing tomorrow here at the jail with him about the violations that they're sending me back on. They're not sending me back on a warrant out of Michigan for any criminal things, it's for these violations. You understand what I'm saying

Karen:

Oh really

Vince:

Oh yeah

Karen:

Uh huh

Vince: Yeah, this is just a, oh Michigan Department of Corrections wants me back for these, as a matter of fact they're using the marijuana one and I said wait a minute they, they dropped them charges, they, they

Karen:

Uh huh

Released me from, so it's a bunch of malarkey, so I am making go through a little hearing here at the jail and I know I'm being found guilty

Karen:

Uh huh

And I know they're gonna send me back anyways

Yeah

But I'm gonna do it for the paper trail reasons of later on, you know what I'm

saying
