

1 **3-4-08:** I searched thru Berkley PD's (Ray Anger) reports today on the Kristine Mihelich case,
2 knowing that they did an extensive investigation/interviews at Hartfields Lanes in Berkley, because
3 of Mihelich's mother working there and Kristine frequenting that location. I checked to see if there
4 was any mention of Christopher Busch, Greg Green or Michael Boldiszar, being regulars at the
5 bowling alley. I did not recognize their names or any other names in these reports that would
6 possibly connect the investigations.

7 **3-4-08:** Garry made contact today with the Detective from the Flint MSP post, who is going to
8 contact Chad Nikle (Green's ex-cellmate) and verify his residence and a good time for us to come
9 interview him. We are waiting to here back from the Flint Detective.

10 **3-4-08:** Garry called the Detective at the Newaygo Michigan post, Scott Rios, who agreed to make
11 contact with Christopher Busch's nephew, Brent Busch to verify his residence and to lay the ground-
12 work for us to come interview him about Busch & Green. Brent Busch lived on the next street over
13 from Greg Green and is the one who introduced Greg Green to Kenneth Bowman. We are going to
14 interview Brent Busch to learn more about Busch's background and hopefully learn when Green
15 arrived back in the Flint area and started running with Chris Busch.

16 **3-4-08:** We made contact today with New York FBI Agent Tommy MacDonald. He has agreed to
17 interview Chris Busch's brother Charles and swab him for DNA. We talked to the FBI agent working
18 with us on this case, Jason Bolinger and he is going to send the questions to Tommy MacDonald
19 that we want him to ask Charles Busch.

20 **3-4-08:** Garry took the polygraph charts from Busch and Green's, 1977, Stebbins polygraph to
21 polygraph examiner Wojnarski's office today for their upcoming meeting on 3-6-08. The 3 polygraph
22 examiners that looked at these charts independently are going to meet, discuss their conclusions
23 and see if they can come up with a consensus on the suspect's charts.

24 **3-5-08:** Garry and I met with Captain Steve Cook (Bloomfield Twp. PD) today and discussed the
25 evidence from the Busch Suicide scene. MSP had located a lab report a few days ago that showed
26 that MSP turned over the ropes and the drawing from Chris Busch's back to Bloomfield Twp. PD in
27 1982. Bloomfield went thru their files and evidence room and located the suicide scene photos from
28 Busch's suicide in November of 1978. These photos showed Busch in bed, lying on his side, facing
29 the wall with a rifle lying next to him. Busch's right arm was extended across the bed near the rifle,
30 in a position to pull the trigger. In the bedroom photo's you can see the drawing of what appears to
31 be the Stebbins boy, pinned to the wall that Busch is facing. Also in the crime scene photo's was a
32 couple of pictures of the ropes & ligatures that were found in Chris Busch's bedroom. The ropes
33 were found in the lying on the floor in the middle of the walk-in closet in Busch's bedroom. These
34 ropes look as if they were left where they were used or thrown on the closet floor. Also found in the
35 bedroom was a single shotgun shell casing, on the desk. In the packet of photo's and reports were
36 a number of latent prints that were lifted from the rifle, ammo box and other items in Busch's
37 bedroom. Captain Cook stated that they were unable to find the ropes and that they were probably
38 destroyed years ago.

39 Captain Cook turned over all of the Bloomfield Twp. PD, original photos, latent prints and reports
40 us. They also gave us the entire file that Tobias had brought into Bloomfield Twp. PD before he
41 died. We will be able to go thru this and see if there was any mention of Busch, Green or
42 Lamborgine, by Tobias. He was a retired investigator who had worked on the OCCK case for many
43 years. *** (See Busch Suicide photos and reports for details) ***

44 **3-6-08:** *** (Tape-recorded interview of James "Vince" Gunnels today at Camp Ojibway in the
45 Upper Penninsula of Michigan) *** MSP Aviation flew Garry & I out of Lansing to Ironwood,
46 Michigan, in Gogebic County today, to interview Gunnels. MSP Detective Tim Doan picked us up
47 and took us to the prison (Camp Ojibway). We began by reading Gunnels his rights, which he
48 stated he understood and agreed to waive and talk to us. While talking to Gunnels, he stated that
49 he knew Christopher Busch from his neighborhood in Flint in the mid-seventies and had been

1 molested by him (oral copulation) several times, in Flint, the cottage on Ess Lake in Montmorency
2 County and also at, what he described as Busch's house in Alpena, Michigan. Gunnels stated that
3 'he two times he was at the cottage on Ess Lake there were several boys there, including his brother
4 Paul, and other Flint boys, but not Kenneth Bowman. Gunnels went on to say that when Christopher
5 Busch took him to the house in Alpena on a couple of occasions, it was just he and Chris. Gunnels
6 told us that on one occasion they arrived at the house, Chris rushed him to the bedroom and brought
7 him a beer and some marijuana to smoke. Gunnels said that Chris then had him undress and pulled
8 a movie screen down from the ceiling that was in the room. Gunnels went on to say that Busch then
9 turned a movie projector on (Possibly 8mm) and began showing a movie (possibly a home movie) of
10 a man anally molesting a boy that was tied up. We asked Gunnels if it was Busch molesting the boy
11 in the movie, to which he stated he didn't think so, but did not know for sure. Gunnels said that
12 Busch then tried to put Vaseline on him so he (Busch) could penetrate him anally and he (Gunnels)
13 ran from the room. Gunnels said that Busch chased after him and said something to another person
14 in the house that Gunnels states he didn't see. Gunnels said that Busch told the other person in the
15 house, something like, "I'll take care of this." Gunnels stated that he thought they were there alone,
16 but thinking back now, the way Busch hurried him into the bedroom when they got there, he believes
17 there was another person in the house. Gunnels described the house as being just outside of town
18 in Alpena and stated that there were other houses around there, but there was quite a distance and
19 woods between them. Gunnels stated that he thought that the house belonged to Chris Busch, but
20 stated maybe Busch shared that house with another person, adding that he (Gunnels) doesn't know
21 for sure. Gunnels described Christopher Busch's car as being a small Pinto type car, possibly
22 brown in color and stated that Busch also had a full size S.U.V. Gunnels stated that Busch never
23 performed anal sex on him, nor ever tied him up. When asked about the incident in Alpena,
24 Gunnels stated that Busch never threatened him and did not threaten him that day, but only told him
25 that he would not try that again.

26 Gunnels then told us that later during that time period, Busch's mother pulled up to him in a
27 limousine in his neighborhood in Flint, and offered him money, not to say anything to the police or
28 testify against her son Chris. Gunnels told us that he and his brother just ran home.

29 While talking to Gunnels about Greg Greene, he stated that he did not know Green and did not
30 remember him from the neighborhood. I showed Gunnels a picture of Green from 1977 and
31 Gunnels stated that he didn't know him. I showed Gunnels the police reports from 1977, when he
32 (Gunnels), Bowman, Jeff Plumley & Brent Busch all went to the drive-in theatre with Greg Green and
33 Green performed oral sex on the boys, including Gunnels. Gunnels stated he doesn't remember
34 that and does not know Green. I reminded Gunnels that they went to see the movie "The Exorcist"
35 that night. I showed him Green's picture again, and then he stated that he kind of looks familiar, but
36 that he does not remember him. Gunnels then stated that he has done a lot of drugs over the years,
37 as if making an excuse not to remember Green.

38 I asked Gunnels about other places he has been with Chris Busch in the past, like the Detroit area
39 or any of his (Busch's friends in the Woodward corridor). Gunnels said he never went to Detroit or
40 anywhere in that area with Chris, including his house in Birmingham. Gunnels stated that he knew
41 that Chris's parents were rich, but was never at their house. I asked him about Chris's house in
42 Alma or in Whitehall. Gunnels said that he was never in Alma, but was at the apartment in Whitehall
43 in 1982, with Brent Busch. Gunnels said that this apartment was above a store in Whitehall and that
44 he believes that John Busch (Brent's Dad & Chris's Brother) then bought the store and lived upstairs
45 in the apartment. I asked Gunnels if he knew Chris to be "into" art, drawing, painting...etc? Gunnels
46 stated no. I asked if he knew if Chris or his family had any pets and if so which places he saw them
47 at, to which he stated he never saw any pets and did not if they had any.

48 I asked Gunnels if he ever saw a boy with Busch that he didn't recognize, or if Busch ever had him
49 perform sex on another boy, to which Gunnels stated no to both. We asked Gunnels if he ever saw

Busch hurt or keep another kid against his will, to which Gunnels stated, no. I asked Gunnels if he ever saw Busch carry any type of a weapon, to which Gunnels stated he thought he carried a knife.

3 The interview was completed at this point. We did not believe Gunnels about not knowing Greg
4 Green and he appeared to be minimizing his information about Busch also. Gunnels information is
5 contradictory to what Bowman told us, when he stated that Gunnels was the closest to Busch and
6 Green of anyone in their group. We made plans to have Gunnels swabbed for DNA and a possible
7 re-approach of Gunnels after the interview of Brent Busch, Jeff Plumley and Kenneth Bowman. ***
8 (See MSP transcripts of this interview for details) ***

9 **3-7-08:** I spoke with Livonia Polygraph Examiner Tim Larion today, who told me the results of the
10 polygraph examiners meeting regarding Busch & Green. Larion stated that due to Cabot, not
11 including relevant questions on the final test for each subject, the 3 examiners are unable to conduct
12 a numeric scoring on these charts. Their official conclusion, based on the charts being incomplete,
13 is that both subjects would be ruled "inconclusive." All 3 examiners agree that either way, they do
14 not see how Cabot could have possibly passed either one of these guys in 1977.

15 **3-7-08: *** (I identified Greg Greene's brothers today) ***** I was able to identify and locate both
16 of Green's brothers today, James Greene & Robert Greene. I performed checks thru the Lexis-
17 Nexis database for both subjects and located James living in Saginaw, Michigan & Robert Greene
18 living in Grand Blanc, Michigan. I check thru Secretary of State, revealed James to be James
19 Douglas Greene, w/m, [REDACTED] & to reside at [REDACTED]
20 Robert was found to be Robert Ewing Greene, w/m, [REDACTED] residing at [REDACTED]
21 [REDACTED] I obtained photographs of both of these subjects. *** (See Greg Greene file
22 for this information and photo's) ***

23 **3-7-08:** Garry called the MSP Detective (Tim Doan) in Gogebic County, Michigan today. Tim is the
24 Detective that picked us up at the airport and took us to Camp Ojibway to interview "Vince" Gunnels.
25 Tim is going to go see Gunnels, swab him for DNA and tell him that we know he lied about knowing
26 Greg Green and we are going to have him shipped down to the Detroit area so we can polygraph
27 him. Tim Doan is also going to tell him that his potential parole that he was looking forward to in
28 April, 2008, is not going to happen unless he is truthful with us.

29 **3-9-08:** I sent an e-mail today to Deputy Bud Shaw at the Montmorency County Sheriffs Dept. He
30 is the Deputy that helped me locate old reports on their investigation into Busch and also the Deputy
31 that helped me locate and identify Busch's cottage on Ess Lake. I asked him in the e-mail if he
32 could help me possibly identify this house in Alpena that Gunnels said Busch took him to a couple of
33 times and tried to anally molest him.

34 **3-10-08: *** (Interview of Brent Harris Busch in Newaygo, Michigan) ***** Garry Gray (MSP) & I
35 went to the Newaygo State Police post today to interview Brent Harris Busch. Brent is the nephew
36 of Christopher Busch. We began the interview by reading Brent his rights, to which he stated, he
37 understood, waived them and agreed to talk to us. We started telling Brent that we wanted to talk
38 with him about some things going on in Flint 30 years ago. Brent right away asked if this was about
39 Greg Greene, to which I stated it was about Greg Greene and Christopher Busch. I asked Brent if
40 he remembers when he first started seeing Greg Greene around his neighborhood in Flint, to which
41 he stated that he believes it was approximately 1974-1975, because he and his family moved to
42 Whitehall late in the summer of 1976, so it was well before that, probably a year or so before they
43 moved. This would match the documented information about Greene actually being discharged
44 from the mental institution in California in July of 1975. Brent said that he did not know about Greg
45 Greene being in a mental institution, or about him coming back from California, he simply stated that
46 he remembered seeing him around the neighborhood in 1975. Brent said that he did not know how
47 Chris & Greg met. Brent said that H. Lee Busch (his grandpa & Chris's father) bought his father
48 John Busch a store in Whitehall, Michigan to run. Brent said his family moved there from Flint and
49 lived in an apartment above the store. Brent said that he, his dad (John Busch), his brother Scott

1 Busch and mother Connie moved to Whitehall. Brent said that he remembers when his uncle Chris
2 got arrested for molesting the kids, stating that his father, John & Chris left Whitehall in a car and
3 were stopped and arrested in the Ionia Michigan area after the police put out an "a.p.b." for Chris.

4 Brent told us about the other boys in the other boys in the neighborhood, stating that he was
5 friends with Jeff Plumley, Kenneth Bowman and the Gunnels boys, Vince & Paul. Brent said that his
6 mother, Connie, was an alcoholic and drank and was friends with Gunnels mom, Monica. This
7 matches information that Gunnels told us about their families.

8 During the course of the interview, Brent admitted that he had been sexually molested in the past
9 by both Greene & his uncle Chris (Chris Busch) in 1975 & 76. Brent talked about how he had spent
10 time with both Busch & Greene alone when they molested him, but stated they were never together
11 when molesting him. Brent started talking about Chris molesting orally & anally and would take
12 pictures of him naked during sex. Brent also said that Chris would have him perform sexual acts on
13 other boys and take pictures of these situations. Brent went on to say that Chris sometimes, would
14 hold the camera up in the air above them while Brent was performing oral sex on him (Chris). We
15 asked Brent if Chris or Greg ever showed him any movies, to which he stated that Chris had shown
16 him some porn movies in the past, but he thought that they were regular adult porn films. We asked
17 if Chris ever filmed him, to which he stated no.

18 Brent told us that Chris would take he and other boys, like Paul and Vince Gunnels, up to his H.
19 Lee Busch's cottage on Ess Lake and had performed oral sex on Brent while they were there. Brent
20 said that Chris insisted on Brent sleeping on the couch in the living room away from the other boys
21 and eventually that evening, molested him. I asked Brent about a home that Chris had in Alpena, to
22 which Brent stated that he did not know about another house, stating that he was only ever at the
23 cottage on Ess Lake. When we talked to Brent about any other houses Chris had taken him to, he
24 stated that he had been to the house in Alma and to Chris's house in Sanford, Michigan. The house
25 in Sanford was only approximately 50 miles away from his house in Alma where Chris
26 owned/worked at the "Scotsman" restaurant. I asked Brent how and why Chris owned all these
27 properties, to which Brent stated that H. Lee Busch probably bought them for Chris. Brent talked
28 about how much money his grandpa, H. Lee Busch (Chris's dad) had. Brent stated, he had been
29 molested by Chris at both of these houses. He said that as far as he can remember or knows, Greg
30 Greene was never at any of Chris's houses or the cottage at Ess Lake, but does not know for sure.
31 He did say that he believed that Chris & Greg, along with having the pedophile bond between them,
32 also had a homosexual relationship going on. We asked about Chris and Greg using force against
33 him or violence, to which Brent stated that they both forced themselves, anally on him, but that it
34 was never violent or where they hurt him. He also stated that Greg had never choked him or ever
35 indicated that he had ever hurt anyone. Brent said that neither one ever tied him up or asked him to
36 be tied up and said that he never saw any ropes or heard about either one doing that to kids. We
37 asked Brent who he believes was the more violent type between Chris & Greg. Brent stated that he
38 thinks Chris was more violent than Greg. Brent said that he never heard anything about either one
39 hurting/killing a kid.

40 We started talking to Brent about whether Chris or Greg ever took him out in their cars and used
41 him to call kids over to the car as a "lure." Brent stated that neither one ever did that and went on to
42 say that when Greg was with him he (Greg) had no interest in being with another boy because he
43 (Greg) was so "into him."

44 We started talking more about the house in Sanford, Michigan. Brent said that when he was there
45 one time, Chris had brought another boy to the house that he thinks was named Ken. Brent said
46 that he did not know the boy, but stated that he did not think the boy was being held against his will.
47 Brent went on to say that Chris left for the day and left him and this boy home alone. I asked Brent if
48 Chris asked him to keep an eye on the boy why he was gone, to which he stated no. Brent said that
49 the only thing Chris said when he got back was, asking if he and this boy had sex why he (Chris)
50 was gone. Brent stated that he didn't see this boy again and has no idea who he was. Brent stated

1 that Chris was involved in the "Big Brother" program, indicating that maybe this is where the
unknown boy came from.

3 We started talking about the house in Birmingham (Chris's parent's home), to which Brent stated
4 that it was a huge home, approximately 6,000 – 7,000 square feet. Brent said he stayed there on
5 occasion with his grand parents, when his parents in Flint & later in Whitehall, were having
6 problems. His parents later divorced. We asked Brent about Chris committing suicide, to which he
7 stated that he remembers that Chris shot himself in the head. We asked him if he remembers why
8 he did it or if there was any talk about why Chris killed himself. Brent stated that he doesn't know
9 why, but believes that Chris couldn't live with his problem (pedophilia) any more. We showed Brent
10 a picture of the drawing of the kid screaming that was pinned to Chris's bedroom wall when he killed
11 himself and Brent appeared visibly shaken, indicating that he had seen the drawing before. Brent
12 said again that he had seen this picture before, but was not sure when, stating that he stayed in
13 Chris's room many times over the years. Brent said that he stayed there off and on, but believes
14 that he saw the picture between 1976 & 77. Brent stated that he believes he remembers it pinned to
15 the wall in Chris's room, above his stereo. When asked about Chris doing artwork or drawings,
16 Brent stated that he never knew Chris to do that, but did not know for sure. We showed Brent the
17 crime scene photos from Busch's suicide regarding the ropes found in the walk-in closet. Brent said
18 that he did not know why he had those, but stated that he can imagine why Chris had them and what
19 he did with them. Brent stated that he had not seen those before at the Birmingham house or any of
20 the houses Chris had access to. We asked Brent about any pets that Chris had at any of the
21 houses, to which he stated that Chris had a tan Labrador type dog and that his parents had a white
22 Scottish terrier dog at the Birmingham house that they brought over from Europe. He did not
23 remember, when asked, seeing either dog at the other houses or cottage with Chris. Brent stated
24 he may have taken them to the other places, but he couldn't say for sure.

26 **** The task force has white animal hairs recovered from the clothing of our victims from the original
27 investigation along with white animal hairs & hairs/fibers found during the recent re-examination by
28 the MSP Forensics Lab in 2007. We also have tan/gold carpet fibers on our victims clothing that
29 could possibly have been from one of the homes or cottage of Busch. The carpets in Chris Busch's
30 bedroom and walk-in closet at his parents home at that time, were tan/gold color. These fibers could
31 also have come from the gold colored ropes/ligatures found in Busch's walk-in closet that he
32 possibly used to bind victims. Some of the fibers we are in possession of were collected from our
33 victim's socks. Two of the victims were determined by the M.E. during their autopsies to have bind
34 marks on their wrist and ankles, possibly from ropes. Therefore, the tan/gold fibers found on the
35 victim's socks, could possibly be from the ropes or ligatures that were used to bind them. Ropes
36 and ligatures were found in Busch's home in Alma and also in the walk-in closet in his bedroom in
37 Birmingham, along with the drawing of what appears to be the Stebbins boy screaming.

38 ****Laboratory Scientist David Metzger from the Michigan State Police Lab in Northville
39 conducted tests in July of 1977 of fibers from Timothy King and fibers from Jill Robinson.
40 Metzger determined the following after these tests: *** Results: Examination of the fiber
41 from Jill Robinson's socks (#7A) revealed that it was microscopically similar in color and
42 physical construction and possessed optical properties in plane polarized light "identical" to
43 numerous fibers removed from the clothing of Timothy King. Metzger also conducted a
44 comparison of fibers from Jill Robinson's blanket to fibers from the genital area if Timothy
45 King. The results of this test was that these fibers were a different shade of yellow and
46 determined to be of an unusual nature, possibly carpet fibers. Gunnels stated that Busch
47 showed him a movie of boys being anally molested that were tied up. Busch himself told the police
48 in 1977, that he & Greene have discussed their fantasies about kidnapping, tying-up and molesting a
49 boy. ***(A crime scene search for trace evidence at Busch's home in Birmingham, especially
50 in the walk-in closet where the ropes were found, is forthcoming, along with searches at
51 other known locations where Busch/Greene could have kept the victims. The trace evidence
we will be looking for is human hair and/or DNA from our victims, animal hairs match the

1 animal hairs from our victims, similar fibers from carpets or the ropes and any other trace
2 evidence that might assist in the investigation)***

3 We were talking with Brent about where Chris was living at certain times and he stated that after
4 Chris was arrested in January of 1977, he lost his restaurant in Alma and he believes the houses in
5 Alma & Sanford. Brent stated that Chris ended up living back at his parent's home in Birmingham,
6 where he lived until he killed himself. Brent told us that Chris's parents were over seas a lot,
7 because of H. Lee Busch's job and because Chris's older brother lived in London, England. Brent
8 said that he thinks David Busch died of Aids in San Francisco. Brent told us that Chris had several
9 homes and places to stay and that he had these places alone, being that his parents lived in
10 England for awhile and also in Germany.

11 We went back to talking to Brent about Greg Greene and about Greene's relationship with the
12 other boys in the neighborhood. I asked how well, Greene knew Vince Gunnels, to which he stated
13 they knew each other, but I don't remember seeing them together. I asked Brent what he would
14 think about Vince Gunnels telling us that he didn't know Greg Greene, to which he stated that as far
15 as he knows they knew each other. I read a paragraph to Gunnels from the MSP report regarding
16 Greene & Busch's 1977, CSC arrest. The paragraph I read, pertained to the night in 1976 when
17 Greg Greene took Bowman, Plumley, Gunnel's & Brent Busch to the drive-in theatre in Flint. In this
18 paragraph, Bowman told police that he observed Greg Greene molest Vince Gunnels and Brent
19 Busch in the back seat of Greene's car. I asked Brent now about Gunnels knowing Greene, to
20 which he stated, I remember that night and I guess that was Vince in the back seat with me & Greg.
21 I just can't picture Vince there. *** (See Transcripts of this interview for further details) ***

22 3-11-08: Garry & I went to [REDACTED] looking for Dale Arthur
23 Cooper. This is the subject listed in Greene & Busch's arrest report from January of 1977. Cooper
24 was listed as a suspect in that case, but there is no mention of him in the narrative of the report. He
25 was an adult from St. Clair, Michigan that was charged with Disorderly person. He may possibly be
26 the third person charged in the Flint CSC case with Busch & Green that was mentioned in the
27 newspaper article when Busch & Greene were cleared by polygraph in the OCCK case. The article
28 stated two men polygraphed in connection to the OCCK case, but said three men arrested. Cooper
29 may be a pedophile associate of Busch & Greene and needs to be interviewed. This address is the
30 Detroit Chapter of Vietnam Veterans building. We spoke with the managers there who had no
31 record of Cooper, but stated that many homeless type people come and go from their office.

32 3-11-08: We received an e-mail from Cindy Ackers today from Jackson Prison in regards to Greg
33 Greene. A couple of guards were interviewed about Greene and both said they do not remember
34 Greene being friendly with anyone, stating that they remember him as a loner, but said that Chad
35 Nikle was his "bunk-mate" at the time of his death.

36 3-12-08: I drove by Busch's home at [REDACTED] this morning.
37 The house is situated on the northwest corner of [REDACTED]. The home
38 appears to be, structurally, the same as it probably did 30 years ago. There was a burgundy
39 minivan in the driveway, bearing Mi. Lic. Plate [REDACTED] I had our dispatch "run" the plate and it
40 came back registered to Geoffrey Saham, on a 2007 Honda Oddysey Mini-van, at [REDACTED]
41 [REDACTED]

42 3-12-08: I met with Jason Bolinger (FBI) at his office in Troy today. I brought Jason completely up
43 to speed on the Busch/Greene lead and what our investigative plans are on this lead. We were
44 talking about the interview Doan conducted on Christopher Busch in January 1977, just before his
45 polygraph. I told Jason that Busch was talking about being a pedophile and named locations he had
46 picked kids up, or dropped them off at in the past year or so. While naming these locations, Busch
47 lists chronologically the three abduction sites for our first three victims. I told Jason that I believe he
48 was possibly doing that because he thought his car might have been seen at those locations, so

1 he's putting himself at those same locations on "legitimate type" business as an alibi, or he was
2 simply "laying out a road map" or giving clues of his involvement.

3 Agent Bolinger & I spent some time today formulating questions for the FBI Agent in New York City
4 that is going to be interviewing Chris Busch's brother, Charles, and "swabbing" him for DNA. We put
5 together approximately 20-30 questions for Agent MacDonald to ask Busch's brother. We called
6 and spoke to Agent MacDonald and made arrangements to conduct a conference call with him from
7 the MSP Metro North Post on Tuesday 3-18-08 at 12:00pm, to brief MacDonald on the case and the
8 interview and to go over the questions we have for him to ask.

9 **3-13-08: *** (Tape-recorded interview of Chad Nikle, Greg Greene's cellmate in prison for 3**
10 **years before Greene died). ***** Garry Gray (MSP) & I drove to Flint today and interviewed Greene's
11 ex-cellmate, Chad Nikle at his house in Flint. Nikle's house is located at [REDACTED]

12 [REDACTED] We started the interview by explaining to Nikle what it is that we are investigating,
13 that he is not in any trouble, and that we were there simply looking for his help. I explained to Nikle
14 that we have been investigating this for a long time and that we have interviewed many people
15 surrounding Greg Greene. I also explained to Nikle that some of the questions we are going to ask
16 him, we already know the answers to and we do that to see if he is going to be truthful with us. I
17 went on to say that I know that he was a cellmate of Greg Greene's before he died and that we also
18 know that they were both from Flint & serving time in prison for the same type of offense (CSC on
19 child u/13). I further explained that we know that they had a lot of time to talk in their cell, and that
20 we know from our experience that cellmates in prison share a lot of information with each other. As
21 we were explaining this to Nikle, he stated that he and Greg did not talk much, and never said
22 anything to him about killing any kids. Nikle was not very convincing when he made that statement
23 and appeared nervous. While I was talking to Nikle about the seriousness of what we are
24 investigating, how long it has been and how bad the families of these victims need closure, I handed
25 the photograph of our 4 victims to Nikle to look at. Nikle had what appeared to me to be a strange
26 reaction to the picture, when he only looked at it momentarily, then turned the picture over, pushing
27 it back at me, hitting my hand with it as he pushed it back. I almost said to Nikle, "I told you to look
28 at it," but didn't say anything about his reaction to the picture at that time. Nikle said again that Greg
29 never talked about anything like that and that they didn't talk much. We told Nikle that we did not
30 think he was "being straight" with us and confronted him with the fact that he appeared nervous and
31 that we did not believe him. We noticed that Nikle kept looking at his elderly mother who was sitting
32 in the other room. We asked Nikle if he wanted to go outside to our car and talk and he agreed.

33 When we got out to the car, we confronted Nikle further about possibly lying to us, at which time
34 he broke down crying heavily and holding his head. We told Nikle that it was just the three of us
35 now and he did not have to worry. Nikle then told us that he and Greg Greene were not only
36 cellmates, but they had a sexual relationship. After explaining this, Nikle appeared to be more
37 truthful after breaking down. We began to ask him questions again about Greg Greene and [REDACTED]
38 Greene said to him about our case. Nikle told us that Greene told him about kids he had molested
39 in the past and gotten away with it. He also told us that Greene told him that he got away with killing
40 4 kids in the past. Nikle was visibly upset at this point. His eyes were watering and he was
41 breathing heavy. We asked Nikle what else Greene told him about it, to which he stated that he's
42 trying to remember, it was along time ago. We asked Nikle to try to remember when Greene told
43 him this. At this point, Nikle began telling us about how he found Greg Greene dead in their cell and
44 performed CPR on him until the guards could get up there. Nikle told us that he does not remember
45 exactly when Greene told him about this, but remembers that they were watching TV and talking
46 about molesting kids in the past when Greene told him about getting away with killing the kids. I still
47 felt that Nikle was holding back and told him that I get the feeling that he is holding back because he
48 is worried about something coming back on him, to which Nikle agreed, stating that he doesn't want
49 anything happening to him. We re-assured him that he would not get hurt and that he would not be
50 in any trouble. We talked with Nikle more about what Greene had told him about killing the kids.
51 Nikle stated that Greene told him that he knew the police were looking for those kids while they were

1 missing and in his possession. Nikle said that Greene told him that he had molested the kids in a
2 field and killed them. We asked Nikle if Greene told him where he kept the kids, to which he stated
3 he doesn't remember. Nikle said that Greene told him that he had the kids for a few days. We
4 asked Nikle if he remembers Greene mentioning the Oakland County Child Killings, to which he
5 stated he didn't remember hearing that. We told Nikle we intend on polygraphing him on this
6 information. We asked Nikle if it was the truth that Greene told you he killed 4 kids, to which Nikle
7 stated, "Yes." We asked Nikle how he would do on a polygraph about this, to which he stated he
8 would pass. Nikle was stressed and expressed his concerns about telling us this. We asked him if
9 he can remember anything else right now about what Greene told him, to which he stated no. Once
10 again we asked if it was true that Greene told him this information, Nikle answered, "yes." We told
11 Nikle again, that we would be polygraphing him on this information, to which he stated he would
12 pass. We asked Nikle if he remembers Greene talking about another person with him during these
13 killings? Nikle stated he didn't think so. I ran the name Christopher or Chris Busch by him? Nikle
14 paused for a second, then, said that the name sounds familiar. We told Nikle to start writing down
15 everything he can remember about what Greene had told him about killing the kids, and he stated
16 he would. We told him that we would be in touch with him about taking the polygraph and
17 terminated the interview. *** (See transcripts from interview for details.) ***

18 **3-14-08:** Garry Gray (MSP) & I went to the Michigan State Police Long-term evidence storage facility today in Lansing, Michigan. We went there to go through the OCK evidence, to see
19 which packages of evidence contained the hairs & fibers we will need for future comparisons
20 the course of this lead. We will be conducting crime scene searches of Busch & Greene's homes &
21 cottage for trace evidence (hairs & Fibers) to collect and compare to known evidence found on the
22 victims. We went through, approximately 10 large bags and/or boxes of evidence such as the
23 victims clothing, victims boots/shoes, and other miscellaneous evidence. We found many slides and
24 containers that held fibers, hairs, blood evidence, & DNA swabs. Some of the hairs and fibers,
25 including animal hairs that were tested and compared during the original investigation, were not in
26 this evidence at this storage facility. Documents located at the storage facility, indicate that these
27 items that were tested, were taken from the long-term storage facility in 1995, to the Northville Lab
28 and not returned. We will be checking with the Northville Lab, due to the fact these particular hairs &
29 fibers will be important for our future comparisons.
30

31 **3-14-08:** I received an e-mail today from Deputy "Bud" Shaw from The Montmorency County
32 Sheriffs Department, who stated that he made contact with officials from Register of Deeds at
33 Presque Isle County Michigan and also Alpena County Michigan. Shaw stated that there is no
34 record of property in the name of Christopher Busch or his father H. Lee Busch in either county. It's
35 possible Vince Gunnels was at Chris Busch's house in Alma and thought it was Alpena, or Busch's
36 house in Alpena was in another persons name or Busch stayed with someone else.

37 **3-15-08:** We are making plans to conduct crime scene searches for trace evidence at several
38 Busch & Greene's homes/cottage in the near future, especially in light of the information from
39 Nikle. We are going to have the State Police Crime Lab conduct these searches, starting with the
40 Busch home [redacted] and the cottage on Ess Lake, where Busch
41 was seen while King was missing. Recovery of any physical evidence during these searches,
42 especially hairs & fibers, will result in immediate comparisons to our trace evidence currently at the
43 MSP Forensics Lab in Lansing, and also at the FBI Forensics Lab in Quantico, Virginia.

44 **3-16-08:** *** (See the Greene "Time-Line," for details of his whereabouts, statements and/or
45 actions during a span of time, beginning when Greene was 15-16 years old living on Baldwin
46 in Flint thru his death in prison in 1995. This time line also includes Christopher Busch and
47 his association with Greg Greene during the time of the child killings from 1976-1977.) ***

48 **3-17-08:** Garry Gray (MSP) called the Michigan State Police Forensics Lab in Lansing today and
49 spoke with a Fingerprint Specialist named Michelle Glasgow. She is in possession of the partial

1 Fingerprint that was recovered from Kristine Mihelich during the autopsy. We are going to have
Michelle Glasgow, compare Busch & Greene's fingerprints to the partial print from Mihelich.

3 We received an e-mail back a short time later from Michelle Glasgow. She stated that she has
4 located the partial print from Mihelich and it looks like it was from Mihelich's parka. Glasgow also
5 stated that she has some latent prints from an envelope.

6 **3-17-08:** Garry contacted the evidence room (Property Sgt.) at the Northville Lab who is going to
7 check their property room for the hair & fiber evidence that was taken from Long-Term storage in
8 Lansing, for tests & comparisons in 1995.

9 **3-18-08:** Garry Gray (MSP) & I drove to Grand Blanc today to interview Greg Greene's brother and
10 "swab" him for DNA. We went to [REDACTED], the home of Greg Greene's
11 older brother Robert Ewing Greene, w/m, [REDACTED]. There was no one home, so we left a
12 note and our business cards to contact us, indicating that we were looking for his help in an old
13 investigation.

14 **3-18-08:** We had the phone conference today with Agent "Tommy" MacDonald (FBI) in New York
15 City, who is going to interview Chris Busch's brother and "swab" him for DNA. Present at the
16 meeting was John Ouellet & Jason Bolinger (FBI), Garry Gray & Dave Robetson (MSP) and myself.
17 We went over the background of the case and the background on this lead into Busch & Greene.
18 We also went over questions that we would like Agent MacDonald to ask Charles Busch about his
19 brother. We e-mailed the Agent pictures of the drawing on the wall in Busch's room when he killed
20 himself, along with a picture of the Stebbins boy alive and a picture of him dead at the scene when
21 his hood with the fur around the edge was up, like in the drawing Busch had. Agent MacDonald is
22 going to conduct this interview next week and ship the DNA swab directly to the DNA lab in
23 Quantico, Virginia where our DNA evidence is.

24 **3-18-08:** While we were all at the MSP Metro North Post today, we had an opportunity to discuss
25 the direction of this investigation and give our opinions on what the priorities are and who needs to
26 be polygraphed. We were all in agreement that Chad Nikle needs to be polygraphed ASAP. A
27 polygraph for Nikle is already arranged for April 7th, 2008 at the MSP 2nd District Headquarters, with
28 polygraph examiner Lt. Robert Dykstra. We all agree that the search of Busch's home in
29 Birmingham should be our top priority for Crime Scene searches and we will start orchestrating this.
30 We then began to discuss whether or not Kenneth Bowman had been truthful during our earlier
31 interviews with him. Bowman had told me during my first interview with him that he is a "co-
32 conspirator" and was visibly shaken and scared during this interview, stating that Busch had him
33 perform oral sex on a boy that he (Busch) had brought down from up north. Bowman stated that it
34 was the same boy that the police showed him a picture of in 1977 that was dead. Bowman identified
35 this as the King boy from the pictures I showed him.

36 I stated that Bowman told the police in January of 1977, that Greene approached him and asked
37 him to help him kidnap and kill a boy. Bowman stated they did not go thru with it. Bowman told us
38 during an interview in 2008, that Busch & Greene would often use him to lure kids over to his car so
39 Greene could get a closer look at them. If Greene was asking Bowman (13 year old boy), to help
40 him kidnap and kill a kid, it was probably, based on him using Bowman in the past as a "lure,"
41 because he (Greene) needed Bowman to lure the kid towards the car so that Greene could get his
42 hands on the boy. For Greene to ask Bowman to kidnap and kill a boy with him there had to
43 possibly be a closer bond between Bowman and Greene that Bowman stated to us in 2008. From
44 my training and experience, that's not the type of thing a person asked a casual acquaintance to do.
45 There would have to be a certain level of trust or fear between the two, for Greene to even asked
46 Bowman. We know, that Greene had choked Bowman unconscious in the past, while molesting him
and that Bowman, from his own words was afraid of Busch and Greene killing him. Greene had told
Bowman that Busch had killed a boy in the past.

1 **** We agreed that Bowman may be "hedging" on cooperation about his possible involvement and
2 it should be a priority to polygraph him ASAP. Bowman may have been more truthful during the first
3 nterview when he was admitting possible involvement and then got scared and backed off from this,
4 3-4 weeks later during the second interview. He will be polygraphed about his possible involvement
5 and/or his possible knowledge of the crimes and/or Busch & Greene's involvement.

6 It also could simply be that Bowman saw Lamborgine on the news in 2006 as the possible
7 Oakland County Child Killer, hates Chris Busch & Greg Greene and is trying to connect them with
8 Lamborgine for the child killings. Once again, this is why it will be important to polygraph Bowman.

9 **3-18-08:** I called Kenneth Bowman's counselor at "Operation Get Down" tonight and left a message
10 for him to call me, indicating that I want to talk to Kenneth again. I also left a message for Jeneay
11 Cheeks, Bowman's Probation Officer and asked her to call about Bowman's current location and
12 that I wanted to talk to him again.

13 **3-19-08:** We were discussing Kenneth Bowman today and talking about how he called himself a
14 co-conspirator during the first interview and about him identifying the King boy as the boy Busch
15 made Bowman have sex with. We talked about Bowman calling me a couple of times after that,
16 concerned about telling me these things and stating that he was scared. My phone rang during this
17 conversation with the number for "Operation Get Down in Detroit." I thought it would be Bowman's
18 counselor, Mr. Phillips returning my call, but it was Kenneth Bowman calling from Mr. Phillips phone.
19 I asked Kenneth how he was doing and he quickly answered "fine," and asked if the DNA came
20 back. Kenneth, again seemed very nervous about the DNA asking how much longer? I told
21 Kenneth that it would be a bit yet and stated to Kenneth, "you still want to help us out and cooperate,
22 right Kenneth?" to which Kenneth said yes. I told Kenneth that there are a couple of things we want
23 to talk about with him, and would get in touch with him. I told Kenneth that I spoke with his probation
24 Officer Ms. Jeneay Cheeks today who told me that he (Kenneth) has been assigned a new probation
25 Officer named Mr. Junious [REDACTED]. I told Kenneth that Ms. Cheeks told me today that you
26 are due to get out of "Operation Get Down" April 25th, 2008. Kenneth stated that is right. I asked
27 Kenneth how long he is on probation, to which he stated January 9th, 2010. I asked Kenneth where
28 he is going to live when he gets out of the halfway house, to which he stated with his mom in
29 Belleville. Kenneth asked me if I wanted the phone number to his mom's and he stated it's [REDACTED]
30 [REDACTED] I told Kenneth that we know where to find him and would be in touch with him.

31 **** It was very interesting how nervous Bowman was once again about the DNA. It's possible that
32 due to Greene possibly being in the Genesee County Jail, awaiting sentencing on the CSC 1's when
33 the last boy (King) was abducted in Birmingham that Busch used Bowman to help him just like
34 Bowman was trying to say during the first interview, when he was talking about being used as a
35 "Lure" by Busch all over Oakland County and along Woodward Ave. We will Ship Bowman's DNA
36 swab ASAP to the DNA Lab in Quantico to compare to the white male body hair that was found in
37 the back of Timothy King's mouth during his autopsy. His reaction again today would indicate that
38 he may have indeed been more truthful during that first interview and may in-fact have been
39 involved.

40 **3-19-08: *** (Conference call to Agent MacDonald in New York City about the interview of**
41 **Chris Busch's brother, Charles.) ***** We called Agent MacDonald today and briefed him over the
42 phone on the background of the child killing case and the background of this lead. We also
43 discussed the approach of Busch's brother to "swab" him for DNA and the questions we want
44 MacDonald to ask. We then e-mailed MacDonald approximately 15-20 questions for Charles Busch,
45 along with photographs from the suicide scene of his brother. These photos included pictures of the
46 ropes and the drawing of the boy screaming found in his brothers room, along with photos of our
47 victims. Agent MacDonald is prepared and will interview and swab Charles Busch, next week in
48 New York. MacDonald is going to ship the DNA swab directly to the FBI, DNA Lab in Qauntico, for
49 our comparisons.

1 **3-19-08:** Garry Gray (MSP) & I drove to [REDACTED] today. This is the home of
2 Greg Greene's younger brother, James Douglas Greene. We were attempting to "swab" James for
3 DNA and interview him about his brother. There was no one home.

4 We had three phone messages from Greg Greene's older brother Robert Greene when we got
5 back to the Metro North Post. We called him and he asked if this was about a relative. We
6 indicated that it was indeed about his younger brother Greg who died in prison. Robert Greene
7 agreed to meet with us at 11:30am Tuesday March 25th in Flint. He seemed cooperative and willing
8 to talk to us. We will attempt to get his DNA and will interview him about his brother Greg.

9 **3-19-08: *** (Identified the Busch's maid from 1978, named Christine Bracken) ***** I had our
10 dispatch perform a check thru the Secretary of State for the name Christine Bracken, [REDACTED]
11 [REDACTED] There was only one person listed with that spelling. This was a, Christine
12 Bracken, white female, [REDACTED]

13 **3-20-08:** I met with Livonia Police Chief Stevenson and Captains Caid & LaBerge today to brief
14 them on the development of the Busch/Greene lead, the investigation into the lead, where the
15 investigation currently stands and what our future plans are to exhaust the lead.

16 **3-20-08:** I called Donna Jones today in the records section of the Genesee County Sheriffs
17 Department, who is going to try to locate fingerprint cards on Greg Greene for me. She has to have
18 someone go to an off-site storage facility to check, and told me to call her on Monday and she
19 should have an answer for me.

20 **3-20-08:** I performed a check thru the Lexis-Nexis system on the Busch's maid, Christine Bracken.
21 The check resulted with only 2 Christine Brackens in Michigan. The first one is the Christine
22 Bracken [REDACTED] This subject shows no past addresses in Detroit.

23 The 2nd Christine Bracken was born [REDACTED] and shows that she is currently deceased.
24 This subject died in 1995 at 79 years old. This subject shows past addresses in Detroit, and may be
25 the Christine Bracken that was their maid. The Busch's maid had an address [REDACTED]
26 [REDACTED]

27 **** After closer review of Bloomfield Twp.'s police reports from the suicide of Christopher Busch, it
28 listed the maid, Christine Bracken as a b/f (black female). The black Christine Bracken on record in
29 this area is listed as deceased, and would be 95 years old today.

30 **3-24-08:** Garry called Camp Ojibway today and spoke with Don Mucharin, the Inspector for the
31 Dept. of Corrections who has been our contact for interviewing Gunnels. We explained to Mucharin
32 that we want to talk to Gunnels again, believing he possibly lied during our first interview with him,
33 about him knowing Greg Greene. We explained that we also wish to polygraph Gunnels about his
34 involvement/ knowledge of our case. Mucharin gave the name of a Mr. Fountain, who is in charge of
35 handling Vincent Gunnels upcoming parole for The Dept. of Corrections.

36 Garry called and spoke with Mr. Fountain and explained our situation with Gunnels and our desire
37 to delay his upcoming parole to allow us to continue to investigate him. Garry requested that The
38 Dept. of Corrections, transfer Gunnels to a facility in the Detroit area to allow us easier access to
39 interview and polygraph Gunnels. Mr. Fountain was very cooperative and receptive to this and
40 requested that we put this request into writing for his office. Garry typed and forwarded this request
41 (e-mail) to Mr. Fountain today.

42 Mr. Fountain called back later in the afternoon today and stated that he received our request, it was
43 approved and Gunnels would be transferred to a facility in the metro Detroit area on April 1st, 2008.
44 Gunnels will arrive on April 2nd, 2008.

45 **3-24-08:** I called Livonia Polygraph Examiner Tim Larion today and requested his assistance in
46 polygraphing Kenneth Bowman in the next couple of weeks, if possible, in regards to his possible

1 involvement/knowledge in the OCK case. Larion called me back a short time later and agreed to
2 polygraph Kenneth Bowman on April 2nd, 2008.

3 **3-24-08:** I spoke with Donna Jones today, from the records department at the Genesee County
4 Sheriff's Department. She stated that she was able to locate fingerprint cards for Gregory Greene. I
5 asked her for their hard copy of the fingerprints to use for a comparison in our case. She stated that
6 would be fine and that I would just have to sign for them. I told her that we would pick those up
7 tomorrow.

8 **3-25-08:** I requested that Dave Robertson (MSP) forward and e-mail to the St. Clair County MSP
9 Post requesting any mug shots or reports they might have involving their arrests of Dale Arthur
10 Cooper in MSP St. Clair in 1977 & 78. The request was sent.

11 We also sent an e-mail to the MSP Intelligence Unit in Lansing, requesting information on whether
12 Dale Cooper is still alive and if so where he currently resides.

13 **3-25-08: *** (Interviewed Greg Greene's Brother Robert today and "swabbed" him for DNA)**
14 ******* Garry Gray (MSP) & I met Robert Greene at the General Motors Metal Fabricating plant in Flint,
15 Michigan today, where Robert works, to interview him about his brother Greg Greene. We
16 introduced ourselves and explained to Robert why we wanted to talk to him. Robert indicated that
17 he knew it was going to be about his brother Greg's possible involvement in the OCK case. Robert
18 indicated that he was willing to talk to us about it. We explained how Mitochondrial DNA works and
19 asked Robert if he and Greg had the same mother, to which he stated that they did. We requested
20 that Robert consent to a DNA Buccal swab for his saliva so we can eliminate his brother as a
21 suspect. Robert asked if we would have to dig his brother up, stating that Greg is buried in a
22 cemetery in Macomb Twp. We told Robert that would not be necessary if we had the saliva sample
23 from him, to which Robert agreed to do and gave his consent. We took 2 DNA Buccal swabs from
24 Robert and placed them into evidence after returning to the Michigan State Police Metro North Post.

25 We then started to interview Robert about his brother Greg Greene. Robert started by saying that
26 he knew about his brother's lifestyle (Pedophilia) and explained that Greg struggled with that until he
27 died in prison in 1995. Robert began to talk about Greg getting arrested and charged in California in
28 the mid 1970's and stated that Greg had hurt a boy real bad. We asked Robert what happened and
29 he told us that a boy was trying to get away from Greg in California, jumped out of a moving car and
30 got hurt. Robert told us that Greg then dropped the boy off at the hospital and that's how he (Greg)
31 got caught. Robert told us that Greg was sentenced to a mental institution in California for what he
32 had done and explained that after awhile, California wanted "rid" of Greg and made arrangements
33 for him to complete his parole in Michigan. Robert stated that his father had to agree to take
34 responsibility for Greg and pick him up at the airport, if California Dept. of Corrections released him
35 from the mental institution. Robert told us that he was the one who picked Greg up at the airport
36 and when Greg stepped off the plane, he (Robert) noticed Greg's eyes right away, stating that he
37 had a glazed over or crazy look in his eyes.

38 ******* We knew already from reports and statements from Greg himself in 1977, that he had actually
39 choked the boy out in California in an attempt to keep him quiet and then, when he thought he had
40 killed the boy, dropped him off at an emergency room and got caught. Greg was charged in
41 California with 50 counts of child molestation, kidnapping & false imprisonment, when he was sent to
42 Patton State Mental Hospital as a mentally disturbed sex offender.

43 Robert explained that he knew his brother had been investigated by the police for the Oakland
44 County Child Killings and had been polygraphed about it after his arrest in 1977, for molesting some
45 kids in Flint. We asked Robert if he knew Christopher Busch, to which he stated that he knew the
46 name, but did not recognize him after we showed him a photo of Busch. Robert stated that Greg
47 had told him that he (Greg) was always frustrated with the fact that he told the police back in 1977,
48 that Chris Busch was involved in killing those kids and that the police never believed him.

1 We began talking to Robert about anything Greg might have said to him over the years, to which
2 Robert stated that Greg wrote he and his brother James a long letter while he was in prison about
3 his life, but stated that they had thrown the letter away after Greg died in 1995. Robert stated that
4 Greg died of a heart attack in prison and that the doctors determined that Greg's heart, even though
5 he was only 45 years old, was like that of an old man. Robert began talking about when Greg was
6 arrested in January of 1977, for the molestations in Flint he (Greg) had been living with their father at
7 [REDACTED] Robert said that he was at the Baldwin house after Greg's arrest and
8 found a hidden room in the crawl space of the attic that Greg had built. Robert told us that when he
9 found it, he knew what Greg built it for and was sick to his stomach over it. We asked Robert to
10 describe this room to us. Robert stated that this room had a hidden door that he found accidentally
11 and stated that the people that reside in the home right now probably do not know it is there. Robert
12 stated that it was a small room behind a wall in the crawl space and stated that it had paneling and
13 carpeting in it. Robert went on to say that the room was big enough for Greg and a boy to stay in.

14 *** We knew from the 1977 police reports, during the interview of the victims of Greg Greene, that
15 one of the victims (Gary Robinson) told the police that he had stayed in a hidden room in the attic of
16 Greg Greene's house where Greene molested him. We asked Robert if Greg ever told him anything
17 about the child killings or his involvement in the killings that might assist us in our investigation, to
18 which Robert stated no. We asked Robert if Greg did ever say anything to him, would he have said
19 something to the police. Robert told us that if Greg ever told him anything like that or if he ever
20 learned any information like that he would have turned him in right away. Robert stated that he is
21 Greg's older brother and was not around the house at [REDACTED] that often and stated that
22 Greg's younger brother James that lives in Saginaw was closer to Greg and lived with Greg and
23 their father on Baldwin at that time. Robert stated that he would give his brother Jim our phone
24 numbers and ask him to call us about an interview. *** (See MSP transcripts of this interview for
25 details) ***

26
27 3-25-08: While we were in Flint today, we stopped by the Genesee County Sheriffs Department
28 records section and picked-up a copy of Gregory Greene's fingerprint cards and a photo of Greene
29 from February 1977. These fingerprint cards will be used for a comparison to a partial fingerprint
lifted off of Kristine Mihelich's coat from January 1977.

30 3-26-08: *** (MSP Forensics Lab in Lansing today, with Busch, Greene & Lamborgine's
31 fingerprint cards) *** Garry & I drove up to the MSP lab in Lansing today to give Fingerprint expert,
32 Michelle Glasgow, Busch, Greene & Lamborgines fingerprint cards today to conduct a comparison
33 on the partial latent print from Kristine Mihelich's coat. We spoke with Michelle Glasgow who
34 showed us the partial latent fingerprint. It appeared to be a fairly clear latent print, but Glasgow
35 explained that she may not be able to make an exact identification with our known suspect prints,
36 but the latent is good enough for elimination purposes. Glasgow explained further that she would
37 also be able to determine if the general pattern of our suspects prints match this latent print. She is
38 going to conduct a thorough examination/comparison with our suspect's fingerprints and would
39 contact us afterwards.

40 While we were there, and discussing the case with her and showing her some photographs, she
41 stated that we could use their technical support unit to possibly enhance the photograph from
42 Christopher Busch's bedroom to determine if the shotgun shell that was on the desk, is in fact a 12
43 gauge shell and also if it had contained "#2" shot. This was the caliber and the size of the shot used
44 to shoot our victim, Jill Robinson in the face.

45 *** If the lab were able to determine that the caliber and size of the shot matched what was used on
46 victim Robinson, this would add credence to the theory that Christopher Busch was possibly laying
47 out clues in his room before he shot himself, as sort of a suicide note. Also found in his bedroom
was the drawing of the boy (Stebbins) screaming and the ropes/ligatures laying out in the walk-in
48 closet. Busch knew how much the police in 1977 thought of him as a suspect, and possibly thought
49 these would be enough clues for the police to put "two & two" together. It is also possible that there
50

1 was in-fact a suicide note from Christopher Busch in the bedroom, but the brother Charles Nels
2 Busch, who was at the house that day, picked up the note without the officer seeing it. It says in the
3 police report from Bloomfield Twp. PD, when they responded to the call at [REDACTED]
4 [REDACTED], that Charles Busch entered the home with the officer and also entered the bedroom where
5 his brother Chris was found dead.

6 Michelle Glasgow called back later this afternoon and stated that she talked to her technical
7 support unit about our photograph, and they stated if we were willing, they would ship the 2 photos
8 to NASA to be enhanced, stating that they have "state of the art" equipment. We agreed and Garry
9 authorized them to go ahead and ship them to NASA.

10 **3-26-08:** We received a call today from Mr. Fountain at Michigan Department of Corrections in
11 Lansing, who stated that James "Vincent" Gunnels parole has been officially violated and he has
12 been put on "suspected felon" status. Mr. Fountain told Garry that Gunnels prior parole date of April
13 15th, 2008, has been suspended until the middle of May 2008. Fountain also stated that Gunnels will
14 be transferred ASAP to the Ryan facility in Southeast Michigan. This will allow us time to re-
15 interview Gunnels and polygraph him.

16 **3-27-08: *** (Sent Greene, Bowman & Hasting's DNA Buccal swabs to the FBI Lab via Fed-Ex
17 today) ***** Garry Gray (MSP) called me today and stated that he shipped Greene & Bowman's DNA
18 Buccal swab's to the FBI Lab in Quantico, Virginia. The DNA scientist there, Connie Fischer, is
19 going to produce Mitochondrial profiles from these swabs that we have collected and compare them
20 to the DNA from the OCKK victims. John Hasting's DNA Buccal swab obtained from Hastings by the
21 Georgia Bureau of Investigation was also sent to Quantico today.

22 **3-27-08:** Garry received a call today from the MSP Forensics Lab in Lansing. They were
23 requesting the negatives of the 2 pictures we left for them to enhance, which will make it easier to
24 enhance and will have better quality. One of these pictures was a picture of a "spent" shotgun shell
25 casing on the desk in Busch's bedroom that was found when he killed himself. We were able to
26 locate the negatives of these pictures and will forward them to the lab.

27 **3-27-08:** I briefed Livonia polygraph examiner Tim Larion today on the upcoming polygraphs he is
28 going to administer on Kenneth Bowman and Vincent Gunnels. I brought Larion "up to speed" on
29 these two subjects, their connection to Busch & Greene and their possible involvement/knowledge of
30 the Oakland County Child Killings.

31 **3-27-08:** I called the records office at the Genesee County Jail today and spoke with Donna Jones
32 about Gregory Greene's inmate status from his arrest in January of 1977, until he was sentenced to
33 prison in June of 1977. The only record that she could find was the jail index card for Greg Greene,
34 file #3515, Case #77-00589. Donna faxed me a copy of this card. The card had typed notes on it
35 that say the following: "2/3/77 2 charges CSC 1st Elliott-CC rel SMP 6/16/77." I asked Donna
36 if their jail was computerized back then, to which she stated no, indicating that the index cards are
37 what they used back then to track inmates. I asked her to explain what the card said. She stated
38 that the 2-3-77 entry, was when he arrived at the jail, then the charges, then where it says Elliott-CC,
39 was the Circuit Court Judge, indicating that Greene was released after his sentencing on 6-17-1977.
40 She stated that it does not appear as if Greene was ever out of the jail between 2-3-77 & 6-17-77
41 and the card shows 141 days credit for time served, sentenced to "Life" in prison by Judge Elliott. I
42 asked Donna if it was possible that Greene was out of the jail at any time or bonded out and it just
43 didn't get put on the card, to which she stated it was possible, indicating that the cards were only as
44 accurate as the people typing the entries on them, but more than likely if he was out or bonded out it
45 would say that on the card. ***** (See copy of this card from Genesee County jail in the Greg
46 Greene file) *****

47 **3-27-08: ***** I was reading thru the pre-polygraph interview Cabot conducted with Greg Greene in
48 1977 and noticed that when Cabot asked Greene what type of person he thinks killed the Stebbins
49 boy, Greene answered, "knew the kid & killed him to keep him quiet." Greene then stated, "Or a 1

1 shot deal, somebody who," then stated, "I don't know." Choking a boy to keep him quiet was
2 Greene's M.O. and it's interesting that that was his first response and then almost as if he caught
3 himself and changed directions, eventually stating that he didn't know. When asked what should
4 happen to the person when he is caught, Greene answered, "Completely depends on the person,"
5 another answer that could indicate personal involvement or knowledge.

6 It is also interesting that Greene first mentioned to Cabot that it was someone that knew the kid.
7 Mark Stebbins lived and was abducted in Ferndale, Michigan. During an interview the task force
8 conducted with Kenneth Bowman in 1977, Bowman was asked if he had knowledge of any friends of
9 Chris or Greg's in the Detroit area. Bowman told the task force that Greg talked about a friend he
10 had in Ferndale and when Bowman inquired about this friend, Greene would not answer and told
11 Bowman it was personal. It's possible that this friend of Greene's and/or Greene himself was
12 familiar with the Stebbins boy through this friend in Ferndale or from going to this friend's home in
13 Ferndale.

14 **3-27-08:** I began searching through the Oakland County Child killer Task Force tip files today in an
15 attempt to identify this possible associate of Greg Greene that possibly lived in Ferndale. While
16 searching this database, I found several possible suspects called into the task force in the 1970's
17 that lived in Ferndale and a few that lived on Saratoga St., the same street Mark Stebbins lived on.
18 Unknown at this point, if any of these Ferndale suspects were associated with Greene or Busch.
19 While searching this database, I also found that Boldiszar was called in on a tip to the task force in
20 the 70's, but it was not Michael Boldiszar. It was Frank William Boldiszar, at the same address of
21 [REDACTED]. This is possibly the father or brother of Michael Boldiszar. This
22 tip was called in by, Berkley Police Officer, Mark Thomas.

23 I performed a check through the Lexis-Nexis database and located Frank William Boldiszar Jr.,
24 w/m, [REDACTED] residing at [REDACTED]. This subject also shows a
25 past address of [REDACTED]. The age of this subject would indicate that he is
26 more than likely a brother of Michael Boldiszar.

27 **3-28-08:** I called and left a message today with Kenneth Bowman's counselor, Mr. Phillips. I
28 indicated to him that we have Kenneth scheduled for a polygraph on Wednesday 4-2-08 at 1:00pm.
29 I asked that either he or Kenneth give me a call and stated that I would pick Kenneth up at
30 "Operation get Down" at 12:00 noon on Wednesday for the polygraph and have him back by
31 4:00pm. Mr. Phillips called me back a short time later and stated he would have Kenneth give me a
32 call on my cell-phone.

33 **3-28-08:** We still have not heard from Greg Greene's younger brother James who lives in Saginaw.
34 Robert Greene was going to have him call us. I left a message today for Robert, on his cell-phone
35 [REDACTED] to have James call me, indicating that we want to interview James next week.

36 **3-31-08:** I went to "Operation Get Down" today after not hearing back from Kenneth Bowman or Mr.
37 Phillips about the polygraph we have scheduled for Bowman at Livonia Police Department on
38 Wednesday April 2nd. The clerk at the front desk made a call for me and stated he would be right
39 down. After approximately 10-15 minutes, the clerk called me over and stated that Mr. Phillips
40 signed Kenneth Adams (Bowman) out to the hospital today to visit his brother. I left my card with my
41 cell-phone number with the clerk to have Kenneth call me.

42 **3-31-08:** I called James Greene's home in Saginaw today [REDACTED] and the son Douglas
43 answered the phone. He gave me his dad's number at work (Perani's Hockey World, [REDACTED])
44 [REDACTED]. I spoke with James Greene, Greg's younger brother who was expecting me to call, stating
45 that he had spoken to his brother Robert Greene about us interviewing Robert last week. James
46 stated that he was living with Greg and their dad at [REDACTED], but that he
47 didn't remember being around the house very much, stating that he was working in Ann Arbor.
48 James told me that his dad was real sick back then, with ulcers. James Greene mentioned the
49 name Dennis Pacetti or Pascereetti, but stated he didn't remember a lot of people in the

1 neighborhood back then, stating that he didn't know how much help he would be. I asked him if he
2 remembers a Chris Busch, to which he stated Busch sounds familiar, but he knows some Busch's
3 so he wasn't sure. James agreed to meet us for an interview, Friday April 4th at 11:30am in the
4 Arby's parking lot on M-46, just west of I-75 in Saginaw. I gave him my cell-phone number and
5 Garry's desk number in case he can't make it.

6 **3-31-08:** I went to [REDACTED] today and spoke with Jeff Plumley and requested a time that
7 we could interview him in length about Christopher Busch & Greg Greene. Plumley indicated that he
8 knew Greg Greene, Vince Gunnels, Kenneth Bowman, & Brent Busch, but stated that he did not
9 remember a Chris Busch. Plumley stated that these are names he hasn't heard for 25-30 years.
10 Plumley agreed to an interview on April 1st, 2008 at 12:00 noon at his house.

11 **4-1-08: *** (Tape-recorded interview of Jeff Plumley today in Linden, Michigan.) ***** Garry
12 Gray (MSP) & I went to [REDACTED] today and interviewed Jeff Plumley. Plumley
13 lived in Flint in the 1970's and was an associate of Greg Greene, Vince & Paul Gunnels, Kenneth
14 Bowman and Brent Busch. Plumley stated that he first met Greg Greene while hitchhiking with
15 Brent Busch in Flint in the mid 1970's. Plumley stated that Greene gave them alcohol and marijuana
16 to smoke and would "party" with them. Plumley admitted being molested by Greene back then,
17 stating he was with Greene approximately 5 different times. Plumley told us that Greene molested
18 him orally and anally, but that Greene never used any type of force or violence to commit these acts
19 against him. Plumley also stated that he was never alone with Greene, stating that it was usually
20 Greg, him & Kenny, referring to Kenneth Bowman. Plumley stated that he was fairly close with
21 Bowman, closer than any of the other boys in the neighborhood, including the Gunnels boys.
22 Plumley talked about an occasion when he, Greg and Kenny went to a motel and had sex.

23 Plumley began talking about Kenny Bowman not really having any friends in the neighborhood and
24 that kids would chase him and beat him up. Plumley told us that the Gunnels boys were especially
25 rough on Kenny, stating that Vince Gunnels hated Kenny. Plumley stated that he was friends with
26 Kenny partly because he felt sorry for him. Plumley told us that Greg Greene beat Kenny up real
27 bad one time, stating that he remembers that Kenny had blood in the whites of his eyes. Plumley
28 said that he didn't know why Greene did this to Kenny and that he didn't think Kenny ever told him
29 why, but he couldn't remember. Plumley told us that he did not know Chris Busch, didn't recognize
30 Busch from the photos we had, but stated that Kenny was with Greg Greene all the time. Plumley
31 went on to say that he knew Brent Busch and his younger brother Scott Busch, stating that he also
32 knew their dad John Busch (Chris's brother), but did not know Chris Busch (Brent & Scott's uncle).

33 When we told Plumley what it is that we are investigating, he stated that he never heard anything
34 about hurting or killing any kids and that he never heard Kenny Bowman mention anything like that.
35 We asked Plumley if Greene ever used him to lure kids to the car, to which he stated, no. We asked
36 Plumley if he ever heard about Bowman, Greene or any of the other boys in the neighborhood going
37 up north to a cottage with a friend of Greene's (Busch), to which Plumley stated, no. None of the
38 other information Plumley supplied investigators about Greg Greene was of immediate assistance to
39 investigators in this investigation. ***** (See transcripts from this interview for further details). *****

40 **4-2-08:** I drove by Boldiszar's house in Berkley this morning, at [REDACTED]
41 [REDACTED] There were no cars in the driveway, no cars in front of the house and no cars in
42 the garage, which was standing open. There were no curtains in any of the windows and some type
43 of a "warning" sign was in the front window of the house. It appeared as if it were vacant and
44 possibly condemned.

45 **4-2-08: *** (Polygraphed Kenneth Bowman today at Livonia Police Department) ***** Kenneth
46 Bowman was polygraphed today, by Livonia Polygraph Examiner Tim Larion. Bowman was
47 polygraphed on his possible knowledge of the Oakland County Child Killings and/or his involvement.
48 Garry Gray (MSP) & I were present and witnessed the polygraph of Bowman. Prior to the first

1 polygraph chart, Bowman denied any participation in the murders, denied being present when they
2 occurred, or withholding any information on who committed the crimes.

3 The subject was asked the following relevant questions which he answered as indicated:

- 4 1. Did you plan or participate with anyone in any of the Oakland County Child Killings? No.
 - 5 2. Were you present when any of the children were killed? No.
 - 6 3. Do you know for sure who killed any of those children in Michigan back in the 1970's? No.
 - 7 4. Are you deliberately withholding any information about the Oakland County Child Killings?
8 No.
-

9 *** Polygraph Examiner Larion rendered the following opinion: The subjects polygraph charts
10 contained some response inconsistencies and erratic tracing abnormalities on the relevant questions
11 set for the above. After careful analysis of the subjects polygraph charts, based on the response
12 inconsistencies and the erratic tracings mentioned above, it is the Examiner's opinion that no valid
13 diagnostic opinion can be reported on this examination. (Inconclusive)

14 **4-3-08:** Garry Gray & Dave Robertson (MSP) took the negatives from the photos taken by
15 Bloomfield Twp. PD at Busch's suicide scene, to the MSP Forensics Lab in Lansing today. They are
16 going to have the negative enhanced/enlarged and they are also going to try to identify the markings
17 on the single, spent, shotgun shell casing on Busch's desk.

18 They also went to the MSP long-term evidence storage facility today to locate & remove the
19 "wadding" & "pellets" from the Jill Robinson homicide for comparison.

20 **4-4-08: *** (Tape-recorded interview of James Greene, Greg Greene's brother in Saginaw) *****

21 Garry Gray (MSP) & I met and interviewed James Greene today in Saginaw. James had agreed
22 previously to meet with us and discuss his brother Greg's possible involvement in the Oakland
23 County Child Killing case. James told us that he remembers his brother coming back from California
24 to Flint in the mid 70's and that he (Greg) was really different when he got back. James stated that
25 he remembers telling his dad that something is wrong with Greg since he returned. James told us
26 that he had talked to his brother Robert about us interviewing him and stated that he didn't know
27 what else he could tell us that his brother Robert didn't already say. James stated that he lived at
28 the house at [REDACTED] with his dad and Greg when Greg got back from California.
29 James said that Greg got a job working with his uncle doing deliveries of appliances in Flint after he
30 returned to Michigan. James stated that he was working a job selling shoes in Ann Arbor after Greg
31 returned, stating that he wasn't around the house in Flint very often. James told us that he was
32 aware of Greg's problem with Pedophilia, stating that he didn't realize what was wrong with his
33 brother (Pedophilia) until after Greg was arrested for child molestation and went to prison. James
34 talked to us about the "hidden room" that Greg had in the attic of the house on Baldwin in Flint,
35 stating that he found out later that Greg had a boy stay in that room that he (Greg) was molesting.
36 James kept mentioning a boy named Steve Pascutti or Pascusso, asking if we heard of him, stating
37 that he was with Greg a lot in the 70's before Greg was arrested.

38 We asked James about vehicles that Greg was driving back then. James told us that he
39 remembers Greg driving a van and could never figure out why his brother would want to drive a van,
40 until Greg was arrested and charged with child molestation and then he understood why Greg had
41 the van. James stated that it was a tan or brown colored van.

42 James told us that Greg wrote a long letter while he was in prison about his problem of Pedophilia,
43 out-lining why he thinks it started. James told us that Greg stated in the letter that he thinks his
44 pedophilia started when he was about 12 or 13 years old and some kids made fun of his penis while

1 in the shower after gym class. James explained that Greg stated that his penis was never
2 circumcised and that's why the kids teased him. James said that it was as if Greg were saying he
3 was searching for the perfect penis. James said that there was nothing in the letters about hurting
4 or killing any kids, but he (James) remembers that a boy got hurt jumping from Greg's moving car in
5 California trying to get away from Greg. James went on to say that Greg then took the boy to the
6 hospital and that's how he got caught. We told James that what actually happened was that Greg
7 choked the boy to keep him quiet and almost choked him to death and that's when Greg panicked
8 and took the boy to the hospital and got caught. James stated that he never heard that before,
9 stating that his brother Greg was always lying about things and twisting things around in his favor.
10 James said that he believes his brother Robert had the box of belongings they received of Greg's
11 from prison after he died. James stated that he didn't think that Robert still has any of Greg's things.
12 James did not supply any other information that would assist immediately in this investigation. The
13 interview was terminated. *** (See transcripts from this interview for further details) ***

14 *** The story James relayed about his brother Greg getting into Pedophilia because he was teased
15 about his penis & in search of the perfect penis, matches what Bowman told the police in the 1977
16 MSP report when he stated that Greg approached him about kidnapping and killing a boy, stating
17 further that he (Greg) would then cut-off the boys penis and put it in a box for Bowman.

18 **4-4-08:** Garry & I stopped by Chad Nikle's place of employment today at Coldwater Rd. & Saginaw
19 Rd. in Flint to make sure Chad is all set for the polygraph on 4-7-08. Chad was not real happy to
20 see Detectives. We told him that the State Police from the Flint Post would pick him up at his house
21 on Monday at 11:30am to bring him to the Northville post for his polygraph. Chad stated reluctantly
22 that he would be ready at 11:30am Monday to be picked up.

23 **4-7-08:** We heard from Agent Tommy MacDonald, New York FBI today about the lead we sent him
24 on Christopher Busch. MacDonald stated that he made phone contact with Chris's Busch's brother,
25 Charles Nels Busch, who is currently in South Carolina on vacation. MacDonald stated that Charles
26 lives in Connecticut and keeps the apartment in Manhattan for weekend visits. MacDonald stated
27 that Charles Busch appeared cooperative and agreed to call MacDonald at the FBI in New York for
28 an interview when he (Charles) returns home in Late April or early May.

29 **4-7-08:** Garry called the Ryan Correctional facility and made arrangements for us to interview
30 Vince Gunnels in the morning on Wednesday 4-9-08. This is the prison we had Gunnels transferred
31 to from Ojibway Correctional in Ironwood, Michigan.

32 **4-7-08: *** (Polygraphed Chad Nikle today at the MSP 2nd District Headquarters) ***** The
33 State Police from the Flint Post brought Nikle down to the Northville Post today for his polygraph. Lt.
34 Robert Dykstra from MSP is the Polygraph Examiner that conducted the test. Prior to the test
35 Dykstra went through a pre-polygraph interview with Nikle, to assist him (Dykstra) in formulating
36 questions for the polygraph. During this interview Dykstra asked Nikle if it were true that when
37 he was cellmates with Greg Greene in prison in the mid 1990's, Greene told him he had gotten away
38 with killing four kids, to which Nikle answered, "No." Dykstra told Nikle he was confused, indicating
39 that Detectives Williams & Gray, that interviewed you a few weeks-ago, told him (Dykstra) that you
40 said Greene told you he killed four kids. Nikle stated that he never said that and never told the
41 police that.

42 Lt. Dykstra then formulated the questions and administered the polygraph test on Nikle. During the
43 test, Dykstra asked Nikle the following question: While in prison, did Greg Greene tell you he got
44 away with killing four kids? Nikle answered, "No."

45 After the test was complete Lt. Dykstra reviewed the relevant questions along with Nikle's
46 responses to these questions and observed, based on his training and expertise in the polygraph,
47 that Nikle was not being truthful, when he answered "No," about whether Greene told him he killed 4
48 kids. Lt. Dykstra then confronted Nikle with the polygraph results indicating to Nikle that he (Nikle)
49 was not being truthful about what Greene had told him. After a period of time, Nikle admitted that he

1 had lied on the polygraph about what Greg Greene had told him and admitted that Greene did in-fact
2 tell him, while they were cellmates in the mid 90's that he had gotten away with killing four kids. Lt.
3 Dykstra asked Nikle, when did Greene tell you he killed those kids? To which Nikle stated, " in the
4 1970's." Nikle told Lt. Dykstra that he lied on the polygraph because he was scared about getting
5 involved and getting hurt. When asked, Nikle stated that when he told Detectives Williams & Gray
6 about what Greene had told him in prison about killing those kids during the interview a few weeks
7 earlier, he had told them the truth.

8 **4-9-08: *** Greg Greene's fingerprint ruled-out after being compared to the partial print from**
9 **Kristine's parka. ***** Garry Gray (MSP) received an e-mail today from Michelle Glasgow, the
10 fingerprint expert at the Michigan State Police Forensics Lab. She stated that the latent print from
11 Kristine Mihelich's parka needs a lot of work and she is going to look into digital enhancement
12 technology to see if there is any, new developments that she might be able to use. Michelle did say
13 that she can rule out Greg Greene based on the fingerprint pattern, stating further that the other two
14 we submitted (Lamborgine & Busch) she can't say either way without more clarity and is working on
15 that.

16 **4-9-08:** Garry Gray has been in contact with Reinhard Pope, an expert from the State Police
17 Forensics Lab, who is looking into enhancing the photos from the Busch suicide scene for us.
18 Reinhard is going to be looking at the photos and negatives today for us and we will be sending him
19 a copy of the old lab report on the "wadding" & "pellets" from the shotgun shell and gun that killed Jill
20 Robinson.

21 **4-9-08: *** (We went to Ryan Correctional today and interviewed James "Vince" Gunnels) *****
22 Garry Gray (MSP) & I went to Ryan Correctional today and interviewed Vince Gunnels about why
23 we believe he lied to us about knowing Greg Greene. Vince was upset when we got there about us
24 having him transferred to Ryan Correctional and holding up his parole. We explained why this was
25 done, the importance of the investigation and what it is we wanted from Vince prior to him being
26 paroled. We explained that because he associated with Busch & Greene at the time of the Oakland
27 County Child Killings, we want to make sure he didn't have information about the killings that he was
28 holding back or repressing in his memory. We explained to Vince that Busch & Greene are our main
29 two suspects, that he (Vince) was just a kid at the time and that we, at this point have no intention of
30 charging him with anything, we simply want to clear him of possibly having knowledge of the case
31 from Busch & Greene. Vince indicated that he wanted to talk to his sister in Montana first and also a
32 lawyer. We asked Vince if he would be willing to consent to a saliva swab for DNA, to which he
33 stated that he didn't want to do that either until he made some phone calls. We told Vince to call
34 whoever he wanted to and if there is an attorney that had questions, he (the attorney) could call
35 either myself or Garry and we would explain that we are simply attempting to clear him of having
36 possible involvement or knowledge in the child killings. We also explained to Vince the 4 questions
37 that would be on the polygraph test and asked him how he would do on those questions, to which he
38 stated he would pass, no problem. We terminated the interview at this point and told Vince to let us
39 about taking the polygraph as soon as he can.

40 **4-10-08:** I had received several calls from Vince Gunnels sister, Karen Zaspke, from Montana in the
41 past few days, in regards to Vince's parole getting delayed because of our investigation. I called her
42 back today and explained the situation to her and that we are simply looking to clear Vince on any
43 possibility that he might have information because of his association to Busch & Greene during the
44 time of our homicides. She said that she understood what we are trying to accomplish, she has
45 concerns about her brother's rights and wanted to talk to a lawyer for him before he decides on
46 taking the polygraph. Vince is supposed to parole to his sisters home in Montana when we are
47 through with him. She took my cell-phone number and stated she was going to talk to Vince and an
48 attorney about all of this and call me back.

49 **4-14-08:** Garry Gray (MSP) sent me a copy of an e-mail today that he sent to Mr. Fountain at
50 Michigan Department of Corrections. Fountain is the corrections official in Lansing that had Gunnels

1 transferred from Camp Ojibway in the upper-peninsula to the Ryan Correctional Facility in Detroit a
2 few weeks ago so we could re-interview him. Garry informed Mr. Fountain that Vince Gunnels was
3 not completely honest with investigators when we interviewed him at Camp Ojibway, and that now
4 he wants to talk to an attorney before he cooperates with us. Sgt. Gray reminded Mr. Fountain of
5 the seriousness of this case and the importance of Gunnels cooperation. Fountain was also
6 informed that if Gunnels refuses to cooperate in our investigation of the child killings, he then, due to
7 his (Gunnels) close association to Busch & Greene, puts himself in the suspect category.

8 **4-14-08: *** (Took photos of Greg Greene's old house in Flint today) ***** I drove to [REDACTED]
9 [REDACTED] in Flint today. This was the house Greg Greene lived in, in the mid to late 1970's, with
10 his sickly father and younger brother James. This is also the house that Greene lived in when he
11 was released from the mental institution in California and returned to Michigan. This house is the
12 house that Greene's brother's Robert & James both told us had a secret, hidden room in the crawl
13 space of the attic that their brother Greg built and used to keep and molest boys in. I took a couple
14 of digital photos of the house. It is a small bungalow or 1 ½ story style home with yellow siding.
15 There are windows at each end of the upstairs, indicating that it may be used as a living area. There
16 did not appear to be a garage or shed of any kind in the rear yard, but there was a large custom van
17 blocking the view to the back.

18 **4-14-08:** I drove by the house today, listed for Michael Boldiszar at [REDACTED]
19 [REDACTED]. I wanted to try to determine if Boldiszar was still living there or if it was empty. There
20 was a sign in the front window that was a warning against trespassing or vandalism. The name on
21 the sign was JCI REO Servicing Corp. with a phone number of [REDACTED] 1. I pulled up in the
22 driveway today and determined that the house is in-fact sitting vacant.

23 **4-17-08:** I drove by [REDACTED] today to see what cars were at the house. This
24 is the home of Michael Boldiszar's son. There was a silver Dodge Ram Pick-up in the driveway,
25 bearing Mi.Lic. [REDACTED] registered to a Judith Manning, at [REDACTED]
26 There was also a cream colored Lincoln in front of the house, bearing Mi. Lic. [REDACTED] registered
27 to John Highlen at [REDACTED]. It does not appear as if the Boldiszar's are at
28 this address anymore. The next address to check is at [REDACTED] Michael
29 Boldiszar's brother Frank lives on Orville in Warren. Michael may also be staying there with his
30 brother.

31 **4-17-08:** I called "William's Refrigeration & Heating" today, located in Warren, Michigan. This is the
32 company listed on Michael Boldiszar's probation record as his employer. I spoke with a manager
33 there who stated that Boldiszar no longer works there.

34 **4-22-08:** I drove by Michael Boldiszar's brothers (Frank) house today at [REDACTED]
35 There were no cars at the house and no one was home. I was going to make contact with Frank to
36 have Michael give me a call.

37 **4-22-08:** Garry Gray (MSP) called me at home tonight and stated that Agent Tommy MacDonald
38 (FBI) in New York called him earlier this evening and stated that he interviewed and swabbed Chris
39 Busch's brother, Charles tonight for DNA. Agent MacDonald told Garry that he and a female agent
40 from his office conducted a 3-hour interview of Charles Busch at the Busch's home in Connecticut.
41 According to the agent, Charles was hesitant at first to consent to a DNA saliva swab and talked
42 about speaking with an attorney first. Busch's wife then arrived home during the interview, asked
43 some questions about the DNA and then advised her husband, Charles to go ahead and give the
44 agents a DNA saliva sample. Charles Busch then gave his consent at which time Agent MacDonald
45 collected the saliva DNA from Busch with a Buccal swab. The swab was then packaged, sealed,
46 initialed and transported to the FBI Office where it was secured overnight. The following morning,
47 the sealed, secured sample was shipped directly to the FBI Lab (DNA Section) in Quantico, Virginia.
48 This DNA sample will be compared to DNA evidence from our victims in this case. *** (See Special
49 Agent MacDonald's report of this interview for details) ***

1 **4-24-08:** I drove by [REDACTED] (Busch's home) today and took a few digital photo's
2 of the house to have somewhat of a better idea on the size of the home, the layout and to have it
3 documented for the file in this lead.

4 **4-25-08:** I performed a check today through the Lexis-Nexis database today on Geoffrey Saham,
5 the owner of [REDACTED]. This is the home that the Busch
6 Family resided in at the time of the Oakland County Child Killings. This check showed the owners to
7 be Geoffrey & Laurie Saham, who bought this home in May of 2005. The results also showed that
8 Geoffrey Saham has a Medical Doctors license in The State of Michigan and possibly practices
9 medicine out of an office located at [REDACTED].

10 I performed a check through the Secretary of State database and located Geoffrey & Laurie
11 Saham, with valid Michigan drivers licenses at [REDACTED].
12 Geoffrey Mark Saham showed a date of birth of [REDACTED]. Laurie Ellen Saham showed a date of
13 birth of [REDACTED]. Neither subject showed any warrants or a past criminal record. I was able to
14 obtain photos of both subjects through the Secretary of State driver's license photo file (MIDRS).

15 **4-28-08:** It has been approximately 3 weeks and we still have not heard back from Vince Gunnels
16 or his sister on whether or not he is going to take the polygraph about his knowledge/involvement
17 with Busch & Greene in the OCCK case.

18 **4-28-08: *** (FBI report from the interview of Chris Busch's older brother, Charles Nels
19 Busch in New York City) *****

20 We received the faxed report today from Special Agent MacDonald (FBI), on the interview of
21 Charles Busch that he and his partner conducted at Busch's part-time residence at [REDACTED].
22 [REDACTED] Charles Busch was cooperative and agreed to an interview with
23 the agents. Charles Busch was somewhat hesitant at first to supplying agents with a sample of his
24 DNA, but later agreed, but with conditions. These conditions are listed on the second page (shows
25 "Pg.4" at the top) of the following FBI report that I scanned into this on-going report.

26 *** It is interesting that Charles Busch has conditions to supplying DNA as far as us notifying him
27 prior to making any announcement (press conference) on the results of the DNA. He also requested
28 that prior to the Task Force making any announcement about Christopher Busch's DNA in the
29 OCCK case, that Busch family members in Michigan be allowed to enter a witness protection type
30 program. According to MacDonald's report, Charles Busch was adamant about these conditions
31 being agreed to prior to supplying his DNA.
