

1 on Thursday 2-15-07 at Birmingham PD, with the King family, to discuss Tazelaar and show them a  
2 photo of him back in 1977.

3 2-13-07: \*\*\* (Phone interview with [REDACTED] \*\*\* I interviewed [REDACTED] over the phone  
4 today, about Carl & Ralph Schonebeck and Georgia "Gina" Busch. [REDACTED] said that he thinks his wife  
5 [REDACTED] has already told us most of the story, but said that if there were anything else that we would  
6 like to know he would be glad to help. He said he has disassociated himself from the entire family and  
7 had the unfortunate luck of being adopted by "Gina" as a child. [REDACTED] said that he was adopted & raised  
8 by Herbert and Gina Cook, who were married until approximately 1975-76. [REDACTED] said that when Gina  
9 moved out, she eventually moved into [REDACTED] Crissman in Utica, Michigan. [REDACTED] said that when he was 6-  
10 7 years old, he would go and stay with his mother Gina, who lost custody to [REDACTED] father. [REDACTED] told me  
11 that he always thought it was strange that when he would spend the night with Gina on Crissman, he  
12 always had to sleep on the couch and was never allowed in her bedroom area. [REDACTED] told me that later on  
13 when the Nye's lived in that house, is when he went into that room and realized that there was a small  
14 bedroom off of the bedroom where Gina slept and that this room had no windows and locked from the  
15 outside. [REDACTED] said that the garage on Crissman was always locked, with the windows blacked out and  
16 when he would ask Gina about that, she would tell him that Carl (her friend) was keeping his race car in  
17 there. [REDACTED] said that he remembers trying to look in the garage to see this race car, but couldn't see in.  
18 He said he also tried breaking into the garage to see this car. [REDACTED] said that when he told his dad about  
19 Gina & Carl doing strange things, he would say that Gina is hanging around weird people right now.  
20 [REDACTED] told me that later, when Keith & Marianne Nye were living in the Crissman house, Keith would work  
21 on cars in the garage and that the inside of the garage was all black, including the windows. I told [REDACTED]  
22 that I talked to Marianne Nye on the phone and had her ask Gina a few questions for me. I told him  
23 that Gina said there was no garage at the house on Crissman and that she didn't remember Carl  
24 Having a Gremlin and didn't know why she moved out. [REDACTED] thought her responses to those questions  
25 were very strange and he didn't know what to make of it. [REDACTED] also said that Gina was always sticking up  
26 for Carl, even when Gina would baby-sit their daughter Katie in the early 90's after Carl got out of  
27 prison, she would have Carl come around the house. [REDACTED] said that he would get upset about Carl being  
28 there because they all knew he was a pedophile. [REDACTED] said that Gina would always say, "he did his  
29 time." [REDACTED] said he didn't care if he did he didn't want a pedophile around his kid. [REDACTED] went on to say that  
30 it wasn't until Detective Murray and other professional people figured out that Gina was a pedophile  
31 also that he and [REDACTED] realized why Gina was always sticking up for him. I was talking to [REDACTED] about Carl  
32 being over at Gina's house on Crissman in 1976-77, stating that he was probably too young to  
33 remember. [REDACTED] said that he does remember that because Gina was working at a "Clock" restaurant at  
34 that time in Utica and also driving a small bus for the senior citizens in the area and would pick [REDACTED] up at  
35 his dad's house in the bus and take him over to her house on Crissman. [REDACTED] said that Carl was living at  
36 the house on Crissman with Joann Feeblecorn before she moved out and Gina moved in.

37 I began talking to [REDACTED] about his uncle Joe [REDACTED] saying that he used to hang around with Carl & Ralph  
38 Schonebeck back in the mid 70's. I asked [REDACTED] if his Uncle Joe had told him that personally, to which he  
39 stated that he had told him that several times. I asked him if he thought it was strange that when [REDACTED]  
40 told Uncle Joe that we were going to talk to him about Carl & Ralph, he said he didn't know anything.  
41 [REDACTED] said that Uncle Joe is a crazy old guy and probably just doesn't want to get involved.

42 [REDACTED] said that in the early 1990's, Carl was working for Don Foltz in Romeo and was bringing these black  
43 homosexuals around. [REDACTED] said that Carl was not only a pedophile, but also a homosexual. [REDACTED] said that  
44 Carl was living on Steel St. in Detroit at this time. He said that Carl was dominant over these black  
45 homosexuals and that several people observed Carl beat one them named "Billy" that they called "Billy  
46 the Bitch because he was Carl's Bitch." [REDACTED] said that this beating took place in the yard at Don Foltz's  
47 business and that Carl beat "Billy The Bitch" with a shovel. I told [REDACTED] if he thinks of anything else about  
48 Carl, Gina or Ralph to call me or "e-mail" me with the information. He said he would.

49 2-13-07: \*\*\* (Interviewed Willem "Bill" Tazelaar today. Josiah's brother) \*\*\* Today I went to  
50 [REDACTED] 12 Mile Rd. in Southfield, Mi. and interviewed Josiah Tazelaar's brother, Bill. Bill is an architect  
51 and owner of Tazelaar Associates Architects, which is situated in Suite 103 at the above mentioned  
52 address. Bill was the only person in the small office where I interviewed him. I identified myself and

1 asked him if he had spoken with his brother recently, to which he stated that they speak all the time. Bill  
2 further stated that he and Josiah are good friends and have become closer over the years. I asked Bill  
3 if Josiah told him that we came to see him recently, to which he stated that Josiah had not. I asked Bill  
4 if he knew why we had contacted and talked to his brother, Bill stated that it must be about the kids. I  
5 asked him what kids he was referring to, which he said, kids that he has molested, referring to his  
6 brothers pedophilia. I explained that I was a member of a Task Force investigating the Oakland County  
7 Child Killings from the 1970's and that his brother's name came up in this investigation and that I would  
8 like to talk to him about his brother. Bill said that he would answer any questions he could. Bill said  
9 that his family came to the United States in the 1940's from the Netherlands. I asked Bill when he and  
10 his wife Ruth first arrived in the Detroit area from the Muskegon/Grand Rapids area, to which he said  
11 that he and his wife lived in Troy, Michigan from 1969-1971 when he first started working as an  
12 architect in this area. Bill said that in 1972 they bought the house on Windemere in Birmingham that  
13 they currently live in. I asked Bill what year Josiah came to the Detroit area from Muskegon and did he  
14 live with him & Ruth. Bills told me that Josiah first came to this area in approximately 1973-74 and lived  
15 with them for 1 1/2- 2 years on Windemere. Bill said that in approximately 1975-76, Josiah got an  
16 apartment on Stevens St. in Highland Park and moved down there. I asked Bill if after Josiah moved  
17 he would come and visit. Bill said that Josiah would come to his house about once every week or two,  
18 to visit, eat and occasionally spend the night. I asked Bill if Josiah would go for walks when he lived on  
19 Windemere or when he would come to visit. Bill said that Josiah would walk, stating that he and his  
20 wife walk too. I asked about walking to the park, to which Bill said I don't know where he walked to or  
21 know if he specifically went to the park, but we would walk by it.

22 I asked Bill if he remembers the Oakland County Child Killings in 1976-77 in this area, stating that it  
23 was all over the news. Bill said he does not remember hearing about that, stating further that he  
24 doesn't watch the news all the time. I asked him if he remembers a little boy named Timothy King that  
25 was abducted from the drug store down the street and lived with his family a few blocks from here in  
26 this neighborhood. Bill said that he doesn't remember anything like that. I asked Bill if Josiah ever  
27 brought any of his friends out to his house, to which he stated "no."

28 I asked Bill if he knew any of Josiah's friends from Port Huron, to which he stated that he (Bill) didn't  
29 know anyone out in that area and he didn't know if Josiah did or not. I asked Bill if he had ever done  
30 any architectural work for anyone in the Port Huron area, to which he stated "no." I asked Bill if he ever  
31 heard the name Francis Sheldon from the Port Huron area or if Josiah ever mentioned his name? Bill  
32 said that he doesn't recognize that name. Bill said that the only thing that he remembers about Port  
33 Huron, was that he remembers hearing that when Josiah was testifying in Port Huron after his  
34 (Josiah's) arrest, that it was about a ring of pedophile men who were employing boys in Port Huron.  
35 We talked about whether or not Bill remembered if Josiah was out on the street after his arrest in  
36 January 1977 and the trial later in the year. At first Bill said that he thought that Josiah had bonded out,  
37 but then said he thought he was still in jail, because he switched from jail to jail.

38 During the course of the interview, Bill asked me 2-3 times, if someone had information about  
39 something, and was afraid to say anything because of retaliation, how do you guys deal with that? I  
40 told Bill that we can keep people confidential, because if word got out that we didn't, we wouldn't get  
41 much information from people. I told Bill that the fear of retaliation is not as great as the fear of going to  
42 prison, further stating that it's always better to be a witness than a defendant. Bill agreed. I told Bill  
43 that I was getting the idea that maybe he had information that he was worried about or maybe Josiah  
44 had told him in the past that he knows something about these crimes but was afraid to come forward.  
45 Bill said that was not the case, but that he would want Josiah to cooperate with us on this if he knew  
46 anything. I told Bill that is a good idea, because if we find out later that Josiah had information or was  
47 involved and didn't relay that information, it could all come back on him and he could end up a co-  
48 conspirator and a defendant and that it would be too late at that point. Bill said that he was following  
49 me. I asked Bill if Josiah would confide such a thing to him, to which he stated that Josiah was closer  
50 to their sister that lives in Seattle and that Josiah may have told her something like that. Bill said that  
51 he was going to call her and ask her if Josiah ever confided anything to her about being in trouble or  
52 knowing something that could get him in big trouble from his past.

1 We began talking about cars that Josiah drove in the past, to which Bill stated that he can't remember  
2 any of Josiah's cars but that maybe his wife would. I asked him about the car Josiah was driving when  
3 he lived with him, to which he stated he doesn't remember. I asked Bill about how Josiah wore his hair  
4 back in the mid seventies, to which he pointed to his collar saying that it was this long and that he  
5 combed it over. I asked if Josiah had brown hair, to which he stated he did.

6 We started talking about friends Josiah had back in the 70's and if Bill ever went down to Highland Park  
7 to see Josiah. Bill said that he would go to Josiah's apartment on Steven's St. and that Josiah lived  
8 there with a pedophile name John Robertson that has since died. Bill also mentioned a friend of  
9 Josiah's named Ed Stahl that was a pedophile that has also died. Bill also mentioned a Louise  
10 Hodgson that Josiah was friendly with in Highland Park. Bill said that he couldn't imagine any of these  
11 guys being involved in something like that. Bill told me that there is a guy that's still alive that Josiah  
12 was friendly with named Ken Collinson (maybe Ken Colister) that would be approximately 60 years old  
13 today, lives in the Dearborn area and lived in an apartment in Grosse Pointe back in the 70's.

John Robertson

14 I began running names by Bill that are involved in our current investigation. I asked bill about Titus  
15 Jones "Duffy," Richard Lawson, Ted Orr Lamborgine, Carl and Ralph Schonebeck, Bob Moore, none of  
16 which Bill remembered hearing before. I described "Duffy" to him and showed a photograph of Carl  
17 Schonebeck to Bill. He stated he did not recognize any of these subjects.

18 Bill told me again that he wants to do anything to cooperate with us, and hopes that Josiah will. I told  
19 Bill that based on our over two-year investigation; we believe that Josiah has information or was  
20 involved. I told Bill that we don't believe him to be the killer and would like to clear him of any of this if  
21 he was not involved, but shame on him if he knows and does not cooperate at this point. I told Bill  
22 again that there are people that we believe are involved that are alive, several of which are in prison  
23 and the others are dead. I said that if this investigation comes full circle and back onto Josiah he's  
24 going to be in trouble. I told Bill that Josiah might be in a great situation to cooperate and that the ones  
25 in prison are going to want to help themselves out. Bill said that he understood. The interview was  
26 terminated at this point. \*\*\* (Notes from this interview are in the Willem Tazelaar file) \*\*\*

27 **2-14-07: \*\*\* (Update on theory & possible connection between Ted, Duffy, Tazelaar, Carl &  
28 Ralph Schonebeck and Francis Sheldon) \*\*\*** John Ouellet (FBI) & I were discussing this case today  
29 and talking about the connections between these suspects and things that several of these people were  
30 not truthful about. Ted failed the Polygraph about involvement in the OCCK's. He never denies  
31 involvement, but makes statements about the fact that he's worried about being labled as a murderer or  
32 accessory to murder. Ted has also stated that he hasn't done what we think he has. **(Ted possibly  
33 made a statement in September 07 to a cellmate that he had sex with the kids from the OCCK  
34 case, but was not the one that killed them. See 9-28-07 for details of this).** When I first interviewed  
35 Josiah Tazelaar he admitted knowing "Duffy" Ted's roommate in Detroit, but denied knowing Ted.  
36 Later Josiah made statements about going to "Duffy's" place in Detroit where "Duffy" would supply him  
37 with kids. Josiah described "Duffy's" place in Detroit as being in the area of 18<sup>th</sup> & Myrtle. I knew that  
38 was the house that "Duffy" shared with Ted in the late 70's. Only when Josiah was confronted with the  
39 fact that he had to know Ted then because they were roommates, did Josiah admit that he knew Ted,  
40 but stated not very well. Josiah also has been in recent contact with "Skinny", knowing we're talking to  
41 "Skinny," had "Skinny" lying for him to us about his relationship with Ted and Bob Moore. Josiah has  
42 really been trying to distance himself from Ted Lamborgine and Bob Moore. It's interesting too that  
43 Josiah when asked about knowing Francis Sheldon stated he only learned of Sheldon after receiving  
44 the "discovery" packet for his CSC case involving Sheldon in Port Huron in 1977. In Gorzens report  
45 (MSP) in 77, Josiah's young boy lover (██████████) told MSP that he met Josiah Tazelaar through  
46 "Gerry" Gerald Richards in Port Huron. Gerald Richards was indicted along with Francis Sheldon (who  
47 fled the U.S. to Amsterdam in 76-77) and was very close with Francis Sheldon. (██████████

48 **! HE NEEDS TO BE INTERVIEWED about Tazelaars,  
49 red, Dutty, and Skinny...etc.)** Another interesting connection here is Ted Miller. Ted Miller called a  
50 priest in March of 1977 stating that he killed Tim King. Miller was located living in the area of 8 mile &  
51 Inkster in Redford at that time. On his interview record, it showed his associate as John Robertson at  
52 88 Stevens in Highland Park. 88 Stevens was Josiah Tazelaar's address in the 70's where he lived with

1 John Robertson. This is also the same house that [REDACTED] told police that he met a boy named  
2 "Skinny" that was brought to 88 Stevens by "Duffy", Ted's roommate for sex. So here we have a guy  
3 trying to confess to the killing of Tim King that is connected to Josiah Tazelaar at the same house  
4 where Ted, who failed the polygraph in the OCCK case's roommate "Duffy", was bringing and sharing  
5 boys. \*\*\* Ted Miller was only cleared because the police in March 1977 interviewed a friend of Ted  
6 Miller's named George Richards, who told police not to believe Ted Miller because he gets drunk and  
7 makes these types of calls all the time. \*\*\***(The police then cleared Miller and never polygraphed**  
8 **him) \*\*\*** This may have been a big mistake, because George Richards was a close friend of Josiah  
9 Tazelaar's and possibly Francis Sheldon, both of which show connections with Ted Lamborgine that  
10 failed the polygraph and possibly made admissions about involvement. This cover-up of Ted Miller by  
11 Richards may have possibly been done to disassociate the co-conspirators in the OCCK case. Also at  
12 this time, Bob Moore (close friend of Ted Lamborgine) had an apartment above the movie theatre on  
13 Woodward Ave. @ 6 mile, a block from 88 Stevens. Remember, according to Lawson, Ted  
14 Lamborgine showed him a Polaroid of Timothy King at Bob Moore's house in the Cass corridor, when  
15 Moore became upset, knowing that Lawson was a snitch. \*\*\* **(See tip on Ted Miller located 2-16-**  
16 **07)...I located Ted Miller, see 2-19-07...I went to his home in Detroit 3-9-07..He was confirmed**  
17 **deceased)...I believe based on this investigation that possibly Ted Lamborgine and Ted Miller are the**  
18 **subjects who dumped Timothy King's body in Livonia. A witness that called Livonia Police dispatch in**  
19 **the evening hours prior to King's body being found, described two subjects on Gill Rd. in a dark colored**  
20 **Gremlin. One supposedly matched the composite and the other had a dark colored small to medium,**  
21 **"afro" type hair. Ted Lamborgine wore fancy wigs and Miller in his 1977 photo has frizzy almost, "afro"**  
22 **looking hair. Ted Miller was familiar with this area and Ted also grew up in Redford.**

23 Another interesting possibility is that Josiah Tazelaar is the "#1" subject that Lawson described to Barry  
24 King in the 1988 FBI report that we have been trying to identify. We had already known that # 2 was  
25 Bob Moore and # 3 was Ted from their descriptions in that report. # 1 had told Lawson in the late 70's  
26 or early 80's, that he had seen the King boy in a child porn movie. According to Lawson, #1 was living  
27 in the Highland Park area at that time and was named by "Kim" (child porn magazine owner in  
28 Amsterdam) to Lawson in 79 when Lawson was in Amsterdam, as having been involved in the killing of  
29 Timothy King. We have already confirmed that Lawson did in fact travel to Amsterdam in 1979 and  
30 according to Louise Hodgson when interviewed in 1977, Josiah makes trips abroad (indicating out of  
31 the country). Josiah is Dutch and Amsterdam is the "Child Porn Capital." This is also where Francis  
32 Sheldon fled to in 1976 while under indictment. Francis Sheldon was a millionaire and was involved in  
33 financing child porn just like Lawson had told me. Francis Sheldon's activities in Amsterdam and this  
34 "Kim" subject were both confirmed by the FBI stationed in Brussels. We had sent a lead to Brussels to  
35 check on this for us and received the positive response 2-7-07. \*\*\* **(See details from FBI report from**  
36 **Brussels on 2-7-07 for this information about Sheldon and "Kim.") \*\*\***

37 **2-14-07: \*\*\* (Identified "David" Shultz today. Real name is Kent Gilbert Shultz, w/m, [REDACTED] -**  
38 **1944.) \*\*\* I was reading over the Francis Sheldon file tonight and observed a Kent Gilbert Shultz, born**  
39 **[REDACTED] -1944, who resides at [REDACTED] Church St. Highland Park, Michigan. We have been trying to identify**  
40 **the David Shultz that Lawson and Ike McKinnon talked about arresting in 1977 for child molestation in**  
41 **Highland Park. I knew David Shultz had lived in the house on Church Street, near Woodward and**  
42 **Church, behind the Methodist Church. I drove by there and observed that all the houses behind the**  
43 **church are gone. I knew the addresses would possibly be 19, 21, 23...etc. This Kent Gilbert Shultz at**  
44 **[REDACTED] Church Street matches what Lawson described for David Shultz.**

45 **2-15-07: This morning I ran a criminal history check on Kent David Shultz and observed an arrest by**  
46 **the Wayne County Task Force in October of 1977 for child molestation. This matches what Richard**  
47 **Lawson and retired Detroit Police Dept. Chief Isiah McKinnon told me about "David" Shultz. I ran a**  
48 **check on Kent Gilbert Shultz through the OTIS system and observed him to be currently in Jackson**  
49 **Prison for Child Molestation. He was sentenced in 1985 to 20-40 years for 2 counts of CSC 1 (child**  
50 **u/13).**

51 **2-15-07: Today Garry Gray (MSP) and I met with the King family at their home in Birmingham. The**  
52 **purpose of this meeting was to update the family on the direction this lead is taking, and the latest**

1 information involving Josiah Tazelaar, who used to reside in their neighborhood in the mid 1970's. We  
2 also showed pictures to the family of Tazelaar, Moore, and Lawson. Lamborgine and others associated  
3 with this lead. Neither the names nor faces were familiar to the King's.

4 2-15-07: After the meeting, I was reading some of the Shultz file from 1977 and observed that Kent  
5 Gilbert Shultz did in fact live behind the Methodist Church at Woodward Ave. & Church St. and was the  
6 caretaker of the church. This file also showed that Kent Shultz worked at a hospital. All this  
7 information matches what Lawson told us about "David" Shultz. An extensive investigation into Schultz  
8 was conducted by the Task Force in 1977. Eventually Shultz was interviewed, polygraphed (passed)  
9 and was cleared of involvement in the OCCK case.

10 2-15-07: \*\*\* (Identified "Ralph the Catch" tonight as Ralph [REDACTED] \*\*\* I was reading the  
11 Shultz file at home tonight and observed that the Task Force in 1977, interviewed a fourteen year old  
12 boy named Ralph [REDACTED], white male, born [REDACTED] 1963. [REDACTED] resided at the time at [REDACTED]  
13 Wanda Detroit, Mi. During the interview [REDACTED] said that he has been a prostitute in the area since  
14 he was 9 years old. He also said that he has been Kent Shultz's Boy Lover for two years. This is  
15 probably the boy named "Ralph" that introduced him to Shultz.

16 2-16-07: When I got to work this morning I performed a check in Mapquest for the address of [REDACTED]  
17 Wanda in Detroit. This showed this address to be located in the area of John R, north of 6 Mile Rd in  
18 Detroit. This is the area that Lawson took me to in 2005, when I drove him around in an attempt to  
19 locate the house that the boy name "Ralph" lived at. Lawson told me that this boy was the one they  
20 called "The Catch" and that he lived at the house in the area of 6 Mile Rd. & Woodward with his older  
21 brother. All this information on Ralph [REDACTED] matches everything that Lawson said about "Ralph"  
22 the prostitute that we should locate, because he may be able to assist in identifying the OCCK.

23 2-16-07: \*\*\* (Located Ralph [REDACTED] this morning.) \*\*\* I performed a criminal history check on  
24 Ralph Tankersley and observed several arrests over the years, most recently an OUIL 3<sup>rd</sup> offense. I  
25 performed an OTIS check on Tankersley and observed him to be alive and currently on probation out of  
26 the Oakland/Pontiac Probation Office. An "Autotrack" check on [REDACTED] revealed that he did in fact  
27 reside in the past at [REDACTED] Wanda in Detroit. This check also showed a last reported address in  
28 Waterford/ Pontiac area. We will need to check with probation on his current reporting address. This is  
29 going to be the "Ralph" that Lawson said we should talk to about the OCCK.

30 2-16-07: \*\*\* (Info from "Tip" on Ted Miller) \*\*\* Today the Task Force met at the Metro North Post  
31 (21) and went through all of the tips from 1977 that pertain the 6 Mile & Woodward area Pedohpiles and  
32 also the Port Huron pedophile ring. We also checked tips connected to Josiah Tazelaar, "Duffy,"  
33 Francis Sheldon, George Richards, Kent "David" Shultz...etc. While looking through these tips, we  
34 noticed that in April of 1977, the Task Force received a tip (tips # 6819 & 10122) from the priest that  
35 conducted Timothy King's funeral. The priest (Father Fedysyak) received a call from an unknown male  
36 a day or two after the funeral who stated that he was involved in the Timothy King murder. He said he  
37 couldn't live with this and wanted to talk to a priest rather than the police. The Task Force had the  
38 priest try to arrange a meeting at a "Denny's" with the caller, but he never showed up. This caller was  
39 eventually identified as Theodore "Ted" Joseph Miller w/m [REDACTED] 1947. Miller was residing in the Grand  
40 River and Inkster area of Redford Twp. at the time of the call. Task Force detectives went and  
41 interviewed Miller, who stated that he was drunk when he made those calls and did not have anything  
42 to do with the killing. An associate of Miller's named George Richards was also interviewed about  
43 Miller, who told the detectives that Miller drinks all the time don't pay any attention to him. We noticed  
44 in the background portion of the interview form that detectives used in 1977, that Miller's associates  
45 lived at 88 Stevens in Highland Park, Mi. One of the associates listed was John Robertson at 88  
46 Stevens. 88 Stevens is where Josiah Tazelaar was living in 1976-77. Tazelaar's roommate at that  
47 time was John Robertson. 88 Stevens is also the house that "Duffy" would bring young boys to from  
48 the Cass Corridor area. When we interviewed Josiah Tazelaar on 11-28-2006, he mentioned the name  
49 Ted Miller while we were asking about Ted Lamborgine. George Richards, the person who verified that  
50 Miller was usually drunk, is an associate of Josiah Tazelaar and still associates with Ted Miller today.

1 **\*\* (No connection was made in 1977, Miller was not polygraphed, instead he was cleared and**  
2 **the tip was closed.) \*\***

3 **2-16-07: \*\*\* (Info from Gorzen that puts Ronald "Skinny" & "Duffy" at Josiah Tazelaars at**  
4 **88 Stevens in Highland Park in 1976.) \*\*\*** During our meeting at the post, we found one of Det.  
5 Gorzen's (MSP) reports to be a report on MSP's investigation into Josiah Tazelaar. Some of the  
6 information in this report was from an interview of Josiah's "Boy Lover" from Port Huron, named Mark  
7 [redacted], white male, born [redacted]-1960. [redacted] told Gorzen that he was at Josiah Tazelaar's house one  
8 time, in the 1970's, at 88 Stevens in Highland Park, and observed Tazelaar perform fellatio on a kid  
9 named "Skinny," and that a black male named "Duffy" brought "Skinny" to Tazelaars. [redacted] told  
10 Gorzen that this "Duffy" brings kids to Tazelaars for the purpose of having sex with children. [redacted]  
11 told Gorzen that there were two other boys there that day named [redacted] Michael & Alfred. The  
12 [redacted] boys were friends with George Richards and their family lived in Highland Park near Tazelaar  
13 year's prior. We identified "Skinny" & "Duffy" during our 2005/2006 investigation into Ted Lamborgine.  
14 "Skinny" is Ronald Edward [redacted] white male, born [redacted] 1962. "Skinny" is testifying against Ted  
15 Lamborgine in his upcoming trial for CSC 1 (child u/13). "Duffy" is Titus Jones, black male, born 5-1-  
16 1916. He was found stabbed to death on January of 1978 (unsolved). (See D.P.D. file #78-51 for  
17 details of murder.)

18 During earlier (FBI) interviews with a subject named [redacted] (associate of the [redacted] &  
19 Boys), [redacted] said that "Duffy" & Ted Lamborgine would take young boys from their neighborhood in the  
20 Cass area to homes north on Woodward Ave to be with other pedophiles. [redacted] described the Royal  
21 Oak area. It's possible that Tazelaar's house on Stevens was the one [redacted] was talking about. It's  
22 also possible that [redacted] was talking about Tazelaar's brother's house off Woodward in Birmingham  
23 (Willem Tazelaar).

24 **\*\*\* (1<sup>st</sup> conversation with "Skinny" about Josiah Tazelaar) \*\*\*** I called "Skinny" at home in Trenton  
25 this afternoon, at approximately 1:00 PM, to ask him about Josiah Tazelaar. [redacted] answered  
26 the phone and stated, "You mean Joe." I asked her if she knew "Josiah" and she said yes, that he has  
27 been friend's with "Skinny" for a long time. She put "Skinny" on the phone and he stated that he has  
28 known Josiah Tazelaar for many years and that he had been to Tazelaar's house with "Duffy" in  
29 Highland Park back in the 70's. I asked "Skinny" when the last time he talked to him was and he stated  
30 it had been about a year. [redacted] was on the other line and reminded "Skinny" that "Jo" had  
31 come to the hospital to see him in December of 2006. "Skinny" said he didn't remember that and  
32 [redacted] yelled at him to tell the truth. "Skinny" then admitted seeing Josiah in the recent past,  
33 stating that Josiah came to see him after we had interviewed Josiah in late November of 2006. Josiah  
34 was asking "Skinny" questions about what we were asking and talking to him about. Josiah had told us  
35 that he was friends with "Duffy," but didn't know Ted Lamborgine, Bob Moore or Richard Lawson.  
36 Josiah told us when we showed him a picture of Ted Lamborgine, that he thought he might look  
37 familiar. I asked "Skinny" if at the times when "Duffy" would take kids out to Tazelaar's house in  
38 Highland Park, if Ted Lamborgine was also there, to which "Skinny" stated "no." I asked "Skinny" if Ted  
39 was at the house at 18<sup>th</sup> & Myrtle when Josiah was there with "Duffy," to which "Skinny" stated "no."  
40 "Skinny" kept saying, "Jo doesn't know Ted." **\*\*\* (See next phone interview of "Skinny" about Ted**  
41 **& Bob Moore on 2-19-2007) \*\*\***

42 **2-16-07: \*\*\* (Info about Gordon Monnier & MICHTRON) \*\*\*** John Ouellet (FBI) called me tonight  
43 and said that he found an article during a "Google" search about Gordon "Gordie" Monnier. This article  
44 was listed under the heading of "ATARI LEGEND." John told me that the article was about Monnier  
45 owning a computer game business in the Waterford/ Pontiac area, called MICHTRON back in the late  
46 70's and early eighties. The information in the article came from an interview of one of Monnier's  
47 partners in MICHTRON named Harry Lafnear. Lafnear said that Monnier was running a very  
48 successful business with him and two other people named Bill Dunlevy and Lane Reynolds into the  
49 early eighties, when all of the sudden Monnier began to make some very strange business decisions  
50 and eventually disclosing it to Lafnear & Dunlevy, what Lafnear describes in the article as "disturbing  
51 information that he cannot repeat." Lafnear describes Gordon Monnier as a school photographer that  
52 got into the computer game business. Lafnear said that MICHTRON then collapsed and no one would

1 do business with Monnier after that. This matches the info that Gordon Monnier is connected to Josiah  
2 Tazelaar, Francis Sheldon & Jerry Richards.

3 2-19-07: This morning I checked "Autotrack" that I had run on Monnier last week. In the Business  
4 Affiliation section, it shows MICHTRON as being a business associated with Gordon Monnier, white  
5 male, born, 7-21-1941, died October of 1991.

6 2-19-07: **\*\*\* (Identified & located Ted Miller) \*\*\*** I had Livonia's Dispatch attempt to locate a drivers  
7 license for Theodore "Ted" Miller, born 1947. They found Theodore Joseph Miller, 1947, to  
8 have a Michigan I.D. card with an address of Taylor St. in Detroit, Mi. I performed an "Autotrack"  
9 check on Miller, which showed other addresses as [REDACTED] Central St. #204 Detroit, Mi. & 24633 Ross St.  
10 Dearborn Mi. No current photo available in Secretary of State files. I drove by both addresses for Ted  
11 Miller.

12 2-19-07: **\*\*\* (Identified & located George Richards) \*\*\*** I performed an "Autotrack" check of George  
13 Richards today, and located George Thomas Richards, born 1947, to have an address of [REDACTED]  
14 Ross St. Dearborn, Mi. A check through the Secretary of State for a photograph of Richards revealed a  
15 photo with the Ross St. address in Dearborn. I requested a current driver's status on Richards, which  
16 revealed him to have a current valid driver's license with an address of Edsel Ford Fwy. (Service  
17 Drive) Detroit, Mi.

18 2-19-07: **\*\*\* (Identified Gordon Monnier's partners in MICHTRON - Bill Dunlevy & Harry Lafnear)**  
19 **\*\*\*** I performed background checks through "Autotrack" on Bill Dunlevy and Harry Lafnear, in an  
20 attempt to located them to find out what the disturbing information was that Gordon Monnier relayed to  
21 them before Michtron's collapse. I found Bill Dunlevy, born 1964 to have a current address of  
22 Mesa, AZ. I found Harry Lafnear, born 1964 to have an address of [REDACTED]  
23 St. # 314 San Jose California. I called information for Bill Dunlevy in Mesa, Arizona and there was no  
24 listing. I called information for Harry Lafnear in San Jose California and the computer message stated  
25 that the customer requested the number not be given out.

26 2-20-07: This afternoon I drove by the addresses for Ted Miller and George Richards. Ted Miller's at  
27 [REDACTED] Taylor in Detroit is a large house with what appears to be separate apartments. The house is  
28 located just west of Woodward and south of Clairmont in Detroit. There were no cars at the address  
29 connected to Ted Miller. I drove by [REDACTED] Ross in Dearborn. This house is connected on Autotrack to  
30 Ted Miller and George Richards. There were no vehicles there, but it appears as if someone is living  
31 there, due to the snow shovel on the porch and a bag of salt. I drove by George Richard's current  
32 address on Edsel Ford Fwy. service drive. There were no vehicles at this house. The house is situated  
33 on the service drive on the south side of I-94, just west of Livernois.

34 2-19-07: **\*\*\* (Identified & Located Louise Hodgson today) \*\*\*** I ran Louise Hodgson through the  
35 Autotrack system and located Louise Hodgson, born 1921 to still be residing at [REDACTED] Parker St. in  
36 Detroit. This is the apartment building called the Park Stone Apartments, located off E. Jefferson east  
37 of the Belle Isle Bridge. Louise Hodgson is the woman that Josiah Tazelaar took his child pornography  
38 to, to hold for him when he was being investigated by MSP in 1977. [REDACTED] told police about  
39 Louise Hodgson being a close friend of Josiah Tazelaar in 1977 and pointed out her apartment building  
40 to them. [REDACTED] told police that she was into the same thing Tazelaar is (meaning pedophilia).

41 2-19-07: **\*\*\* (2<sup>nd</sup> conversation with Ronald "Skinny" [REDACTED] about Josiah Tazelaar) \*\*\*** I called  
42 Ronald "Skinny" [REDACTED] today at his home in Trenton, at approximately 2:30 PM. "Skinny" lives there  
43 with his brother Robert "Fats" [REDACTED] and his sister-in-law, Tammy [REDACTED]. I asked Ronald if he had talked  
44 to Josiah Tazelaar since we last talked, to which he stated he had, indicating that he ("Skinny") had  
45 called Josiah over the weekend. I asked "Skinny" if Josiah asked him questions about what we were  
46 investigating. "Skinny" said that he (Josiah) did talk to him about that and that he ("Skinny") told Josiah  
47 that it's about those four kids that were killed. "Skinny" went on to say that Josiah told him that we  
48 came to see him too and he (Josiah) ain't sayin nothing. "Skinny" told me that Josiah told him on the  
49 phone this weekend that he did know "Ted," referring to Ted Lamborgine or Ted Orr. "Skinny" told me  
50 that Josiah remembers him from "Duffy's" house at 18<sup>th</sup> & Myrtle. "Skinny" told me that Josiah told him

1 that he didn't know Ted personally, but that he just knew him from "Duffy's." I asked "Skinny" how &  
2 when Josiah first met Ted, to which "Skinny" said, "he met him before Bob Moore." (I never mentioned  
3 Bob Moore) "Skinny" then changed it and said, "he didn't know Bob Moore." I told Skinny" that he had  
4 just said that Josiah met Ted before Bob Moore. "Skinny" stated again, adamantly that he (Josiah)  
5 didn't know Bob Moore. The conversation was terminated. It appears that "Skinny" is lying for Josiah  
6 about knowing Ted & Bob Moore.

7 **2-20-07: \*\*\* (Willem Tazelaar turns down request to take the polygraph) \*\*\*** This afternoon, I went  
8 to Willem "Bill" Tazelaar's place of business located at [REDACTED] W. Twelve Mile Rd in Southfield, Mi. I  
9 went there to ask him if he would take a polygraph about having information about the case to get a  
10 reaction from him and so that we could clear him. At approximately 12:45 PM, I was about to go in  
11 when I noticed Bill approaching his own car in the lot. I met him by the driver's door and when he  
12 looked up at me and realized whom I was, he had a startled look, almost like he'd seen a ghost. I told  
13 Bill that I just wanted to talk to him for a minute and he put his head down and said I already talked to  
14 you, I'm not saying anything else. Bill appeared very nervous and had a completely different demeanor  
15 towards me than he did during our first conversation. I reminded Bill that during our first meeting, he  
16 had indicated to me that he wanted to cooperate as much as he can. I also reminded Bill that he told  
17 me, he was going to talk to Ruth (his wife) and call me with more information. Bill then stated in a quiet,  
18 nervous manner that he already talked to me, told me everything he can, and stated that he wasn't  
19 going to say anything else. I told Bill that we just wanted to clear him about having information; it's a  
20 standard procedure, so that we can move on with our investigation and leave him alone. I told Bill, in  
21 order to do this; we'd like him to take a polygraph, so that like I just said, we can move on. Bill without  
22 making any eye contact, and his head hanging down stated, quietly, "no I'm not gonna do that, I don't  
23 have to do that." He appeared even more nervous at this point as if he was shaking. I told Bill that he  
24 was right; he doesn't have to do that, and asked him, stating "you want to cooperate right?" Bill again  
25 stated, "I did talk to you and I'm not saying any more." I asked Bill, "you do want to continue to  
26 cooperate and see this case solved someday for the parents of those poor kids don't you?" Bill just  
27 hung his head, appearing very nervous scared and shaking his head, stating "I'm not saying anymore",  
28 as he opened his car door. I told Bill that I wanted to ask him one more question. I asked him what he  
29 would like to see done to the people that were responsible for these crimes when we catch them. Bill  
30 just kept hanging his head, shaking it, and after a long pause, grunted he didn't know, breathing real  
31 hard at this point, whispering, "jail, I guess." Bill closed his car door and took off.

32 **2-20-07:** After talking to Willem Tazelaar I went to the MSP post to talk to Garry Gray (MSP) about  
33 what had just taken place with Willem. While there, I called Michael Elkins (Josiah Tazelaar's Attorney)  
34 at approximately 1:20 PM and left a message for him to call me about Josiah. Elkins did not call back  
35 on 2-20-07. I am going to offer Josiah a polygraph to clear him and will explain to Elkins what  
36 questions will be on the test, to encourage Josiah to take the polygraph about having information.

37 **2-21-07:** John (FBI), Garry (MSP) & I talked today and we agreed that it is time to have Rob Moran  
38 (Wayne County Prosecutors Office), "start the ball rolling" on the possible agreement with Ted  
39 Lamborgine to cooperate with us in the OCCK case. This agreement may also include limited immunity  
40 for Lamborgine in this case.

41 **2-22-07: \*\*\* (Buccal Swab of Willem Tazelaar today.) \*\*\*** Today, John Ouellet (FBI) & I, went to  
42 Willem "Bill" Tazelaar's office in Southfield to talk to him about taking a polygraph in the OCCK case.  
43 Bill had a client in his office and was not happy to see us there. We told him that we wanted to talk to  
44 him in person and alone, about his brother. Bill said that he told me before that he has nothing else to  
45 say to us and that anything we have to say, we can say right now. Bill became more upset, stating that  
46 we should have called first and that he wanted us to leave. I told him that this is not going away. Bill  
47 told John & I that he was going to call the police. We stated, "We are the Police." I told Bill that he  
48 does not have to say anything, but that he is going to want to at least hear what we have to say. I also  
49 told him that I was positive that he wouldn't want anyone else to hear this and that it would only take a  
50 few minutes and that we would leave. The "client" in the office agreed to leave for a few minutes and  
51 Bill agreed to listen to us. I told Bill that if he does not take a polygraph, then we have to investigate  
52 him through interviewing and that would mean, talking to his wife, relatives, neighbors and friends about

1 his brother's name coming up in the OCCK investigation. I also told Bill that the polygraph would be  
2 specific to the OCCK case and told him what the four questions would be. I asked Bill if he was  
3 involved in those killings, to which he stated no. I told him that there was no reason then, not to take  
4 the polygraph. I further stated that we set up a date to take the test, he passes it, we move on and you  
5 never see us again. Bill agreed to take the polygraph, but said he had to make some calls and would  
6 call us back about the dates for the test. I then told Bill that we have DNA evidence in this case and  
7 would like to take a saliva sample from him to clear him in this case. I reminded him that he already  
8 told us that he had no involvement in the killings, so should not have any problem with a DNA  
9 comparison. Tazelaar agreed and consented to the saliva swab. I performed a Buccal Swab for saliva  
10 from Willem Tazelaar's mouth, packaged, sealed, initialed and tagged the swab as evidence in this  
11 case. This swab will be turned over to Garry Gray (Michigan State Police), who will ship it to the FBI,  
12 DNA lab in Quantico, Virginia for comparison to the hair from Timothy King's mouth.

13 2-22-07: This evening I received a voicemail, approximately an hour or so after John & I left Willem  
14 Tazelaar's office. An Attorney named Patrick Ball left a message, stating that he had received a call  
15 from Willem Tazelaar and that he is now representing him. Ball stated that he works in the Mt.  
16 Clemens, Michigan area and left a phone number of 586-468-9850, requesting that I call him.

17 2-26-07: \*\*\* ( [REDACTED] identifies the Tazelaar's from e-mailed photos) \*\*\* Today John Ouellet  
18 (FBI) forwarded me an e-mail he received from [REDACTED]. We had e-mailed [REDACTED] the photos of the  
19 Tazelaar brother's last week, to see if these were possibly the men at the houses off Woodward Ave. in  
20 the Royal Oak area in the 1970's. [REDACTED] stated that he recognized both men, stating that he is 100%  
21 sure these are two of the men he encountered in the 70's at homes in Oakland County. [REDACTED] further  
22 stated that the subject identified as Josiah Tazelaar is one of the men who raped him in a home off  
23 Woodward in Royal Oak, with Ted Lamborgine. [REDACTED] recognized the subject identified as Bill Tazelaar  
24 as a man he has seen at another house in the Oakland County area. [REDACTED] also in this e-mail, gives a  
25 graphic description of these rape incidences at these homes in Oakland County, involving Ted  
26 Lamborgine and other adult men, possibly now, the Tazelaar's. \*\*\* (See e-mails in the  
27 file for further details) \*\*\*

28 2-26-07: I talked to Patrick Ball this afternoon (Bill Tazelaar's Attorney). I explained to him some  
29 background on our investigation and how his client and his client's brother, Josiah, became involved in  
30 our investigation. I told Mr. Ball, that we would like him to take a polygraph about having information in  
31 the OCCK case. I explained the questions that would be on the test and if he does not take the  
32 polygraph he (his client) will be fully investigated. I told him that we would like to avoid turning Bill's  
33 "world upside down" if we didn't have to. I explained the seriousness of our investigation and that we  
34 are obligated to investigate this case and anything that is developed out of our investigation. I told Mr.  
35 Ball that the polygraph test would only take a few hours and we would not interview Bill before the test.  
36 I further stated that if Bill passes they would never hear from us again. I also explained to Mr. Ball that  
37 we do not want to have to talk to Bill's wife, neighbors...etc, but if he does not take the polygraph, we  
38 will have no other choice. Mr. Ball told me that he understands and would talk it over with his client and  
39 call me back.

40 2-26-07: \*\*\* (Phone conversation with "Duffy's" son Titus Michael Jones Sr.) \*\*\* I called a phone  
41 number to a current address in Missouri for Titus Jones. When I called a male subject answered that  
42 was later identified as "Duffy's" grandson, telling me that I must be looking for his dad, Titus Michael  
43 Jones Sr. I told the grandson that I was calling about his grandfathers murder and that I would like to  
44 talk to his dad. The grandson indicated to me that he was not aware that his grandfather had been  
45 murdered, stating that his death was a family secret. He told me that he would call his father and have  
46 him get in touch with me. A short time later, Titus Michael Jones Sr. called and I told him what this is all  
47 about. We began to talk about the young white boys that were around his father, to which Titus Sr.  
48 stated his father was a bi-sexual. He then asked me if some of the young boys were under age. I  
49 asked him if he remembers his father living at 18<sup>th</sup> & Myrtle in Detroit, to which he stated he did. I  
50 asked him if he remembers who his father lived with at that house and what he looked like. Titus Sr.  
51 stated that he can kind of picture a white guy that was younger, but wasn't sure. I said the name Ted,  
52 to which he stated, "that name sounds familiar." I told Titus Sr. that I was investigating the Oakland

1 County Child Killings and that his dad's old roommate is a suspect. I told him that it's possible that Ted  
2 killed his father too and that I would like to talk to him about that. Titus said that he would call me  
3 tomorrow about setting up a time to come into the Livonia Police Dept. and discuss this. I told him that  
4 I was in possession of the Detroit Police Dept's file on his father's murder and that I would like to talk  
5 about some of the suspects and show him some photographs.

6 2-26-07: This afternoon I called and left a message with Josiah Tazelaar's Attorney (Michael Elkins). I  
7 told him that we developed through our investigation, the fact that it appears that his client (Josiah) had  
8 an alibi during the killings of the kids in Oakland County, but we would like to polygraph him about  
9 having information in this case. I relayed to Elkins in my message, that we did not want to "turn his  
10 client's world upside down", but he is right in the middle of this investigation and a polygraph would  
11 clear him and he would never hear from us again. I am waiting to hear back from Elkins.

12 2-27-07: \*\*\* (Discussed the Polygraph with Josiah Tazelaar's Attorney) \*\*\* I spoke with Josiah's  
13 Attorney, Michael Elkins today. I told him that through our investigation, it appears as if his client  
14 (Josiah Tazelaar) has an alibi for at least three of the four kids abducted in 1976-77 (OCCK). I told  
15 Elkins that we specifically want to polygraph his client about having information about the case, not  
16 about being the killer. I told Elkins that there are four questions that will be on the polygraph, two are  
17 about direct involvement and two are about knowing about the case. I informed Elkins that we are  
18 mainly interested in the two questions about him having information, based on the fact that he has an  
19 alibi during the killings, but we have to ask him if he committed the killings or we would be negligent in  
20 our testing. Elkins understood and stated that he would not normally recommend to his clients to take a  
21 polygraph and he is not sure he wants Josiah to. I told Elkins that we do not want to open this guys  
22 past up if we don't have to, but we have discovered through our investigation, that Josiah has molested  
23 other young boys in the past, that he has not been charged with. Elkins then told me that he would  
24 probably let his client take the test if we could offer Josiah immunity against prosecution in past CSC  
25 type crimes. I told him that would probably not be a problem, we are only interested in the child killing  
26 case and informed him that I would talk to the prosecutor and get back to him. Elkins asked me to call  
27 him after talking it over with the prosecutor.

28 2-27-06 \*\*\* (Interview with "Duffy's" son, Titus Michael Jones Sr. b/m [REDACTED] \*\*\* This  
29 afternoon, I interviewed "Duffy's" son in the Detective Bureau conference room at the Livonia Police  
30 Department. This interview was conducted to gather information about "Duffy," his background and the  
31 circumstances surrounding his murder in January of 1978. I also conducted the interview to try to  
32 "bridge the gaps with possible pieces of the puzzle," between "Duffy" & Ted Lamborgine, "Duffy &  
33 Josiah/Willem Tazelaar and other adult pedophile associates of "Duffy's." Another reason I wanted to  
34 talk to "Duffy's" son was to try and get an idea, whether or not he ("Duffy's" son) could possibly have  
35 been involved in his father's death.

36 Titus Sr. ("Duffy's" son) was born and raised in the Detroit area by his mother (Lily Jones) at  
37 [REDACTED] in Detroit. He told me that he currently lives there in his mother's house at [REDACTED]. Titus  
38 said that his dad was a bi-sexual and lived on his own in the area when he (Titus) was growing up.  
39 Titus stated that he was close to his dad over the years, while growing up and that his dad was always  
40 around the area managing apartment buildings and apartment houses. Titus told me that he realized  
41 when he was about 11-12 years old that his dad was a homosexual and was always with young white  
42 males. Titus said he knows now that some of the white males that his dad was with were underage.  
43 Titus said that at first he was quite upset when he was a teenager, about his dad's homosexuality and  
44 his lifestyle. Titus stated that his mother told him the reason one day, why his dad was always with  
45 young white males, sexually. She told him that when "Duffy" was about 11 years old, he had been  
46 raped by white sailors, down in Mississippi, who threatened to kill him if he ever said anything. I asked  
47 Titus where his dad got the name "Duffy," to which he stated that his dad got the name while playing  
48 semi-pro baseball in the south, when he was young, stating that he was a "catcher."

49 Titus told me that when he was growing up and when he returned from Vietnam, his dad always had  
50 young white males around him and that Douglas "Doug" Carver was one of them that did odd jobs for  
51 his dad over on Belvedere in Detroit. I asked Titus if his dad ever molested him or tried to molest him,

1 to which he stated "no." He said his dad was real good to him and his mother even though he didn't  
2 live with them. Titus told me that he didn't really know the other adult homosexual/pedophile men that  
3 his dad associated with, but stated that most of them were white. Titus said that his dad had a white  
4 homosexual friend that he was real close with that lived across the river in Windsor, Canada and that  
5 his dad was always over there. Titus went on to say that he went over to Canada with "Duffy" one time  
6 to his friends home and there was a picture there of his dad with an all white family and his dad was  
7 holding a young boy. Titus told me that these kinds of things really irritated him sometimes.

8 We began talking about his dad's murder and I asked him who he thought was involved in the murder  
9 and why he thought his dad was killed. Titus said he always thought about his dad's homosexual friend  
10 named "Bill," stating that his dad called him Carter. (I identified Cornelius Carter a.k.a. "Bill" a few  
11 months earlier) I asked why he thought that, to which he stated that his dad was killed violently and  
12 robbery was not the motive. Titus went on to say that it was a homosexual type murder. I asked him  
13 how he knows that, to which he stated that they (homosexuals) are very passionate about each other  
14 and that that's how upset they get. I asked Titus if he was a homosexual or a pedophile, to which he  
15 stated "no." He told me that he loves his own kids and doesn't think about kids that way. I told him that  
16 the motive could have been to keep your dad quiet and asked Titus what his thoughts are on that.  
17 Titus told me that he has been thinking about his dad's murder and stated that he can't see his dad  
18 killing one of those kids, but could see his dad getting himself into a position that he couldn't get out of  
19 with these homosexual friends of his. I asked him to explain further. Titus said he could see his dad  
20 ("Duffy") walking in on one of the homosexual(s) with one of those kids from Oakland County and being  
21 involved all of the sudden and then maybe forced to do something that he shouldn't have. I told Titus  
22 that that was quite a theory and asked him when he came up with that, to which he stated that after I  
23 called him the other night and mentioned that I was investigating the Oakland County Child Killings and  
24 came across his dad's murder while investigating those killings. I asked Titus if his dad ever told him  
25 that he had gotten himself involved in something bad like that, to which Titus said "no." I asked Titus if  
26 his dad ever told him that he was in trouble and got himself into something he shouldn't have, to which  
27 he stated "no." I asked Titus if his dad would have called him to ask him for help if he got into a mess  
28 like that, to which he stated that his dad has called him in the past when he needed help, stating that he  
29 took a shotgun and went and stayed with his dad one time when his dad was being threatened over  
30 some money. I asked Titus if he ever saw his dad with any photos of any naked kids or saw his dad  
31 with one of the kids from Oakland County, to which he stated "no." I asked Titus if he would be willing  
32 to take a polygraph about being involved in his dad's killing or having information about the child  
33 killings, to which he stated that "he would have no problem doing that, indicating that everything he told  
34 me is truth."

35 I began asking Titus about his background. He told me that in 1971-72 he fought in Vietnam. Titus  
36 said that he was in the U.S. Air Force, assigned to the 405<sup>th</sup> Combat Support Company. Titus told me  
37 that he saw quite a bit of combat while in Vietnam and never received any medals. Titus said that he  
38 had a very hard time after returning from Vietnam and has Post Traumatic Stress Syndrome. Titus went  
39 on to say that he got into drugs while in Vietnam and developed a bad drug habit after returning home.  
40 Titus said that he had a very hard time adjusting back in the states and ended up in the psychiatric  
41 ward at the V.A. Hospital.

42 Titus told me that after Vietnam, he got a job delivering auto parts for McDonald Ford. He went on to  
43 say that he drove a van and delivered these parts all over the Detroit Metro area. Titus said he also did  
44 some construction work after Vietnam. I asked Titus if he was in Vietnam with anyone he knew from  
45 Detroit, to which he stated that he met a subject named Horace Allen at Ft. Wayne before he shipped  
46 out and that they remained friends after the war. Titus also mentioned associates named Eric Williams  
47 "Walker" & a Melvin Newton.

48 2-28-07: I talked to Rob Moran (Wayne County Prosecutor's Office) today about Josiah Tazelaar  
49 requesting Immunity from prosecution on any old CSC cases, prior to taking the polygraph. Moran said  
50 that he does not have a problem with that and would request approval from Kym Worthy (the Wayne  
51 County Prosecutor) and let me know.
