Information from John Doe January 14, 2014

- 1. Busch and Fisher families are well known and wealthy
 - a. Fishers are "old" money
 - b. Both men are described as the black sheep of their family
 - c. H. Lee Busch riding herd over Busch
 - i. Note: We know this person is Chris Busch
 - d. Cousin Mickey Briggs riding herd over Fisher
 - i. Note: I am going to posit the black sheep Fisher is Everell Edward Fisher Jr. Everell is the eldest son of Everell Edward Fisher Sr and Susan Briggs, daughter of Walter Owen Briggs Sr. Basil "Mickey" Briggs is her nephew. Everell and Susan were two trust fund babies that married but unlike most of the other Fisher family members who moved from Boston Ave in Detroit to Grosse Pointe, they resided at 927 Lone Pine until the early 70's. That specific address on Lone Pine no longer exists however many of those homes have been torn down and rebuilt in the last 10 years. They had another son and daughter but both married and were part of various charities and activities. Everell died in 1989 and was living in Charleston, SC at the time of his death. He never married or had children.
 - ii. The Everell Fisher family lived on the west side of Detroit while the rest of the family members resided primarily on the east side. If you know the Detroit area, generally west siders don't mix with east siders and vice versa. The perps had extensive knowledge of the streets on the west side of Detroit which would indicate someone who had grown up and/or had lived there for some length of time. They were VERY knowledgeable about the streets and backroads in Oakland County.
 - e. Busch and Fisher met in the Cass Corridor
 - f. House on Burt Lake
 - i. Everell Sr's obituary as of 1979 lists Everell Jr of Burt Lake.
 - g. Send the bill to Deloitte, Haskins and Sells in the Guardian Building
 - i. As Cathy as speculated, this was probably a trust fund
 - h. Attorney relative available to fix anything 24/7
 - Note: Basil "Mickey" Briggs was listed as a tax and investment attorney (died 2019)
 - ii. Mickey's older brother Walter was an Investment Counselor (died 2012).
 - iii. Another attorney with close ties to Mickey was Jerry D. Luptak, 3000 Guardian Bldg., Detroit, Mich. See FISHER v. COMMISSIONER | 27 T.C.M. 1048 (1968) | tcm10481865 | Leagle.com
 - Jerry Luptak was an original partner in Beztak Properties. Jerry died in 2013.
 - i. Slept in the master bedroom on Walden.
 - i. In the mid-70's there was one house on Walden Lake in Bloomfield Township located off Walnut Lake Rd and Franklin. The house is 4540 Walnut Lake Rd. Built in 1924 it was 3.62 acres and on Walden Lake (more of a large pond). It has

5 bedrooms and 7 baths, 4,600 sq ft. Sometime in 1976/77, the surrounding properties were subdivided and new building began. 4589 Walden Dr was built in 1976 but it is not on the lake, is much smaller and not close to the above mentioned house. 3 other houses were built on Walden Dr sometime in 1977 with the same characteristics as 4589. If he was really staying on a house on Walden Lake, I suspect that the Walnut Lake address was it.



In 1976/1977, the homes facing Walden Dr were not there. The house itself sits back from Walnut Lake Rd closer to the water. It would have been very private and within the vicinity of where the 4 children were picked up and discarded.

The property deed with ownership needs to be pulled to verify who owned the property at that time.

Internet information shows that Sheldon and Harriet Fuller purchased the property sometime in the early to mid-1980's. I have been unable to locate records online prior to then.

- i. Never visited the house on Gilbert Lake
 - My guess is that is because the parents, Everett Sr and Susan resided at that house. They may have moved from the 927 Lone Pine address as the area was built up. Gilbert Lake would be very close in proximity to their prior address.
 - Property deeds would need to be pulled to verify if this is correct and who actually owned a Gilbert Lake property.

Speculations:(Questions and Opinions are my own)

- 1. All 4 children were killed in Feb, Dec close to the Xmas holiday and in Mar. Is that because Mr. Fisher normally of Burt Lake needed to be in town to attend family events in the above timeframe?
- 2. While the Fisher name is old money, but the Briggs ladies, particularly Jane Briggs Hart seemed to be the ones who were used to the limelight. After Jane's husband died, she continued her political activities and remained in DC. Did the FBI really loose the files of the individual who was hypnotized or did the session result in the identification of a relative of Ms. Hart's? Was she notified and the situation made to "Go Away"?
- 3. The perps were pretty sophisticated in how they picked up and discarded the children in different cities so that the small town police forces would be fighting with each other. Where did they get that knowledge? We know there had to be dirty cops that were pedophiles. Were they directly or indirectly involved?
- 4. When the maid could not get into the Busch's house as the doors were locked, she contacted Chris's older brother Charles.
