Dear Investigator Duncan,

I am reaching out to you in the hopes you will discuss any recollections you have concerning the below referenced polygraph you conducted on John Hastings on behalf of the Michigan State Police in October 2009. I realize this was quite some time ago, but I am hoping the attached documents help refresh your recollection.

The documents were supplied from the MSP as part of a FOIA response to my family. My brother Tim was murdered in 1977 and I believe John Hastings was involved or has knowledge concerning not only Tim's abduction, captivity and murder, but also the murders of three children in Oakland County from 1976 to 1977.

While the name "John Hastings" is redacted, the MSP provided that document in a binder marked "John Hastings." As the narrative prepared by Det./Sgt. Garry Gray (now long retired) notes, Det./Sgt. Cory Williams, then of Livonia PD was retired at the point you conveyed the results of Hastings' polygraph. Cory went on to work for almost a decade as an inspector with the Wayne County Prosecutor's Office, where he continued to work on the child killer case (my brother's body was dumped in Wayne County). He retired from that office and is now an investigator for the Catholic Diocese in the Detroit area.

Two weeks ago, Cory Williams confirmed to me that he had never been shown or told about your results and conclusions in the polygraph of Hastings. That this information came during a time when he had been "kicked off" the child killer task force (jurisdictional in-fighting) and that he believes it was purposefully kept from him.

I filed the attached FOIA request with Georgia Highway Patrol because the MSP charged my family over \$11,000 in the past for some 3,400 pages of documents. We had to hire attorneys and contest their initial denial, so there were attorneys fees and court costs on top of the \$11,000. I was really disappointed the information about Hastings with GHP had been destroyed, but these FOIA pages do indicate you sent the MSP copies of the DVDs, reports and pre-polygraph interviews with Hastings to the MSP and I will file a FOIA request with them in an attempt to obtain the material.

I received this response from the Georgia Open Records department yesterday. Last night, in what is a powerful coincidence, a private investigator working on allegations concerning a child porn and sex ring from the same time period and community where these child killings took place, texted me to say that a living victim said "John Hastings knows EVERYTHING" concerning these child killings.

I would appreciate any information you can give me concerning your recollections of this polygraph and interactions with Garry Gray

I would appreciate any information you can give me concerning your recollections of this polygraph and interactions with Cary Gray or any other member of the MSP concerning John Hastings.
