- Mark Stebbins, 12, of Ferndale, was last seen leaving an American Legion Hall on Sunday afternoon, February 15, 1976. He had told his mother he was going home to watch television. His body was found on February 19, neatly laid out in a snowbank in the parking lot of an office building at Ten Mile Road and Greenfield in Southfield (some reports claim Oak Park; Greenfield is the boundary between the two cities). He had been strangled and sexually assaulted with an object. Rope marks were seen on his wrists. He was fully clothed in the outfit he was wearing when last seen alive. [2]
- Jill Robinson, 12, of Royal Oak, packed a backpack and ran away from her home on Wednesday, December 22, 1976, following an argument with her mother over dinner preparations. The day after her disappearance, her bicycle was found behind a hobby store on Main Street in that city. Her body was found on the morning of December 26, along the side of Interstate 75 near Big Beaver Road in Troy. She was killed by a single shotgun blast to the face. She was fully clothed and still wearing her backpack. The body was placed within sight of the Troy police station, once again, laid out neatly in the snow. [2]
- Kristine Mihelich, 10, of Berkley, was last seen Sunday, January 2, 1977 at 3:00 pm at a 7-Eleven store on Twelve Mile Road at Oakshire in Berkley, purchasing a magazine. A mail carrier spotted her fully clothed body 19 days later on the side of a rural road in Franklin Village. She had been smothered. The body was laid within view of nearby homes, eyes closed and arms folded across the chest, once again in the snow. [2]
- Timothy King, 11, borrowed 30 cents from his older sister and left his home in Birmingham, skateboard in hand, to buy candy at a drugstore on nearby Maple Road on Wednesday, March 16, 1977, at about 8:30 pm. He left the store by the rear entrance, which opened to a parking lot shared with a supermarket, and vanished. An intensive search was executed that covered the entire Detroit metropolitan area, and there was widespread media coverage, already heavy with coverage on the previous three slayings. In an emotional television appeal, Timothy's father, Barry King, begged the abductor to release his son unharmed. In a letter printed in the *Detroit News*, Marion King wrote that she hoped Timothy could come home soon so she could serve him his favorite meal, Kentucky Fried Chicken. In the late evening hours of March 22, 1977, two teenagers in a car spotted his body in a shallow ditch alongside Gill Road, about 300 feet south of Eight Mile Road in Livonia, just across the county line in Wayne County. His skateboard was placed next to his body.

Attached is a signature copy of Mr. Karrick's recent letter. When I originally spoke with Tony, he requested that we meet at some convenient location. I advised him that I would not talk to anyone about this case without a police officer present in accordance with my past practices. He indicated that he was represented by counsel and I asked him to talk with his attorney and call me back at his convenience. In the meantime, I honored his request for confidentiality. When Tony called me back on February 23, 2014, he advised me that he and his attorney were meeting with Jessica Cooper regarding a grant of immunity. After the immunity was granted, he intended to go public with his information. This is the last conversation I had with Tony as I have not heard from him since that date.

I respectfully request that one or more of you contact me at 248.644.5398 regarding any follow up on this information.

In regard to the other letter, which I have referred to as the "GM letter", the author requested a small, additional amount of time to talk to his source and I have not returned that call as of this date. However, I will advise him that I will send signature copies of that letter to the police authorities and it might be wiser to discuss it with me before we take this formal position.

I grew up in Southfield in the 70's. This case was/is the first major imprint of my childhood and has always been in the back of my mind so to speak throughout my life.

By way of a personal related anecdote: a woman very close to me was the daughter of a GM executive who served that company at the same time Busch's father was there. She was sexually abused as a child by her father (and several of his 'professional associates') throughout the midto-late 1970's.

In the late 90's we engaged a private investigator to help prepare a legal case against her father and these monsters, and among the investigator's conclusions was the theory that there existed an organized "ring" of pedophiles within GM's Executive Management at the time — and that 'offering up' a child was a kind of ticket into the upper ranks of management. By the way, the investigator (who was from the West Coast) met with a certain degree of cooperation from local law enforcement, but was told time and time again "Don't waste your time, the case won't go anywhere".

Alas, time and money were not on our side. We were not able to pursue the case, and the woman's father left the state, took ill, and died before I could question him myself in a more "direct" manner.

I had never heard of Busch until the media came out with that story a few years ago. When I heard the details: GM Executive, organized ring of sexual abuse, etc., my blood ran cold.

May G-d give you strength to continue fighting the good fight. Thank you.

- A. Affiant is a Detective with the Michigan State Police and has been a police officer for 30 years.
- B. Affiant is one of the police officers from several police departments that are continuing to investigate a series of homicides of children that occurred in Oakland County, Michigan in the years of 1976 and 1977. These homicides were believed to have been committed by the same perpetrator or perpetrators based on similarities in the kidnapping, length of time before the subsequent disposal of the bodies, and the physical trace evidence that was recovered during the autopsies of the victims.
- C. Affiant has reviewed the police reports that have been prepared by officers and investigators of several police departments involved in the investigations, including a task force that was created to investigate the homicides. These included the following departments or agencies: Michigan State Police, Michigan State Police Crime Lab, Federal Bureau of Investigation, FBI Crime Labs, Oakland County Sheriffs Department, Wayne

County Sheriffs Department, Berkley Department of Public Safety, Ferndale Police Department, Troy Police Department, Royal Oak Police Department, Birmingham Police Department Southfield Police Department, Franklin Village Department of Public Safety, Beverly Hills Department of Public Safety, Livonia Police Department, Warren Police Department, Sterling Heights Police Department and Oakland County Prosecutors Office.

- D. Affiant further states that on February 15, 1976, a missing person report was filed with Sgt. Dingman of the Ferndale Police Department in Ferndale, Michigan by the mother of Mark Douglas Stebbins, a 12-year-old male. (Complaint #C76-43 1) The police report indicates that Ruth Stebbins reported that Mark was at the American Legion Hall in Ferndale at approximately 3:30. He said that he was going home to watch a movie on TV and left. She stated that he had not returned home.
- E. On February 19, 1976, the Southfield Police Department responded to a call reporting the discovery of a body. They found the body of Mark Stebbins lying in an apartment house parking lot. He was fully dressed and was wearing a hooded jacket. The autopsy by Oakland County Medical Examiner Dr. Thomas Petinga, determined that the cause of death was asphyxia due to smothering. The autopsy report indicates that "examination of the body by this prosector revealed an unusually patulous anal orifice with linear tears at the mucocutaneous junction; indicative of abnormal sexual acts (sodomy). Examination of smears taken from several orifices (as noted) revealed the presence of sperm." The autopsy also indicates "Crusted lacerations" on Mark's scalp. There was "slight brown discoloration of wrist and above ankles."
- F Affiant further states that on December 22, 1976, a missing person report was filed with the Royal Oak Police Department by Tom Robinson, father of Jill Robinson, an 11-year-old female. (Report # 76-10779) Mr. Robinson reported that Jill, who was living with her mother, had left her home at 6:30 PM. and had not returned nor arrived at his residence. Jill's mother, Karol Robinson, told Police that her daughter left her home after an argument over household chores.
- G. Affiant has reviewed Troy Police Department Police Report number 76-26637 and was thereby informed that on December 26, 1976, at approximately 8:45 AM, a call was received by the Troy Police Department regarding a body found next to Interstate 75 in Troy. Responding Officers Kerr, Snyder and Tuck observed the body of Jill Robinson. She was lying on the grass next to the east shoulder of the expressway. She was fully dressed. Officers observed that the top of her head was missing and skull fragments were seen in the surrounding area. The autopsy determined that death was caused by a shotgun wound of the head. The autopsy report does not indicate signs of sexual molestation.
- H. Affiant further states that on January 2, 1977, at 6:00 PM, Deborah Ascroft, mother of Kristine Mihelich, age 10, made a missing person report to the Berkley

Department of Public Safety. (Report No 77-14). She stated that her daughter left the house at 3 PM to go to a nearby 7-11 convenience store and had not returned.

- I. Affiant further states that on January 21, 1977, a postal employee called the Franklin Village Police Department and reported the discovery of a body in a snowbank. Responding officers found the body of Kristine Mihelich. She was fully clothed.
- J. Affiant reviewed the autopsy report of Kristine Mihelich prepared by Dr Sillary and evidence technician James Steggall. Affiant was thereby informed that the cause of death was asphyxia due to suffocation. Bruises on her nose indicated that the killer had pinched her nostrils while covering her mouth. There was no gross evidence of sexual molestation of the vagina or anus. Two hairs were found in Kristine's mouth. The Medical Examiner indicated that her body was not yet frozen, indicating she had been placed in the snow only a short time before the body was discovered. Affiant reviewed a Michigan State Police Crime Laboratory report written by Charlotte Day, who indicated that an examination of the hairs indicated one was an animal hair and the other was similar to Kristine's hair, but at that time was not sufficiently characteristic for identification.
- K. Affiant further states that the police reports indicate that despite Kristine having been missing for 19 days, her clothing was neat and clean. Her mother told officers that some of the facts regarding the condition of the clothing suggested that another person had dressed Kristine before disposing of the body. Kristine's blouse was tied in front, rather than in back as usual, and her pants had been tucked into her boots, which Kristine never did.
- L. Affiant further states that on March 16, 1977, a missing person report was made to the Birmingham Police Department by Barry King, father of Timothy King, age 11. (BPD #77-333) Timothy had left the family home at approximately 8:00 PM to buy candy at a nearby drug store. He had not returned home.
- M. A cashier at the Hunter/Maple Pharmacy at 655 E. Maple. recalled Tim King buying candy. Officers spoke to Marjorie Hoffman. Hoffman said that she had been at the drug store at approximately 8:30 PM on March 16, 1977. Hoffman recalled a child resembling Timothy's description talking to a man in a parking lot next to the drug store. They were standing next to a small blue car with a white strip down the side. Officers were able to prepare a composite drawing based on the description provided by Mrs. Hoffman.
- N. Affiant has reviewed police reports written by Det/Sgt Milan Varajon and Det/Sgt Brandemihl of the Livonia Police Department and is thereby informed of the following: On March 22, 1977, Livonia Police Officers in neighboring Wayne County received a call reporting a body lying in a ditch. Livonia officers responded and the body of Timothy King was discovered at the edge of the roadway a short distance south of the

Oakland County border. The autopsy was conducted by the Wayne County Medical Examiners Office. The autopsy report states that the cause of death was smothering. Linear abrasions were observed on the lips and around the mouth. Marks on the wrists and on one ankle suggested binding. The anal canal was grossly dilated and there were abrasions of the lining of the anal canal, indicating sexual abuse. Two foreign hairs were found on Timothy's body. One of the hairs appeared to be a pubic hair. A large amount of trace evidence in the form of fibers and animal hairs were found on the clothing of the victim. The time of death was estimated to be no more than 6-8 hours before discovery of the body. It was noted in the autopsy report that the body, including fingernails and toenails, was exceptionally clean.

- O. Affiant has reviewed a laboratory report prepared by Laboratory Specialist John Schoonover and David Metzger of the Michigan State Police, and was thereby informed that these Lab Specialists seized items during the autopsy of Timothy King and from the clothing of Timothy King, including hairs and fibers.
- P. Affiant further states that Affiant has reviewed a report prepared by MSP Lab Specialist David Metzger on or about July 13, 1977, and was thereby informed that Metzger had examined fibers recovered from the socks of Jill Robinson and from her blanket. He noted that several yellow fibers were found. He indicated that he examined fiber from Jill Robinson's socks and his opinion indicated that it was microscopically similar in color and physical construction, and possessed optical properties in plane polarized light identical to numerous fibers removed from the clothing of Timothy King. He further indicated that these fibers from the socks of Jill Robinson and the clothing of Timothy King appeared to be carpet fibers, and could have a common origin.
- Q. Affiant was informed by MSP Lab Scientist Lynne Helton that she recently received from the FBI crime lab a slide containing five animal hairs that were recovered from the clothing of Jill Robinson in 1977.
- R. Affiant has reviewed a police report prepared on January 25, 1977 by Southfield Police Officer Lourn Doan, now retired, who was assigned to the Oakland County Child Killer Task Force in 1977, and was thereby informed of the following: Doan was contacted by Flint PD and advised that a subject they had arrested for Criminal Sexual Conduct with a Minor may have information about the person who killed Mark Stebbins. Doan went to Flint PD and interviewed one Gregory Greene. Green told Doan that he believed a man named Christopher Busch had murdered Mark. Doan included in his report that both Green and Busch were sexually involved with young boys.
- S. Affiant further states that Detective Lourn Doan's report (Southfield PD report 76-3079) dated January 28, 1977 reports that Detective Doan, Det Cattell from Ferndale PD and Flint officers Waldron and Rivard interviewed Christopher Busch on January 28, 1977. He admitted to being a pedophile and liking young boys. During this

interview, Busch told detectives that he and Greene had discussed and planned how they would kidnap, hold and molest young boys. Busch stated that he and Greene agreed that one would work days and the other nights, so that one of them would always be with the kidnapped child. Busch further described 3 locations where he picked up young boys in the past. These locations are as follows:

9 Mile and Woodward area in Ferndale;

In Royal Oak near 13 Mile Rd and Woodward;

In the area of 12 Mile and Greenfield Rd, more specifically, Hartfield's Bowling Alley and the 7-11 party store located directly across the street.

Doan reported that he asked Busch what they intended to do with the child after they were through with him. Doan wrote in his report that Busch could not answer.

- T. That Affiant is informed, based on his investigation and review of the police reports, that the three locations described by Busch are the suspected abduction location for Mark Stebbins, the area where Jill Robinson is believed to have been abducted, and the area where Kristine Mihelich was last seen, respectively.
- U. Affiant has reviewed a police report written by D/Sgt Thomas Dyer of the Michigan State Police, now retired. The report was written in January 1977. Affiant is thereby informed of the following:
- 1. On January 26, 1977, Kenneth Bowman, then age 14, was interviewed by Sgt Frances Miller of the Flint Police Department. Bowman said that he knew Chris Busch and Greg Greene. He said that on a Saturday during early summer, 1976, Greene and Busch came to his house and picked him up. Greene was driving a blue Chevy Vega with a white stripe on the side, which belonged to Busch.
- 2. Greene drove them to a location in Oakland County. Busch asked Bowman if he wanted to go for a walk. Bowman was afraid that if he got out of the car, he would be killed. Busch told Bowman to pull down his pants. Busch then performed fellatio on Bowman. Bowman then performed fellatio on Busch. They then drove him back to his home.
- 3. Bowman told Miller that Busch had engaged in sex with him three times before this incident. He said that he met Busch through Greg Greene. Bowman also said that Greg Greene had engaged him in sexual acts, including forcing him to engage in anal intercourse. He said that on one occasion, he was in a vehicle with Greene. He said during oral sex, that Green grabbed Bowman by the neck and choked him until he passed out. Bowman said he also saw Greene having sexual acts with some of Bowman's friends:
- 4. Bowman said that Greene told him Chris Busch had killed a kid out in the woods near Busch's house a couple years earlier.

- 5. Sgt Dyer also wrote in the report that Greg Greene was interviewed by Officer Tom Waldron of the Flint Police Department on January 26, 1977. Greene said that he and Christopher Busch went to Bowman's house and picked him up. He said that Chris drove them to a location near Mt. Holly. Busch knew that Greene had had sexual relations with Bowman. Busch asked Bowman to go in the bushes. Bowman was scared. Busch got in the backseat and Busch performed oral sex on Bowman, then Bowman performed oral sex on Busch. Busch then performed oral sex on Bowman a second time. While this happened, Greene was driving around. Afterwards, Busch drove them back to Flint and took Bowman home. Dyer also reports that Christopher Busch was charged with third degree Criminal Sexual Conduct in Oakland County, and subsequently pled guilty to Assault with intent to commit sexual penetration.
- V. Affiant has obtained and reviewed a Polygraph report prepared by Ralph E Cabot, who at that time was a Michigan State Trooper and a member of the Polygraph Unit at the Flint Post. Cabot reported that he conducted a polygraph test of Christopher Brain Busch on February 15, 1977. During the pre-test interview, Busch admitted that he was sexually attracted to young males in the 12-13 year old age bracket. He said he has had affairs with young boys. He denied that he had anything to do with the Stebbins kidnapping and murder. Cabot tested Busch and concluded that he was being truthful. Based on these polygraph test results, Busch was not investigated further as a suspect in the Oakland County child murders.
- W. Affiant further states that Affiant was informed by Det Cory Williams of the Livonia Police Department that he received a tip from a relative of Timothy King that a polygraph examiner named Patrick Coffey had information pertinent to the investigation. Coffey told Williams that during a convention of Polygraph examiners in Las Vegas, he met a person from Michigan named Larry Wasser. Wasser told Coffey that he had polygraphed a subject who had admitted he killed one of the children.
- X. Affiant further states that he was told by Sgt. Williams that Wasser was served with an investigative subpoena. After a period of litigation regarding Wasser's assertion of privilege, Wasser told Sgt Williams that a subject he had tested had been tested by a State Police examiner who had passed and cleared him of any involvement. He said that the examiner had not been the regular polygrapher used by the Child Killer Task Force, and the examiner should not have passed the subject. At a later date, Wasser told Sgt Williams that the polygrapher's last name was Cabot.
- Y. Affiant further states that the polygraph charts from Christopher Busch's polygraph test administered by Ralph Cabot were recently reviewed by three polygraph examiners, Lt Robert Dykstra of the Michigan State Police, Tim Larion of the Livonia Police Department and former State Police polygraph examiner John Wojnaroski. Affiant

was told by the three examiners that the polygraph charts do not indicate truthfulness, and that at best, the result should have been deemed inconclusive.

- Z. Affiant has reviewed police reports prepared by Bloomfield Township Officer Richard J McNamee on November 20, 1978 and is thereby informed of the following:
- 1. On November 20, 1978 Officer McNamee was dispatched to 3310 Morningview Terrace to check on the welfare of Christopher Busch. McNamee was informed by Christeen Bracken that she was the Busch's maid and she hadn't been able to get in the house that morning. The newspapers from three days earlier were still outside the door and she suspected that something was wrong. She went to a neighbor's house and the neighbor called Christopher Busch's brother, Charles Busch. Charles had then called Bloomfield Twp. PD. Charles told Officer McNamee that Christopher Busch was living in that home with their parents, who were at that time in England. The officers made entry into the home. Christopher Busch was found deceased lying on a bed in a bedroom. He had a bullet wound in the forehead and a rifle was lying on the bed next to his body. The report was titled, "suicide."
- AA. Affiant further states that Affiant spoke to FBI Agent Thomas MacDonald and reviewed a report written by MacDonald, and is thereby informed of the following:
- 1. MacDonald interviewed Charles Busch, Christopher Busch's brother, on April 22, 2008 Charles said that at the time of Christopher's death, his parents had a white haired Welsh Terrier. Christopher also had a light tan colored dog. Both dogs were at the house on the day Christopher's body was discovered. Charles said that after Christopher had been charged with molesting a child, that Charles was told by their brother, John, now deceased, that John's sons told John they were also molested by Christopher.
- BB. Affiant further states that Affiant has obtained and viewed photographs of the bedroom that had been taken on the day Busch's body was discovered. A penciled drawing was pinned to a wall of the bedroom. The picture depicts a screaming boy wearing a hooded jacket. Affiant has compared the drawing to photographs and composites of Mark Stebbins and believes there to be a very strong resemblance in respect to the facial features, hair, and clothing that Mark Stebbins was wearing during the time of his disappearance and when his body was discovered. The photographs also show that in a closet, there are several pieces of rope on the floor. One piece of rope appears to have a dark red stain. The size and color of the rope are of the type believed to have been used to bind the children. It was also noted that the color of the carpeting in the room could be similar to the color of the carpet fibers recovered from the clothing of the victims.

- Affiant has spoken to Dr. Howenstine and Jeff Nye of the MSP Crime Lab in Lansing, Michigan, Affiant was thereby informed that the clothing of the four children had been recently examined again and that additional trace evidence had been obtained. Two human hair fragments and one animal hair were found on the clothing of Kristine Mihelich. White animal hairs were found on the coat of Mark Stebbins. White animal hairs were found on the clothing of Timothy King.
- Affiant was informed by MSP Crime Lab specialist Heather Vitta that even after nearly thirty years, that trace evidence such as human or animal hair, carpet fibers and blood or DNA residue can be recovered from a house by searching in the air ducts, under baseboards or moldings or flooring, and that this evidence can be tested for comparisons with other samples. Affiant was also told that if a person or child bled through carpeting or flooring, it is possible that detectable amounts of DNA could be recovered from that blood.
- Affiant further states that based on the above information, that there is probable cause to believe that seizure of trace evidence including human or animal hair, carpet fibers and blood or DNA residue from the premises at 3310 Morningview Terrace in Bloomfield Township, to be compared with evidence preserved and retained from the bodies and clothing of Mark Stebbins, Jill Robinson, Kristine Mihelich and Timothy King, is relevant and necessary to the continuing investigation of their abductions and murders.
- Affiant further requests that pursuant to MCL 780.651, that the search warrant, affidavit and tabulation be suppressed. Affiant states that officers are continuing to contact persons who may have knowledge regarding the suspects being investigated, and that disclosure of the direction of the investigation may negatively affect those interviews. Affiant further believes that disclosure of the facts in the affidavit, or that a search warrant is being executed in furtherance of the Oakland County Child Killer investigation, is likely to negatively impact the right of privacy of the present owners and occupants of the dwelling. Affiant's belief is based on the extent of television and newspaper reports that have resulted from previous disclosures of information when facts relating to new leads in the investigation have been disclosed.

- Retired Detective Parks does NOT have information linking Lamb to the property.
- "Hockey stick" stripe differences observed: The original witness described the Gremlin as blue with a white "hockey Stick" stripe. Our recovered piece is a "GREMLIN X". Some research of the changes in the striping for the Gremlin X is shown below in photos. From what it looks like on our scrap piece, it is hard to verify if the stripe kicks up over the wheel like the 1973 or is straight across like the 1971. (A review of the 1973 Gremlin catalog showed the "Gremlin X" came out in 1971 with the pinstripe as seen in the photo below. In 1973, the X model changed the pinstripe to include a "kick" up over the rear wheel well. However neither model as the "face of the hockey stick", it is just a stripe. The 1975 Gremlin does have the "hockey stick") When comparing to the photos, it appears that it is a 1971 Gremlin X.
- Significant information from Gremlin files:

The following Gremlins were registered to Grand Blanc. Of these, Auto Vest jumps out as SABO had "Action Auto", however unknown if related.

. When running these names and addresses in the tip files, the following was most significant:

Last name of Bunker: A Harold Bunker was at the Timothy King drop site in a 2 door Lincoln. Unknown if relation to Anne Bunker. (A lot of people visited the drop site)

Last name of Babbish: A "James" Babbish was found on tips #281 and #16198. It is unknown if this is the "J" Babbish listed above. These tips were found to have been called in by Officer James Babbish of the Oak Park Police Department and do not seem related.

· Significant information from review of tip files:

When running the ALLMON name (previous owner of property was John W. Allmon and Neddie M. Allmon), tip # 13556 was located on a "John Allmon" owning a 1974 Gremlin

This was called in on Feb 7, 1978 on Allmon, John Belleville, MI () owning a Blue '74 Gremlin TTN 967. He was a Custodian at Ypsi Schools. The reason for the tip was "look alike". Allmon reported he got the car in the summer of 1977. Allmon did not fit the suspect description at the time. The vehicle was reported to have been on the verge of falling apart.

For the 1971 model year the "X" appearance/equipment <u>trim package</u> was introduced as a \$300 option on the 4-passenger model and "proved extremely popular." It included body side tape stripes, body color front fascia, slotted road wheels with Goodyear Polyglas D70x14 tires, blackout grille insert, bucket seats, and "X" decals.

The 2-passenger Gremlin version entered into its second and final season. The 232 cu in (3.8 L) I6 engine that was optional for 1970 became standard, while a longer-stroke 258 cu in (4.2 L) version became the option. Compression ratios dropped from 8.5:1 to 8:1 for 1971, resulting in 135 hp (101 kW; 137 PS) (gross) from the 232 cu in (3.8 L) and 150 hp (112 kW; 152 PS) (gross) from the 258 cu in (4.2 L)^[28]

1971 Gremlin prices increased slightly (up by \$20 to \$1,899 for the base model), $^{[27]}$ and sales for this first full model year rose to 53,480. $^{[29]}$

For the 1973 model year, AMC strengthened bumpers able to withstand a 5-mile-per-hour (8 km/h) impact in the front and a 2.5-mile-per-hour (4 km/h) impact in the rear, to meet new safety mandates by the U.S. National Highway Traffic Safety Administration (NHTSA). Optional was a Levi's interior trim package, which included spun nylon upholstery made to look like denim (fire safety regulations prohibited the use of real cotton denim). Details included removable map pockets, burnished copper denim rivets, and red Levi's logo tabs. Rear-seat legroom was increased. The X package received a new tape-striping pattern that kicked up over the Gremlin's rear wheel flares

The Arab Oil Embargo of October 1973 came just as the 1974 model year began. AMC improved the Gremlin's back seat. A deeper front fascia made the car appear longer. A larger front bumper was mounted on self-restoring telescoping gas and oil cylinders. Unlike most other designs, the Gremlin did not use filler panel between bumper and body. A stronger rear bumper was set lower - front and rear passenger car bumpers were now required by NHTSA to have uniform heights, take angle impacts, and sustain 5-mile-per-hour (8 km/h) impacts with no damage. The rear fascia was modified slightly to blend with the design changes. The Gremlin X stripe pattern was given a "hockey stick" look for 1974: the stripes followed the window line as it tapered aft, and swept up now to include four diagonal lines on the wide C-pillar. A new typeface for nameplates was used by AMC for 1974, including on the Gremlin. With the car's 1974 model year extended into November to delay the need to install catalytic converters required by United States Environmental Protection Agency (EPA) 2004 regulations starting with 1975 models, AMC sold 171,128 1974 Gremlins, an increase of nearly 40% over 1973 and 130% over 1971


