Investigator Tullock,

Let me first begin by expressing how surprised I was to hear from your office, as I was completely dismissed by your department in 2007 after two weeks of emails so to hear from you out of the blue was incredibly surprising. I also have to state that I am more than curious as to why now? The skeptic in me wonders if it doesn't have to do with the pending \$100 million dollar lawsuit brought forward by the parents of the murdered four children, but I will put that aside and do what you asked me to do and detail the reasons why I believe events surrounding satanic killings and my family in Omaha are connected to the four ritually murdered children you have on your books in Oakland, Michigan. However, I should warn you that, because I am concerned that this is just going to end up in some file somewhere- by the time this letter reaches you I will have already posted it on my blog at <http://www.DavidShurter.com> and shared it with others. I want to make it clear from the very beginning that I am not doing this so that you can cover your butts with some lawsuit- but rather because I think that these situations are not only connected, but they also need to be exposed.

First of all- my father had close ties with Michigan. Growing up in Niles, Michigan- my father's family basically owned the town of Cassopolis- as our last name was not Shurter but Rathbens-(not sure of the spelling). My great uncle Phil- who lived in Cassopolis- was the man who first inducted my father and his younger brother into the cult- just as my father tried to induct me later on. As strange as it sounds- this connection to Satanism in my family has been generational, but as far as my father and his family are concerned- much of our background originated in Michigan.

You asked about the significance of lunar cycles and killings- and what you need to understand is that these cycles are incredibly important to Satanists- and the killings happened around "holidays" that Satanists adhere too. Just so we are clear- these are the dates of your murdered children... Mark Stebbins-Feb.15th 1976-----Jill Robinsion Dec.22,1976-----Kris Mchilich Jan,2 1977-----Tim King, March 16th,1977. Each one of these coincides with a time when I KNOW that things were hot and heavy in Omaha. Let me explain.

In my book Rabbit Hole: A Satanic Ritual Abuse Survivor's Story-(which I am sending you along with this letter), I talk about a man who came in search of his missing daughter- A man that I was forced to murder when I was ten, which just happened to be in 1976. By this time, my family was basically on the run- moving first to Fremont to escape the problems that were being presented at the time of child disappearances and murders of a ritual nature that were happening in Omaha at the time, and then to Graettinger Iowa after my family murdered the man in our basement. I detail the events in my past in the book, however, I want to make it clear that this whole child trafficking and cult activity had been going on for quite some time before I ever came along- and actually- from my research, has been going on a lot longer than I ever expected. Here in Omaha- everything publically is connected to a failed savings and loan called Franklin Credit and the events that came out from that- but the truth is, there had been serious rumblings for over a decade before- and Franklin was actually



Mysterious 'Bob' is back with a news conference today about Oakland County Child Killer

"Bob" is back.

The man who says he knows the true identity of the Oakland County Child Killer -- believed to have murdered four children in 1976-77 -- is announcing his fourth news conference since May today.

It's unlikely Bob will be there since he hasn't shown up at past news conferences, although he once spoke to reporters via speaker phone. He refuses to reveal his real name or any other details.

The secretive man has been calling reporters and law enforcement officials for years to say -- without providing evidence -- that the children killed by the Oakland County Child Killer were victims of wiccans, cult activity, a killer motivated by the lunar calendar or perhaps a Shakespearean poem.

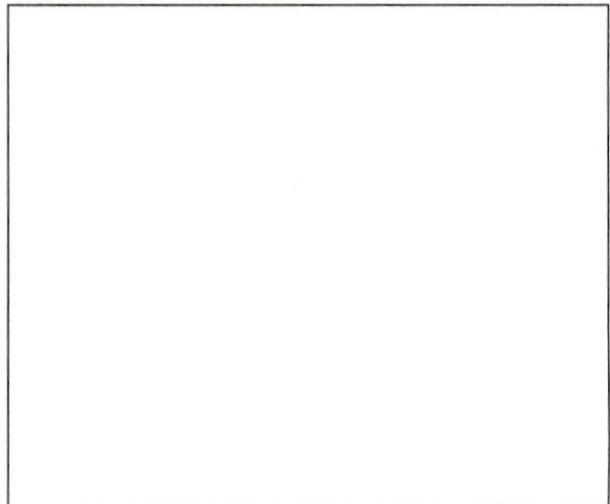
At today's news conference, Detroit attorney Paul Hughes, who works closely with Bob, is expected to announce that Bob believes the deaths of the children can be linked to other deaths in and out of Michigan.

Hughes promised to send, via e-mail to Detroit news media outlets, a list of sites so they can "make arrangements with their affiliates and schedule support staff to obtain photographs and video footage" for their upcoming stories on Bob's latest revelations.

The Free Press is not invited to today's event. Hughes told the Free Press by e-mail last week that "we are working with news sources of our choice." Hughes represents Deborah Jarvis, whose daughter Kristine Mihelich, 10, was killed in 1977. Hughes filed a federal lawsuit on behalf of Jarvis in April, alleging a massive 36-year conspiracy among the Oakland County Prosecutor's Office, Oakland County Sheriff's Office and Michigan State Police to cover up the identity of the killer.

Jarvis, who has attended Hughes' press conferences in the past, hired him after Bob began calling her to say he had crucial information that could lead to her daughter's killer. She has said she has spoken to Bob hundreds of times, but

doesn't know who he is. She hired Hughes on Bob's recommendation.

Jarvis confirmed she has exhausted her life savings and maxed out her credit cards to pay for Hughes' representation. She declined to discuss the amount she paid or to comment further when contacted last week.

Hughes also previously said he didn't know Bob's identity. He would not answer specific questions sent by the Free Press via e-mail last week, including how much Jarvis has paid him or whether Bob had received any of Jarvis' money.

"Ms. Jarvis and I have acknowledged from the beginning that she has used some of her funds to pay for costs of the lawsuit. There is nothing illegal or unethical about that, and I am sure you know that," Hughes wrote. "Beyond that, I take offense with regard to your remarks of 'finder's fees' which are clearly illegal and would not be conduct I would take part in."

Bob, who portrays himself as connected with high-ranking law enforcement, contacted the Free Press in August. He said the current police task force investigating the killings cannot be trusted, and the investigation should be turned over to the U.S. Justice Department.

Hughes' lawsuit seeks \$100 million and relies heavily on Bob's claims, including a sworn declaration. Signed simply "Bob," it details the alleged conspiracy and is attached as a court record.

The suit names Oakland County Prosecutor Jessica Cooper, Oakland County Sheriff Michael Bouchard, some of their staff, and several State Police investigators. The case is assigned to U.S. District Judge Denise Page Hood.

Oakland County attorneys have put Hughes on notice -- through court filings -- that they intend to seek sanctions and court costs, should the judge find the suit frivolous. Hood is expected to issue a ruling within weeks.

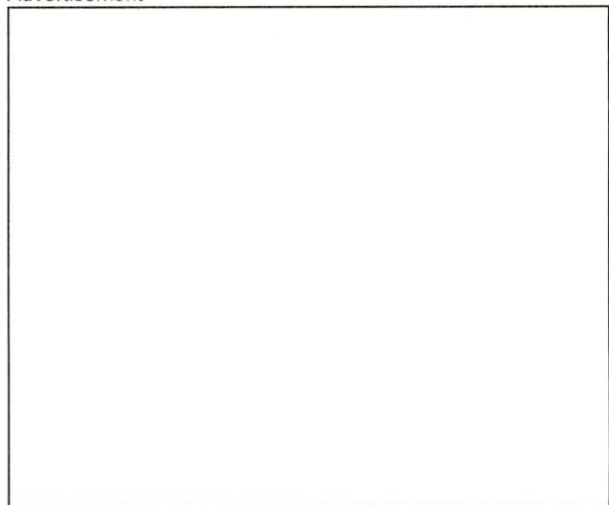
Cooper, the target of criticism in many of Bob's news releases sent via Hughes, said she doesn't believe Bob is credible.

"Really, our concern is that he does not appear to be stable," she said.

Prominent attorneys who practice in federal court said using an anonymous person for a sworn statement is unheard of. They predicted the suit would fail.

"That's so whack-a-doodle that nobody

who practices law in the circles I do would ever try that," said Deborah Gordon, a Bloomfield Hills attorney who has successfully sued several governmental agencies in federal court. "It's a joke."

Attorney Robert Harrison, who practices in federal court, said he has never heard of such a thing.

"It certainly is inadequate to establish a standard for a good-faith argument that the action is legitimate," he said, "because without the declarant's identity disclosed, there is no way anybody could challenge the accuracy of the statement."
