

My bother also had a friend of mine killed, but they couldn't prove it because the guy who killed her refuse to tell where the body was.My friend was a black girl.The guy who killed her had told her about my bother. Said they were friends and my bother wanted to destroy my life. James passes hisself off as apreacher. He told the guy that my friend and I were Jezebels and needed to be destroyed in the eyes of God. James Rukkila moves constantly. He has resided in Florida, where he abused his wife and kids. He resided in Oak Park Mich., Detroit Michigan where he married a canadian girl and abuse her and her daudhter and stalked them after divorce, forcing them to move. He married other women and abusaed them to and stalked and threatened them, harassaed them after divorce. He has caused fraud on churches from Michigan to Virginia and Tenn. He has tracked me down from state to state. The local authorities will not help. My niece is terrified and afraid daily, because she sees him following her and calls out her name. 

Emmanuel's History

<u>1950</u> – In September 1950, Bethlehem Lutheran Church Extension began Sunday school and Worship services in Coffey School in Detroit, with Rev. Henry L. Aukee as interim pastor.

1951 – In the fall of 1951 Pastor Melvin E. Hagelberg began work as Mission Developer. Services moved to Emerson School in Detroit and a parsonage was purchased. The Northwest Mission was organized.

<u>1953</u> – Dec.13, Northwest Emmanuel Evangelical Lutheran Church was organized with a charter membership of 295 adults; Pastor Melvin E. Hagelberg called as Emmanuel's first pastor.

1956 – July 10, ground-breaking for a new church building in Southfield.

<u>1957</u> - June 16, first worship service in new church building; a dedication service was held on Oct. 17th.

1958 - June, hosted National Suomi Synod Convention

1962 – Emmanuel joined the LCA and dropped "Northwest" from its name.

<u>1965</u> – February 7, Rev. Donald W. Muehlnickel called to be Emmanuel's second pastor. The parsonage in Detroit was sold and a new parsonage was built on Plum Hollow Street. A pipe organ, audio system and new room dividers for the fellowship hall were purchased and installed.

The chancel was renovated and the parking lot was paved.

1967 – May 21, new parsonage dedicated.

<u>1968</u> – Pastor William A. Graf served as Vicar at Emmanuel. Under his leadership a strong youth program was developed.

1971 – February 14, new Wick pipe organ dedicated.

1973 – Major remodeling and renovation program completed.

- 1976 October 10, Rev. L. Alden Erlandson called to be Emmanuel's third pastor.
- 1978 Silver Anniversary Celebration.
- <u>1986</u> Emmanuel enters the "Computer Age", using a computer for church membership and financial records.
- 1988 35th Anniversary Celebration.
- 1989 Emmanuel becomes part of the E.L.C.A.
- 1991 July 14, Rev. Roland C. Troike, Jr. called to be Emmanuel's fourth pastor.
- 1995 Emmanuel enters the Stephen Ministry program.
- 1996 Elevator dedicated.
- 2000 Summer Pastor Troike's sabbatical.

Handicap bathroom constructed.

- 2002 Peace Garden dedicated.
- 2003 June 8, 2003 Dedication of new Hand bells.
- 50th Anniversary Celebration.
- July, 2003 Rev. Troike takes a call and goes to St. Peter's in St. Claire, MI.
- Rev. John Freed comes to serve as supply pastor until the end of the year.
- 2004 Rev. Michael Rothgery, interim pastor from January 2004 June 2005.
- 2005 Pastor David O. Maddox II arrives as our 5th pastor, June 27, 2005.

His installation service is held on July 17, 2005.

Established a ministry for the residents living at the Fountains of Southfield.

The food pantry to assist the needy was revitalized.

Holy Communion began to be administered every Sunday.

2006 – Nursery- Multi-purpose room constructed by John and Craig Moilanen Families and crew

Front steps to the church are repaired.

- 2007 October, new hymnals arrive.
- <u>2008</u> The Community Garden is established in cooperation with the Southfield Garden Club.
- <u>2010</u> April 18, 2010 With many tearful goodbyes, Pastor David O. Maddox II leaves Emmanuel for a new call in his hometown of Philadelphia, PA. We once again begin the process of searching for a new pastor.

June 2010 - Pastor Dellis W. Hudson joins us as Interim Pastor

December 2010 - The Kitchen floor is retiled for the first time since the building was built.

2011 - May 2011 Pastor Dellis W. Hudson leave us as Interim Pastor

December 2011 – Christmas Caroling to the shut-ins resumes after many years.

2012 - More to come...

The Case (Mark Stebbins)

This case would officially start with a boy named Mark Stebbins. Mark from all accounts was a likeable 12 year old in the seventh grade, who had lived with his mother Ruth Stebbins after his parents had split up when he was 5, and when he grew up, young Mark had his sites set on becoming a Marine. The last time he would ever see his Mother, would be around 12:25 in the afternoon on Feb. 15, 1976 at The American Legion Hall on 9 mile and Livernois in Ferndale. It was a party for Ruth and her co-workers, and at the time there was a pool tournament going on. According to Ruth, Mark had asked her for money to go to the local hobby shop, to which she said "no" because he had already been given his allowance. The little boy didn't seem mad, or even upset by this. He just simply said "okay", and that he had wanted to go home to watch a movie. So Ruth said goodbye to her son and expected to see him at home later. Mark then set out on his short three block walk home. Later in the day at around 7:15 Ruth called home to check on Mark, but there had been no answer. It appeared Mark wasn't home. When Ruth arrived at the house a little before 9:00 p.m. Mark still wasn't there. Alarmed by this Ruth decided that she'd wait one more hour and then call the police. Mark it would seem was missing for about 10 hours, so Ruth finally called the police. "We haven't had any kidnappings in Ferndale in 10 years," said the police. They just assumed maybe he was out with friends or possibly a run away, and would likely turn up soon.

With Mark not turning up, the police began searching abandoned buildings and searching around every conceivable location. According to Ruth she stayed up all night laying awake the night mark dissappeared. "I kept hearing noises and thinking it was Mark, and the next few days I set three places at the table in the hope that he'd come home."

Four days later at just before noon on February 19, at a parking lot, Mark was found dead, his body placed there, curled-up as if he were sleeping near a dumpster in the parking lot of an office building

in Oak Park (some reports claim Ten Mile Road and Greenfield in Southfield, Greenfield is the boundary between the two cities). It appeared he had only been dead for less than 8 hours. Police at the scene noticed bruising and wounds indicating Mark had been beaten and tied up. He was probably held for some time in the trunk of a car. The exact manner of death is often reported differently, but some reports stated that there appeared to be a ligature wound around the small boy's throat. Indicating he had likely been strangled to death.(Although newspaper accounts at the time reported two different versions of his death. In most versions it states that mark had been smothered.) The boy had also been molested by his killer. Mark had been washed clean by his killer, and nails manicured, so no evidence would be left under the fingernails. His clothes were washed, dried, pressed. Then he was redressed, his shoes put back on, his coat zipped back up, and even his hood pulled up over his head on his jacket. He was then tenderly placed at the dump site in the sleeping position. Because of this the killer would earn the nickname "The Babysitter".

At this point Ferndale police were involved due to the missing person's report, and now the Southfield police were part of this murder. An error in retrospect by police soon followed when Southfield police moved Mark's body before the county medical examiner had even had the chance to arrive at the scene. Mark's body had been taken to the Southfield Police Department, rather than directly to the morgue. Police then removed Mark's clothing before he was sent to the morgue, which likely contaminated and destroyed any evidence in the process. The police with the help of local psychiatrist Bruce Danto, quickly went back to the dump site, and placed a child-sized manikin dressed as Mark was at the drop-off site in an attempt to lure the killer back to the scene. Because of shoddy police work no real evidence could be recovered in this crime. Before forensics could even get to the crime scene Mark's body had already been taken to the morgue and stripped of clothes destroying any possible evidence left behind.

After Mark's funeral, at the exact spot where Mark had been placed, the police would find a funeral card from Mark's service. Possibly left there by the killer as a taunt, suggesting he was at Mark's funeral. "I didn't recognize everyone who came," stated Ruth Stebbins. "I might even have shaken hands with the killer." After all this Mark's 17 year old brother Michael stopped studying, and started using drugs and alcohol, and had a run in with the law. Ruth was too distraught to work, and soon found herself depending on welfare, and taking Valium from time to time. To this day every time Ruth hears about a child's death it brings back memories of Mark. "Every time a child has been killed since Mark, it happens to me all over. I still think about it every day." Mark's case quickly went unsolved, although it was felt at the time that Mark's killer had been driven to commit this murder with the recent spat of homicides in the area (Cynthia Cadieux and Sheila Shrock). Possibly as a grab for attention in the media.
