01 Report of Interview with Chris Varchola. Chris Varchola currently
02 lives at [REDACTED] She was
03 contacted at her parents house [REDACTED]
04 [REDACTED] Chris was the person who made the initial tip on [REDACTED]
05 [REDACTED]. That tip was received by the Task Force on June 17,
06 1977.

08 In that tip, she said that [REDACTED] was a homosexual, very
09 nervous and shaky about police. He was often seen near the
10 Woodward and Chester area. He had followed her (the informant) on
11 different occasions. He did work as a cook at Biff's at Maple and
12 Telegraph and was fired 2 months ago. Now he works where he seems
13 to have plenty of money. He is also a friend of the weekend night
14 manager. He quit about 2 months ago. The friend has worn a ring
15 with satan on it and claimed he worships satan.

17 I asked Chris to explain her relationship to [REDACTED], who she called
18 [REDACTED]. She noted that the family calls him [REDACTED]. She said that
19 when she was about 18 or 19 years old, she dated [REDACTED], who was then
20 about 28 years old. They met at Biff's at Maple and Telegraph,
21 where [REDACTED] had a job cooking. [REDACTED] drove a blue and white
22 Thunderbird, which she described as an old classic model. She said
23 that he also had a Volkswagen Beetle that she thought was orange in
24 color. They dated for less than a year. Though she couldn't put
25 a specific date on it, she believes it was from probably April or
26 May of 1976 through the early winter of 1977. She basis this on
27 the fact that she turned 19 in February of 1977 and she was not

02 dating [REDACTED] at the time. She said she primarily turned the tip in
03 because the composite pictures looked like [REDACTED] at the time. I
04 reviewed the details of the tip with her and she said she can't
05 recall explaining the tip, in that, she doesn't recall that [REDACTED]
06 ever followed her on different occasions, like the tip says. She
07 also can't recall the night manager or the friend with the satan
08 ring on it. What she does recall, she says, is that she was at a
09 party once with [REDACTED] in Royal Oak. This was a house party put on
10 by one of [REDACTED] friends. She doesn't know who it is. At that
11 party she was approached by a friend of [REDACTED] with a mustache, who
12 told her that she looked like a singer named Steve Tyler from the
13 band Arrow Smith. Later on in the conversation, she can't remember
14 how it came up, she recalls him saying "It's not their fault they
15 reminded me of my ex-wife." From those two comments, and her
16 knowledge of the song by the band Arrow Smith, the song had the
17 phrase "Children of the season." She believed that [REDACTED] and the
18 guy with the mustache might be involved in the Oakland County child
19 killings together. She said she couldn't recall why she didn't
20 turn that tip into the Task Force, instead of the one that she did
21 that she says is not true. She said she dated [REDACTED] prior to
22 calling the tip in and when she called the tip in, she was not
23 dating him anymore. The only place [REDACTED] took her other than to
24 this house party when they were going out together was his car,
25 she said they went parking or back to his house on [REDACTED]. She
26 said [REDACTED] was the address where they went into his bedroom.
27
28 She said that she doesn't recall if [REDACTED] every drank alcohol. She
