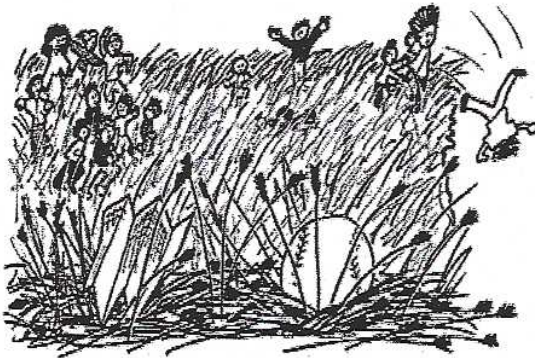

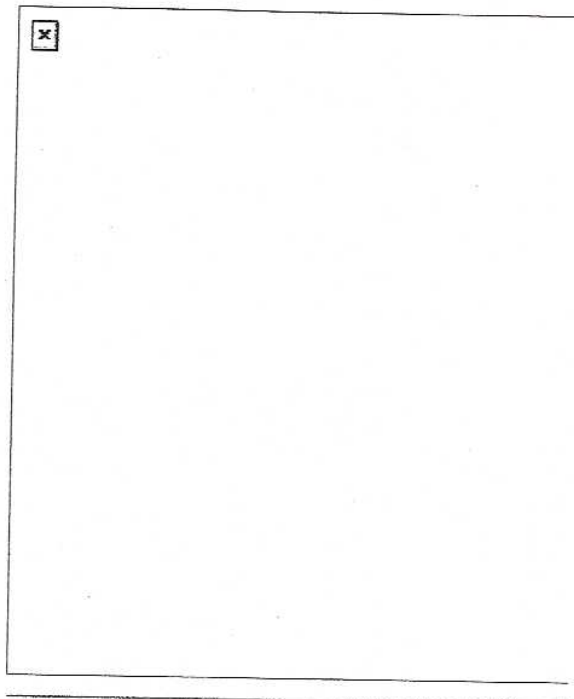

#### TESTIMONY by HELEN DAGNER ~ MARCH 2001

During the winter months of 1976-77, four children between the ages of 4 to 12 were abducted and killed in towns in and around Oakland County, suburban area north of Detroit. Authorities said the children were held from 4 to 19 days before being killed. They had all been bathed after being abducted, thus earning the offender the nickname the "BABYSITTER"



#### VICTIMS:

- Mark Stebbins, 12 of Ferndale was last seen alive in an American Legion Hall on February 13, 1976. His body was found February 19, 1976 in a parking lot in Southfield. He was strangled and sexually assaulted, with a mortem, with an object.
- Jill Robinson, 12 of Royal Oak ran away from her home December 2, 1976. Her body was found December 26, 1976 dumped along the side of an interstate in Troy. She was killed by a single shotgun blast to the face. She was fully clothed and still wearing her backpack when she was found.
- Kristine Mihelich, 10 was last seen alive January 2, 1977 at 3p.m. at an Eleven store in Berkley. Her fully clothed body was found 19 days later.

- Timothy King, 11 was last seen in a Birmingham parking lot March 16, 1977 around 8:30 p.m. His body was found March 22, 1977 in a shallow grave in Livonia. He had been suffocated and sexually assaulted post-mortem.

Now who would do such a horrible crime, and why?...Could it be a home to a person?

Yes, John lived in Birmingham, attended school, and graduated from High School in Birmingham...and when he worked, it was also in Oakland County...

Why did he do this? When I first met John, I didn't know he was a killer, this was September 1991, and although I was married to a police officer, I didn't even know that four children had been murdered in Oakland County...

I had met John for coffee at a restaurant...it was by invitation, the mother of his child, had asked me if I wanted to meet John, I always went for coffee at that time of day, so I said sure...little did I know what was to become of this meeting.

The first question John asked me was so what are you doing with your life...why I said this I will never know...but I said it...oh I'm going to write a book on serial killers...he said that is a horrible idea, how could you stand to be around someone like that? I remember saying, "I'm not judgmental". We weren't through with the first cup of coffee, when he asked what I knew about the Oakland child killings, I said nothing, what do you know? The first thing he told me was the guy really took good care of the children...fed them their favorite foods...cleaned them all up...and was very nice to them. I said, "Well why did he kill them?" John said he was saving them from a life as he knew it...that he was probably living in what should have been a hell to do community, if his mother might have had to baby-sit to make ends meet...I said, "John it almost sounds like you know this guy!" He said well I was interviewed by the original task force...I ask how was that? His reply was they were interviewing every one in his age group... We continued talking...then he said would you like to go for coffee tonight, I could probably help you with your book... I said well what I really need to do is talk to a serial killer...we all laughed, and he said well maybe I can help you to find one.

This started a 9 month, daily coffee meeting with John, 3-6 hrs a day every day...

That night I ask John what he thought the killers motive was? He started by telling me, he felt the killer was inadequate socially, most likely couldn't get a girl friend and wound up doing odd jobs like washing dishes. He couldn't get a higher education felt he was cheated out of his rightful place in society...I realized, at some point in the conversation...John was no longer talking in the third person...he was talking in the first!

When I was driving John home that night, it started to snow, he was sitting in the front passenger seat, the head lights were cutting a beam in front of us...

John went into a trance like state and appear to be completely unaware of

anything I said to him or that he was even in the car going down the road...upon arriving at his apartment he seemed to smoothly shift out of the trance state...back to his normal self...the whole thing gave me the creeps.

I didn't know at this time that I would see this same thing ...every time I was with John, driving down the road, when it started to snow...It was at least 3 weeks before I realized John was reliving the body drop off nights...once I had this realization...I started asking more questions.

He was now talking in the first person...he thought his father had money because he owned 2 homes, but let the family struggle financially, he attended and all boys Catholic school, which made him feel more out of place-something happen at that school, a boy was found dead, and there were rumors of sexual assault, as John told me about this, I felt he had been sexually assaulted...also a boy that was his friend fell off a water tower to his death, John was present when it happen...my thought at the time was

John pushed him...he didn't go to the funeral...but his family did.

Just prior to the first murder, John's first girl friend, that he had hoped to marry, dumped him-because he was broke, with no prospects....It was that he stared thinking more about the injustices social & financial class system and how he was a victim of it all-

He wanted to cause the upper class deep and permanent pain, he decided that since money could be replaced the only way to do it was to strike at their children, besides this was something he could do, were as taking their money was beyond his ability...each killing gave him a sense of power and significance and intellectual superiority...yet some how he felt he was saving the children...

At the time of the murders, John was writing a book on the economic collapse, and causing a major depression, ruining the upper class...bringing them down to his level...he was still working on the book when I last saw him.

We talked about the murders everyday...a very few words were ever spoken that didn't included the Oakland County child killings...then one night when we were having coffee I told John I was having difficulty...not having ever been to Oakland County...figuring out the body drop off sites...he took 4 place-mats...and drew the areas...I had never seen anyone draw map like that...they were perfect...just like a store bought map...I was impressed...the next day is when I called the Birmingham police and told them they had to see these maps...and they had to talk to John as he seem to have a lot of inside info.

I remember their telling me, they would have to have more info...so that night at coffee I told John, I don't think you are the killer and you need to give me some information about each one of the kids that only the killer ..and the police...and the family would know...he said are you nuts? When he realized I was going to leave...or he thought I was thinking less of him...he said, "I put a chicken bone in Tim's pocket" I told him I thought I had heard that before, then he said

"Kristine had little orange or pink things on her slack's...Jill had a book in her back pack and a quarter in her pocket."

One of the boys he dropped off with no shoes...he ended up telling me 300 plus matches to the crimes...then the police came up...he took 2 polygraph's...showed them a pass port were he was out of the country at the death of one child...and they let him walk...

I told them John's passport was a fake...that he had wanted to go into the second pass port business...but they just couldn't get be on the pass port. I remember when they called me, late one night at my daughters...he's not are man Helen...I couldn't believe what he was saying...when they mention

the pass port...I asked if they had someone who knew about these things, to check it out...they said no...I then asked, did you ask him where he stayed aboard? No....did you ask him where he ate, who he talked to. NO....well did you check with INTER-POL, yes...but they couldn't confirm...

I remember thinking...COP'S!!! In fact, I said it a loud...my daughter, a detective, just looked at me...the next day I called Mr. Robinson, in fact John had given me his number, I came right out and told him the name of the book in his daughters back pack...the next day Det. Anger and some other officer came up to Alpena.. I gave them a sample of John's hair and a note book of facts, we drove by John's apartment.

They took some photos...I gave them a photo of John...I didn't realize Det. Anger, had his own suspect...David Norberg...who's body he would exhum some 8 years later, trying to match his DNA, to a hair found on Tim...so many years had gone by, but when I read where the DNA didn't match...I had to call Anger again and ask him if John's hair had matched...he didn't even remember my giving it to him...he still works with Jerry Tobias on the case...but he will probably go to his grave...thinking Norberg is the man....but I know better, no child would have gone with Norberg, as he always smelled of liquer. He couldn't feed him self...much less the children, and he certainly wouldn't of bathed the children...and he had nowhere to keep them for the length of time they were held.

8 years after he died, his wife shows up with a necklace...with Kristine's name on it...that was suppose to have been in his personal stuff...it may have been...but it took 8 years to find...when the man didn't own a shoe box full of stuff...besides, I already had met the killer...and yes a child would have gone with John...3 weeks ago Tobias told me yes we have to talk to John. So the next day, I called Det. Anger...

I thought well if there going to talk to John, I will give them some of my hold back info...he was to busy to talk...was on his way out of the office...when he didn't return my call...I realized it was the old smoke-and mirrors game again. No one was in search of a child killer, at least no one I knew.

Somewhere, would I find these people in Oakland County who were still alight with public outcry over the seemingly never ending spate of murders


It's been 25 years....I decided I would join a Coldcase group on the internet...I started receiving 25-50 e-mails a day wanting to know about this case. It was then I thought I would e-mail the attorney generals office, and the FBI, and ask every one else to do the same...so that is were it is at on this 24 of March 2001.

#### UPDATE....DECEMBER 2002

Received MORE interesting info. We have lots of info that we cannot post on a public web-site at this time. But make no mistake....things are still very active.

I have found that Helen was very correct in her statement that she received no feedback on her tip. I have experienced the same...but I know they are aware of this info.

The old site meter shows and records it VERY CLEARLY. IF this has been reviewed and ruled out.....why won't anyone let us know?? I've never had

ANY problem ANYWHERE else getting feedback from officials.

**UPDATE: January 13, 2003:**

Although I have never received any kind of reply from any local government official, I must admit I DID hear from a Detroit area Federal Agent about this matter at the end quarter of 2002. His words confirmed MANY things to me. Most importantly the fact that they local government INDEED are full aware of this information. This site does not yet give full details to all of the available data. But I have to ask....ever wonder what happened to the killer?? Did he just stop killing...or move out of the area?

There is something wrong with this investigation- which is to say....that there is very much in the way of evidence that adds up, but authorities seem unable or unwilling to do the math and arrive at the one conclusion that makes sense...

I have been involved in this case for 13 years now and as recently as

yesterday Police are still sitting pat...on the same old  
investigation...same suspects...

Now I ask- if Norbergs DNA didn't match, after his body was exhumed...and he had no were to hold the children- and there are absolutely no matches to him and the crimes, then WHY? Are the cops not moving on...then we have another police dept...that still think Larry Allen Smith a convicted pedophile, who is in the Az state prison until 2025 and has been there since 1986 for molesting young girls...must be the one...however his DNA did not match either....and can anyone tell me if they know of any case-anywhere-in which a pedophile..who molested young girls-has ever kept the 4-19 days-bathed them-fed them-killed them-dumped them-but never had sex with them...so why are they not moving on??..and how is it possible for the authorities to continue misinforming the press for over 25 years-

yep I received a letter from a Detroit free press reporter, who has been on this story from day one and he was told -all the info John gave me was either-not true or was available in the news media- he however could not find it anywhere- so if any person in authority can show me were the following was printed- I will concede/

Kristine had orange-ish pink appliques on her slacks and was laid down with her jacket open---and how do I know this to be fact---the police grilled me on this...then taped what I said...and then showed me her drop off photo...and guess what -It was exactly as John said...so if there was no other info...that in it self would be a CLUE...John also told me he picked her up by a bowling ally-

What about the map's,like myself..I'm sure the readers of this site-will find it more than a little strange-that when I met John,it was 15 years after the killings,and not only was he able to draw extremely detailed maps of each drop off site-he also remembered all their names,ages,addresses,schools..ect.ect.--What goes far beyond the realms of strangeness or improbability...is why would John hide a manicure-pedicure set in a shoe-box office..up behind a drawer on a ledge..when he had a large apt.,with not much more than his books in it...was it because it was his souvenir??...after all the children had been freshly manicured-the set was inside a 1970's brocade fabric case.

→ ..and why would John tell me there was NO -blue gremlin...and why would John have a collection of books about latent prints..how to pass a polygraph-how to change your identity,with out leaving a paper trail--and many books on forensics...and how would he know Jill's book was inscribed????-John had motive-means and opportunity-In checking a perpetual calander,he was off work or unemployed on the dates of every pick up,murders,and drop off--How could he have a passport that showed he was out of the country on the date of one child's death?..because he had two of them-i saw them..and he told me one was fake-and then there were the letters,were he ordered the passport-and was going to go into the 2nd passport business.

Then there is his alibi..his brother?I think they should ask ,the brother if he will take a polygraph ...or what about the sister,that called John before he went for the poly-and said-get out of there...before they find out the family secret...maybe she would take one too...about her knowledge of these events...or what about his mom--who told me she babysitted for John in the 70's...John had NO children at that time.....there's MORE

**UPDATE February 1st:**

We've heard from many people even Jerry Tobias himself. As well as Det. Wurtz at the Oakland County S.O. And an odd assortment of "concerned" people...with odd questions. As well as many questions from citizens that continue to come in.

Have also been in touch with LOCAL MEDIA...WXYZ. Hope to hear something very soon.

I have lots of letters as well as some from a Federal Agent in the area describing HIS OWN interpretation of what the problem REALLY is. I have so far withheld that information publicly as it is my desire to do the right thing in this case.

I cannot prove Helen's tip is a valid tip....no way to prove anything from someone else's point of view. But I KNOW what I personally have experienced

I DID write a letter FULLY disclosing my information to state Senators on January 9th. I suspect that was the catalyst that finally pushed local officials to respond. I WILL post that info IF and WHEN I can.

I am trying my very best to cooperate fully and do the right thing in this case. Very UNSURE of what the right things IS...or who to trust!

Is there any record of Helen giving someone the hair?? If so....where is it?? Has it been compared and ruled out? Can't they compare it to whatever they were going to compare to Norberg?? Evidentially they have something to compare to....or they would not have exhumed him.

Can anyone tell me...is there a record of Helen giving a sample of John's hair to a Detective?

If so...was it compared to other evidence?? Was this the reason that John was ruled out 4 times?

Was this drug used in the murder of these children?? In Helen's notes it is mentioned she found a half full glass vial of this drug at her suspect's home.

In further research of this drug I found interesting info. The drug has a warning that cause "CARDIAC ARREST IN CHILDREN AND ADOLESCENT PATIENTS RECEIVING SUCCINYLCHOLINE"

Just one of many reasons that I would like to see Helen fully questioned by officials to wonder if there were traces of this drug found during autopsy?

**UPDATE: March 22, 2003:**

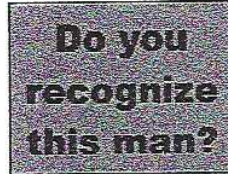
Succinylcholine, a powerful muscle relaxant that causes a person to stop breathing and respiratory arrest. The drug typically is used before inserting a breathing tube for surgery.

Without the insertion of the breathing tube, the drug can kill anyone. In particular, as the drug has been also linked to cardiac arrest as well. Cardiac arrest follows as a result of Hyperkalemia.

Hyperkalemia is a condition caused by higher than normal levels of potassium in the bloodstream. Cardiac arrest (absent heartbeat) may occur at any time during treatment of hyperkalemia. The risk of hyperkalemia in these patients increases over time and peaks at 7 to 10 days after the injury.

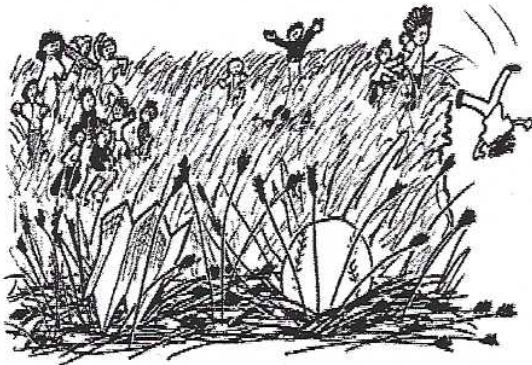

The time frames are similar.

Like yourself being only 50 % convinced.....still enough to pursue.

I slacked off this case for many reasons. Distance, lack of local interest..etc...

I even became convinced that the locals must have ruled this out as possibility as I could not imagine a good tip would go unchecked. Think that maybe ruled it out....but simply were too rude to let me know. And that was OK by me....as long as they knew the info.

And I know the local government has seen the site....one of the links on the page is connected to a site meter.

I initially left the site online....hoping that it would receive a tip that would allow me to generate a new interest in the case...just in case something was overlooked. And I do get mail from local citizens who remember the case. No tips...just support.

I just cannot in good conscious.....leave this to the side. I am more convinced than ever that no one has even looked into the tips.

I mentioned that I would continue to inform you of any updates to the case. I'm just at a loss of how to proceed right offhand. I do know that I must do something.

So as you can see.....Senators....I as well as Helen have tried desperately to pass along this information. We both do indeed realize even more now than ever that this is a chapter that many would like to forget. But it simply cannot into the past.

The REACTION of local officials is even more shocking than the TIP itself.

I know now that even if this tip....is not a valid tip....any actual tips that come in will likely never see the light of day.

The agent, I believe began with very good intentions.....only to be silenced later??? I have to wonder how much trouble he will be in fo trying to help and make a more secure place for the nations children? had rather suffer myself than to see him in trouble for his efforts.

If this is in error then why wasn't he able to tell me this was an invali tip during the months that we communicated?? Because I believe this I valid tip....and the truth is being evaded.  
I even found a "possible" connection to the Atlanta killings after tracki the name of the man that Helen is referring in her statement.

As I said before.....I did get opinions on this case from other organizations. Portions of these opinions are as follows.....

"This would not be the first time a jurisdiction has let murderers go unpunished."

".....it can backfire and they could be sued for prosecutorial misconduct if they have no further evidence than what they have now, f ethics would not allow them to charge someone without the prima facie established. That is a very gray area..... I have known cases to go a grand jury with less than what you have right now."

"The first thing to do is to determine who is dragging their heels. "

"I have had prosecutors tell me in the past they would not take a case trial even if the suspect walked into their office and dumped the bones the victim on their desk."

.....suggest the families retain a good lawyer."

"The most important is to have the families band together with a lawyer seek a grand jury, and have the FBI "invited" in to participate"

".....families can bring a civil suit against the suspect for wrongfu deaths."

"..... the cats will run from the bag, draw some press interest (key mc there) and force someone to do something."

"Once the family has a lawyer, one thing that has worked in the past is have the lawyer write a letter on behalf of the families (they are victim too and they have certain rights that no one in authority seems to pay attention to)."

".....request that if the police need assistance the family requests they invite the FBI to assist in the case. If they do no then they are bordering on being on the wrong end of a lawsuit."

I have always been very capable of locating the families of the victim

But I had rather do the right thing.

I know the local officials have been able to effectively kill any media inquiries generated in hopes to spark movement on the matter....for now

Is there any HOPE for resolution on this matter that has gone ignored almost 2 years from my initial start on the case?? Helen has spent decades on the case. And she has FAR more information that is revealed on the site.

Has some turn of events proved this information incorrect?? IF this information is in any way invalid.....will someone PLEASE tell me? Otherwise Helen and I have no choice but to continue to pursue things the best of our ability.
