

Dear Sheriff Bouchard:

I was surprised on July 16, 2014 when Assistant Oakland County Prosecutor Jeffrey Kaelin advised the Michigan Court of Appeals that his office had arranged for a three-hour videotaped conference with me. I assume Kaelin had reference to the August 31, 2012 conference with Lieutenant Gary Miller. The Oakland County Prosecutor ("OCP") did not participate in arranging this meeting. After the OCP refused at least 10 oral and written requests for a conference, I wrote you a short note requesting a meeting with your chief investigator. You promptly responded to this request and I met with Miller. I do not recall being advised that it was being videotaped. I would appreciate it if you could provide me with a copy of the videotape.
