PROPERTY INFORMATION:

During the search of the residence belonging to the family of Christopher Busch located at [redacted] back in October of 2008 by laboratory scientist, Lori Bruski, Cheryl Lozen and Guy Nutter, numerous items of [redacted]

Lori Bruski advised that during the following months after the search, she and the Northville team meticulously went over all associated evidence [redacted]

[redacted] Lori advised that additional (New), evidence had been located with evidence, (slides) taken from the children back in 76/77. This new evidence had to be identified marked and separated. After new evidence slides were produced, Lori Bruski authored a detailed letter of explanation advising what new evidence had been found along with what types of examinations that will be requested from the FBI Laboratory located in Quantico, VA. [redacted]

The attached letter of evidence explanation dated April 3, 2009, was mailed to Kary Oien of the FBI Evidence Control Unit at Quantico. **SEE ATTACHED.** In addition to the letter, a 6 page detailed list of evidence, past and present and the analysis requested with said evidence is also attached.

On June 5th 2009, the undersigned received confirmation from Case Coordinator, Charles A.
