David and Rob,

It's been a month and I am checking in to see if progress has been made with the MSP regarding digitization of the files and provision of the documents I have informally requested. More importantly, what is the position of the state lab on my request for a full written explanation of their position on further testing of the evidence in the four child homicide cases.

Unless I hear otherwise from you, I will proceed to file a FOIA request for clean copies of the four improperly redacted documents attached in my previous email.

How much will it cost to digitize the entire OCK case file? Even a rough estimate will due. I will start a Go Fund Me for this project if the MSP continue to resist the digitization project, because I'm sure the next excuse for this failure will be cost.

Whatever the position of the state lab, enough time has passed that they owe the families and the public answers about the state of the evidence. It will surprise no one if the conclusion is that the evidence has been so seriously mishandled from the very beginning that it is not amenable to third party lab testing. I will write the MSP colonel and copy the governor and the media if they continue the state lab's resistance to transparency in this case.

Furthermore, it is obvious to any sex offender who may have participated in these crimes, incarcerated or otherwise, that if the state lab had developed any usable DNA samples along the way, this case would not be the stalled-out failure that it is. Which brings me to

the failure of police to listen to and understand the statements of [REDACTED] a teen victim of Busch and Greene, who made consistent statements over the years that he was forced to have sex with a boy who looked like my brother and that Busch filmed/photographed this crime.

These three men were in their teens when they were victimized and then used by older pedophiles in Michigan to gain access to children. [REDACTED] Imagine if anyone in law enforcement had carefully listened to and documented the information male and female victims of the Michigan pedophile and child pornography rings had tried to convey post-2006. There would be a documented record of events that would have assisted greatly in any interrogation of a living suspect/participant.

These monsters used their teen victims to lure kids and to have sex with them that was filmed or photographed. That is why I sent you the transcript of Dr. Robert Sillery discussing the possibility that a teen had sex with Kristine. In addition to the reasons he gives in the transcript, Kristine could have also been drugged and this would explain the lack of injury that would indicate resistance.

Unless there is some response from the MSP concerning the above, I intend to move forward on my own and I will document all of it, with the exception of [REDACTED] in my blog. I imagine it is not that easy for your office to deal with the state lab or the MSP, but I intend to make a record of the continued failures of agencies in the State of Michigan to offer any transparency or accountability in the OCK case. If that is all I can accomplish, it is better than being played by law enforcement.
