

## AFFIDAVIT OF DEBORAH LOSEMAN

1. My name is Deborah Loseman. I am over 18 and, if called to testify, would testify as set forth below:

2. I reside in San Pedro, California.

3. I was first introduced to Sean Michael MacMaster back in 1990 when he was approximately 16 years of age. At this time, I had started dating his father, Donald MacMaster. It was very obvious to me right from the beginning, as he was an only child, Sean was a VERY spoiled, self-centered, pathological liar and was never held accountable for his actions.

4. The following is one example of the lying, very early in my relationship with Don, Sean came to visit from Michigan (where he was living with his mother, Barbara Orr). Since Don lived in Palmdale, CA and I then lived in Carson, CA, we left Sean at my parent's home while all of us were at work. The following month when my parents received their phone bill, there was approximately \$75.00 worth of charges to "900" phone numbers. In 1990, "900" numbers were Sex Chat Lines and the phone bills back then listed date, number and time the calls were made. When Sean was questioned about the charges, he flat out lied and said it wasn't him. No one else was home during the time the calls were made.

5. Don and I eventually moved in together which allowed Sean to move from Michigan to Torrance, CA where he was born and raised prior to moving to Michigan with his mother. As I mentioned above, Sean is an only child and always played the

“victim.” I didn’t know Sean until he was 16 years old, so I don’t know if he was always like this, but I saw it first hand when he came to live with us.

6. Sean has always had a low opinion of women. For example, when Sean was filling out paperwork to enroll in Torrance High School, where he dearly wanted to go, in front of his friend he made a very degrading, insulting and hurtful comment to me. He asked me what my title should be on the emergency card and before I could respond, he said, “House Whore?” Sean never took into account that if it wasn’t for me, he wouldn’t be back in Torrance.

7. In high school, if one of his friends didn’t praise him for something that he thought he should be praised for, all of sudden he perceived his friend as unappreciative and felt betrayed.

8. After his father’s death in 1994, Sean and I remained close. My parents and myself attended Sean’s college graduation. For many years on Father’s Day, I would receive a Father’s Day card because Sean felt that I was a strong and very important part of his life. After high school, Sean attended Lake Superior State College in Sault Ste. Marie, Michigan. During this time in college, between 1992-1997, Sean had a few roommates. Numerous times, Sean would call and be upset stating that his roommate was “picking on him” or some sort of other drama. After a few years of this, Don and I concluded that it couldn’t possibly be the other guys fault all the time.

9. Sean was and still is a spiteful and revengeful man. An example of this is one time he bragged to a very reliable source that because his hockey coach benched him

from a game, that he got even by sleeping with this coach's wife. I was never sure if he was lying or telling the truth.

10. After graduation, Sean met and impregnated a young woman named Darci. Darci gave birth to a baby boy on February 22, 1999. Sean eventually told me about this and he claimed that she wouldn't allow him to be part of Nathan's life. This was just another example of Sean falsifying reality so that he wouldn't have to admit that he was choosing not to be in his son's life. I later found out that Sean was ignoring his responsibility of paying his child support and it ended up being a court issue. I would tell Sean that he needed to keep proof that he had tried to contact his son because I felt that someday the boy would come looking for him and he would be able to show him that he had tried to have a relationship with him, but that his mother, Darci, wouldn't allow it. I was always very sad that I wasn't able to know or see my 1st grandchild. Darci later married and had other children. I was told that when Sean heard this, he asked Darci to have her husband adopt Nathan so that he wouldn't have to continue to pay child support.

11. Sean, then went on to become a police officer in Detroit, Michigan, and he worked in the precinct that was investigated for corruption in approximately 2003. Sean and I spoke about this incident and he alleged that he hadn't done anything wrong but he knew some of his fellow co-workers were guilty of the charges. I later learned that Sean was also being investigated, but he had quit the force before he could be charged for his own form of misconduct.



12. In 1998, Sean met Johanna while working in a restaurant in Oxford, Michigan. In 2003 Sean and Johanna moved to Gainesville, Florida, where Sean became a police officer with the Gainesville Police Department. In 2004, they got married after dating for 5-6 years. Sean then left the Gainesville Police Dept. in 2007 to obtain employment with the Florida State Agency of Alcohol, Beverage and Tobacco. This new job position took them to Vero Beach, FL, where they purchased their 1st home. Johanna was commuting over 3 ½ hours to her place of employment to support Sean's career. My 2nd grandchild, [REDACTED] was born on [REDACTED] in Gainesville, Florida, where they were again residing to support another one of Sean's career moves. My daughter-in-law, Johanna, would send me pictures of [REDACTED] via email to keep me involved in their lives, since I lived on the West coast. I was physically present to a loving, committed family unit between Sean, Johanna and [REDACTED]. I later discovered through court proceedings that this was a complete farse created by once again by Sean.

13. I developed a very close relationship with my daughter-in-law Johanna during their marriage and it still remains very strong today. I was saddened by the decision to terminate their marriage. I was very concerned about Johanna being so concerned and her generosity towards Sean's well-being during their separation and divorce. Here are some examples of my last comment: During the separation, I know for fact that Johanna's brother Jeff housed Sean so that he and [REDACTED] didn't have to spend all their time in a hotel, park or library. Sean and Johanna put most of their savings to pay off the house mortgage. I know that Johanna refinanced the home, found renters that

would provide income for Sean and later gave up her half of the equity they had built up in their home to Sean, once again for his financial gain. Johanna was still very much in love with him and continued to want to see him succeed. Sean, didn't want to give Johanna anything, this really concerned me because Johanna was willing to give him everything— house, retirement and allowed him to only pay half of the child support recommended by the court. She did this for the safety of her child, meaning that she found out some additional disturbing facts about Sean and was afraid to leave [REDACTED] with him on overnight visits.

14. The divorce became final in early December 2012 and the Schulte family (Johanna's family) hosted Sean on Christmas of that same year. I came to visit Johanna and [REDACTED] the very next month at which time Bill & Pat Schulte left their home and went to stay with other members of the family so that Johanna, Sean, [REDACTED] and myself could have time together. Five months later, Johanna, Sean and [REDACTED] came and saw me in California and the 3 of them slept on an air mattress together in my apartment. Our visits and time shared together continued until 2016 when my Granddaughter disclosed the horrific actions being done to her by her father.

15. Sean really presented himself as being a good person, which he is not. He is Dr. Jekyll and Mr. Hyde. I had thought he had outgrown his deceptive ways that Don and I were so concerned about, but evidently not. Sean literally told me that he had become a better person because of Johanna, her family and myself. Now, he is publicly slandering these wonderful people so that he once again doesn't have to take

accountability for his horrific actions against his own daughter. Sean is alleging that he is the victim of a bad divorce, trying to take away the real issue at hand. He uses distraction tactics by blaming others.

16. I could go on and on with examples of Sean's deceptiveness, immaturity and lack of accountability for his major life choices, high school relationships, college experiences, career failures, marriage, dysfunctional parenting and now this criminal act against his own child.

17. I declare, under penalty of perjury, that to the best of my knowledge, information, and belief, that the above statements are true.

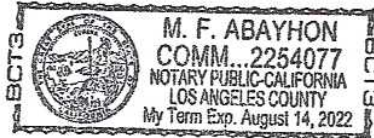
