I just finished a phone call with Carolyn at [redacted]. She saw Tim in a Blue Gremlin with Busch on March 22. Tim and she exchanged glances and he appeared to be composed. She passed them on M-59 and turned south on Dequindre.

When she arrived at 14 Mile and Dequindre she called the Birmingham police. She recognized Tim from the newspaper photos.

She saw the Investigative Discovery program and immediately recognized Busch. His beard was so bushy she thought it might be fake.

Her son is a MSP cadet and she told him about this incident. She has told no one else in her family because she does not want her memory tampered with. The son told Det. Sgt. Ken Walker of the MSP about her story. When she decided to call me Walker asked that he be told first and she or her son make this call. We can assume the MSP has the story.

I told her that Williams might call her, but we can assume the MSP knows about this lead. I told her I would call when we decided how to handle this. Where should we go?
